This matter came before Administrative Law Judge Eric L. Lipman upon the application of the Minnesota Department of Natural Resources (Department) for a legal review under Minn. Stat. § 14.388 (2024) and Minn. R. 1400.2400 (2023).

On July 1, 2025, the Department filed documents with the Office of Administrative Hearings seeking review and approval of the above-entitled rules.

Based upon a review of the written submissions by the Department, and the entire rulemaking record,

## IT IS HEREBY DETERMINED THAT:

- 1. The Department proposes these rules to conform Parts 6262.0576 and 6262.0577 to recent amendments to Minn. Stat. §§ 17.4982 and 97A.432 (2024).
- 2. The Department has the authority under Minn. Stat. §§ 14.388 (2024) to incorporate specific changes in administrative rules using the exempt rulemaking process when the changes are set forth in statute and no interpretation of law is required.
- 3. The rules were adopted in compliance with the procedural requirements of Minnesota Statutes, Chapter 14, and Minnesota Rules, Chapter 1400.

IT IS HEREBY ORDERED that the adopted rules are APPROVED.
