74.22 **Subdivision 1. Public input and access to proposed eligibility bylaws, policies, and**  
74.23 **procedures.** (a) The league shall adopt procedures to ensure public notice of all eligibility  
74.24 rules and bylaws, policies, and procedures that will afford the opportunity for public hearings  
74.25 on proposed eligibility rules bylaws, policies, and procedures. If requested by 100 25 or  
74.26 more parents or guardians of students, the public hearing must be conducted by an
