NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 75 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. This is a ten-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Proposed and adopted emergency rules do not appear in this set because of their short-term nature, but are published in the State Register.

If an agency seeks outside opinion before issuing new rules or rule amendments, it must publish a NOTICE OF INTENT TO SOLICIT OUTSIDE OPINION in the Official Notices section of the State Register. When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety in the State Register, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the Minnesota Guidebook to State Agency Services.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues 1-13 inclusive; issues 14-25 inclusive; issue 26, cumulative for issues 1-26; issues 27-38 inclusive; issue 39, cumulative for 1-39; issues 40-51 inclusive; and issue 52, cumulative for 1-52. An annual subject matter index for rules appears in August. Proposed Rules

Pursuant to Minn. Stat. of 1982, §§ 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing, as long as the agency determines that the rules will be noncontroversial in nature. The agency must first publish a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the State Register. The notice must advise the public:

- 1. that they have 30 days in which to submit comment on the proposed rules;
- 2. that no public hearing will be held unless 25 or more persons make a written request for a hearing within the 30-day comment period;
- 3. of the manner in which persons shall request a hearing on the proposed rules; and
- 4. that the rule may be modified if the modifications are supported by the data and views submitted.

If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.14-14.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the State Register.

Pursuant to Minn. Stat. §§ 14.29 and 14.30, agencies may propose emergency rules under certain circumstances. Proposed emergency rules are published in the *State Register* and, for at least 25 days thereafter, interested persons may submit data and views in writing to the proposing agency.

Proposed Revisions to the Occupational Safety and Health Standards

Notice is hereby given that the Department of Labor and Industry, Occupational Safety and Health Division (Minnesota OSHA) proposes to adopt the following revisions to the Minnesota Occupational Safety and Health Standards, as authorized under *Minnesota Statutes* § 182.655 (1986) amending the Occupational Safety and Health Standards that have already been proposed and adopted by the federal Occupational Safety and Health Administration (Federal OSHA).

Standards as Proposed

5205.0010 ADOPTION OF FEDERAL OCCUPATIONAL SAFETY AND HEALTH STANDARDS BY REFERENCE. The Minnesota Department of Labor and Industry, Occupational Safety and Health standards and rules are amended by incorporating and adopting by reference, and thereby making a part thereof, Title 29 of the *Code of Federal Regulations* as follows:

Part 1910: Occupational Safety and Health Standards as published in Volume 43, No. 206 of the *Federal Register* on October 24, 1978 and corrected in Volume 43, No. 216 on November 7, 1978 which incorporates changes, additions, deletions, and corrections made up to November 7, 1978; and subsequent changes made prior to December 1, 1987 April 1, 1988:

Part 1926: Construction Safety and Health Regulations as published in Part VII, Volume 44, No. 29 of the *Federal Register* on February 9, 1979 which incorporates changes, additions, deletions and corrections made up to October 17, 1978 and includes General Industry Occupational Safety and Health Standards (29 CFR Part 1910) which have been identified as applicable to construction work; and subsequent changes made prior to June 1, 1984 April 1, 1988:

Federal Register, Vol. 52, No. 187, dated September 28, 1987; "Revision of Construction Industry Test and Inspection Records (1926.500, 1926.552, and 1926.903); Final Rule."

Federal Register, Vol. 52, No. 233, dated December 4, 1987; "Occupational Exposure to Formaldehyde—1926.55."

Summary of Standards: The following summary of the proposed standards is very brief; persons interested in reviewing any of these standards in their entirety may obtain a copy as noted above.

A) "Occupational Exposure to Formaldehyde—1910.1048 and 1926.55." On December 4, 1987, Federal OSHA amended its existing standard for occupational exposure to formaldehyde. The revised standard reduces the permissible exposure limits (PELs) from 3 parts formaldehyde per million parts of air (ppm) to 1 ppm as an 8-hour time-weighted average (TWA). The peak allowable

exposure of 10 ppm (for up to 30 minutes) is revoked and the 5 ppm ceiling is reduced to 2 ppm as a 15-minute short term exposure limit (STEL). An "action level" of 0.5 ppm, measured as an 8-hour TWA, is included to minimize the compliance burden for employers whose employees have exceedingly low exposures to formaldehyde. The standard also contains provisions for employee exposure monitoring, medical surveillance, recordkeeping, regulated areas, emergency procedures, preferred methods to control exposure, maintenance and selection of personal protective equipment, and hazard communication.

The standard applies to all industries covered by OSHA including construction, maritime, and general industries and it applies to all occupational exposures to formaldehyde. This includes exposures in foundries, apparel manufacturing, the health care industry, cosmetology, general office environments, and the construction industry. [Although the construction industry already has a standard governing formaldehyde exposure, it has been determined that, until such time that the construction standard can be updated, this revised rule governing formaldehyde exposure shall apply to construction worksites.]

"Formaldehyde" is defined simply as the chemical entity, HCHO, as covered under the Chemical Abstracts Service Registry No. 50-00-0. Therefore, the standard applies to formaldehyde gas, its solutions, and a variety of materials, such as trioxane, paraformaldehyde, hexamethylenetetramine, and resin formulations from which formaldehyde may be generated. Solids and any mixture containing formaldehyde are included in this standard to the extent that they are sources of formaldehyde exposure.

The standard includes five appendices that primarily provide additional information. Appendix A, Substance Technical Guidelines for Formaldehyde, and Appendix B, Sampling Strategies and Analytical Methods for Formaldehyde, are designed to aid employers in complying with the requirements of the standard. Appendix C, Medical Surveillance Guidelines for Formaldehyde, and Appendix D, Medical Disease Questionnaire (nonmandatory), provide examining physicians with the information necessary to conduct the medical surveillance programs mandated by this standard. Appendix E provides the protocols for quantitative and qualitative fit testing for negative-pressure respirators. Employers are specifically required by the standard's training provision to provide their employees with the information contained in Appendix A.

The standard became effective at the federal level on February 2, 1988, except for the information collection requirements which were under review at the Office of Management and Budget. On March 2, 1988, Federal OSHA published a notice of partial approval of the information collection requirements of the standard; these provisions became effective March 2, 1988, with the exception of paragraphs (m)(1)(i) through (m)(4)(ii). These paragraphs include the hazard communication requirements of the Formaldehyde Standard, including labeling and material safety data sheets. Until Federal OSHA determines what further steps to take in response to OMB's denial, OSHA will continue to enforce the labeling and material safety data sheet requirements of the Hazard Communication Standard.

By this notice, Minnesota OSHA proposes to adopt the Occupational Exposure to Formaldehyde Standard, 1910.1048 and 1926.55, as published in the *Federal Register* on December 4, 1987. The standard will become effective sixty days after publication of the adoption notice. Initial monitoring the determine expsure levels, initial medical surveillance, and implementation of an emergency plan must be completed within six months of the effective date; respiratory provisions within nine months; and engineering and work practice controls within one year. Pathology, histology and gross anatomy laboratories must follow the above schedule. Other laboratories have until September 1, 1988, to comply with the various provisions, except for the STEL and PEL sections. Labeling and material safety data sheet requirements for occupational exposure to formaldehyde, will be governed by the Minnesota Employee Right-to-Know Act until Federal OSHA obtains OMB approval of paragraphs (m)(1)(i) through (m)(4)(ii).

B) "Grain Handling Facilities—1910.272, 1917.1, and 1917.72." On December 31, 1987, Federal OSHA adopted a final standard for grain handling facilities which contains minimum requirements for the control of fires, grain dust explosions, and other safety hazards associated with grain handling facilities. Employees in these facilities have been and continue to be exposed to fires and explosions. Additionally, employees are exposed to other safety hazards such as the dangers of entry into bins, silos, and tanks. The requirements in this standard are intended to decrease the number and mitigate the effects of fires and explosions and to control other known safety hazards in grain handling facilities.

Paragraphs (a) through (m) of this section apply to grain elevators, feed mills, flour mills, rice mills, dust pelletizing plants, dry corn mills, soybean flaking operations, and the dry grinding operations of soycake. Paragraphs (n), (o), and (p) apply to grain elevators. The standard does not apply to seed plants which handle and prepare seeds for planting of future crops, not to on-farm storage or feed lots.

The standard requires employers to: (1) develop and implement an emergency action plan covering those designated actions employers and employees are to take to ensure employee safety from fire and other emergencies; (2) provide training to employees

Proposed Rules:

in the recognition and prevention of hazards associated with grain facilities, especially those hazards associated with their own work tasks; (3) implement a permit system for hot work to assure that control over operations involving hot work is maintained and to assure that employees are aware of and utilize appropriate safeguards when conducting these activities; (4) issue a permit for entry into bins, silos and tanks unless the employer or employer's representative is present during the entry operation; (5) inform contractors performing work at the facility of known potential fire and explosion hazards related to the contractor's work as well as the safety rules of the facility; (6) develop and implement a written housekeeping program that establishes the frequency and methods determined best to reduce accumulations of grain dust on ledges, floors, equipment and other exposed surfaces; and (7) implement preventive maintenance procedures to control dust and ignition sources. The standard also requires grain stream processing equipment (such as hammer mills, grinders and pulverizers) to be equipped with an effective means of removing ferrous material from the incoming grain stream; requires at least two means of emergency escape; requires all direct-heat grain dryers to be equipped with automatic controls by April 1, 1991; and requires implementation of special safety precautions and procedures, as well as the installation of safety control devices on inside bucket elevators.

By this notice, Minnesota OSHA proposed to adopt the final rule for Grain Handling Facilities as published in the *Federal Register* on December 31, 1987, with the exception of the information collection requirements contained in 1910.272(d) and (i) which are awaiting approval of the Office of Budget and Management.

C) "Presence Sensing Device Initiation of Mechanical Power Presses—1910.217." On March 14, 1988, Federal OSHA adopted a final rule amending its standard for mechanical power presses, 29 CFR 1910.217, Subpart O, to allow (but not require) presence sensing device initiation (PSDI) on certain types of power presses. The amended standard addresses the use of presence sensing devices as well as the entire mechanical power press safety system involved in operating in the PSDI mode. OSHA also amended the related standard on definitions, 29 CFR 1910.211, as appropriate, to support the revision to the mechanical power press standard. Prior to this amendment, OSHA did not permit PSDIs, but rather required that a mechanical power press operator physically initiate the stroke of the press by using hand controls or a foot pedal.

Because presence sensing device initiation has been used safely in other countries for some time and on an experimental basis in the United States since 1976, OSHA believes this prohibition is technically outdated and that PSDI, overall, enhances employee safety. This revision allows a presence sensing device to initiate the stroke of the press automatically when the operator's body is out of the danger zone.

The standard allows presence sensing device initiation (PSDI) of mechanical power presses unless present state-of-the-art technology will not allow it to be done safely. Only part revolution type mechanical power presses are approved for PSDI. Similarly, only presses with a configuration such that a person's body cannot completely enter the bed area are approved for PSDI. Requirements are included for brakes, brake monitoring, pneumantic systems, flywheels and bearings, cycle control and control systems, environmental requirements, safety systems, safeguarding the point of operation, and safety system certification/validation. Appendices A and C to the standard include mandatory requirements for certification validation of the PSDI safety system; Appendix B includes nonmandatory supplementary information and guidelines relating to certification/validation of the PSDI safety system.

By this notice, Minnesota OSHA proposes to adopt the "Presence Sensing Device Initiation of Mechanical Power Presses" standard as published in the *Federal Register* on March 14, 1988.

D) This notice also corrects the February 1, 1988, notice which adopted Federal OSHA standards governing 'Servicing of Single Piece and Multi-Piece Rim Wheels at Marine Terminals (1917.44)" and "Revision of Construction Industry Test and Inspection Records (1926.550, 1926.552, and 1926.903)." 5200.1105 RENTAL RATES FOR TRUCKS ON HIGHWAY PROJECTS.

Drivers who own and operate trucks on contract work shall be compensated for their equipment according to the following formula: Truck Rental Rates Equals Labor Cost Plus Operating Cost.

Labor cost shall be the rate determined to be prevailing by the Department of Labor and Industry using existing survey methods under parts 5200.1000 to 5200.1120.

Operating cost shall be determined by averaging the itemized costs of operating a vehicle as submitted from not less than four trucking firms selected by the commissioner as representative of the industry.

The following items shall be considered as operating costs of a vehicle: the average cost of the vehicle depreciated over seven years, insurance, fuel, oil, tires, taxes, licenses, and any administrative expense associated with the vehicle's operation.

Within 30 days of determination of rates, an informal conference will be held by the commissioner or the commissioner's representative, for the purpose of further input prior to certification. Interested parties shall be given at least ten days' prior notice of the conference date, time, and location, through publication in the *State Register*.

At the conference the department shall produce and review the data, summary sheets, and other documents upon which its determination was based.

Notice of the certification and its effective date shall be published in the State Register in accordance with part 5200.1080.

Emergency Executive Order #88-5 Providing Fire Fighting Assistance to the Commissioner of Natural Resources

WHEREAS, the Commissioner of the Department of Natural Resources has requested assistance in the effort to control several wildfires throughout the State of Minnesota; and

WHEREAS, the number and locations of these fires are beyond the capabilities of local emergency resources;

NOW, THEREFORE, I hereby order that:

- 1. The Adjutant General of Minnesota order to active duty on or after April 9, 1988, in the service of the State, such elements and equipment of the military forces of the state as needed and for such period of time as necessary to ensure the safety of our citizens.
- 2. The cost of subsistence, transportation, fuel, and pay and allowances of said individuals shall be defrayed from the general fund of the State as provided for by *Minnesota Statutes* 1986, Section 192.49, Subdivision 1, Section 192.51 and Section 192.52.

Pursuant to *Minnesota Statutes* 1986, Section 4.035, Subdivision 2, this Order shall be effective April 9, 1988 and shall remain in effect until such date as elements of the military forces of the State are no longer required.

The portion of the percentage change in the index in excess of a multiple of ten percent shall be disregarded. Dollar amounts change only in multiples of ten percent of amounts appearing in law effective August 1, 1981.
