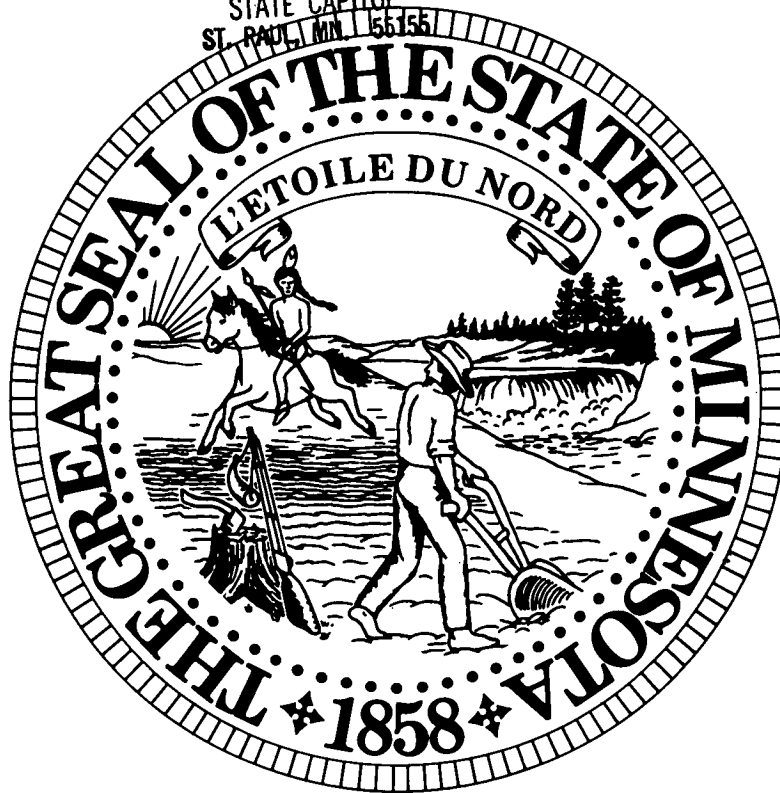

# Minnesota Rules: Amendments and Additions

## NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 75 state agencies have the authority to issue rules. Each agency is assigned specific *Minnesota Rule* chapter numbers. Every odd-numbered year the *Minnesota Rules* are published. This is a ten-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Proposed and adopted emergency rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

If an agency seeks outside opinion before issuing new rules or rule amendments, it must publish a NOTICE OF INTENT TO SOLICIT OUTSIDE OPINION in the *Official Notices* section of the *State Register*. When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*; only the changes made since their publication as **Proposed Rules**. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues 1-13 inclusive; issues 14-25 inclusive; issue 26, cumulative for issues 1-26; issues 27-38 inclusive; issue 39, cumulative for 1-39; issues 40-51 inclusive; and issue 52, cumulative for 1-52. An annual subject matter index for rules appears in August. **Proposed Rules**

Pursuant to Minn. Stat. §§ 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing, as long as the agency determines that the rules will be noncontroversial in nature. The agency must first publish a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the *State Register*. The notice must advise the public:

1. that they have 30 days in which to submit comment on the proposed rules;
2. that no public hearing will be held unless 25 or more persons make a written request for a hearing within the 30-day comment period;
3. of the manner in which persons shall request a hearing on the proposed rules; and
4. that the rule may be modified if the modifications are supported by the data and views submitted.

If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.14-14.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the *State Register*.

Pursuant to Minn. Stat. §§ 14.29 and 14.30, agencies may propose emergency rules under certain circumstances. Proposed emergency rules are published in the *State Register* and, for at least 25 days thereafter, interested persons may submit data and views in writing to the proposing agency.

**Proposed Permanent Rules Relating to Ambulance Services**

**Notice of Intent to Adopt a Rule Without a Public Hearing**

NOTICE IS HEREBY GIVEN that the Minnesota Department of Health intends to adopt the above-entitled rule without a public hearing following the procedures of the Administrative Procedures Act for adopting rules without a public hearing in *Minnesota Statutes*, sections 14.22 to 14.28. The statutory authority to adopt the rule is *Minnesota Statutes*, section 144.804, subdivision 3.

All persons have 30 days or until 4:30 p.m. on June 7, 1989 in which to submit comment in support of or in opposition to the proposed rule or any part or subpart of the rule. Comment is encouraged. Each comment should identify the portion of the proposed rule addressed, the reason for the comment, and any change proposed.

Any person may make a written request for a public hearing on the rule within the 30-day comment period. If 25 or more persons submit a written request for a public hearing within the 30-day comment period, a public hearing will be held unless a sufficient number withdraw their request in writing. Any person requesting a public hearing should state his or her name and address, and is encouraged to identify the portion of the proposed rule addressed, the reason for the request, and any change proposed. If public hearing is required, the agency will proceed pursuant to *Minnesota Statutes*, sections 14.131 to 14.20.

The proposed rule may be changed if the changes are supported by data and views submitted to the agency and do not result in a substantial change in the proposed rule as noticed. A copy of the proposed rule is attached to this notice.

A statement of need and reasonableness that describes the need for and reasonableness of each provision of the proposed rule and identifies the data and information relied on to support the proposed rule has been prepared and is available from Wayne Arrowood on request.

Adoption of these rules will not result in additional spending by local public bodies in excess of \$100,000 per year for the first two years following adoption under the requirements of *Minnesota Statutes*, section 14.11.

If no hearing is required, on adoption of the rule, the rule and the required supporting documents will be submitted to the Attorney General for review as to legality and form to the extent the form relates to legality. Any person may request notification of the date of submission to the Attorney General. Persons who wish to be advised of the submission of this material to the Attorney General, or who wish to receive a copy of the adopted rule, must submit the written request to Wayne Arrowood.

#### 4690.0100 DEFINITIONS.

Subp. 3. **Variance to allow intravenous infusion.** The commissioner shall grant a variance to allow the establishment or maintenance of intravenous infusions by basic ambulance services only if the applicant shows that:

A. to C. [Unchanged.]

D. continuing education or clinical training is provided annually to persons authorized to establish or maintain intravenous infusions; and

E. ~~the administration of intravenous infusions is restricted to solutions administered only for fluid volume replacement; and~~  
F. documentation of items A to ~~E~~ D is retained in the licensee's file.

Persons who possess intermediate emergency medical technician and paramedic certificates are deemed to comply with the requirement in item A.

Subp. 4. to 6. [Unchanged.]

# Adopted Rules

The adoption of a rule becomes effective after the requirements of Minn. Stat. § 14.14-14.28 have been met and five working days after the rule is published in *State Register*, unless a later date is required by statutes or specified in the rule.

If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed.

If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

An emergency rule becomes effective five working days after the approval of the Attorney General as specified in Minn. Stat. § 14.33 and upon the approval of the Revisor of Statutes as specified in § 14.36. Notice of approval by the Attorney General will be published as soon as practicable, and the adopted emergency rule will be published in the manner provided for adopted rules under § 14.18.

## Department of Public Service

### Adopted Permanent Rules Relating to Cost-Share Maxi-Audit Grants for Public and Private Institutions

The rules proposed and published at *State Register*, Volume 13, Number 31, pages 1852-1855, January 30, 1989 (13 S.R. 1852) are adopted with the following modifications:

#### Rules as Adopted

#### 7660.0090 FUNDING.

Subp. 2. **Limits.** Grants will be issued by the department for eligible applications ~~up to the funding limits~~, based on ~~building size, as shown in the following table~~ a formula of \$.04 per square foot of area plus \$2,000. The department will reimburse grantees for 80 percent of the actual cost of a cost-share maxi-audit or the approved grant amount, whichever is less, when the requirements of part 7660.0080 have been met.

# Emergency Rules

## Proposed Emergency Rules

According to Minn. Stat. of 1984, §§ 14.29-14.30, state agencies may propose adoption of emergency rules if: 1) expressly required; 2) authorized by statute; or 3) if the manner permitted by a directive (given by statute, federal law or court order) does not allow for compliance with sections 14.14-14.28. The agency must, however, publish a notice of intent to adopt emergency rules, along with the rules themselves, in the *State Register*. The notice must advise the public:

- 1) that a free copy of the proposed emergency rule is available upon request from the agency;
- 2) that notice of the date that the rule is submitted to the attorney general will be mailed to persons requesting notification;
- 3) that the public has at least 25 days after publication of the proposed emergency rule to submit data and views in writing; and
- 4) that the emergency rule may be modified if the data and views submitted support such modification.

## Adopted Emergency Rules

Emergency rules take effect five working days after approval by the attorney general, and after compliance with Minn. Stat. §§ 14.29-14.365. As soon as possible, emergency rules are published in the *State Register* in the manner provided for in section 14.18.

Emergency rules are effective for the period stated in the notice of intent to adopt emergency rules. This may not exceed 180 days.

## Continued/Extended Emergency Rules

Adopted emergency rules may be continued in effect (extended) for an additional 180 days. To do this, the agency must give notice by: 1) publishing notice in the *State Register*; and 2) mailing the same notice to all persons who requested notification on rulemaking. No emergency rule may remain in effect 361 days after its original effective date. At that point, permanent rules adopted according to Minn. Stat. 14.14-14.28 supercede emergency rules.

### 62I.21 ACTIVATION OF MARKET ASSISTANCE PLAN AND JOINT UNDERWRITING ASSOCIATION.

At any time the commissioner of commerce deems it necessary to provide assistance with respect to the placement of general liability insurance coverage on Minnesota risks for a class of business, the commissioner shall by notice in the *State Register* activate the market assistance plan and the joint underwriting association. The plan and association are activated for a period of 180 days from publication of the notice. At the same time the notice is published, the commissioner shall prepare a written petition requesting that a hearing be held to determine whether activation of the market assistance plan and the joint underwriting association is necessary beyond the 180-day period. The hearing must be held in accordance with section 62I.22. The commissioner by order shall deactivate the market assistance program and the joint underwriting association at any time the commissioner finds that the market assistance program and the joint underwriting association are not necessary.

### 62I.22 HEARING.

**Subdivision 1. ADMINISTRATIVE LAW JUDGE.** The commissioner shall forward a copy of the petition to activate the market assistance plan and the joint underwriting association with respect to a class of business to the chief administrative law judge. The chief administrative law judge shall, within three business days of receipt of the copy of the petition, set a hearing date, assign an administrative law judge to hear the matter, and notify the commissioner of the hearing date and administrative law judge assigned to the matter. The hearing date must be no less than 60 days nor more than 90 days from the date of receipt of the petition by the chief administrative law judge.

**Subd. 2. NOTICE.** The commissioner of commerce shall publish notice of the hearing in the *State Register* at least 30 days before the hearing date. The notice should be that used for rulemaking under chapter 14. Approval by the administrative law judge of the notice prior to publication is not required. The notice must contain a statement that anyone wishing to oppose activation beyond 180 days for any particular class, must file a petition to intervene with the administrative law judge at least ten days before the hearing date. If no notice to intervene is filed for a class then the class is activated beyond the 180-day period without further action.

**Subd. 3. CONTESTED CASE; REPORT.** The hearing and all matters after the hearing are a contested case under chapter 14. Within 45 days from the commencement of the hearing and within 15 days of the completion of the hearing the administrative law judge shall submit a report to the commissioner of commerce. The parties, or the administrative law judge, if the parties cannot agree, shall adjust all time requirements under the contested case procedure to conform with the 45-day requirement.

**Subd. 4. DECISION.** The commissioner shall make a decision within ten days of the receipt of the administrative law judge's report.

**Subd. 5. WAIVER OR MODIFICATION.** If all parties to the proceeding agree, any of the requirements of this section may be waived or modified.

CASE PRESENTATION.** The department of commerce, upon request by small businesses as defined by section 14.115, subdivision 1, shall assist small businesses in any specific class requesting continuation of coverage beyond the 180-day period, in coordinating the class and presenting the case in the contested hearing.

Pregnant women count as two people. Add \$2,040 for each additional family member for families with more than 8 members.

As of April 1989, more than 7,000 children are enrolled. The potential for enrollment is estimated to be 30,000 children under age 9. Current Legislation has been introduced to expand the age limit to 18. The potential enrollment for children between ages 9 and 18 is estimated to be another 30,000.

**C2-88-2382 Thomas J. Fielding v. George A. Hormel Company and Minnesota Department of Jobs and Training. Workers' Compensation Court of Appeals.**

1. If an injured employee voluntarily goes out on strike, this provides grounds for the suspension of benefits; but the suspension of benefits will be lifted once it has become demonstrable that the disability due to the work injury is the cause of the employee's inability to find work elsewhere.

2. The general recall letter to all striking employees, while extending an offer of re-employment, contained no assurances to disabled employees of placement in light-duty jobs on their return; and as such, did not operate as an effective offer of employment to disabled employees so as to suspend benefits upon a failure to respond.

Both motions were consolidated for hearing and came before the Honorable Arthur C. Roemer, Judge of the Minnesota Tax Court, on January 23, 1989, at the Courtroom of the Tax Court, 520 Lafayette Road, St. Paul, Minnesota.

Keith A. Queenen and John C. Boylan, Attorneys at Law, of the Rerat Law Firm, P.A., represented the appellants.

David R. Brennan and Anita Crews, Attorneys at Law, with the firm of Faegre and Benson, appeared as Special Attorneys for the Attorney General of Minnesota, representing the appellee.

The sole issue in the action is whether any portion of railroad retirement benefits received by the appellants are includible in gross income for Minnesota income tax purposes.

Affidavits and briefs in support of their respective motions were filed by both parties, and the matter was submitted to the Court for decision on February 28, 1989.

The Court, having heard and considered the arguments of counsel and upon all of the files and records herein, now makes the following:

#### ORDER

1. Appellants' motion for summary judgment is hereby granted.



2. Appellee's motion for summary judgment is hereby denied.

**First Half of Property Taxes Due May 15:** Property owners have until Monday, May 15 to pay the first half of their property tax payment. About 40 percent of Minnesota's property owners include their property tax payment in their monthly mortgage payments to banks or financial institutions, which then send the payments to the counties. Sixty percent handle payment themselves. Minnesotans can make their payments in person at the county treasurer's offices or by mail with a postmark no later than the date due. The second half payment is due Oct. 15, 1989. In Minnesota, property taxes collected by county treasurers are used entirely to fund local governments and schools.

District E covers Anoka County; District F, the cities of Robbinsdale, Golden Valley, St. Louis Park, Edina, Richfield and Bloomington; District G, Carver, Scott, and western Hennepin Counties; and District H, Dakota and southern Washington Counties.

**Twin Cities Metro-Area Unemployment Rate:** The unemployment rate for the Minneapolis-St. Paul metropolitan area declined to 3.6 percent in March, down from 3.8 percent in February, considered a normal change between these two months. The March 1988 unemployment reading was 3.5 percent. The number of employed people grew by 0.4 percent for the month, while the number of unemployed workers decreased by 5.1 percent. The comparable national unemployment rate for March was 5.2 percent. The statewide unemployment rate in March was 4.5 percent. Compared with March a year ago, the size of the Twin Cities metropolitan area civilian labor force increased by 0.5 percent; the number of employed people increased by 0.3 percent; and the number of unemployed workers increased by 5.2 percent. The metropolitan area labor force in March was 1,385,900, up 2,400 from February, and up 6,700 from March of last year. The number of people employed in March was 1,335,400, up 5,100 from February and up 4,200 from March a year ago. The number of unemployed people in the Twin Cities area in March was 50,500, down 2,700 from February and up 2,500 from March a year ago.

**St. Louis Fishing Restrictions:** New restrictions on catching game fish in the Minnesota-Wisconsin boundary waters of the St. Louis River are in effect. The Department of Natural Resources (DNR) says the changes are designed to control the river ruffe, an exotic species of fish, in the St. Louis River by restricting the number and minimum size of game fish that can be taken from the St. Louis River and prohibiting harvesting of minnows from the river. The river ruffe is a European fish accidentally released into Lake Superior and the St. Louis River when ocean-going vessels emptied ballast tanks.

River ruffe are an aggressive fish which compete with native species and destroy fish habitat. "The river ruffe will take over the niches that game fish occupy to the detriment of the native game fish," said Jack Wingate, research manager for the DNR section of Fisheries. "We're trying to build up the predator populations in the St. Louis with the hope that the game fish will prey on the river ruffe and eliminate the exotic species from the river. You can no longer harvest minnows from the St. Louis. The restrictions on bait harvesting are put in effect so that anglers don't inadvertently harvest the ruffe and carry them inland," Wingate said. Also included is a ban on the possession or transportation of river ruffe and white perch. **Fishing Restrictions on the St. Louis River:** 1) Species 2) Open Season 3) Limits 4) Size 1) Walleye, 2) April 29, 3) Two, 4) Minimum size 15", 1) Northern Pike, 2) April 29, 3) Two, 4) Minimum size, 1) Largemouth and Smallmouth, 2) May 27, 3) Five, 4) Minimum size 12", 1) Muskellunge, 2) May 27, 3) One, 4) Minimum size 36", NOTE: • The taking of minnows for bait purposes is prohibited, • No person shall fish in the St. Louis River from the Minnesota-Wisconsin boundary cable downstream to the Hwy. 23 bridge from March 1 through May 18, • No fishing at any time in the St. Louis River from the Fond du Lac Dam downstream to approximately one-half mile from the Minnesota-Wisconsin boundary cable • There is a ban on the possession of river ruffe and white perch. The Minnesota season on the St. Louis for walleye and northern pike opened April 29 while the Wisconsin season doesn't open until May 13.
