Minnesota Rules: Amendments and Additions =

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 75 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. This is a ten-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Proposed and adopted emergency rules do not appear in this set because of their short-term nature, but are published in the State Register.

If an agency seeks outside opinion before issuing new rules or rule amendments, it must publish a NOTICE OF INTENT TO SOLICIT OUTSIDE OPINION in the Official Notices section of the State Register. When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety in the State Register, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the Minnesota Guidebook to State Agency Services.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues 1-13 inclusive; issues 14-25 inclusive; issue 26, cumulative for issues 1-26; issues 27-38 inclusive; issue 39, cumulative for 1-39; issues 40-51 inclusive; and issue 52, cumulative for 1-52. An annual subject matter index for rules appears in August. Adopted Rules

The adoption of a rule becomes effective after the requirements of Minn. Stat. § 14.14-14.28 have been met and five working days after the rule is published in *State Register*, unless a later date is required by statutes or specified in the rule.

If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous State Register publication will be printed.

If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous State Register publication will be cited.

An emergency rule becomes effective five working days after the approval of the Attorney General as specified in Minn. Stat. § 14.33 and upon the approval of the Revisor of Statutes as specified in § 14.36. Notice of approval by the Attorney General will be published as soon as practicable, and the adopted emergency rule will be published in the manner provided for adopted rules under § 14.18.

Adopted Permanent Rules Relating to Minnesota Grown Labeling Statements

The rules proposed and published at State Register, Volume 13, Number 38, pages 2267-2270, March 20, 1989 (13 S.R. 2267) are adopted as proposed.

Emergency Rules

Proposed Emergency Rules

According to Minn. Stat. of 1984, §§ 14.29-14.30, state agencies may propose adoption of emergency rules if: 1) expressly required; 2) authorized by statute; or 3) if the manner permitted by a directive (given by statute, federal law or court order) does not allow for compliance with sections 14.14-14.28. The agency must, however, publish a notice of intent to adopt emergency rules, along with the rules themselves, in the *State Register*. The notice must advise the public:

- 1) that a free copy of the proposed emergency rule is available upon request from the agency;
- 2) that notice of the date that the rule is submitted to the attorney general will be mailed to persons requesting notification;
- 3) that the public has at least 25 days after publication of the proposed emergency rule to submit data and views in writing; and
- 4) that the emergency rule may be modified if the data and views submitted support such modification.

Adopted Emergency Rules

Emergency rules take effect five working days after approval by the attorney general, and after compliance with Minn. Stat. §§ 14.29-14.365. As soon as possible, emergency rules are published in the *State Register* in the manner provided for in section 14.18.

Emergency rules are effective for the period stated in the notice of intent to adopt emergency rules. This may not exceed 180 days.

Continued/Extended Emergency Rules

Adopted emergency rules may be continued in effect (extended) for an additional 180 days. To do this, the agency must give notice by: 1) publishing notice in the *State Register*; and 2) mailing the same notice to all persons who requested notification on rulemaking. No emergency rule may remain in effect 361 days after its original effective date. At that point, permanent rules adopted according to Minn. Stat. 14.14-14.28 supercede emergency rules.

Outside Opinion Sought Regarding Amendments of State Water Quality Standards (*Minnesota Rules* Chapter 7050)

NOTICE IS HEREBY GIVEN that the Minnesota Pollution Control Agency (Agency) is seeking opinions, suggestions, and comments from sources outside the Agency to assist in the preparation of proposed amendments to state water quality standards found in *Minnesota Rules* Chapter 7050. Chapter 7050 includes general standards applicable to all waters of the state, numerical water quality standards for the protection of specific beneficial uses such as swimming and fishing, effluent standards for dischargers, and a use classification system for all waters of the state.

The Clean Water Act Amendment of 1987 requires states to establish water quality standards for certain toxic substances. Guidance from the U.S. Environmental Protection Agency to states on how to meet these requirements indicates that states can adopt numerical standards, the procedures for developing numerical standards or both. The Agency is seeking opinions on any portion of the cited rule, but is particularly interested in comments on the amendments the Agency is considering to comply with the federal requirements. A notice to solicit outside public opinion on these amendments appeared in the *State Register* on December 27, 1988. The Agency is soliciting comments again because the scope of the amendments has changed, and the Agency wishes to give the public ample opportunity to comment on the following amendments.

- 1. Procedures for developing standards for toxic substances. The Agency is proposing to include a detailed procedure in the rule that will be used to set numerical water quality standards for surface waters. The procedure the Agency is considering will protect fish and other aquatic organisms, the health of people who catch and eat fish, and wildlife that eat aquatic plants and animals. The range of toxic substances for which standards must be set includes common industrial chemicals such as solvents and petroleum byproducts, trace metals such as lead and mercury, and pesticides such as chlordane and atrazine. Some of these substances have direct toxic effects on aquatic life (systemic), some are believed to cause cancer, and some are bioaccumulative or persistent in the environment.
- 2. Numerical standards for 50 to 70 toxic substances will be proposed to protect surface waters for fisheries and recreational uses. The standards will be determined using the procedures referenced in number 1 above.
- 3. The Agency is required to consider the economic impact of the proposed amendments, but the weight given to economics is open for comment. The public may wish to consider the extent standards should take into account potential costs to consumers, communities, businesses and industries that must meet the standards.
- 4. As a result of internal review and outside requests, the Agency will consider two waters for possible reclassification as Class 7 limited resource value waters. Waters assigned the Class 7 use classification are generally low flow streams and ditches where the

national "fishable/swimmable" goal appears to be unattainable. While Class 7 waters are protected so as to allow secondary body contact use, to preserve the ground water for use as a potable water supply and to protect the aesthetic qualities of the water, the aquatic life standards are not applicable to these waters. The waters proposed to be considered for possible reclassification along with their existing or potential wastewater dischargers are as follows:

5. The Agency is proposing that additional waters be designated as Outstanding Resource Value Waters (ORVWs). Waters assigned the ORVWs designation are unique to the State in that they are "exceptional recreational, cultural, aesthetic or scientific resources." Water designated as ORVWs are protected through the nondegradation provisions of *Minnesota Rules* Part 7050.0180. As of this date, the Agency is proposing that three additional calcareous fens be designated as ORVWs. Calcareous fens are rare wetland plant communities which in general have a disproportionate number of rare, threatened and endangered plant species. These three calcareous fens are identified as follows:

PLEASE TAKE NOTICE that the Minnesota Pollution Control Agency (MPCA) proposes to issue the city of Russell a variance from the requirements in *Minnesota Rules* pt. 7075.0409, subp. 2, which specifies the submittal dates for an amended facilities plan, plans and specifications, addendum, sewer service charge system, and corrections to items in subp. 2.C.

The city of Russell previously received a Step 1 grant for facilities planning, was on the fiscal year 1989 Municipal Project List, and submitted an application for a construction grant in fiscal year 1989. The city met all the requirements for fiscal year 1989 funding. The city revised the estimated project costs during the application process. Upon review of the application package the city of Russell and the MPCA questioned the affordability of the proposed project and determined that the city could not afford the upgrade of the existing mechanical plant to bring it into compliance with effluent limits. Because the high monthly costs of the proposed facility were not affordable to the city, the MPCA withdrew the grant offer and returned the application.

Official Notices

The city of Russell has been exploring other treatment options both with their consultant and with MPCA staff. After further testing of land sites, revised estimates of operation, maintenance, and replacement costs of other facilities, and with the assistance of the MPCA Staff, the city of Russell was able to locate a site that would be acceptable for the construction of a stabilization pond system; a project which the city of Russell can afford to build, operate, and maintain, if a fiscal year 1990 grant were available. Therefore, the city of Russell has applied for a variance to the submittal dates in *Minnesota Rules* pt. 7075.0409 in order to be placed on the fiscal year 1990 Municipal Project List. The pond system has advantages for the city and state by avoiding any effluent discharge to the Redwood River in the summer when pollutant loads are most critical. This river flows through Camden State Park.

The MPCA Commissioner has made a preliminary decision to grant a variance in order to allow the city of Russell to be placed on the fiscal year 1990 Municipal Project List. This preliminary decision will be presented to the MPCA Board at its July 25, 1989, meeting. The Commissioner believes that granting the city of Russell this variance is in accordance with the MPCA goals and guidelines. The estimated amount of federal grant dollars necessary for the project is \$624,800.

C9-87-2434 State of Minnesota, by Stephen W. Cooper, Commissioner, Department of Human Rights, Appellant v. Hennepin County. Court of Appeals.

An applicant rejected for a position as a detention deputy due to a job qualification which requires uncorrected vision of 20/100 is not substantially limited in one or more major life activities and as such is not a disabled person under the Minnesota Human Rights Act, *Minnesota Statutes* § 363.01, subd. 25(a) (Supp. 1983).

Affirmed. Popovich, C.J.

Dissenting, Coyne and Wahl, JJ.

C7-88-2586, C3-88-2620 Winford J. McIntosh v. The Honorable Michael J. Davis, Judge of the Fourth Judicial District and the Honorable Peter Lindberg, Chief Judge of the Fourth Judicial District, Petitioners, and James L. Hadley v. The Honorable Charles Porter, Judge of the Fourth Judicial District, the Honorable Michael J. The cumulative effect of errors involving subversion of the independence of the grand jury, the distribution of an informational packet prepared by former jurors and erroneous and misleading instructions is error requiring dismissal of the grand jury's indictments.
