# Minnesota Rules: Amendments and Additions =

#### NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 75 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. This is a ten-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Proposed and adopted emergency rules do not appear in this set because of their short-term nature, but are published in the State Register.

If an agency seeks outside opinion before issuing new rules or rule amendments, it must publish a NOTICE OF INTENT TO SOLICIT OUTSIDE OPINION in the *Official Notices* section of the *State Register*. When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues 1-13 inclusive; issues 14-25 inclusive; issue 26, cumulative for issues 1-26; issues 27-38 inclusive; issue 39, cumulative for 1-39; issues 40-51 inclusive; and issue 52, cumulative for 1-52. An annual subject matter index for rules appears in August. # **Proposed Rules**

Pursuant to Minn. Stat. §§ 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing, as long as the agency determines that the rules will be noncontroversial in nature. The agency must first publish a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the *State Register*. The notice must advise the public:

- 1. that they have 30 days in which to submit comment on the proposed rules;
- 2. that no public hearing will be held unless 25 or more persons make a written request for a hearing within the 30-day comment period;
- 3. of the manner in which persons shall request a hearing on the proposed rules; and
- 4. that the rule may be modified if the modifications are supported by the data and views submitted.

If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.14-14.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the *State Register*.

Pursuant to Minn. Stat. §§ 14.29 and 14.30, agencies may propose emergency rules under certain circumstances. Proposed emergency rules are published in the *State Register* and, for at least 25 days thereafter, interested persons may submit data and views in writing to the proposing agency.

# **Board of Electricity**

### **Proposed Permanent Rules Relating to Uniform Electrical Violation Citation**

#### Notice of Intent to Adopt Rules Without a Public Hearing

NOTICE IS HEREBY GIVEN that the State Board of Electricity ("Board") proposes to adopt the above-entitled rule without a public hearing. The Board has determined that the proposed adoption of this rule will be noncontroversial in nature and has elected to follow the procedures set forth in *Minnesota Statutes* § 14.22 to 14.28. Authority for the adopting of this rule is contained in *Minnesota Statutes* § 326.241, subd. 6. Additionally a statement of need and reasonableness that describes the need for and identifies the data and information relied upon to support the proposed rule has been prepared and is available from Mr. Quinn upon request.

This rule has been withdrawn from consideration for approval by the Attorney General and the 30 day comment period is re-opened. All persons have 30 days in which to submit comment in support of or in opposition to the proposed rule or any part or subpart of the rule. Comment is encouraged. Each comment should identify the portion of the proposed rule addressed, the reason for the comment, and any change proposed.

Any person may make a written request for a public hearing on the rule within the 30-day comment period. If 25 or more persons submit a written request for a public hearing within the 30-day comment period, a public hearing will be held unless a sufficient number withdraw their requests in writing. Any person requesting a public hearing should state his or her name and address, and is encouraged to identify the portion of the proposed rule addressed, the reason for the request, and any change proposed. If a public hearing is required, the agency will proceed pursuant to *Minnesota Statutes* §§ 14.13 to 14.20. If no hearing is requested, the agency will adopt the proposed rule effective five working days after final publication in the *State Register*.

### **Proposed Permanent Rules Relating to Examinations**

#### Notice of Intent to Adopt Rules Without a Public Hearing

**NOTICE IS HEREBY GIVEN** that the Minnesota Board of Medical Examiners (hereinafter "Board") intends to adopt the above-entitled rules without a public hearing following the procedures set forth in the Administrative Procedure Act for adopting rules without a public hearing in *Minnesota Statutes* §§ 14.22 to 14.28 (1988). The statutory authority to adopt the rules is *Minnesota Statutes* §§ 147.01, subd. 3, 147.02, subd. 1.(c), and 147.03(c) (1988).

All persons have 30 days in which to submit comment in support of or in opposition to the proposed rules or any part or subpart of the rules. Comment is encouraged. Each comment should identify the portion of the proposed rules addressed, the reason for the comment, and any change proposed.

Any person may make a written request for a public hearing on the rules within the 30-day comment period. If 25 or more persons submit a written request for a public hearing within the 30-day comment period, a public hearing will be held unless a sufficient number withdraw their request in writing. Any person requesting a public hearing should state his or her name and address and is encouraged to identify the portion of the proposed rules addressed, the reason for the request, and any change proposed. If a public hearing is required, the Board will proceed pursuant to *Minnesota Statutes* §§ 14.131 to 14.20 (1988).

#### **Rules as Proposed**

#### 5600.0400 GRADES EXAMINATION RETAKING, PASSING SCORES, AND SITTINGS.

A weighted average grade of 75 shall be the passing grade on all examinations prepared and graded by the Federation of State Medical Boards of the United States. If an applicant falls below a weighted average grade of 75, it shall constitute a failure. In order to be eligible for licensure, the applicant may repeat those parts of the examination on which he received a grade less than 75 or may repeat the entire examination. The latest grade received shall be the only one considered by the board.

- Subpart 1. Federation licensing examination passing scores. For examinations taken before June 1, 1985, a Federation Licensing Examination weighted average score of 75.0 shall be the passing score on examinations prepared and graded by the Federation of State Medical Boards of the United States. The latest weighted average score shall be the only weighted average score considered by the board. For examinations taken after June 1, 1985, the passing score on examinations prepared and graded by the Federation of State Medical Boards of the United States shall be a score of 75.0 on each component of the examination. The latest score for each component shall be the only one considered by the board except as provided in subpart 4.
- Subp. 2. Examination sittings. Except as provided in subpart 4, each administration of the Federation Licensing Examination constitutes a sitting by the applicant whether the applicant takes one or more examination components in the examination administration. An applicant may take the number of sittings allowed in items A and B.
- A. After June 1, 1985, an applicant who has not received a passing score on one or both components of the Federation Licensing Examination, may complete up to five sittings of the examination before January 1, 1991, to obtain a passing score on both components of the examination. No additional sittings for the Federation Licensing Examination are permitted by the board after January 1, 1991, if the applicant has had three or more sittings as of January 1, 1991. After January 1, 1991, an applicant may take the Federation Licensing Examination components in separate sittings subject to subpart 3.
- B. After January 1, 1991, an applicant not receiving a passing score on each component of the Federation Licensing Examination within three sittings shall not be eligible for licensure by the board nor permitted additional examination sittings.
- Subp. 3. Retaking of examinations. An applicant who did not receive a passing weighted average score before June 1, 1985, must retake the entire Federation Licensing Examination.

An applicant who did not receive a passing score of 75.0 on a component of the Federation Licensing Examination after June 1, 1985, may either retake the entire examination and obtain passing scores on both components or retake the examination component for which the applicant did not receive a passing score and obtain a passing score on that examination component.

Subp. 4. Licensure eligibility exception. Applicants who were not eligible for licensure after June 1, 1985, because their Federation Licensing Examination passing scores were obtained in two but not more than five separate sittings may apply to the board after July 1, 1990, for licensure without retaking and passing an additional component or components of the Federation Licensing Examination.

The application shall be on forms prepared by the board and shall include the information required in part 5600.0200, subpart 2, items A to E, together with the fees described in part 5600.2500.

#### 5600.0600 LICENSE BY RECIPROCITY TO PRACTICE MEDICINE AND SURGERY.

Subpart 1. Who may apply. An application for a license to practice medicine and surgery by reciprocity without a written examination according to *Minnesota Statutes*, section 147.03, may be made by a physician licensed by an accredited state licensing board or agency. an applicant having a valid license to practice issued by the proper agency in another state who has received a passing score from the Federation of State Medical Boards of the United States pursuant to part 5600.0400 or who has passed a licensing examination of another state with a grade average score of 75 or higher.

# **Adopted Rules**

The adoption of a rule becomes effective after the requirements of Minn. Stat. \$14.14-14.28 have been met and five working days after the rule is published in *State Register*, unless a later date is required by statutes or specified in the rule.

If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous State Register publication will be printed.

If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

An emergency rule becomes effective five working days after the approval of the Attorney General as specified in Minn. Stat. §14.33 and upon the approval of the Revisor of Statutes as specified in §14.36. Notice of approval by the Attorney General will be published as soon as practicable, and the adopted emergency rule will be published in the manner provided for adopted rules under §14.18.

# Adopted Permanent Rules Relating to Trifecta and Twin Trifecta Wagering and Class C Licenses

The rules proposed and published at *State Register*, Volume 14, Number 31, pages 1922-1926, January 29, 1990 (14 S.R. 1922) are adopted as proposed.

# Official Notices =

Notices of intent to solicit outside opinion must be published in the *State Register* and all interested persons afforded the opportunity to submit data or views on the subject, either orally or in writing.

# **Department of Commerce**

# Bulletin of Pending Applications under the Reciprocal Interstate Banking Act *Minnesota Statutes* § 48.98, Subdivision 2,(2)

The following listing of applications are pending with the Commissioner of Commerce subject to criteria for approval as set out in *Minnesota Statutes* § 48.93 and shall be disapproved if:

- (1) The financial condition of any acquiring person is such as might jeopardize the financial stability of the bank or prejudice the interests of the depositors of the bank;
- (2) The competence, experience, integrity of any acquiring person or if any of the proposed management personnel indicates that it would not be in the interest of the depositors of the bank, or in the interest of the public to permit the person to control the bank;
  - (3) The acquisition will result in undue concentration of resources or substantial lessening of competition in this area;
  - (4) The application failed to adequately demonstrate that the acquisition proposal would bring net new funds into Minnesota;
- (5) A subsidiary of the acquiring bank holding company has failed to meet the requirements set forth in the federal Community Reinvestment Act; or
- (6) The acquisition will result in over 30 percent of Minnesota's total deposits in financial institutions as defined in section 13A.01, subdivision 2, being held by banks located in this state owned by reciprocating state bank holding companies. This limitation does not apply to consideration for approval pursuant to section 48.99, special acquisitions.





The consultant would not collect new data nor replicate the Hedonic Model approach, but would use the existing work and assessor data to verify the reasonableness of the assumptions and outcome.

The consultant's product, a short technical report, would be used by staff preparing the Anoka and Washington County draft EISs and the Hennepin County final EIS.

# Tax Court—Regular Division

Docket No. 5168—Dated: March 13, 1990

Segal Wholesale, Inc., Appellant, vs. Commissioner of Revenue, Appellee.

The above-entitled matter was submitted to the Honorable M. Jean Stepan, Chief Judge of the Minnesota Tax Court, on the basis of a written Stipulation of Facts and briefs filed by both parties.

Don G. Paterick, Attorney at Law, represents the appellant.

Barry R. Greller, Special Assistant Attorney General, represents the appellee.

The Court, having considered the stipulation, the briefs of counsel, and upon all of the files and records herein, now makes the following:

#### FINDINGS OF FACT

- 1. Appellant, Segal Wholesale, Inc., a Minnesota corporation, has been a licensed wholesale distributor of cigarettes, tobacco products, and candy since 1899. Appellant's sole place of business is located at 531 Rice Street, St. Paul, Minnesota 55103.
- 2. Appellant is subject to the requirements of the Minnesota Cigarette Tax Act. As such, appellant is required to purchase stamps to be affixed to packages of cigarettes distributed by appellant in Minnesota. Appellant is also required to file monthly returns showing the quantity of cigarettes manufactured, purchased, or brought into Minnesota, and the quantity of cigarettes sold in Minnesota.
- 3. Appellant's cigarette tax returns for the months September, 1986 through November, 1987 were timely filed and subsequently audited and adjusted by the Commissioner of Revenue.
- 4. The Commissioner, prior to June, 1987, netted overages and shortages over the time period covered by the audit. As a result of Laws of 1987, ch. 268, art. 13, § 17, codified as Minnesota Statutes § 297.07, subd. 5 (1988), the Commissioner changed his methodology of applying overages and shortages in cigarette tax liability on a month to month basis. The audit and its adjustments are divided into two time periods due to the statutory change. The adjusted monthly totals are summarized as follows:

- 5. For the months September, 1986 through May, 1987, the Commissioner determined that appellant's adjusted return reflected an overpayment of \$2,734.56 after charging interest on the underpayments. The Commissioner determined that no tax was due and owing. Therefore, the appellant was assessed no tax, penalty or interest for the months September, 1986 through May, 1987.
- 6. For the months June, 1987 through November, 1987, the Commissioner determined that appellant's adjusted return reflected an underpayment of \$4,265.59 as follows:

The Commissioner assessed interest of \$264.63 on this unpaid tax liability. The Commissioner, in an Order dated June 13, 1988, assessed appellant for a total tax deficiency of \$4,530.22 for the taxable period September, 1986 to November, 1987.

7. The Court finds that an overpayment in both the month immediately before and after an underpayment may be applied to offset an underpayment in a given month.

#### **CONCLUSIONS OF LAW**

- 1. Both the June, 1987 (\$821.75) and August, 1987 (\$815.05) overpayments shall be applied as offsets to the July, 1987 (\$1,409.32) underpayment.
- 2. Both the September, 1987 (\$715.54) and November, 1987 (\$1,712.47) overpayments shall be applied as offsets to the October, 1987 (\$5,380.49) underpayment.
- 3. The proper assessment of appellant's tax liability for the period September, 1986 through November, 1987 is \$2,952.48 plus interest. The Commissioner's Order shall be so modified.

LET JUDGMENT BE ENTERED ACCORDINGLY. A STAY OF 15 DAYS IS HEREBY ORDERED.

Villaume Steel Co. and Stott Warehousing Company, Appellants, vs. Commissioner of Revenue, Appellee.

The above-entitled matter came on for hearing before the Honorable Earl B. Gustafson, Judge of the Minnesota Tax Court, on February 12, 1990, at the Courtroom of the Tax Court, 520 Lafayette Road, St. Paul, Minnesota.

### Tax Court =

George W. Fulford, Jr., President of both Villaume Steel Co. and Stott Warehousing Company, appeared *pro se* for appellants and with Mr. Jerry A. Bremer, C.P.A.

Thomas K. Overton, Special Assistant Attorney General, appeared on behalf of the appellee.

The appellants are contesting the Commissioner's assessment of corporate income taxes for the calendar years 1985 and 1986.

The Court, having heard and considered the evidence adduced at the hearing and upon all of the files and records herein, now makes the following:

#### FINDINGS OF FACT

- 1. Appellants Villaume Steel Co. and Stott Warehousing Company are related corporations that conduct all of their business in the State of Minnesota.
- 2. For the taxable years ending December 31, 1985 and 1986, the two appellant corporations filed Minnesota income tax returns as members of a unitary group.
- 3. To allocate Minnesota income attributable to the individual corporations in a unitary group, a three-factor formula is used. The three factors are sales, payroll and property.
  - 4. Appellant Villaume Steel Co. had no sales, no property and no payroll during 1985 and 1986.
  - 5. Appellant Stott Warehousing Company had sales and property but no payroll during 1985 and 1986.
- 6. Appellants' returns allocated 100 percent of the payroll factor to Villaume Steel Co. even though neither corporation had any payroll.
- 7. The appellee rejected the allocation of any income to Villaume Steel Co. and attributed all of the income to Stott Warehousing. Appellants appeal this determination by appellee.
  - 8. The attached Memorandum is hereby made a part of these Findings of Fact.

#### CONCLUSIONS OF LAW

- 1. The Commissioner of Revenue has authority to apportion all income to appellant Stott Warehousing Company and no income to appellant Villaume Steel Co., pursuant to *Minnesota Statutes* § 290.171, Art. IV, § 13, and *Minnesota Statutes* § 290.19, subd. 2(b) (1984).
- 2. The Order of the Commissioner of Revenue dated July 7, 1989, relating to appellants' income tax liability for years 1985 and 1986, is hereby affirmed.

LET JUDGMENT BE ENTERED ACCORDINGLY. A STAY OF 15 DAYS IS HEREBY ORDERED.

Richard J. Courts (Courts Machinery Company), Appellant, vs. Commissioner of Revenue, Appellee.

The above-entitled matter came on for hearing before the Honorable Arthur C. Roemer, Judge of the Minnesota Tax Court, on October 4, 1989, at the Cottonwood County Courthouse in Windom, Minnesota.

Daniel McDonald, Attorney at Law, appeared on behalf of the appellant.

James W. Neher, Special Assistant Attorney General, appeared on behalf of the appellee.

The sole issue at trial was whether the selling price of equipment involved in 16 out-of-state transactions is subject to the Minnesota sales or use tax. Subsequent to trial this Court was advised that the parties reached agreement on all but one of the transactions at issue

Post-trial briefs were filed by both parties and the matter was submitted to the Court for decision on December 27, 1989.

The Court, having heard and considered the evidence adduced at the hearing and upon all of the files and records herein, now makes the following:

#### FINDINGS OF FACT

1. The appellant, Richard J. Courts, is the sole owner of Courts Machinery Company, and has been engaged since 1981 in the purchase and sale of used construction machinery.

- 2. The business is transacted from appellant's home at Rural Route 2, Windom, Minnesota. Appellant owns a 35 acre parcel on which his home is located. Vacant land adjacent to his home is used for storage of bulldozers, scrapers, cranes, loaders and other construction machinery for sale. Most of his sales occur in southwestern Minnesota and South Dakota.
  - 3. There are no employees. The appellant's spouse assists in taking phone calls and doing the accounting.
- 4. Appellant regularly calls on contractors to buy or sell used equipment, which he purchases directly from contractors or sells to contractors. Appellant regularly attends auctions of used construction machinery to purchase machinery for resale.
  - 5. Appellant holds an exemption certificate permitting him to purchase items for resale without payment of the state sales tax.
- 6. During the period August 16, 1982 through October 5, 1985, appellant on 16 occasions was asked by contractors to purchase equipment held for sale by private contractors or sold at auction.
  - 7. Appellant has never had a brokerage agreement with respect to his purchases and sales of construction equipment.
- 8. In the case of each purchase, appellant paid for the equipment with his own personal check and was reimbursed (usually the next day) by the purchaser.
- 9. Except in one instance where the machinery was picked up by the purchaser, appellant arranged with "common carriers for the transportation of the equipment to the purchaser or the site designated by the purchaser." The purchaser then paid the common carrier for the cost of the transportation.
  - 10. When requested by the seller, an agent, or an auctioneer, appellant provided his resale exemption certificae.
- 11. Appellant and the purchaser agreed in each case on the portion of the appellant's travel expenses that the purchaser would defray the commission to be paid appellant. These negotiations occurred after the sale.
- 12. None of the equipment involved in the 16 transactions was delivered to the appellant's storage lot nor to a site selected by the appellant.
- 13. By Stipulation dated November, 1989, the parties reached agreement as to the taxable status of all but one of the transactions at issue. Subsequent findings refer to the one transaction remaining for determination.
- 14. In May 1985, appellant knew that Lundin Crane Service (hereinafter "Lundin") was looking for a used crane. Appellant also had a listing on 3 used cranes owned by Clark Taylor Made Structures, Inc., located in Hartford, South Dakota.
- 15. An agent for Lundin inspected the subject crane which was located in a yard in Worthington, Minnesota, and agreed to purchase the crane for \$75,000.
- 16. Courts Machinery Company purchased the crane and on May 4, 1985 executed a "Product Purchase Agreement" on a standard form used by Courts Machinery Company. It was signed by Dick Courts on behalf of Courts Machinery Company and by Richard C. Lundin, President, on behalf of Lundin. The agreement included the truck crane, identified by number and spare parts totaling \$80,500. It contained the statement, "Unit sold for Clark Taylor Made Co."
- 17. Lundin's finance company issued a check payable to Courts Machinery Co. Rather than accept this properly endorsed check, the bank that held the mortgage on the crane preferred a check written by Courts Machinery for the purchase price less commission.
- 18. A bill of sale was executed on May 23, 1985 between an agent of Lundin (signing as buyer) and Philip Clark on behalf of Clark Taylor Made Co. (signing as seller); the terms being cash, as is (no warranty), with the buyer assuming all responsibility for the crane and liability on delivery in Worthington.
- 19. Appellant did not transport the crane, nor was it ever placed in his lot. Transportation from Worthington to Mankato (Lundin's headquarters) was arranged by Lundin, probably driven by one of Lundin's employees.
  - 20. The attached Memorandum is hereby made a part of these Findings of Fact.

#### CONCLUSIONS OF LAW

- 1. The appellant acted as a broker in the transaction at issue.
- 2. The appellant did not buy or sell the truck crane at issue, and did not take possession or acquire title thereto.
- 3. The Order of the Commissioner of Revenue dated August 9, 1988 is hereby modified to exclude from the gross receipts upon which the additional tax was imposed, the gross receipts arising from the sale of the truck crane at issue (exhibits 13 and 14) and the gross receipts from the sales described in the stipulation (evidenced by exhibits 1, 3, 5, 6, 7, 8, 10, 11, 12, 15, 16, 17 and 18) which the appellee agreed to exclude from the Order assessing additional tax.

LET JUDGMENT BE ENTERED ACCORDINGLY. A STAY OF 15 DAYS IS HEREBY ORDERED.




