Minnesota Rules: Amendments and Additions:

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 75 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. This is a ten-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Proposed and adopted emergency rules do not appear in this set because of their short-term nature, but are published in the State Register.

If an agency seeks outside opinion before issuing new rules or rule amendments, it must publish a NOTICE OF INTENT TO SOLICIT OUTSIDE OPINION in the Official Notices section of the State Register. When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety in the State Register, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the Minnesota Guidebook to State Agency

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues 1-13 inclusive; issues 14-25 inclusive; issue 26, cumulative for issues 1-26; issues 27-38 inclusive; issue 39, cumulative for 1-39; issues 40-51 inclusive; and issue 52, cumulative for 1-52. 

Proposed Rules

Pursuant to Minn. Stat. §§ 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing, as long as the agency determines that the rules will be noncontroversial in nature. The agency must first publish a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the State Register. The notice must advise the public:

- 1. that they have 30 days in which to submit comment on the proposed rules;
- 2. that no public hearing will be held unless 25 or more persons make a written request for a hearing within the 30-day comment period;
- 3. of the manner in which persons shall request a hearing on the proposed rules; and
- 4. that the rule may be modified if the modifications are supported by the data and views submitted.

If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.14-14.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the *State Register*.

Pursuant to Minn. Stat. §§ 14.29 and 14.30, agencies may propose emergency rules under certain circumstances. Proposed emergency rules are published in the *State Register* and, for at least 25 days thereafter, interested persons may submit data and views in writing to the proposing agency.

Proposed Permanent Rules Relating to Surveillance and Utilization Review of Medical Assistance Services

Notice of Intent to Adopt a Rule Without a Public Hearing

NOTICE IS HEREBY GIVEN that the State Department of Human Services intends to adopt the above-entitled rule without a public hearing following the procedures set forth in the Administrative Procedure Act for adopting rules without a public hearing in *Minnesota Statutes*, sections 14.22 to 14.28. The statutory authority to adopt the rule is *Minnesota Statutes*, section 256B.04, subdivisions 2, 4, 10, and 15.

All persons have 30 days or until 4:30 p.m. on July 31, 1991 in which to submit comment in support of or in opposition to the proposed rule or any part or subpart of the rule. Comment is encouraged. Each comment should identify the portion of the proposed rule addressed, the reason for the comment, and any change proposed.

Any person may make a written request for a public hearing on the rule within the 30-day comment period. If 25 or more persons submit a written request for a public hearing within the 30-day comment period, a public hearing will be held unless a sufficient number withdraw their request in writing. Any person requesting a public hearing should state his or her name and address, and is encouraged to identify the portion of the proposed rule addressed, the reason for the request, and any change proposed. If a public hearing is required, the agency will proceed pursuant to *Minnesota Statutes*, sections 14.131 to 14.20.

The proposed rule may be modified if the modifications are supported by data and views submitted to the agency and do not result in a substantial change in the proposed rule as noticed.

Minnesota Rules, parts 9505.0180 and 9505.2160 to 9505.2245 (Rule 64) govern surveillance and utilization review standards and procedures used by the Department to: monitor compliance with medical assistance program requirements; identify fraud, theft, or abuse by medical assistance recipients or providers; establish administrative and legal sanctions in cases of fraud, theft, or abuse; and investigate and monitor compliance with federal and state laws and regulations related to the medical assistance program. Minnesota Rules, part 9505.2165 is a general definition section.

Minnesota Rules, part 9505.2165, subpart 2 defines "abuse." When notice of the rule's adoption was published at 15 S.R. 2563, the word "repeatedly" was incorrectly inserted at the beginning of Minnesota Rules, part 9505.2165, subpart 2, item A, subitem (9) rather than at the beginning of subitem (10).

This amendment correctly places the word "repeatedly" at the beginning of *Minnesota Rules*, part 9505.2165, subpart 2, item A, subitem (10). The amendment ensures that only repeated failure by a provider to properly report duplicate third party payments for covered services provided to a recipient under a program and billed to the Department constitutes "abuse." This change eliminates any possibility that a provider or recipient of medical assistance could suffer adverse action through a single error. This amendment is consistent with public testimony during the recent Rule 64 public hearing and agreed-upon language following the hearing.

Adoption of these rules will not result in additional spending by local public bodies in excess of \$100,000 per year for the first two years following adoption under the requirements of *Minnesota Statutes*, section 14.11.

If no hearing is required, upon adoption of the rule, the rule and the required supporting documents will be submitted to the Attorney General for review as to legality and form to the extent the form relates to legality. Any person may request notification of the date of submission to the Attorney General. Persons who wish to be advised of the submission of this material to the Attorney General, or who wish to receive a copy of the adopted rule, must submit the written request to Nancy Bishop at the address above.

Rules as Proposed 9505.2165 DEFINITIONS.

Subp. 2. Abuse. "Abuse" means:

A. in the case of a provider, a pattern of practices that is inconsistent with sound fiscal, business, or health service practices, and that result in unnecessary costs to the programs, or in reimbursements for services that are not medically necessary or that fail to meet professionally recognized standards for health service. The following practices are deemed to be abuse by a provider:

- (9) repeatedly failing to disclose or make available to the department the recipient's health service records or the provider's financial records as required by part 9505.2180;
- (10) <u>repeatedly</u> failing to properly report duplicate payments from third party payers for covered services provided to a recipient under a program and billed to the department;

7a) PROJECT-03-91

Library Archives and Overflow Facility University of Minnesota Twin Cities Campus

The University of Minnesota is planning to build a new Library Archives and Overflow Facility on the Twin Cities campus, site to be determined. The building will serve two functions. It will house in one environmentally controlled facility, the University's highly regarded collections of archives, rare books, special collections, and manuscripts. It will also serve as a book repository and distribution center for less frequently used materials, freeing much needed space throughout the Twin Cities campus libraries.

The project will consist of approximately 260,00 gsf of new construction. Of this, approximately 140,000 asf will be material storage space for both the Archives and Overflow facility. The Archives area will contain lobby, display, reception, and conference spaces. Reading rooms, service and reference areas, and microfilm reading and storage will be provided for users of the Archives. Archival materials will not circulate outside the building. The Overflow facility will usually send requested materials to user libraries; it will have a small on-site reading room.

Workspace is to be provided for 60 Archives staff and 15 Overflow staff. In addition, there will be workrooms, areas for microfilming and photocopying, and a photographic laboratory. Service spaces will include a loading dock, recycling area, shipping and receiving, holding and staging, fumigation and treatment, workroom, container storage, and preservation laboratory.

An architectural consultant is needed for conceptual studies of possible building configurations on several typical sites. Some of the sites being considered assume utilization of mined space for the storage component of the building and will require a qualified geotechnical engineer, with experience in the design of underground space, to be part of the consultant team. A systems level cost estimate will be required. The architect is to analyze the cost/benefits of the building and site options and make a recommendation. Utility costs are to be projected. Demonstrated experience in planning facilities with stringent environmental requirements and experience in planning library type facilities is desirable. This analysis must be completed by early fall 1991. The University intends to retain this architectural consultant only for conceptual level studies. Once funding is received, the University intends to ask the State Designer Selection Board to select the architectural firm to design the project.

The Minnesota Department of Natural Resources is requesting proposals for an evaluation of its Aquatic Plant Management (APM) Program. A. Scope of Project

The purpose of this project is to study and evaluate the aquatic plant management program of the MN Department of Natural Resources. - 4. It is highly likely that a Rule will be developed to replace the existing Commissioner's Order governing aquatic plant management, and that a hearing(s) will be held as part of the rulemaking process. Minnesota Statutes 256B.0917 authorizes the approval of 4 to 6 Seniors' Agenda for Independent Living (SAIL) projects for the FY 92-93 biennium (beginning July 1, 1991), and provides funding to help defray the administrative expenses associated with the projects. The purpose of the SAIL projects is to test ways to reduce or avoid institutionalization, provide alternative services, and address issues associated with the projected increase in the number of elderly persons in need of long term care services and support.

This legislation describes the parameters of the SAIL projects, defines the general organizational structure and the purposes of the projects, and provides guidance on project selection.

The SAIL projects will emphasize cooperation among local agencies that are involved in long-term care. County social service and public health agencies, public boards of health, and Area Agencies on Aging must be part of local coordinating teams.

Each county or group of counties that is approved to implement a SAIL project will identify a unique local long-term care strategy that is appropriate for the area. Applicants are encouraged to serve local needs using innovative approaches that are consistent with the broad state SAIL goals outlined in the legislation. These projects should demonstrate the feasibility and cost effectiveness of local long-term care strategies. SAIL projects may not duplicate existing services, or substitute for existing funding.

The State Department of Human Services will serve as the lead agency for the application process. Applications from eligible applicants that are received by October 1, 1991, will be evaluated according to legislative criteria by an interagency review team that has been formed to implement SAIL at the state level. Technical assistance will be available to applicants. The interagency review team will make recommendations to the commissioner of Human Services, who will issue approvals to successful applicants by November 1, 1991, for project start-up in January 1992.

Snowmobile License Fee Increase: Registration and license renewal fees for snowmobiles have been increased in an effort to provide adequate funding for trail construction and maintenance, according to the Minnesota Department of Natural Resources (DNR). The increase, due to action by the 1991 Legislature, is the first increase since 1982, said Dennis Asmussen, acting director of the DNR Trails and Waterways Unit. "Without the increase," Asmussen said, "the state's account dedicated to the building and maintenance of snowmobile trails would have gone into the red in less than two years." Asmussen said that the fee changes were needed because costs to the state's grant-in-aid program serving more than 10,000 miles of snowmobile trails were rising while income from fees stayed the same. The grant-in-aid program provides funding for snowmobile trail development and maintenance. "It's important that snowmobilers realize the increase directly benefits their trail system," Asmussen said. The 1991 Legislature increased snowmobile license fees from \$6 to \$10 per year. Those registering their machines or renewing their license now will pay \$30 for a three-year license. It is now also possible to register a snowmobile at the place of purchase, thanks to the new legislation. The recent legislation also calls for the DNR commissioner to complete a study and make recommendations concerning the portion of the gas tax dedicated to the snowmobile grant-in-aid account and the stability of funding for trail grooming. The current amount is three-quarters of one percent, which is the estimated proportion of fuel used to operate snowmobiles in Minnesota. The commissioner's report is due in January 1992.

Grant Program for Community Tree Planting: A grant program for community tree planting is being offered by the Minnesota Department of Natural Resources, in conjunction with the Federal Small Business Administration (SBA). Minnesota will receive \$127,155 for community tree planting grants under the SBA's "Natural Resources Development Program." To receive funding, a community must have an eligible tree planting project, must meet the standards of the Tree City USA program, and contribute at least 50 percent of the total project cost either in cash or in-kind contributions. To become a Tree City USA, communities must have: • a legally constituted tree board or department; • a municipal tree ordinance; • a comprehensive community forestry program supported by a minimum of \$2 per capita; • an annual Arbor Day proclamation and observance. Furthermore, communities must agree to utilize small business contractors or concerns in connection with the planting project. To the extent possible, communities must also divide the planting project so more than one small business concern may perform the work. Planting projects are scheduled to start as early as this fall. Communities that do not currently meet the Tree City USA standards may still apply for grant funding, but will not receive approval until the standards are achieved. (Grant monies may be used to help meet the per capita expenditure requirement.) Application materials may be obtained by contacting the DNR Division of Forestry at (612) 297-3507. Completed applications must be received in the DNR Forestry Division Office at 500 Lafayette Road in St. Paul no later than 4:30 p.m. on Wednesday, July 10.

New Personal Watercraft Law: Personal watercraft (also known as Jet Skis, Wave Runners, Wet Jets, water scooters, etc.) are subject to new laws in Minnesota beginning June 27. "The increased popularity of water scooters

has brought numerous calls voicing concerns from other boaters as well as from the general public," said Tim Smalley, Minnesota Department of Natural Resources (DNR) boating safety specialist. In addition, DNR statistics show that personal watercraft are involved in a disproportionate percentage of watercraft accidents, Smalley said. "Even though they make up less than 1 percent of all registered boats in the state, personal watercraft account for 11 percent of the accidents," Smalley said. Those concerns have led to a new law regulating the operation of personal watercraft in Minnesota, passed by the 1991 Legislature. The new law imposes several requirements: • Anyone operating or riding on a personal watercraft must wear a U.S. Coast Guard approved type I, II, III or V personal flotation devie (PFD or life jacket). • Personal watercraft may not be operated between sunset and 8 a.m. the following day. • Personal watercraft may not be operated at greater than a slow-no-wake speed within 100 feet of any shoreline, dock, swimmer, any moored or anchored watercraft, any non-motorized watercraft, or any swimming or diving raft. (Slow-no-wake is defined as the operation of a watercraft at the slowest possible speed necessary to maintain steerage, but never greater than five miles per hour.) • If towing a person on water skis, a kneeboard, an inflatable craft or any other device, there must be a second person on board the personal watercraft to act as an observer. (The skier/kneeboarder must also be wearing a PFD, or there must be one on board the personal watercraft for the skier.) • People may not operate personal watercraft without the lanyard-type engine cutoff switch being attached to their body, clothing or personal flotation device. People may not operate a personal watercraft on which the spring-loaded throttle mechanism has been removed, altered or tampered with. • Personal watercraft operators may not chase or harass wildlife. • Operators may not travel through emergent or floating vegetation at greater than slow-no-wake speed. • People may not operate personal watercraft in a manner that unreasonably or unnecessarily endangers life, limb or property. • Operators may not weave through congested watercraft traffic, or jump the wake of another watercraft within 100 feet of the other watercraft. This includes other personal watercraft. AGE RESTRICTIONS ALSO APPLY: There are also age restrictions regarding the operation of personal watercraft— • Those under 13 years old may not operate a personal watercraft, regardless of horsepower, unless there is an adult (18 or older) on board. • A 13-year-old must have a watercraft operator's permit (available from the DNR) to operate a watercraft without an adult on board. With a permit, the 13-year-old must be in full view of an adult while operating a personal watercraft. • Operators ages 14-17 may not operate a personal watercraft without possessing a valid watercraft operator's permit, unless they have an adult on board. Personal watercraft are considered motorboats, Smalley noted. Therefore, personal watercraft are subject to all regulations that govern other motorboats. Violation of any watercraft safety law is a misdemeanor punishable by a fine of up to \$700 and/or 90 days in jail. GENERAL WATERCRAFT LAWS: • All personal watercraft must display valid registration decals and registration numbers on the forward half of both sides of the craft. • All personal watercraft with enclosed engine or fuel compartments (almost all personal watercraft fall into one or the other category) must carry a fully charged, readily accessible U.S. Coast Guard approved fire extinguisher. • It is also unlawful to operate while intoxicated. Effective July 27, personal watercraft rental operators must provide a summary of the laws and rules governing personal watercraft operation and provide instruction regarding the laws, rules and safe operation of personal watercraft to each person renting a personal watercraft.
