

A State Register Contracts Supplement is published every Thursday. The Monday edition is the vehicle for conveying all information about state agency rulemaking, including official notices; hearing notices; proposed, adopted and emergency rules. It also contains executive orders of the governor; commissioners' orders; state contracts and advertised bids; professional, technical and consulting contracts; non-state public contracts; state grants; decisions of the supreme court; a monthly calendar of scheduled cases before the supreme court; and other announcements. The Thursday edition contains additional state contracts and advertised bids, and the most complete listing of contract awards available in one source.

In accordance with expressed legislative intent that the State Register be self-supporting, the following subscription rates have been established: the Monday edition costs \$140.00 per year and includes an index issue published in August (single issues are available at the address listed above for \$3.50 per copy); the combined Monday and Thursday editions cost \$195.00 (subscriptions are not available for just the Contracts Supplement); trial subscriptions are available for \$60.00, include both the Monday and Thursday edition, last for 13 weeks, and may be converted to a full subscription anytime by making up the price difference. No refunds will be made in the event of subscription cancellation.

Both editions are delivered postpaid to points in the United States, second class postage paid for the Monday edition at St. Paul, MN, first class for the Thursday edition. Publication Number 326630 (ISSN 0146-7751).

Minnesota Rules: Amendments and Additions =

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 75 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. This is a ten-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Proposed and adopted emergency rules do not appear in this set because of their short-term nature, but are published in the State Register.

If an agency seeks outside opinion before issuing new rules or rule amendments, it must publish a NOTICE OF INTENT TO SOLICIT OUT-SIDE OPINION in the Official Notices section of the State Register. When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety in the State Register, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the Minnesota Guidebook to State Agency Services.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues 1-13 inclusive; issues 14-25 inclusive; issue 26, cumulative for issues 1-26; issues 27-38 inclusive; issue 39, cumulative for 1-39; issues 40-51 inclusive; and issue 52, cumulative for 1-52. An annual subject matter index for rules appears in August. 

Proposed Rules

Pursuant to Minn. Stat. §§ 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing, as long as the agency determines that the rules will be noncontroversial in nature. The agency must first publish a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the *State Register*. The notice must advise the public:

- 1. that they have 30 days in which to submit comment on the proposed rules;
- 2. that no public hearing will be held unless 25 or more persons make a written request for a hearing within the 30-day comment period;
- 3. of the manner in which persons shall request a hearing on the proposed rules; and
- 4. that the rule may be modified if the modifications are supported by the data and views submitted.

If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.14-14.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the *State Register*.

Pursuant to Minn. Stat. §§ 14.29 and 14.30, agencies may propose emergency rules under certain circumstances. Proposed emergency rules are published in the *State Register* and, for at least 25 days thereafter, interested persons may submit data and views in writing to the proposing agency.

Proposed Permanent Rules Relating to Waste Pesticide Collection

Notice of Intent to Adopt a Rule Without a Public Hearing

NOTICE IS HEREBY GIVEN that the Minnesota Department of Agriculture intends to adopt the above-entitled rule without a public hearing following the procedures set forth in the Administrative Procedures Act for adopting rules without a public hearing in *Minnesota Statutes*, sections 14.22-14.28. The statutory authority to adopt this rule is *Minnesota Statutes*, section 18B.065.

All persons have 30 days in which to submit comment in support of or in opposition to the proposed rule or any part or subpart of the rule. Comment is encouraged. Each comment should identify the portion of the proposed rule addressed, the reason for the comment, and any change proposed.

Any person may make a written request for a public hearing on the rule within the 30-day comment period. If 25 or more persons submit a written request for a public hearing within the 30-day comment period, a public hearing will be held unless a sufficient number withdraw their request in writing. Any person requesting a public hearing should state their name and address, and is encouraged to identify the portion of the proposed rule addressed, the reason for the request, and any proposed change. If a public hearing is required, the department will proceed according to *Minnesota Statutes*, sections 14.131-14.20.

The proposed rule may be modified if the modifications are supported by the data and views submitted to the department and do not result in a substantial change in the proposed rule as noticed.

A copy of the proposed rule is attached to this notice.

A Statement of Need and Reasonableness that describes the need for and reasonableness of each provision of the proposed rule and identifies the data and information relied upon to support the proposed rule has been prepared and is available upon request from Ms. Milligan.

The proposed rule deals with a program entered into voluntarily by local units of government and therefore, has no significant impact on small businesses.

If no hearing is required, upon adoption of the final rule, the rule and the required supporting documents will be submitted to Attorney General for review as to legality and form to the extent the form relates to legality. Any person may request notification of the date of submission to the Attorney General. Persons who wish to be advised of the submission of this material to the Attorney General, or who wish to receive a copy of the adopted rule must submit a written request to Ms. Milligan.

Rules as Proposed (all new material) 1509.0010 AUTHORITY.

Parts 1509.0010 to 1509.0050 govern the waste pesticide collection program pursuant to Minnesota Statutes, section 18B.065.

Parts 1509.0010 to 1509.0050 establish a process for: (1) assessment schedule and payment; (2) cosponsor selection; and (3) cooperative agreement.

1509.0020 **DEFINITIONS.**

- Subpart 1. **Scope.** The definitions in this part apply to parts 1509.0010 to 1509.0050.
- Subp. 2. Collection site. "Collection site" means a permanent or temporary designated location with scheduled hours for authorized collections where pesticide end-users may bring their waste pesticide.
 - Subp. 3. Commissioner. "Commissioner" means the commissioner of agriculture or an agent authorized by the commissioner.
- Subp. 4. Container. "Container" means a package, can, bottle, bag, barrel, drum, or other containing device used to enclose a pesticide formulation for storage, transport, or other handling.
- Subp. 5. Cosponsor. "Cosponsor" means the state or local unit of government selected to enter into a cooperative agreement with the commissioner to administer a waste pesticide collection program.
- Subp. 6. **Pesticide end-user.** "Pesticide end-user" means a farmer or other person who uses, intends to use, or owns a pesticide. Pesticide end-user does not include a dealer, manufacturer, formulator, or packager.
- Subp. 7. **Pesticide formulation.** "Pesticide formulation" means a substance or mixture of one or more active ingredients and inerts that is used to mitigate or control pests.
- Subp. 8. Waste pesticide. "Waste pesticide" means an unusable pesticide including: suspended, canceled, or degraded pesticide. Waste pesticide does not include other materials contaminated with pesticide formulations.

1509.0030 ASSESSMENT SCHEDULE AND PAYMENT.

- Subpart 1. Assessment schedule. A pesticide end-user voluntarily participating in a collection authorized under *Minnesota Statutes*, section 18B.065, may be assessed a portion of the disposal costs based on gross weight in pounds of the pesticide formulation and container collected, up to a maximum of 2,200 pounds. The assessment of individual pesticide end-users must be based on costs described in the current hazardous pesticide waste packing, transportation and disposal service contract and invoiced at the rates determined under items A to C.
- A. Agencies of government or their representatives must be assessed costs equal to 125 percent of the disposal price, but not less than \$7 per pound to participate in a waste pesticide collection.
 - B. Assessments for other participants must be based on amounts for disposal at the following rate:
 - (1) no cost for disposal of 150 pounds or less;
- (2) costs equal to 15 percent of the disposal price, but not less than \$1 per pound for quantities greater than 150 pounds, up to 300 pounds;
- (3) costs equal to 50 percent of the disposal price, but not less than \$3 per pound for quantities greater than 300 pounds, up to 1,000 pounds; or
- (4) costs equal to 100 percent of the disposal price, but not less than \$6 per pound for quantities greater than 1,000 pounds, up to a maximum of 2,200 pounds.
- C. Assessments must be made based on the cumulative poundage of pesticide formulation and its container collected from each participant disposing of waste pesticides.
- Subp. 2. Payment. The commissioner shall invoice participants promptly for disposal costs based on the assessment schedule in subpart 1.

1509.0040 PROGRAM OPERATION AND ADMINISTRATION.

- Subpart 1. Cosponsor selection. A potential cosponsor seeking sole or joint participation in the operation and administration of a collection authorized under *Minnesota Statutes*, section 18B.065, shall complete and return an application form provided by the commissioner. Cosponsor selection must be based on the following criteria:
 - A. a completed application;
 - B. willingness to commit financial, physical, and other resources to collection;

Subp. 2. Cooperative agreement. The commissioner and cosponsor must agree to the terms of the cooperative collection and sign a cooperative agreement defining responsibilities and conditions of each party in conducting a waste pesticide collection. Cosponsor roles and responsibilities may include:

- A. providing funds for local administration and on-site operation;
- B. obtaining a United States Environmental Protection Agency hazardous waste generator identification number;
- C. supplying necessary physical and human resources for on-site operation;
- D. reimbursing the commissioner for disposal costs; and
- E. other described responsibilities and conditions agreed upon by the commissioner and cosponsor in the cooperative agreement.

1509.0050 DEPOSIT OF FUNDS.

Assessments collected under parts 1509.0030 and 1509.0040 must be deposited in the state treasury and credited to the waste pesticide collection account according to *Minnesota Statutes*, section 18B.065, subdivision 5.

Minnesota Regulated Loan Act—Adjustment of Dollar Amounts

Commissioner of Commerce Bert J. McKasy announced today that an additional 10% change will occur in certain dollar amounts indexed in the Regulated Loan Act (The Act), *Minnesota Statutes*, Chapter 56. The Act provides for periodic adjustment in dollar amounts that would be effective on July 1, in even-numbered years based on a percentage change in the Implicit Price Deflator for the Gross National Product.

Information obtained from the U.S. Department of Commerce, Bureau of Economic Analysis indicates a percentage change from the revised reference base to be 58% calculated to the nearest whole percentage point as required. The index was revised nationally to 1987 = 100, with the statutory reference based index for dollar adjustments being December 1980. The rebased index for December 1980 is 74.4, increasing to 117.9 in 1991, for a percentage change of 58.47%. The statute requires that the percentage change in the reference base index be 10% or more in order to adjust the dollar amounts. The portion of the percentage change in the index in excess of a multiple of ten percent shall be disregarded as dollar amounts change only in multiples of ten percent. The law was effective August 1, 1981, and there was no change in dollar amounts in 1982.

According to Commissioner McKasy, this means indexed dollar limits will increase an additional 10% effective July 1, 1992 after factoring out prior year's adjustments. The results of indexing are as follows, with the percentage increased noted under the various dates:

Section 56.131, subdivison 1(a)(1) was amended in 1990, effective April 24, 1990, increasing the principal loan amount subject to the 33% per year interest rate. This dollar amount was not subject to indexing on July 1, 1990 as indicated in the 1990 revisors' technical corrections bill.

*Important. These amounts may change prior to the July 1, 1992 effective date based on the passage of S.F. No. 2213 as it amends Section 56.131 subdivision 4. The legislature passed the bill which has not yet been signed by the Governor. The bill provides publication before June 30 to confirm the amendment that establishes December 30, 1990 as the reference base index for dollar adjustments to the \$750 in subdivision 1(a)(1) and the \$1,000 in subdivision in 2(d). These dollar amounts will remain unchanged from 1990.

**Section 56.131, subdivision 2(d), setting a minimum advanced required to charge discount points and appraisal fees, was added by a 1990 amendment. This statutory amount was to have been adjusted in 1990 to \$1,400; however, its publication was inadvertently overlooked. The \$1,000 will remain the correct level for compliance purposes. The dollar adjustment is subject to amendment, and no change, based on #S.F. No. 2213 as previously discussed.

The minimum default charge permitted in Section 56. 131, subdivision 1(f)(4) increased to \$4.00 by amendment effective June 25, 1985. Section 56.131, subdivision 4 was also amended to use December 1984 as the reference base index date for dollar adjustments on default charges. The rebased index for December 1984 is 92.3, increasing to 117.9 in December 1991, for a percent change of 27.74%. The portion of the percent change in the index in excess of a multiple of ten percent shall be disregarded as dollar amounts shall change only in multiples of ten percent of amounts appearing in law. This results in an additional 10% increase effective July 1, 1992 with historic and current indexing of the default charge as follows, with the percentage increase noted under the indexed dates:

These statutes provide that the dollar amounts will be adjusted in even numbered years based on a percentage change in the Implicit Price Deflator for the Gross National Product.

Subdivision 1a states the periodic adjustments are to follow the indexing provisions of section 550.37, subdivision 4a. The amendment was effective April 24, 1990 requiring a cumulative 40% increase to be used for July 1, 1990 as the reference base index for this dollar adjustment is December 1980.

DOLLAR ADJUSTMENTS FOR EXEMPT PROPERTY

Minnesota Statutes, Section 550.37 subdivision 4(a) required indexing the \$4,500 personal property exemption in Subdivision 4 since 1984. Subdivision 4(a) was amended in 1985, effective July 1, 1986, to include dollar amount adjustments for other exempt property within this section of statute, which received a cumulative 30% adjustment in 1988 as the reference base index for dollar adjustments is December 1980. A further amendment to subdivision 4(a) in 1989 fixed \$13,000 as the maximum amount for subdivision 5 and 7 and established \$30,000 as the amount for employee benefits in subdivision 24(2). The \$30,000 was adjusted a cumulative 40% in 1990 when the percent change from the December 1980 reference base index was applied.

The applicant's share is one percent of cost for each \$1,000 or fraction of income above 60 percent of the State gross median income for a household of the same size as the applicant's. The applicant's percent share is found on the schedule by looking under the number which corresponds with the number of members in the applicant's household to find the income level which includes the applicant's annual household income. The applicant's percent share is shown on the far left of that income level. For each additional household member greater than 10, add 3 percent to 144 percent for each additional household member and multiply the new percentage by the State's dollar amount for four-person households.

The public may also submit written comments to the MPCA regarding the proposed SIP, which is available for review.

The Clean Air Act (CAA) Amendments of 1977 requires states to prepare and submit to the United States Environmental Protection Agency (EPA) a SIP, which is the state's plan to implement measures to attain and maintain national ambient air quality standards (NAAQS) and other requirements of the CAA. Sulfur dioxide is a criteria air pollutant for which the EPA has established national primary and secondary NAAQS.

The Twin Cities seven county metropolitan area S02 nonattainment area includes the counties of Anoka, Carver, Dakota, Hennepin, Ramsey, Scott, and Washington. The MPCA requested the EPA to designate this area as nonattainment for S02 in response to the CAA Amendments of 1977. The designation is based on monitored primary NAAQS violations in the area from 1975 through 1977.

The overall SIP involves regulating emissions from all sources contributing S02 to the nonattainment area through issuance of administrative orders. The MPCA proposes issuing administrative orders to the following sources impacting the Twin cities S02 nonattainment area:

MPCA has issued administrative orders to Koch Refining Company and Koch's Sulfuric Acid Unit Plant. The MPCA will propose to issue administrative orders to Northern States Power Company—Inver Hills, Continental Nitrogen and Resources Corporation, and Ashland Petroleum Company. Administrative orders for these emission sources will be included in subsequent S02 SIP submittals.

The MPCA has determined that if the facilities receiving administrative orders under this proposed S02 SIP comply with the requirements of the administrative orders, Minnesota should attain and maintain compliance with the NAAQS for S02 in the seven county metropolitan area. This determination is based on air dispersion modeling.

In addition to the administrative orders, the SIP includes background on Minnesota SIP submittals, EPA administrative requirements for SIPs, and a technical support document (TSD). The TSD, through air dispersion modeling, provides the technical justification for the emission and operating requirements in the administrative orders.




