# Minnesota Rules: Amendments and Additions :

#### NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 75 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. This is a ten-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Proposed and adopted emergency rules do not appear in this set because of their short-term nature, but are published in the State Register.

If an agency seeks outside opinion before issuing new rules or rule amendments, it must publish a NOTICE OF INTENT TO SOLICIT OUT-SIDE OPINION in the *Official Notices* section of the *State Register*. When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the *Minnesota Guidebook to State Agency Services*.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues 1-13 inclusive; issues 14-25 inclusive; issue 26, cumulative for issues 1-26; issues 27-38 inclusive; issue 39, cumulative for 1-39; issues 40-51 inclusive; and issue 52, cumulative for 1-52. An annual subject matter index for rules appears in August. 

# **Proposed Rules**

Pursuant to Minn. Stat. §§ 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing, as long as the agency determines that the rules will be noncontroversial in nature. The agency must first publish a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the *State Register*. The notice must advise the public:

- 1. that they have 30 days in which to submit comment on the proposed rules;
- 2. that no public hearing will be held unless 25 or more persons make a written request for a hearing within the 30-day comment period;
- 3. of the manner in which persons shall request a hearing on the proposed rules, and
- 4. that the rule may be modified if the modifications are supported by the data and views submitted.

If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.14-14.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the *State Register*.

Pursuant to Minn. Stat. §§ 14.29 and 14.30, agencies may propose emergency rules under certain circumstances. Proposed emergency rules are published in the *State Register* and, for at least 25 days thereafter, interested persons may submit data and views in writing to the proposing agency.

#### **Proposed Permanent Rules Relating to Natural Preservation Routes**

#### Notice of Intent to Adopt Rules Without a Public Hearing

**NOTICE IS HEREBY GIVEN** that the Minnesota Department of Transportation intends to adopt the above-entitled rule without a public hearing following the procedures set forth in the Administrative Procedure Act for adopting rules without a public hearing in *Minnesota Statutes*, sections 14.22 to 14.28. The statutory authority to adopt the rule is found in *Minnesota Statutes*, 162.02 Subd. 2, 162.021 and 162.09 Subd. 2.

All persons have 30 days in which to submit comment in support of or in opposition to the proposed rule or any part or subpart of the rule. Comment is encouraged. Each comment should identify the portion of the proposed rule addressed, the reason for the comment, and any change proposed. The 30 day comment period will expire at 4:00 p.m. on November 4, 1992.

Any person may make a written request for a public hearing on the rules within the 30 day comment period. If 25 or more persons submit a written request for a public hearing within the 30 day comment period, a public hearing will be held unless a sufficient number withdraw their request in writing. Any person requesting a public hearing must state his or her name and address, and is encouraged to identify the portion of the proposed rule addressed, the reason for the request, and any change proposed. If a public hearing is required, the agency will proceed pursuant to *Minnesota Statutes*, sections 14.131 to 14.20.

Comments or writtent requests for a public hearing must be received by the department by 4:00 on November 4, 1992.

The proposed rule may be modified if the modifications are supported by data and views submitted and do not result in a substantial change in the proposed rule as noticed.

A copy of the proposed rule is attached to this notice. A free copy of the proposed rule and the Statement of Need and Reasonableness that describes the need for and reasonableness of each provision of the proposed rule is available upon request by contacting the address given above.

Adoption of the proposed rule will not require a total expenditure of public monies by local public bodies of more than \$100,000 in either of the two years immediately following adoption. Therefore, *Minnesota Statutes*, section 14.11, subdivision 1, is not applicable to this rulemaking procedure.

### Proposed Rules =

Adoption of the proposed rule will not have a direct or substantial impact on agricultural land. Therefore, *Minnesota Statutes*, section 14.11, subdivision 2, is not applicable to this rulemaking procedure.

Adoption of the proposed rule will not affect small business. Therefore, *Minnesota Statutes*, section 14.115 is not applicable to this rulemaking procedure.

If no hearing is required, upon adoption of the rule, the rule and required supporting documents will be submitted to the Attorney General for review as to legality and form to the extent the form relates to legality. Any person may request notification of the date of submission to the Attorney General. Persons who wish to be advised of the submission of the material to the Attorney General, or who wish to receive a copy of the adopted rules, must submit a written request to the address given above.

### Rules as Proposed

#### 8820.0100 DEFINITIONS.

[For text of subps 1 to 12, see M.R.]

<u>Subp. 12a.</u> Natural preservation route. "Natural preservation route" means an existing or proposed roadway that has been designated as a natural preservation route by the commissioner upon petition by a county board and that possesses sensitive or unique scenic, environmental, or historical characteristics. Examples may include roads along lakes, rivers, wetlands, or floodplains or through forests or hilly, rocky, or bluff terrain.

#### 8820.2500 MINIMUM STATE-AID STANDARDS.

Subpart 1. Geometric design standards. The standards in part 8820.9910 apply to rural design undivided roadways, new or reconstruction.

The standards in part 8820.9930 apply to suburban design roadways that meet indicated conditions, new or reconstruction.

The standards in parts 8820.9935 and 8820.9940 apply to urban design roadways, new or reconstruction.

The requirements in parts 8820.9925, 8820.9945, and 8820.9970 apply to resurfacing projects.

The roadway classifications in part 8820.9950 apply to urban roadways.

The vertical clearances for underpasses in part 8820.9955 apply.

The standards in part 8820.9965 apply to designated forest highways within national forests and state park access roads within state parks, new or reconstruction.

The standards in parts 8820.9980 and 8820.9985 apply to designated natural preservation routes.

#### NATURAL PRESERVATION ROUTES

#### 8820.4000 REQUEST TO COUNTY BOARD.

Any person may make a written request to designate a county state-aid highway as a natural preservation route. The request must be directed to the county board having jurisdiction over the route. A county board is not required to propose designation for the entire length of a county state-aid highway. The county board shall act on the request within 60 days. The county having jurisdiction over the route only after receipt of a board resolution from the county having jurisdiction over the road.

The county board shall use the descriptions in part 8820.4010 as a guide for determining which designation type best fits a particular route. All of the descriptors may be used in combination. No single descriptor, including ADT, may be used to eliminate a route type from consideration.

#### 8820.4010 CHARACTERISTICS OF ROUTE TYPES.

<u>Subpart 1.</u> Selection criteria generally. To be considered for designation as a natural preservation route, a route must be on the county state-aid highway system. It may be selected if it possesses particular scenic, environmental, or historical characteristics such as routes along lakes, rivers, wetlands, or floodplains or through forests or hilly, rocky, or bluff terrain.

Subp. 2. Type I natural preservation route. A type I natural preservation route is best characterized as one in which the natural surroundings convey a feeling of intimacy with nature. This type of route carries local passenger vehicles with occasional commercial

vehicles. This route has very low volumes with leisurely driving speeds and may be used by pleasure drivers. The roadway alignment follows the terrain, which may be hilly or curving around lakes and wetlands, and can be described as lying lightly on the land. There are few reported accidents related to the geometric design of the roadway or accidents can be minimized without realignment. The operating speeds are generally lower than on regular county state-aid highway routes.

<u>Subp. 3.</u> Type II natural preservation route. A type II natural preservation route creates a feeling similar to the feeling created by a type I natural preservation route, but the surroundings and vistas may be more distant from the roadway. It carries local traffic with moderate amounts of commercial vehicles. This route generally has low volumes but may have seasonal peaks greater than 300 vehicles per day. It has leisurely driving speeds and may be used by some commuters and pleasure drivers. The roadway alignment follows the terrain, which may be hilly or curving around lakes and wetlands. Some modifications may be made to the land surface. There are few reported accidents related to the geometric design of the roadway or accidents can be minimized with mitigation as referred to in part 8820.4060. The operating speeds may be lower than regular county state-aid highway routes.

Subp. 4. Type III natural preservation route. A type III natural preservation route goes through an environment similar to the types I and II natural preservation routes, but the surroundings and vistas may be more distant from the roadway. It may function as a minor or major collector and may be used by general commercial traffic. It generally has volumes less than 750 vehicles per day but may have seasonal peaks. This type of roadway passes through diverse terrain features and the alignment is consistent with the traffic mix. It may have required some modifications to the land surface. The safety problems that may exist are related to the traffic volumes and to the geometric design of the roadway. The problems can be corrected with mitigation as referred to in part 8820.4060 or with reconstruction. The operating speeds may be lower than a comparable county state-aid highway route that is not on the natural preservation route system.

#### 8820.4020 REQUIREMENTS FOR ROUTE DESIGNATION PROPOSALS.

Subpart 1. County board resolution. The county board shall submit a formal request to the commissioner in the form of a resolution.

Subp. 2. Required information. The request must be accompanied by:

A. an index map that identifies the proposed natural preservation route by county state-aid highway number and termini;

<u>B. a narrative describing the history of the route, any controversy surrounding it, the inplace cross section, the particular scenic, environmental, or historical characteristics considered desirable to preserve, and which designation category (type I, II, or III) of natural preservation route being requested;</u>

C. photographs of the route;

D. a listing of parks, rivers, or other designated natural or historical resource areas that the highway corridor passes through or adjoins and that are considered desirable to preserve;

E. a description of any safety hazards existing along the route and a discussion of the accident record over the past five years;

<u>F. a transportation plan that considers alternate routes, or traffic management plan for the area including compatibility with the existing roadway network, as well as the existing and projected ADT;</u>

<u>G.</u> a description of the function of the route including the functional classification, the type of traffic using the route, and a discussion of seasonal variations and trip purposes;

H. a comparison of the current operating speed, the legal speed limit, and the rationale for the selection of the planned design speed;

I. a preliminary description of the planned design if construction or reconstruction is proposed, including a discussion of:

(1) what natural or historical elements might be affected by different construction alternatives;

(2) which safety features might be affected by different construction alternatives; and

(3) how any changes in the continuity of design will be mitigated;

J. preliminary cost estimates of the various alternatives considered;

K. environmental documentation that may have been completed, including public notices and public meetings that have occurred;

L. a description of existing and projected land uses, any zoning in effect, and compatibility with the natural preservation route characteristics; and

M. a description of any provisions to address bicycles, pedestrians, and equestrians.

#### 8820.4030 ADVISORY COMMITTEE.

The commissioner shall appoint an advisory committee for each construction district consisting of seven members: one member from the department of natural resources, one county highway engineer, one county commissioner, one representative of a recognized environmental organization, and three members of the public. The commissioner shall refer each county board submittal received to the advisory committee for the construction district in which the county exists. The advisory committee shall consider all data relative to the petition for designation and make a recommendation to the commissioner. No elected or appointed official that represents a political subdivision requesting the designation or any public member residing in that county may serve on the committee.

#### 8820.4040 DESIGNATION BY COMMISSIONER.

Following receipt of the advisory committee recommendation, the commissioner may designate the roadway as a natural preservation route.

#### 8820.4050 EXTENT OF STATE AID.

The extent of state aid participation for a construction project must be determined on the same basis as a regular county state-aid highway project, except that landscaping items are eligible for up to two percent of the total construction allocation of the year in which any construction on the natural preservation route is completed.

#### 8820.4060 GEOMETRIC STANDARDS.

The standards in parts 8820.9980 and 8820.9985 apply to designated natural preservation routes. The designer shall consider the use of guardrails, retaining walls, and curb sections to protect natural amenities. The designer shall consider landscaping, including native species, curving alignments, variable back slopes, variable ditch bottoms, limited clearing, and other means available to limit the impacts on the environment while still addressing public safety.

#### 8820.4070 RECONSTRUCTION NOTIFICATION.

<u>A county proposing a project that requires removal of the entire surface of a county state-aid highway that is a natural preservation</u> route shall send to owners of property abutting the highway a written notice that describes the project. In addition, the county shall hold a public meeting to discuss design and construction alternatives. Spot maintenance projects, such as culvert replacements or subgrade corrections, do not require notice.

#### 8820.4080 SIGNS.

Route markers must be posted at public road entry points to and at regular intervals along natural preservation routes. Signs posted must conform to the Minnesota Manual on Uniform Traffic Control Devices adopted under Minnesota Statutes, section 169.06. Properly posted signs are prima facie evidence that adequate notice of a natural preservation route has been given to the motoring public. Signs must conform to the requirements in part 8820.9990.

#### 8820.4090 REMOVAL OF DESIGNATION.

A county board, after notice and a public hearing, may petition the commissioner to remove the natural preservation route designation if the board believes the characteristics on which the natural preservation route designation was approved have substantially been lost. The petition for removing the designation must be based on, and the advisory committee shall consider, such items as loss of aesthetic qualities, changes in land use, changes in road function, or significant increases in accidents. The committee shall then make a recommendation to the commissioner. Following receipt of the advisory committee's recommendation, the commissioner may remove the natural preservation route designation from the roadway.

A. The t-test of polled pooled variance is applied using conventional statistical techniques. Significance is determined at the five percent level for a one-tailed test. The statistical analysis rounds the value of t to three decimal places. The sample t table is taken from a standard statistical text: Blalock, Social Statistics, Second Edition 1972, published by McGraw-Hill, page 559. The degrees of freedom is the total number of employees in male-dominated and female-dominated classes, minus two. To be significant, the value of t for a jurisdiction must be at or above the level listed, except that for degrees of freedom not listed, the required level of t is taken from a standard normal distribution table.

• Income, Corporate Franchise, and Estate Taxes — For returns, payments, and estimated payments of income, corporate franchise, or estate taxes that would have been due on or after September 15, 1992 and before January 15, 1993, the commissioner will abate penalties imposed on taxpayers for failure to file and failure to make payments or estimated payments as long as taxpayers file the returns and make the payments by January 15, 1993. If the Internal Revenue Service grants an extension beyond January 15, 1993 or finds reasonable cause for a taxpayer's late filing of federal returns or late payment of federal tax, the commissioner will find reasonable cause for the taxpayer's failure to file a return or pay tax for the same tax type. The commissioner will not, however, abate interest.

• Withholding and Sales Tax — For returns and payments of withholding and sales tax that would have been due during the period of September 11, 1992, through November 2, 1992, the commissioner will abate penalties imposed on taxpayers for failure to file and failure to make payments as long as taxpayers file the returns and make the payments by November 16, 1992. The commissioner will not, however, abate interest.

• All Returns and Other Documents — All returns and other documents that are filed under any provision in this Notice should be clearly marked "INIKI" on the top center of the return or document. Taxpayers and tax practitioners who want to use the provisions of this Notice but whose addresses are not within the designated federal disaster areas should also include a brief statement as to how the disaster adversely affected their ability to meet their tax obligations.

#### Notice of Solicitation of Outside Information or Opinions Regarding the Issuance of a Conditional 401 Water Quality Certification to Minnesota Power & Light Company

**NOTICE IS HEREBY GIVEN** that the Minnesota Pollution Control Agency (MPCA) proposes to issue a conditional 401 water quality certification to Minnesota Power & Light Company (MP) for its St. Louis River Project and is seeking comments on this action. Notice is also given that a Memorandum of Agreement (MOAO has been developed by the MPCA, MP and the Fond du Lac Band of Lake Superior Chippewa (FDL) for the coordination of studies relating to the St. Louis River Project.

MP is an electric utility that serves northern Minnesota. Based in Duluth, the company's power production facilities include the St. Louis River Project. This project is a hydropower system consisting of four hydropower impoundments on the mainstem of the St. Louis River and five storage reservoirs on tributaries to the St. Louis River.

The two upstream hydropower impoundments on the mainstem of the St. Louis River (Knife Falls and Scanlon) are operated in run-of-river mode. The Thomson Reservoir is operated in a peak mode, which means water is held in the reservoir overnight and released during the day. Normally this fluctuation is about one foot, although it can be as much as two to three feet during low flow periods. The last hydropower impoundment in the system, Fond du Lac Reservoir, is operated as run-of-river but is downstream from the Thomson Reservoir.

The five storage reservoirs on the tributaries are operated on a seasonal basis to supplement flow during times when the St. Louis is low. Typically, the reservoirs are held at a constant pool elevation during the summer. A drawdown begins in the fall and lasts through late winter. In early spring the drawdown ends and the reservoirs are allowed to refill with meltwater and spring rain. Historically, MP had fluctuated some of the reservoirs more than 20 feet. In the last few years, however, MP has changed its target drawdown elevations to allow the reservoirs to refill more easily in the spring.

FDL is a constituent Band of the Minnesota Chippewa Tribe, which is a federally recognized tribe organized pursuant to 25 USC 476 et seq., is an affected Indian Tribe as defined in 18 CFR 4.38 (a)(1). The St. Louis River forms the north and portions of the eastern boundaries of the FDL reservation.

In accordance with federal requirements [18 CFR 16.8], MP has submitted a final application to the Federal Energy Regulatory Commission (FERC) for the relicensing of the St. Louis River Project (FERC Project No. 2360). Pursuant to the Clean Water Act [CWA 401 (a), 33 USC 1341 (a)], MP must obtain 401 water quality certification from the MPCA before FERC can reissue a hydropower license.

The issuance of a conditional 401 certification by the MPCA staff is due to the complexity of the water quality issues arising from MP's operation of the St. Louis River Project. The conditions center on the potential role of the storage reservoir operations on mercury levels in fish. The conditional 401 specifies the additional mercury studies that will be carried out on these reservoirs, which will require the cooperation of the MPCA, FDL, and MP beyond the December 31, 1993, expiration date of the current FERC license.

In addition, the MPCA, FDL, and MP have developed a MOA. The purpose of this agreement is two-fold. First, it will provide a mechanism for the MPCA, FDL, and MP to coordinate the implementation and review of the additional mercury studies required in the conditional 401. Second, the MPCA, FDL, and MP will engage in additional review and study of biotic uptake of contaminants from sediment in Thomson Reservoir.

The MPCA requests information and opinions concerning the conditional 401 certification and the MOA. Copies of these documents are available for review upon request. Interested persons or groups may submit data or views on the subject of concern in writing or orally.

During this comment period, any person may also submit a request for a public informational meeting or a contested case hearing on the proposed conditional 401 action. 




