

Requests for deadline extensions should be made only in valid emergency situations.

**Notices of public hearings on proposed rules and notices of intent to adopt rules without a public hearing are published in the Proposed Rules section and must be submitted two weeks prior to the issue date.

The *State Register Contracts Supplement* contains additional state contracts and advertised bids.

In accordance with expressed legislative intent that the *State Register* be self-supporting, the following subscription rates have been established: the Monday edition costs \$150.00 per year and includes an index issue published in August (single issues are available at the address listed above for \$3.50 per copy); the combined four editions cost \$195.00 (subscriptions are not available for just the *Contracts Supplement*); trial subscriptions are available for \$60.00, includes four editions, last for 13 weeks, and may be converted to a full subscription anytime by making up the price difference. NOTICE: How to Follow State Agency Rulemaking in the *State Register*

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 75 state agencies have the authority to issue rules. Each agency is assigned specific *Minnesota Rule* chapter numbers. Every odd-numbered year the *Minnesota Rules* are published. This is a ten-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Proposed and adopted emergency rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

If an agency seeks outside opinion before issuing new rules or rule amendments, it must publish a NOTICE OF INTENT TO SOLICIT OUTSIDE OPINION in the *Official Notices* section of the *State Register*. When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues 1-13 inclusive; issues 14-25 inclusive; issue 26, cumulative for issues 1-26; issues 27-38 inclusive; issue 39, cumulative for 1-39; issues 40-51 inclusive; and issue 52, cumulative for 1-52. An annual subject matter index for rules appears in August. Adopted Rules

The adoption of a rule becomes effective after the requirements of Minn. Stat. §14.14-14.28 have been met and five working days after the rule is published in *State Register*, unless a later date is required by statutes or specified in the rule.

If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed.

If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

An emergency rule becomes effective five working days after the approval of the Attorney General as specified in Minn. Stat. §14.33 and upon the approval of the Revisor of Statutes as specified in §14.36. Notice of approval by the Attorney General will be published as soon as practicable, and the adopted emergency rule will be published in the manner provided for adopted rules under §14.18.

Department of Public Safety

Adopted Permanent Rules Relating to Furniture Flammability

The rules proposed and published at *State Register*, Volume 17, Number 5, pages 219-224, August 3, 1992 (17 SR 219), are adopted with the following modifications:

Rules as Adopted

7510.5520 DEFINITIONS.

Subp. 9. **Public occupancies.** "Public occupancies" means:

- A. Group I Occupancies;
- B. child day care centers;
- C. public auditoriums and stadiums; and
- D. public assembly areas of hotels containing more than ten articles of seating furniture.

Public occupancies do not include home and community-based waiver sites and intermediate care facilities for the mentally retarded with fewer than 16 beds.

Subp. 12. **Seating furniture.** "Seating furniture" ~~has the meaning given it in *Minnesota Statutes*, section 299F.841, subdivision 3-~~ means movable or stationary furniture, including children's furniture, that satisfies the following conditions:

A. It is manufactured on or after March 1, 1993.

B. It is made of or with loose or attached cushions or pillows or is itself filled, or able to be filled, in whole or in part with filling material, hidden by fabric or other covering. Cushions or pillows belonging to or forming part of the furniture also satisfy this condition.

C. The components described in item B, together with the structural units, the filling material, and the container and covering, can be used as a support for a person's body or a person's limbs and feet when sitting or resting in an upright or reclining position.

Seating furniture does not include infant or child car seats and infant carriers.

7510.5530 PERFORMANCE STANDARDS ADOPTED BY REFERENCE.

Seating furniture manufactured on or after March 1, 1993, that is sold, used, or intended for use in public occupancies must meet the requirements of either item A or B.

A. Seating furniture meeting the requirements of this item must meet the test requirements set forth in Technical Bulletin 133 of the state of California, "Flammability Test Procedure for Seating Furniture for Use in Public Occupancies," published in January 1991 by the California Bureau of Home Furnishings and Thermal Insulation which is incorporated by reference, is not subject to frequent change, and is available at the State Law Library, 25 Constitution Avenue, Minnesota Judicial Center, Saint Paul, Minnesota 55155.

B. Seating furniture meeting the requirements of this item must be constructed using upholstery fabric and filling materials that meet the test requirements set forth in Technical Bulletin 117 of the state of California, "Requirements, Test Procedures and Apparatus for Testing the Flame Retardance of Filling Materials Used in Upholstered Furniture," published in January 1980 by the California Bureau of Home Furnishings and Thermal Insulation which is incorporated by reference, is not subject to frequent change, and is available at the State Law Library, 25 Constitution Avenue, Minnesota Judicial Center, Saint Paul, Minnesota 55155.

7510.5540 EXEMPT ARTICLES.

Subp. 2. **Sprinklered buildings.** An article of seating furniture is exempt from the requirements of part 7510.5530 if the following criteria are met:

A. the article is used in a public occupancy that is protected throughout by an automatic sprinkler system in conformance with the *Minnesota Uniform Fire Code* as set out in part 7510.3120 or the *Minnesota Building Code* as set out in part 1305.6910;

B. all filling materials contained in the article meet the test requirements set forth in Technical Bulletin 117 of the state of California, "Requirements, Test Procedures and Apparatus for Testing the Flame Retardance of Filling Materials Used in Upholstered Furniture," published in January 1980 by the California Bureau of Home Furnishings and Thermal Insulation which is incorporated by reference, is not subject to frequent change, and is available at the State Law Library, 25 Constitution Avenue, Minnesota Judicial Center, Saint Paul, Minnesota 55155; and

C. the article, if it is a finished article of upholstered furniture, meets the test requirements set forth in Technical Bulletin 116 of the state of California, "Test Procedures and Apparatus for Testing the Flame Retardance of Upholstered Furniture," published

in January 1980 by the California Bureau of Home Furnishings and Thermal Insulation which is incorporated by reference, is not subject to frequent change, and is available at the State Law Library, 25 Constitution Avenue, Minnesota Judicial Center, Saint Paul, Minnesota 55155.

Subp. 3-2. **Reupholstered furniture.** An article of seating furniture manufactured before March 1, 1993, that is reupholstered after March 1, 1993, may not be used in a public occupancy unless it meets the requirements of part 7510.5530, item A or B, or unless it meets all one of the following criteria:

A. the article was in use in a public occupancy before January 1, 1993;

B. the article has never met the requirements of part 7510.5530;

C. all replacement and additional filling material is fire retardant; and the fabric used to reupholster the article meet the requirements of part 7510.5530, item B; or

D. B. all filling material is completely encased in material designed to slow the spread of fire, increase escape time, prevent rapid combustion, insulate internal materials, and restrict generated gases.

Subp. 4-3. **Health care, beauty, and barber furniture.** The owner or operator of a public occupancy may apply for an exemption from compliance with parts 7510.5500 to 7510.5570 for an article of furniture. The fire marshal shall grant an exemption if the article of furniture is necessary to provide health care, beauty, barber, or other important service to the occupants of the public occupancy, if a complying article of furniture is not commonly available on the market, and if the fire marshal determines that the noncomplying article of furniture will not unreasonably compromise fire safety.

Subp. 4. **Personal furniture.** An article of seating furniture in a nursing care or convalescent home is exempt from the requirements of part 7510.5530 if the following criteria are met:

A. the article is used in accordance with Minnesota Statutes, section 144.651, subdivision 22, and Code of Federal Regulations, title 42, part 483.10;

B. the article belongs to a resident;

C. the article is used in the resident's personal living area; and

D. the resident has no more than one such exempt article in the nursing care or convalescent home.

For purposes of this subpart, a Group I Occupancy that is a certified or uncertified boarding care facility or an intermediate care facility for the mentally retarded with 16 or more beds is considered a nursing care or convalescent home.

For purposes of this subpart, a chair and accompanying footstool are considered one article of seating furniture.

7510.5550 LABELING REQUIREMENTS.

Subpart 1. **Standard TB 133 label.** An article of seating furniture conforming to the requirements of part 7510.5530, item A, shall have a label permanently attached to the surface of the article, in plain view, stating as a minimum the following:

"NOTICE

THIS ARTICLE IS MANUFACTURED FOR USE IN PUBLIC OCCUPANCIES AND MEETS THE FLAMMABILITY REQUIREMENTS OF CALIFORNIA BUREAU OF HOME FURNISHINGS TECHNICAL BULLETIN 133. CARE SHOULD BE EXERCISED NEAR OPEN FLAME OR WITH BURNING CIGARETTES."

The fire marshal shall permit another label upon request, if the person making the request shows that the label indicates compliance with Technical Bulletin 133 and the label is accepted by another jurisdiction as an indication of meeting the requirements of Technical Bulletin 133.

Subp. 2. **TB 117 label for furniture in sprinklered buildings.** An article of seating furniture that is exempt from conforming to the requirements of part 7510.5530 because it meets the requirements of part 7510.5540, subpart 2, item B, must have a label permanently attached to the surface of the article, in plain view, stating as a minimum the following:

"NOTICE

ONLY THE RESILIENT FILLING MATERIALS CONTAINED IN THIS ARTICLE MEETS ALL FLAMMABILITY REQUIREMENTS OF MEET CALIFORNIA BUREAU OF HOME FURNISHINGS BULLETINS 116 AND

~~47~~ FLAMMABILITY REQUIREMENTS. CARE SHOULD BE EXERCISED NEAR OPEN FLAME OR WITH BURNING CIGARETTES.”

The fire marshal shall permit another label upon request, if the person making the request shows that the label indicates compliance with Technical ~~Bulletins 46 and~~ Bulletin 117 and the label is accepted by another jurisdiction as an indication of meeting the requirements of Technical ~~Bulletins 46 and~~ Bulletin 117.

Subp. 3. **Label for reupholstered furniture.** A reupholstered article of seating furniture that meets the requirements of part 7510.5540, subpart 3 2, and that is exempt from the requirements of part 7510.5530 shall have a label permanently attached to the surface of the article, in plain view, stating as a minimum the following:

“NOTICE

THIS ARTICLE HAS BEEN REUPHOLSTERED FOR USE IN PUBLIC OCCUPANCIES AND MEETS THE FLAMMABILITY REQUIREMENTS OF MINNESOTA RULES, PART 7510.5540, SUBPART 3 2. THIS ARTICLE IS EXEMPT FROM THE FLAMMABILITY REQUIREMENTS OF CALIFORNIA BUREAU OF HOME FURNISHINGS TECHNICAL ~~BULLETIN 117 and~~ BULLETINS 117 and 133. ~~HOWEVER,~~ CARE SHOULD BE EXERCISED NEAR OPEN FLAME AND WITH BURNING CIGARETTES.”

7510.5570 ENFORCEMENT.

Subp. 2. **Inspect, audit, and review.** When the state fire marshal has sufficient cause to believe that the testing of seating furniture does not comply with parts 7510.5500 to 7510.5570 and that the seating furniture is used or intended for use in a public occupancy, the fire marshal shall inspect or audit the testing and shall review records as necessary to ascertain compliance with parts 7510.5500 to 7510.5570. When requested by the state fire marshal, a manufacturer of seating furniture shall permit the state fire marshal to inspect or audit the testing of the manufacturer's seating furniture and to review the manufacturer's documentation that an article complies with ~~Technical Bulletin 433~~ parts 7510.5500 to 7510.5570.

Revenue Notices

Effective July 1, 1991, the Department of Revenue has authority to issue revenue notices. A revenue notice is a policy statement made by the department that provides interpretation, details, or supplementary information concerning the application of law or rules. This authority was provided by the Legislature in 1991 Session Laws Chapter 291, article 21, section 6 and will be codified at *Minnesota Statutes* section 270.0604.

Department of Revenue

Revenue Notice #93-5: MinnesotaCare

Gross Revenues Subject to Tax

1. *Minnesota Statutes*, section 295.50, subd. 3 defines gross revenues as “total amounts received in money or otherwise . . .” The word “otherwise” means the fair market value in money, of services, or property given in lieu of money.

When a hospital provides inpatient or outpatient services to its employees at a reduced price or free of charge, the taxable amount is the higher of either the amount actually paid, or the average price at which the hospital provides similar inpatient or outpatient services to other similarly situated paying patients.

2. Revenues resulting from inpatient or outpatient services provided by the hospital are subject to the tax unless otherwise excluded.

EXAMPLES: Collection agency payments and any money the hospital receives to cover bad debts generated by inpatient or outpatient services, are subject to the tax. In the case of a collection agency, the total amount paid by the patient, representing payments for inpatient or outpatient services, including the portion the hospital pays the agency as a fee, is subject to the tax.

Regional Centers

The tax status of regional centers is currently under discussion. The Department of Revenue will request the 1993 legislature to exempt these centers as defined in *Minnesota Statutes* § 253B.02, subd. 18 and named in §§ 252.025, subd. 1 and 253.015, subd. 1. The Department will therefore not require these regional centers to make estimated payments of the taxes.

If the request for the exemption is unsuccessful, the Department will abate penalties and interest related to the late filing and payment. The regional centers will then make the estimated tax payments the next due date.

Grants and Donations

All hospitals licensed under chapter 144 of the *Minnesota Statutes* are subject to a 2 percent tax on the gross revenues the hospitals receive for inpatient or outpatient services.

Payments received from Medicare, medical assistance, general assistance medical care, and the MinnesotaCare program are excluded from the tax.

Minnesota Statutes, section 295.50, subd. 3(b) provides that gross revenues subject to the tax exclude "governmental, foundation, or other grants or donations to a hospital or health care provider for operating or other costs."

This exclusion exempts all grants which are not directly related to providing inpatient or outpatient services. Grants and donations are directly related to providing inpatient or outpatient services when they are given to a hospital for the purpose of providing treatment, diagnosis, observation or care for a particular person or a class of people.

Exempt Grants and Donations**Examples**

- Grants to build a new emergency room;
- Research grants;
- General donations to a hospital;
