*Deadline extensions may be possible at the editor's discretion; however, none will be made beyond the second Wednesday (12 calendar days) preceding the issue date for rules, proposed rules and executive orders, or beyond the Wednesday (5 calendar days) preceding the issue date for official notices. Requests for deadline extensions should be made only in valid emergency situations.

**Notices of public hearings on proposed rules and notices of intent to adopt rules without a public hearing are published in the Proposed Rules section and must be submitted two weeks prior to the issue date.

It also contains executive orders of the governor; commissioners' orders; state contracts and advertised bids; professional, technical and consulting contracts; non-state public contracts; state grants; decisions of the supreme court; a monthly calendar of scheduled cases before the supreme court; and other announcements. The State Register Contracts Supplement contains additional state contracts and advertised bids.

In accordance with expressed legislative intent that the State Register be self-supporting, the following subscription rates have been established: the Monday edition costs \$150.00 per year and includes an index issue published in August (single issues are available at the address listed above for \$3.50 per copy); the combined four editions cost \$195.00 (subscriptions are not available for just the Contracts Supplement); trial subscriptions are available for \$60.00, includes four editions, last for 13 weeks, and may be converted to a full subscription anytime by making up the price difference. NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 75 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. This is a ten-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Proposed and adopted emergency rules do not appear in this set because of their short-term nature, but are published in the State Register.

If an agency seeks outside opinion before issuing new rules or rule amendments, it must publish a NOTICE OF INTENT TO SOLICIT OUT-SIDE OPINION in the *Official Notices* section of the *State Register*. When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues 1-13 inclusive; issues 14-25 inclusive; issue 26, cumulative for issues 1-26; issues 27-38 inclusive; issue 39, cumulative for 1-39; issues 40-51 inclusive; and issue 52, cumulative for 1-52. An annual subject matter index for rules appears in August. Proposed Rules

Pursuant to Minn. Stat. §§ 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing, as long as the agency determines that the rules will be noncontroversial in nature. The agency must first publish a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the *State Register*. The notice must advise the public:

- 1. that they have 30 days in which to submit comment on the proposed rules;
- 2. that no public hearing will be held unless 25 or more persons make a written request for a hearing within the 30-day comment period;
- 3. of the manner in which persons shall request a hearing on the proposed rules; and
- 4. that the rule may be modified if the modifications are supported by the data and views submitted.

If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.14-14.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the *State Register*.

Pursuant to Minn. Stat. §§ 14.29 and 14.30, agencies may propose emergency rules under certain circumstances. Proposed emergency rules are published in the *State Register* and, for at least 25 days thereafter, interested persons may submit data and views in writing to the proposing agency.

Proposed Permanent Rules Relating to Septic System Grants

Notice of Intent to Adopt a Rule Without a Public Hearing

The Department of Trade and Economic Development intends to adopt a permanent rule without a public hearing in accordance with the procedures set forth in the Administrative Procedures Act, *Minnesota Statutes*, sections 14.22 to 14.28. You have 30 days to submit written comments on the proposed rule and may also submit a written request that a hearing be held on the rule.

Subject of Rule and Statutory Authority. The proposed rule is about a new septic system grant program for certain tourism related businesses funded through the Legislative Commission on Minnesota Resources. The proposed rule sets forth eligibility requirements, procedures for soliciting grant applications, guidelines and criteria for awarding grants and related information. The statutory authority to adopt this rule is *Minnesota Statutes* 116J.035, Subdivision 2. A copy of the proposed rule is published in the *State Register* and attached to this notice as mailed.

Comments. You have until 4:30 p.m., July 14, 1993 to submit written comment in support of or in opposition to the proposed rule or any part or subpart of the rule. Your comment must be in writing and received by the agency contact person by the due date. Comment is encouraged. Your comment should identify the portion of the rule addressed, the reason for the comment, and any change proposed.

Request for a Hearing. In addition to submitting comments, you may also request that a hearing be held on the rule. Your request for a public hearing must be in writing and must be received by the agency contact person by 4:30 p.m., July 14, 1993. Your written request for a public hearing must include your name and address. You are encouraged to identify the portion of the proposed rule which caused your request, the reason for the request, and any changes you want made to the proposed rule. If 25 or more persons submit a written request for a hearing, a public hearing will be held unless a sufficient number withdraw their request in writing. If a public hearing is required, the agency will follow the procedures in *Minnesota Statutes* 14.131-14.20.

Modifications. The proposed rule may be modified as a result of a public comment. The modifications must be supported by the data and views submitted to the agency and may not result in a substantial change in the proposed rule as attached and printed in the *State Register*. If the proposed rule affects you in any way, you are encouraged to participate in the rulemaking process.

Statement of Need and Reasonableness. A Statement of Need and Reasonableness is now available from the agency contact person. This statement describes the need for and reasonableness of each provision of the proposed rule and identifies the data and information relied upon to support the proposed rule.

Small Business Considerations. The department has determined that the effect of the proposed rule on small businesses, as defined

in *Minnesota Statutes*, section 14.115, subject to its provisions will be positive as it provides an opportunity for some of those businesses to obtain financial assistance to replace failing or nonconforming septic systems. The program may also help to improve the local environmental quality of ground and surface waters associated with the businesses.

Expenditure of Public Money by Local Public Bodies. County officials will be asked to verify whether septic systems installed with assistance from this program were installed in accordance with state or local requirements and whether there is an existing or potential health or water quality problem. This will only involve verifying information which counties are already required to document. It is not anticipated that this rule will result in any significant additional costs to local governments. Therefore, *Minnesota Statutes*, section 14.11, subdivision 1 is not applicable.

Impact on Agricultural Lands. Because the proposed rule would not have a direct and substantial impact on agricultural land in Minnesota, *Minnesota Statutes*, section 14.11, subdivision 2, is not applicable.

Adoption and Review of Rule. If no hearing is required, after the end of the comment period the agency may adopt the rule. The rule and supporting documents will then be submitted to the Attorney General for review as to legality and form to the extent form relates to legality. You may request to be notified of the date the rule is submitted to the attorney general or be notified of the attorney general's decision on the rule. If you wish to be so notified, or wish to receive a copy of the adopted rule, submit your request to the agency contact person listed above.

Rules as Proposed (all new material) 4290.0010 DEFINITIONS.

Subpart 1. Scope. The following terms used in parts 4290.0010 to 4290.0050 have the meanings given them.

Subp. 2. Commissioner. "Commissioner" means the commissioner of the Department of Trade and Economic Development or persons delegated to act in the commissioner's behalf.

Subp. 3. Department. "Department" means the Department of Trade and Economic Development.

Subp. 4. Eligible business. "Eligible business" means a sole proprietorship, partnership, limited liability company, corporation, or other person engaged in, and determined by the department to constitute, a tourism-related business providing overnight lodging. In making its determination, the department shall use the state industrial classification codes of 7011 and 7033 in the Standard Industrial Classification Manual, prepared by the Executive Office of the President, Office of Management and Budget, United States Government, and published in 1987. This manual is incorporated by reference. It is available at the state law library and at the Department of Trade and Economic Development library, 500 Metro Square, 121 Seventh Place East, Saint Paul, Minnesota. A copy of the relevant sections of the manual may be obtained at no charge from the department. The document is not subject to frequent change.

The business must be located within 1,000 feet from the ordinary high water level of a lake, pond, or flowage, or 300 feet from a river or stream, or the landward extent of a floodplain designated by ordinance on a river or stream, whichever is greater.

Subp. 5. Eligible cost. "Eligible cost" means design, engineering, excavation, construction, installation, and materials costs related to the replacement of existing septic systems.

Subp. 6. Eligible project. "Eligible project" means a project that proposes to replace a failing or nonconforming septic system or systems with a new sewage treatment system or a connection to a sewer system.

Subp. 7. Septic system grant. "Septic system grant" means a specific sum of money made available through June 30, 1995, by the state to an eligible business for the replacement of failing or nonconforming septic systems.

4290.0020 APPLICATION PROCESS FOR SEPTIC SYSTEM GRANTS.

Subpart 1. Eligibility of applicant. An eligible business may apply for a septic system grant. To receive a grant, an eligible business must satisfy the requirements in parts 4290.0010 to 4290.0050. An eligible business may receive only one grant through the septic system grant program for the period ending June 30, 1995. The application must be submitted by the eligible business.

Proposed Rules =

Subp. 2. Eligibility of project. A grant must be to an eligible business for an eligible cost. The maximum state grant may not be for more than 50 percent of the total eligible cost of the project, with a maximum grant of \$10,000 for any one business. Project-related costs incurred before July 1, 1993, are ineligible.

Subp. 3. Application content and requirements. The department shall make the application documents and information available to all eligible businesses upon request. The application materials shall include instructions for completing and submitting the application. The completed application must be submitted in the format required and address all information requested. The department may request additional information from the applicant if it is necessary to clarify and evaluate the application. A formal closing date for receipt of the application shall be established by the department and included in the application materials provided.

4290.0030 PROCEDURE FOR SEPTIC SYSTEM GRANT EVALUATION AND APPROVAL.

Subpart 1. Evaluation of eligibility. Upon receipt of the completed application, the department shall make a determination whether the business, project, and costs are eligible. If it is determined that the business, project, or costs are ineligible, the application will not receive further evaluation and will not be considered for funding. If it is determined that the business, project, and costs are eligible, the application according to the procedures and criteria in subpart 2.

Subp. 2. Evaluation of completed application. Upon receipt of the completed application and a determination of eligibility, the department shall evaluate the application based on the criteria in items A to C:

A. Qualifying criteria are:

(1) the ability of the eligible business to meet the matching fund requirement and complete the project subject to the reimbursement procedure of the program; and

(2) whether the proposed project could be completed before July 1, 1995.

If the application does not adequately demonstrate that the qualifying criteria can be satisfactorily met, the application will not receive further evaluation and will not be considered for funding. If the qualifying criteria are met, the department shall proceed with the evaluation of the priority criteria in items B and C. In completing its evaluation and ranking, the department shall place greater emphasis on the priority one criteria in item B.

B. Priority one criteria are:

(1) the degree to which the proposed project would protect groundwater and surface water quality;

(2) the extent to which the proposed project would correct existing health or safety problems related to groundwater or surface water contamination;

(3) whether the system has been verified as a failing system; and

(4) whether a written order has been issued by local authorities to repair or replace the system.

C. Priority two criteria are:

(1) the extent to which the nonconforming status of the existing system has impeded, or will likely impede, the operation of the eligible business;

(2) the extent to which the proposed project would contribute to the economic viability of the eligible business;

(3) whether the proposed project represents a different approach or technology for on-site treatment that might have potential for adoption by other persons currently using traditional individual septic systems and would be permitted under state and local regulations;

(4) whether the proposed system would serve more than one eligible business; and

(5) a determination of the reasonableness of the estimated project costs.

Subp. 3. Competitive review, ranking, and allocation process. A priority ranking shall be established, based on the priority criteria for each application that meets the qualifying criteria. Grants shall be allocated to eligible businesses in descending order of priority, as determined by the ranking, until all funds are exhausted.

Subp. 4. Notification. All applicants shall be notified by the department about the disposition of their projects after the competitive review, ranking, and allocation process has been completed and a funding determination has been made.

4290.0040 PROJECT AGREEMENT.

Upon approval, the department shall execute a project agreement with the applicant. The project agreement shall specify the terms and conditions of the grant, including the responsibilities of the grantor and the grantee.

4290.0050 DISBURSEMENT OF GRANT.

The applicant shall initially pay for the project costs as specified in the project agreement. The applicant shall submit to the

department a payment request for reimbursement of costs incurred in the completion of the project. Upon receipt of the payment request containing the documentation required in the project agreement, the department shall audit the payment request documentation to determine the eligibility and propriety of the costs incurred by the applicant. This documentation shall include a letter or other written verification from the local government official or officials responsible for certifying and/or approving the installation of the system that the project has been completed in accordance with all applicable regulations and requirements. The project site shall be subject to inspection by department personnel during the project period and prior to final closeout of the grant to ensure that the project has been completed in accordance with the project agreement.

Adopted Rules

The adoption of a rule becomes effective after the requirements of Minn. Stat. \$14.14-14.28 have been met and five working days after the rule is published in *State Register*, unless a later date is required by statutes or specified in the rule.

Notice of approval by the Attorney General will be published as soon as practicable, and the adopted emergency rule will be published in the manner provided for adopted rules under §14.18.

7077.0100 PURPOSE.

This chapter provides for the Minnesota Pollution Control Agency's administration of financial assistance programs for the construction of municipal wastewater treatment systems. The programs in this chapter are:

E. the individual sewage treatment systems grant grants program for grants awarded on or after July 1, 1990, under *Minnesota Statutes*, section 116.18, subdivision 3c.

Parts 7077.0111 to 7077.0292 apply to the financial assistance program.

Parts 7077.0300 to 7077.0330 apply to the combined sewer overflow program.

Parts 7077.0500 to 7077.0560 apply to the corrective action grants program.

Parts 7077.0600 to 7077.0660 apply to the capital cost component grants program.

Parts 7077.0700 to 7077.0765 apply to the individual sewage treatment systems grants program.

7077.0105 DEFINITIONS.

Subp. 11b. Dwelling. "Dwelling" means any building or place used or intended to be used by human occupants as a single family or two-family unit.

Subp. 11c. Evaluator/designer. "Evaluator/designer" means a person approved by the commissioner, in accordance with part 7077.0720, who investigates soils and site characteristics to determine suitability, limitations, soil type, and sizing requirements for individual sewage treatment systems and design treatment systems that conform to chapter 7080.

Subp. 13a. Expanded discharge. "Expanded discharge" to an outstanding resource value water means a discharge that changes in volume, quality, location, or any other manner after the effective date the outstanding resource value water was designated as described in parts 7050.0460 and 7050.0470, such that an increased loading of one or more pollutants results. In determining whether an increased loading of one or more pollutants would result from the proposed change in the discharge, the agency shall compare the loading that would result from the proposed discharge with the loading allowed by the agency as of the effective date of outstanding resource value water designation.

For all other waters of the state, expanded discharge means a discharge that changes in volume, quality, location, or any other manner after January 1, 1988, such that an increased loading of one or more pollutants would result from the proposed change in discharge₇. The agency shall compare the loadings that would result from the proposed discharge with the loading allowed by the agency on January 1, 1988.

7077.0115 PROJECT PRIORITY LIST.

Subp. 3. **Request for placement on list.** A municipality may submit a written request to the commissioner for placement of a project on the project priority list. The request must include a description of the need for the new or upgraded wastewater treatment system. If known, the request shall also include a description of the proposed project and its costs. The municipality must submit any information that is necessary for the project to receive accurate review under subpart 4. <u>Unless a municipality requests that its project be placed on the list with total points equal to one</u>, information must be submitted according to items A to C.

7077.0165 PRIORITY POINTS FOR TYPE OF PROJECT.

The type of wastewater treatment system currently serving the project service area shall determine how priority points are assigned to the project. If any portion of the project service area is covered by an NPDES permit, the project shall be considered an NPDES project and shall receive points under parts 7077.0167 to 7077.0176. If no portion of the project service area is covered by an NPDES permit but some portion of it is covered by an SDS permit, the project shall be considered an SDS project and shall receive points under parts 7077.0186. If no portion of the project service area is covered by an NPDES or SDS permit, the project service area is covered by an NPDES or SDS permit, the project service area is covered by an NPDES or SDS permit, the project shall receive points under parts 7077.0186 [7077.0187] to 7077.0196.

7077.0195 EXTRA POINTS FOR WASTEWATER TREATMENT SYSTEMS WITHOUT AN NPDES OR SDS PERMIT.

Subp. 2. Eliminate discharge. When the project will eliminate a surface discharge, points shall be assigned equal to three times the percentage of structures with wastewater flow flows in the project service area which are identified to have surface discharges. Surface discharges are wastewater discharges to the soil surface or to a surface water.

Subp. 6. Nondomestic wastewater. When the discharges of nondomestic wastewater will be eliminated by the project, points equal to 150 times the number of the discharges eliminated in the project service area shall be assigned equal to 150 times the number of the discharges eliminated in the project service area, divided by the total number of structures with wastewater flows in the project service area. A nondomestic discharge is a nonsewage discharge from a nonresidential structure with wastewater flows or a nonsewage discharge from a residential structure with a water using business.

7077.0274 PLANS AND SPECIFICATIONS.

Subp. 2. Contents. A complete set of plans and specifications must address the following items in the amount of detail that is appropriate to describe a project accurately:

A. plans and specifications signed by:

(1) a professional engineer registered in Minnesota for in the case of wastewater treatment systems; or

(2) a professional engineer or an evaluator/designer for in the case of individual sewage treatment systems designed to treat 5,000 gallons or less of wastewater per day;

7077.0292 REQUEST TO WITHHOLD FINANCIAL ASSISTANCE PAYMENTS.

Failure of a project to conform substantially to approved plans and specifications or failure of a municipality to comply with the requirements of parts 7077.0286 and 7077.0288 constitutes grounds for the commissioner to request that the authority withhold payments to the municipality. Once an agreement for correcting the condition which led to the withholding of funds is reached between the commissioner and the municipality, the commissioner shall recommend to the authority that the retained funds be released according to the provisions in the agreement.

Revenue Notices :

Effective July 1, 1991, the Department of Revenue has authority to issue revenue notices. A revenue notice is a policy statement made by the department that provides interpretation, details, or supplementary information concerning the application of law or rules. This authority was provided by the Legislature in 1991 Session Laws Chapter 291, article 21, section 6 and will be codified at *Minnesota Statutes* section 270.0604.

Revenue Notice #93-10: Income Tax-Residents of Minnesota Living Abroad

To avoid being treated as residents for Minnesota income tax purposes, qualified individuals domiciled in Minnesota but living abroad have three months from the date they move out of the country to revoke the homestead status of their Minnesota residence. *Minnesota Statutes* 1992, section 290.01, subdivision 7, as amended by *Laws 1993*, chapter 375, article 8, section 5. This requirement became law on May 24, 1993 and is effective for tax years beginning after December 31, 1992. This means that this law change affects individuals who left Minnesota in 1993, prior to its enactment. For some of these individuals, the three month period has expired. For the others, the period partially expired before enactment.

To prevent the unfair effects of retroactively applying this change, qualified individuals who left the country prior to May 24, 1993 will be considered non-residents provided they give notice of revocation of the homestead status of their Minnesota residence by September 1, 1993.

Revenue Notice 93-11: Sports Bookmaking Tax.

A new sports bookmaking tax goes into effect on July 1, 1993. A person engaged in sports bookmaking will be required to file a monthly return and pay a tax of 6 percent of gross bets handled.

For purposes of this tax, the taxpayer will remain anonymous. The Department of Revenue will maintain no records regarding the taxpayer other than the sports bookmaking tax return. The only information that will be shown on the tax return is the taxable period, the gross amount of bets handled, the amount of the tax, and a number that is assigned each return.

The return cannot be used to start an audit.

The Department will accept cash or a check as payment of the tax. When each filing and payment is made, a portion of the return with that returns assigned number will be detached and furnished as a receipt.

NOTICE IS HEREBY GIVEN that the Minnesota Department of Health is seeking information or opinions from sources outside the Department in preparing to revise adopted *Minnesota Rules*, Chapter 4720 governing public water supplies. Within Chapter 4720 the department is considering amending the following rule parts:

Part 4720.0350 RULES AND STANDARDS ADOPTED BY REFERENCE

Part 4720.2300 ADDITIONAL MONITORING REQUIREMENTS

Part 4720.3910 TYPHOID FEVER

Part 4720.3920 GENERAL REQUIREMENT FOR THE CONSTRUCTION OF SURFACE WATER TREATMENT FACILITIES

Part 4720.3942 FILTRATION

Authority for the commissioner to adopt and amend rules relating to public water supplies is governed by *Minnesota Statutes*, section 144.383, paragraph (e) of the Minnesota Safe Drinking Water Act. This authority compels the commissioner "to promulgate rules, pursuant to chapter 14 but no less stringent than federal regulation, which may include the granting of variances and exemptions."

The need to revise existing public water supply rules is prompted by new National Primary Drinking Water Regulations contained in Code of Federal Regulations, title 40, parts 141, 142 and 143.

1) On January 30, 1991, the Environmental Protection Agency (EPA) adopted maximum contaminant levels or treatment techniques for 33 new chemicals, 26 synthetic organic chemicals and seven inorganic chemicals. This brings the total number of maximum contaminant levels to 83. The National Primary Drinking Water Regulations include monitoring, reporting, and public notice requirements for these compounds. Adopted by the EPA are secondary maximum contaminant levels for two contaminants and one-time monitoring requirements for approximately 20 synthetic organic chemicals and inorganic chemicals.

2) On June 7, 1991, maximum contaminant level goals (MCLGs) and national primary drinking water regulations for controlling lead and copper in drinking water were adopted by the EPA. The EPA promulgated an MCLG of zero for lead and MCLG of 11.3 milligrams per liter for copper. The adopted federal drinking water regulations for lead and copper consist of a treatment technique requirement that includes corrosion control treatment, source water treatment, lead service line replacement, and public education.

3) On July 1, 1991, the EPA adopted regulations that revised the monitoring requirements for eight volatile organic contaminants originally promulgated July 8, 1987. This change synchronizes requirements for these eight contaminants with monitoring requirements promulgated on January 30, 1991. EPA also promulgated the MCLGs and a maximum contaminant level for aldicarb, aldicarb sulfoxide, aldicarb sulfone, pentachlorophenol, and barium. Some errors and clarifications are also addressed.

4) On July 17, 1992 the EPA adopted maximum contaminant level goals and maximum contaminant levels for 18 synthetic organic chemicals and five inorganic chemicals. Monitoring, reporting and public notice requirements for these chemicals were adopted. Regulation of sulfate was deferred. The regulations include the best available technology on which the MCLs are based and the best available technology for the purpose of issuing variances.

At this time the department is also providing notice of the potential repeal of existing part 7420.3910 TYPHOID FEVER on the basis that this rule is redundant of other existing standards and is now obsolete.

The department anticipates adoption of the rules by October 1993, effective before January 17, 1994. A advisory task force will not be formed, however, representatives of the owners and operators of public water supplies will receive a copy of this notice and any proposed rules and notice to adopt.

The health care providers listed below are required to collect and submit descriptive and aggregate financial data on number of patients served (by state of residence and Minnesota county); site or sites where the health care provider provides services; the number of individuals employed, by type of employee, by the health care provider; the services and their costs for which no payment was received; total revenue by type of payer, including but not limited to, revenue from Medicare, Medical Assistance, MinnesotaCare, nonprofit health service plan corporations, commercial insurers, health maintenance organizations, and individual patients; revenue from research activities, educational activities, out-of-pocket payments by patients, donations, grants and/or government subsidies. Summary expenditure data must be provided at least for the following categories: salaries/wages and employee benefits, purchased services, other expenditures, and administrative costs, bad debt, and charity care deductions. Other information, including but not limited to, indicators of quality of services and outcomes of care will also be required.

Hospitals and Freestanding Outpatient Surgical Centers: The new information required under the 1993 legislative mandates will be incorporated into the existing reporting forms on aggregated financial and utilization information. Data for the calendar year 1993 must be submitted by the reporting date established by the Health Care Cost Information System (HCCIS), under *Minnesota Statutes* 144.695-703. Sample forms and instruction materials will be made available before July 1, 1993. Final forms with instructions and definitions will be mailed to all hospitals and freestanding outpatient surgical centers at least 60 days before the report due date. Physician group practices and Health Care Clinics: For health care clinics, the aggregated financial and utilization information required under these legislative mandates will be incorporated into new reporting forms. Sample forms and instruction materials will be mailed to each clinic before July 1, 1993 Final forms with instructions and definitions will be mailed no later than November 1, 1993. It includes, but is not limited to health insurance companies, health maintenance organizations (HMOs), nonprofit health service plan corporations, and other health plan companies; employee health plans offered by self-insured employers; trusts established in a collective bargaining agreement under the federal Labor-Management Relations Act of 1974, US CFR title 29, section 141, et seq.; the Minnesota comprehensive health association; group health coverage offered by fraternal

Section II.G. <u>Convictions for Attempts, Conspiracies, and Other Sentence Modifiers</u>: For persons convicted of attempted offenses or conspiracies to commit an offense, or for persons convicted of Solicitation of Juveniles under *Minnesota Statutues* § 609.494, subd. 2(b), or <u>Solicitation of Mentally Impaired Persons under *Minnesota Statutues* § 609.493, the presumptive sentence is determined by locating the Sentencing Guidelines Grid cell defined by the offender's criminal history score and the severity level of the completed or intended offense, and dividing the duration contained therein by two, but such sentence shall not be less than one year and one day except that for Conspiracy to Commit a Controlled Substance offense as per <u>Minnesota Statutues</u> § 152.096, in which event the presumptive sentence shall be that for the completed offense.</u>

II. PROPOSED MODIFICATIONS DIRECTED BY 1993 LEGISLATURE FOR CONSIDERATION

The 1993 Legislature passed language directing the Commission to consider modifying the guidelines so that credit for time spent in confinement under Huber Law would be given at the rate of one day for each day served. The Commission proposes the following language with an effective date of August 1, 1994, as specified by the legislation: C. Jail Credit: ... Time spent in confinement under Huber Law (*Minnesota Statutues* § 631.425) shall be awarded at the rate of twelve hours for each 24 hour period one day for each day served. See <u>State v. Deschampe</u>, 332 N.W.2d. 18 (Minn. 1983).

<u>Comment</u>

III.C.02....Jail credit for time spent in confinement under the conditions of Huber Law (Minnesota Statutues § 631.425) should be awarded at the rate of 12 hours for each 24 hour period one day for each day served.

III. PROPOSED MODIFICATIONS TO IMPLEMENT THE NEW FELONY SENTENCING SYSTEM

The Commission proposes the following changes to the Sentencing Guidelines and Commentary:

II.C.02. In the cells below and to the right of the dispositional line, the guidelines provide a fixed presumptive sentence length, and a range of time around that length. Presumptive sentence lengths are shown in months, and it is the Commission's intent that months shall be computed by reference to calendar months. Any sentence length given that is within the range of sentence length shown in the appropriate cell of the Sentencing Guidelines Grid is not a departure from the guidelines, and any sentence length given which is outside that range is a departure from the guidelines. In the cells above and to the left of the dispositional line, the guidelines provide a single fixed presumptive sentence length.

The presumptive duration listed on the grid, when executed, includes both the term of imprisonment and the period of supervised release. According to Minnesota Statutes § 244.101, when the court sentences an offender to an executed sentence for an offense occurring on or after August 1, 1993, the sentence consists of two parts: a specified minimum term of imprisonment equal to two-thirds of the total executed sentence and a specified maximum supervised release term equal to one-third of the total executed sentence. A separate table following the Sentencing Guidelines Grid illustrates how executed sentences are broken down into their two components.

<u>The Commissioner of Corrections may extend the amount of time an offender actually serves in prison if the offender violates</u> <u>disciplinary rules while in prison or violates conditions of supervised release.</u> This extension period could result in the offender's serving <u>the entire executed sentence in prison</u>.

II.E. Mandatory Sentences:... When an offender has been sentenced according to *Minnesota Statutues* § 609.11, subd. 5a the presumptive duration of the prison sentence is the mandatory minimum term sentence for dangerous weapon involvement plus the mandatory minimum term sentence for the second or subsequent controlled substance offense or the duration of prison sentence provided in the appropriate cell of the Sentencing Guidelines Grid, whichever is longer.

II.F.02....The second or subsequent judge can pronounce the durations indicated in the Sentencing Guidelines Grid at the zero criminal history column for the severity level for the current offense, and can state that this sentence would be consecutive to the previous presumptive sentence. The institutional records officer will aggregate the separate durations into a single fixed presumptive sentence, as well as aggregate the terms of imprisonment and the periods of supervised release. For example, if Judge A executed a 44 month fixed presumptive sentence, and Judge B later executes a 24 month fixed presumptive sentence to be served consecutively to the first sentence, the records officer has the authority to aggregate those sentences into a single 68 month fixed presumptive sentence, with a <u>specified minimum</u> 45.3 month term of imprisonment and a <u>specified maximum</u> 22.7 month period of supervised release, provided all good time were that all good time were earned.

III.C.02. The Commission also believes that jail credit should be awarded for time spent in custody as a condition of a stay of imposition or stay of execution when the stay is revoked and the offender is committed to the Commissioner of Corrections. The primary purpose of imprisonment is punishment, and the punishment imposed should be proportional to the severity of the conviction offense and the criminal history of the offender. If, for example, the presumptive duration in a case is 18 months, and the sentence was initially executed by means of a departure the <u>specified minimum</u> term of imprisonment would be 12 months if all good time were carned.

III.C.03. In order to ensure that offenders are not penalized for inability to post bond, credit for time in custody shall be computed by the Commissioner of Corrections after projected good time is subtracted from the sentence. and subtracted from the specified minimum term of imprisonment.

For offenders sentenced prior to August 1, 1993, credit for time in custody shall be computed by the Commissioner of Corrections after projected good time is subtracted from the executed sentence.

The Commission proposes the following table be added to the backside of the Sentencing Guidelines Grid:

<u>Examples of Executed Sentences (Length in Months) Broken Down by:</u> <u>Specified Minimum Term of Imprisonment and Specified Maximum Supervised Release Term</u>

Offenders committed to the Commissioner of Corrections for crimes committed on or after August 1, 1993 will no longer earn good time. In accordance with Minnesota Statutues § 244.101, offenders will receive an executed sentence pronounced by the court consisting of two parts: a specified minimum term of imprisonment equal to two-thirds of the total executed sentence and a supervised release term equal to the remaining one-third. This provision requires that the court pronounce the total executed sentence and explain the amount of time the offender will serve in prison and the amount of time the offender will serve on supervised release, assuming the

offender commits no disciplinary offense in prison that results in the imposition of a disciplinary confinement period. The court shall also explain that the amount of time the offender actually serves in prison may be extended by the Commissioner if the offender violates disciplinary rules while in prison or violates conditions of supervised release. This extension period could result in the offender's serving the entire executed sentence in prison. The court's explanation is to be included in a written summary of the sentence.

IV. PROPOSED MODIFICATIONS TO CLARIFY MINIMUM PERIODS OF SUPERVISION FOR SEX OFFENDERS RELEASED FROM PRISON

The Commission proposes the following Commentary language:

<u>II.05.</u> <u>Minnesota Statutes § 609.346 requires that when a court sentences a person to prison for a violation of section 609.342, 609.343, 609.344, or 609.345, the court shall provide that after the person has completed the sentence imposed, the commissioner of corrections shall place the person on conditional release for five years, minus the time the person served on supervised release. If the person was convicted for a violation of one of those sections a second or subsequent time, or sentenced to a mandatory departure pursuant to section 609.346, subd. 4, the person shall be placed on conditional release for ten years, minus the time served on supervised release.</u>

The Commission also proposes to modify the Sentencing Guidelines Grid by adding language to the description of the unshaded area of the grid:

Presumptive commitment to state imprisonment. First Degree Murder is excluded from the guidelines by law and continues to have a mandatory life sentence. See section **II.E. Mandatory Sentences** for policy regarding those sentences controlled by law, including minimum periods of supervision for sex offenders released from prison.

V. SEVERITY LEVEL RANKING CONSIDERATIONS FOR CRIMINAL VEHICULAR HOMICIDE

The Commission is considering whether to modify the sentencing guidelines by ranking violations of section 609.21, subdivisions 1, clauses (3) and (4), and 3, clauses (3) and (4) in severity level VII of the sentencing guidelines grid. These crimes are currently ranked at severity level VI and carry a presumptive prison sentence of 21 months for offenders with no criminal history score. The Commission would like public comment on this issue before deciding whether to adopt any change in severity level for these crimes.

VI. PROPOSED MODIFICATIONS TO CLARIFY OR MAKE TECHNICAL CHANGES

The Commission proposes the following Commentary language:

II.B.302... The Commission believes that offenders whose current conviction is for criminal vehicular homicide or injury and who have prior violations under 169.121, 169.1211 or 169.129 are also more culpable and for these offenders there is no limit to the total number of misdemeanor points included in the criminal history score due to DWI violations. To determine the total number of misdemeanor points under these circumstances, first add together any non DWI misdemeanor units. If there are less than four units, add in any DWI units. Four or more units would equal one point. Only DWI units can be used in calculating additional points. Each set of four DWI units would equal an additional point. For example, if an offender had two theft units and six DWI units, the theft would be added to the two DWI units to equal one point. The remaining four DWI units would equal a second point. In a second example, if an offender had six theft units and six DWI units, the first four theft units would equal one point. The remaining two theft units could not be added to the remaining two DWI units for a third point. The total misdemeanor score would be two.

To section II.A.02.b. of the Commentary:

b. If multiple offenses are an element of the conviction offense, such as in Subd. 1 (h) (ψ) (iii) of first degree criminal sexual conduct, the date of the earliest offense should be used as the date of the conviction offense.

VII. PROPOSED SEVERITY LEVEL RANKINGS FOR INADVERTENTLY UNRANKED OFFENSES

Several felony offenses have been recently discovered that have not been considered for ranking by the Commission. These crimes are technically unranked at this time. The Commission proposes the following severity level rankings for these crimes which will have an effective date of August 1, 1994, after the 1994 Legislature has reviewed the adopted rankings:

The Commission proposes to increase the severity level ranking of certain prostitution crimes that involve force. These crimes are currently ranked at severity level V and the Commission proposes to increase the rank to VII. These new rankings, if adopted, will be effective August 1, 1994, after they receive a review from the 1994 Legislature.




