Minnesota Rules: Amendments and Additions =

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 75 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. This is a ten-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Proposed and adopted emergency rules do not appear in this set because of their short-term nature, but are published in the State Register.

If an agency seeks outside opinion before issuing new rules or rule amendments, it must publish a NOTICE OF INTENT TO SOLICIT OUTSIDE OPINION in the Official Notices section of the State Register. When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety in the State Register, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the Minnesota Guidebook to State Agency Services.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues 1-13 inclusive; issues 14-25 inclusive; issue 26, cumulative for issues 1-26; issues 27-38 inclusive; issue 39, cumulative for 1-39; issues 40-51 inclusive; and issue 52, cumulative for 1-52. An annual subject matter index for rules appears in August. Adopted Rules

The adoption of a rule becomes effective after the requirements of Minn. Stat. §§14.14-14.28 have been met and five working days after the rule is published in *State Register*, unless a later date is required by statutes or specified in the rule.

If an adopted rule is identical to its proposed form as previously published, a notice of adoption and citation to its previous State Register publication will be printed.

If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous State Register publication will be cited.

An emergency rule becomes effective five working days after the approval of the Attorney General as specified in Minn. Stat. §14.33 and upon the approval of the Revisor of Statutes as specified in §14.36. Notice of approval by the Attorney General will be published as soon as practicable, and the adopted emergency rule will be published in the manner provided for adopted rules under §14.18.

9550.0010 **DEFINITIONS**.

Subp. 2a. Authorized representative. Authorized representative" means a parent of a minor child, a guardian, a person who is authorized by power of attorney under *Minnesota Statutes*, section 523.01, a person who is appointed by the applicant or client, or a person who is authorized by a court of law to act on the applicant's or client's behalf in matters involving community social services. The case record must document the name of the person or names of the persons appointed and the reason or reasons for the appointment.

9550.0040 GRANTS AND PURCHASE OF SERVICE CONTRACTS.

- Subp. 2. Grant and contract requirements. Grants and purchase of service contracts for community social services must contain the following:
 - B. an explicit a description of the service or services as defined in the community social services plan;

9550.0060 SOCIAL SERVICES FEES.

Subp. 2. Ability to pay. County-established fees and fee schedules must be based upon a client's ability to pay, as determined by considering. In determining ability to pay, counties must consider family size, and income, and may consider other resources. Fees and fee schedules must reflect a sliding scale in which the fee charged varies in accordance with factors that would affect the amount a client is able to pay.

Fees must not be based upon a minimum charge to all clients.

9550.0070 APPLICATION FOR SOCIAL SERVICES.

Subpart 1. **Right to apply.** The local agency must post a notice in a prominent place within the local agency advising individuals of their right to apply for social services. The local agency must advise all individuals who ask about <u>receiving social services</u> or request social services of their right to sign an application form for social services without delay during normal business hours and that the application form will be processed after it is signed and completed.

Rules as Adopted

5210.0539 EMPLOYEE AND AUTHORIZED EMPLOYEE REPRESENTATIVE CONTESTS.

Subp. 2. Filing.

B. Within seven days of the employee's or authorized employee representative's receipt of the employee notice of contest form, the employee or authorized employee representative shall file the fully completed form with the commissioner. For purposes of this part, an employee notice of contest is filed only upon its receipt by the commissioner. The day the notice of contest is received shall not be included in calculating the 20 seven calendar days. The last day of the 20 day seven-day period shall be included, unless it is a Saturday, Sunday, or state holiday, in which event the period runs until the next day which is not a Saturday, Sunday, or state holiday. An employee notice of contest form may be filed with the commissioner by postage prepaid first class mail, personal delivery, or facsimile transmission according to part 5210.0554, subpart 2.

Adopted Permanent Rules Relating to Experimental Nursing Programs; <u>Licensure Without Examination and Registration Fees</u>

The rules proposed and published at *State Register*, Volume 20, Number 26, pages 1788-1790, December 26, 1995 (20 SR 1788), are adopted with the following modifications:

Rules as Adopted

6301.0810 EXPERIMENTAL PROGRAMS; EXEMPTION FROM CERTAIN RULES.

Subpart 1. Eligibility for exemption. A professional or practical nursing program approved by the board and desiring to experiment within the program is eligible to seek an exemption from the rules identified in subpart 2. To be eligible for the exemption, the program of theory and practice must evidence one or more of the following: development of a multidisciplinary or interdisciplinary educational program, major change in the focus of the curriculum, major change in the focus of student-client interactions, or another revision of a similar magnitude. The program shall continue to prepare graduates to practice safely, competently, and ethically within the full scope of practice as defined in *Minnesota Statutes*, section 148.171, paragraph (3), for professional nursing, or paragraph (5) for practical nursing. The program shall be prepared to implement the experimental program within 18 months after the exemption is granted by the board.

Notice of Withdrawal of Proposed State Agency Rulemaking in the Matter of Proposed Rule Amendments to *Minnesota Rule* 7001, Governing Issuance of Section 401 Water Quality Certifications

NOTICE IS HEREBY GIVEN that the Minnesota Pollution Control Agency (MPCA) is withdrawing proposed rulemaking governing the issuance of Section 401 Water Quality Certifications (Minnesota Rule 7001). A Notice to Solicit Outside Information and Opinion was published for this rule in the State Register on October 18, 1993 (CITE 18 S.R. 1129). The intent of this rulemaking was to clarify the process and means of determination for issuing Section 401 Water Quality Certifications on federal discharge permits affecting waters of the state. Minnesota Statutes § 14.05, subd. 3, gives state agencies general authority to withdraw proposed rules.

From the comment period provided in the October 18, 1993 notice and other rulemaking activity, the MPCA determined that the 401 water quality certification process and requirements would best be clarified through informative public guidance documents, rather than through state agency rulemaking. In withdrawing this rulemaking, the MPCA will continue to review and issue 401 certifications under existing rule.

The authority to issue revenue notices is found in *Minnesota Statutes* §270.0604.

Revenue Notice #96-03: Insurance Premium Tax - Bail Bonds

Bail bonds issued by an insurance company are a form of surety bond subject to the insurance premiums tax set forth in *Minnesota Statutes*, § 60A.15 subd. 1. The entire premium, including amounts retained as fees by an agent, is subject to taxation.

Notice of Public Hearing on the Issuance of an Agricultural Development Revenue Bond Under *Minnesota Statutes*, Chapter 41C

NOTICE IS HEREBY GIVEN that a public hearing will be held on April 24 1996, at 9 A.M. in Room 145 Department of Agriculture Building, 90 West Plato Boulevard, Saint Paul Minnesota, on a proposal that the Minnesota Rural Finance Authority (the Authority) issue its revenue bond under Minnesota Statutes, Chapter 41C, in order to finance the purchase of approximately 160 acres with buildings located in Section 23, T103N, R43W, Nobles County, Minnesota on behalf of Bruce & Kate McCann, a married couple (the Borrowers). The maximum aggregate face amount of the proposed bond issue is \$145,000.00. The revenue bond will be a limited obligation of the Authority, payable solely from the revenue pledged to the payment thereof. No holder of such revenue bond will ever have the right to compel any exercise of the taxing power of the State of Minnesota to pay the bond or the interest thereon, nor to enforce payment against any property of the Authority or the State of Minnesota, except the revenues specifically pledged to the payment thereof. Before issuing the revenue bond, the Authority will enter into an agreement with the Borrower whereby the Borrower will be obligated to make payments at least sufficient at all times to pay the principal of an interest on such revenue bond when due. All persons interested may appear and be heard at the time and place set forth above, or may file written comments with the Executive Director of the Authority prior to the date of the hearing set forth above.


