Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1995 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Adopted Rules

A rule becomes effective after the requirements of *Minnesota Statutes* §§ 14.05-14.28 have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule.

If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed.

If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

Exempt Rules

An exempt rule adopted under Minnesota Statutes §§ 14.386 or 14.388 is effective upon its publication in the State Register.

Emergency Expedited Rules

Provisions for the Commissioner of Natural Resources to adopt emergency expedited Game and Fish Rules are specified in *Minnesota Statutes* §§ 84.027. The commissioner may adopt emergency expedited rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Emergency expedited rules are effective upon publication in the *State Register*, and may be effective up to seven days before publication under certain emergency conditions. Emergency expedited rules are effective for the period stated or up to 18 months.

Department of Health

Adopted Permanent Rules Relating to Alcohol and Drug Counselor Licensing

The rules proposed and published at *State Register*, Volume 22, Number 10, pages 376-396, September 8, 1997 (22 SR 376), are adopted with the following modifications:

4747.0030 DEFINITIONS.

- Subp. 26. **Qualified interpreter.** "Qualified interpreter" means a <u>neutral</u> person who is readily able to communicate, verbally and simultaneously, facilitate communication between two languages and accurately translate spoken and, written, or <u>sign</u> language <u>communication</u> between a client and a licensee.
- Subp. 27. **Sign language.** "Sign language" means <u>American Sign Language or</u> any form of manual communication used to communicate with persons who are deaf or, hard-of-hearing, or <u>deaf-blind</u>.

4747.1100 CONTINUING EDUCATION REQUIREMENTS.

- Subp. 2. Continuing education requirements for licensee's first four years. Licensees must, as part of meeting the clock hour requirement of this part, obtain and document the following clock hours within the first four years after their initial license effective date according to the commissioner's reporting schedule. Alcohol and drug counselor training obtained up to three years prior to the effective date of this chapter which meets the requirements of this subpart must be considered as having met the requirements of this part. Alcohol and drug counselor classroom education obtained any time prior to the effective date of this chapter which meets the requirements of this subpart must be considered as having met the requirements of this part.
 - A. Twelve Six clock hours in Native American issues, including gaining knowledge of:
 - B. Twelve Six clock hours in Asian American issues, including gaining knowledge of:
 - D. Twelve Six clock hours in Chicano/Latino issues, including gaining knowledge of:
 - E. Twelve Six clock hours in disability issues, including gaining knowledge of:
 - F. Twelve Six clock hours in African American issues, including gaining knowledge of:
- G. If the licensee practices alcohol and drug counseling with deaf, deaf-blind, hard-of-hearing, or late-deafened clients, then the licensee must obtain an additional six hours in the areas described in item A, subitem (3), within the four-year period.

Adopted Rules

- Subp. 3. Continuing education requirements after licensee's initial four years. Beginning four years following a licensee's initial license effective date and according to the commissioner's reporting schedule, a licensee must document completion of the following requirements each continuing education reporting period as part of the 40 clock hour requirement under this part. Clock hours obtained under items A to F must comply with the requirements of subpart 2:
 - A. three clock hours in deaf and hard of hearing issues;
 - B. three clock hours in African American issues:
 - C. three clock hours in Asian American issues;
 - D. three clock hours in Chicano/Latino issues;
 - E. three clock hours in disability issues;
 - F. three clock hours in Native American issues; and
- G. a minimum of six clock hours each reporting period in one or more of the areas described in subpart 2. Licensees must also document completion of six clock hours in courses directly related to the rules of professional conduct in part 4747.1400.
 - Subp. 9. Competency in practice with ethnic minority, disabled, and identified population group clients.
- A. A licensee meets the standards in part 4747.1100, subpart 2, when practicing alcohol and drug counseling with a client who is a member of an ethnic minority group, an identified population group, or a client with a disability by acting according to this subpart. If a licensee is inexperienced as compared to other licensees or the professional community's standard of care in practicing alcohol and drug counseling with ethnic minority, identified population, or disabled clients, the licensee:
 - C. Licensees who practice alcohol and drug counseling with deaf, deaf-blind, hard-of-hearing, or late-deafened clients:
- (1) are proficient in American Sign Language at the advanced-plus level or higher of the Sign Communication Proficiency Interview (SCPI) ratings, if the client's primary or preferred language is American Sign Language; or
- (2) are trained in working with and work with an American Sign Language interpreter who qualifies as both a certified interpreter and a certified transliterator by the Registry of Interpreters for the Deaf or certified at level three four or higher by the National Association of the Deaf; or

Proposed Rules

Comments on Planned Rules or Rule Amendments

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, and within 60 days of the effective date of any new statutory grant of required rulemaking.

Rules to be Adopted After a Hearing

After receiving comments and deciding to hold a public hearing on the rule, an agency drafts its rule. It then publishes its rules with a notice of hearing. All persons wishing to make a statement must register at the hearing. Anyone who wishes to submit written comments may do so at the hearing, or within five working days of the close of the hearing. Administrative law judges may, during the hearing, extend the period for receiving comments up to 20 calendar days. For five business days after the submission period the agency and interested persons may respond to any new information submitted during the written submission period and the record then is closed. The administrative law judge prepares a report within 30 days, stating findings of fact, conclusions and recommendations. After receiving the report, the agency decides whether to adopt, withdraw or modify the proposed rule based on consideration of the comments made during the rule hearing procedure and the report of the administrative law judge. The agency must wait five days after receiving the report before taking any action.

Rules to be Adopted Without a Hearing

Pursuant to *Minnesota Statutes* § 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing. An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public. The agency then publishes a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the *State Register*. If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.14-14.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the *State Register*.

Notice of Continuation of Hearing on the Minnesota Energy Code

Proposed Amendment to *Minnesota Rules*, chapter 7670, and Adoption of New *Minnesota Rules*, Chapters 7672, 7674, 7676, and 7678, in Combination Known as the Minnesota Energy Code.

Continuation of Public Hearing. The Department of Public Service has scheduled the continuation of the December 19, 1997 public hearing on the aforementioned matter. The public hearing will reconvene at Conference room #1 of the Minnesota Department of Agriculture, 90 West Plato Boulevard, St. Paul (one block West of Wabasha Street, across the river from downtown St. Paul), starting at 9 a.m. on Tuesday, January 27, 1998. Additional days of hearing will be scheduled if necessary. All interested or affected persons will have an opportunity to participate by submitting either oral or written data, statements, or arguments. Statements may be submitted without appearing at the hearing. You may present your views either orally at the hearing or in writing at any time before the close of the hearing record. The agency requests that any person submitting written views or data to the Administrative Law Judge prior to the hearing or during the comment period also submit a copy of the written views or data to the agency contact person at the address stated below. Persons planning to attend the January 27 public hearing may wish to contact the Department of Public Service as indicated below with any questions regarding the hearing's timing or location.

Administrative Law Judge. The hearing will be conducted by Administrative Law Judge Richard C. Luis, who can be reached at the Office of Administrative Hearings, 100 Washington Square, Suite 1700, Minneapolis, Minnesota 55401-2138, telephone 612-341-7600, and FAX 612-349-2665. The rule hearing procedure is governed by *Minnesota Statutes*, Sections 14.131 to 14.20, and by the rules of the Office of Administrative Hearings, *Minnesota Rules*, Parts 1400.2000 to 1400.2240. Questions concerning the rule hearing procedure should be directed to the Administrative Law Judge.

Subject of Rules. The Minnesota Board of Animal Health requests comments on its planned amendment to rules governing pseudorabies. The Board is considering rule amendments that:

- (1) make provisions to allow movement of pigs through nursery facilities and subsequently to remote finishing sites,
- (2) amend requirements for testing in qualified negative swine herds to allow for use of official random sample testing,
- (3) amend requirements for release of quarantine by official random sample to eliminate inconsistencies between eradication stages,
- (4) repeal obsolete language regarding qualified negative gene-altered vaccinated herds,
- (5) clarify requirements for movement of swine from Stage IV and V areas.

Persons Affected. The amendment to the rules would likely affect Minnesota swine producers and the veterinarians who provide health care service to them.

Statutory Authority. *Minnesota Statutes*, section 35.03 and 35.255, authorizes the Board to adopt rules to protect the health of domestic animals and control pseudorabies in swine.
