

# Minnesota Rules: Amendments and Additions =

#### NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. # **Proposed Rules**

#### **Comments on Planned Rules or Rule Amendments**

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, and within 60 days of the effective date of any new statutory grant of required rulemaking.

#### Rules to be Adopted After a Hearing

After receiving comments and deciding to hold a public hearing on the rule, an agency drafts its rule. It then publishes its rules with a notice of hearing. All persons wishing to make a statement must register at the hearing. Anyone who wishes to submit written comments may do so at the hearing, or within five working days of the close of the hearing. Administrative law judges may, during the hearing, extend the period for receiving comments up to 20 calendar days. For five business days after the submission period the agency and interested persons may respond to any new information submitted during the written submission period and the record then is closed. The administrative law judge prepares a report within 30 days, stating findings of fact, conclusions and recommendations. After receiving the report, the agency decides whether to adopt, withdraw or modify the proposed rule based on consideration of the comments made during the rule hearing procedure and the report of the administrative law judge. The agency must wait five days after receiving the report before taking any action.

#### Rules to be Adopted Without a Hearing

Pursuant to *Minnesota Statutes* § 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing. An agency must first solicit **Comments on Planned Rules or Comments** on **Planned Rule Amendments** from the public. The agency then publishes a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the *State Register*. If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.14-14.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the *State Register*.

Proposed Rules Governing Deed Tax; Definitions; Determination of Tax; *Minnesota Rules,* parts 8123.0100 and 8123.0200

**Introduction.** The Department of Revenue intends to adopt rules without a public hearing following the procedures set forth in the Administrative Procedure Act, *Minnesota Statutes*, sections 14.22 to 14.28, and rules of the Office of Administrative Hearings, *Minnesota Rules*, parts 1400.2300 to 1400.2310. If, however, 25 or more persons submit a written request for a hearing on the rules within 30 days or by 4:30 p.m. on Wednesday, October 18, 2000, a public hearing will be held at the Minnesota Department of Revenue, Skjegstad Room, 2nd Floor, 600 North Robert Street, St. Paul, Minnesota 55146, starting at 9:30 a.m. on Wednesday, November 8, 2000. To find out whether the rules will be adopted without a hearing or if the hearing will be held, you should contact the agency contact person after October 18, 2000 and before November 8, 2000.

**Subject of Rules and Statutory Authority.** The proposed rules govern the deed tax, an excise tax imposed on the grantor when a taxable deed or deed-like document is presented to a county recorder or registrar for recording or registering. The amount of tax due with regard to a particular taxable deed is generally determined from the amount of consideration, as provided in *Minnesota Statutes*, section 287.21, subd. 1. The proposed rules specifically define the phrases "engaged in the business of land sales or construction of buildings and other improvements," and "affiliated person," as those phrases are used in *Minnesota Statutes*, section 287.20, sub. 2 (d). These definitions will inform taxpayers whether they are liable for deed tax on the consideration for improvements added to real estate during the term of a contract for deed.

The statutory authority to adopt the rules is Minnesota Statutes, section 270.06, clause (14), which provides that the

Commissioner of Revenue shall make, publish, and distribute rules for the administration and enforcement of state tax laws. Under these two statutes, the Department has the necessary authority to adopt the proposed rules.

**Comments.** You have until 4:30 p.m. on October 18, 2000, to submit written comment in support of or in opposition to the proposed rules or any part or subpart of the rules. Your comment must be in writing and received by the agency contact person by the due date. Comment is encouraged. Your comments should identify the portion of the proposed rules addressed, the reason for the comment, and any change proposed. You are encouraged to propose any change desired. Any comments that you would like to make on the legality of the proposed rules must also be made during this comment period.

**Request for a Hearing.** In addition to submitting comments, you may also request that a hearing be held on the rules. **Alternative Format/Accommodation.** Upon request, this Notice can be made available in an alternative format, such as large print, Braille, or cassette tape. **Modifications.** The proposed rules may be modified, either as a result of public comment or as a result of the rule hearing process. You may also submit written material to the Administrative Law Judge to be recorded in the hearing record for five working days after the public hearing ends. This five-day comment period may be extended for a longer period not to exceed 20 calendar days if ordered by the Administrative Law Judge at the hearing. Following the comment period, there is a five-working-day response period during which the agency and any interested person may respond in writing to any new information submitted. No additional evidence may be submitted during the five-day response period. All comments and responses submitted to the Administrative Law Judge must be received at the Office of Administrative Hearings no later than 4:30 p.m. on the due date. All comments or responses received will be available for review at the Office of Administrative Hearings. Administrative Law Judge.

# CHAPTER 8123 DEPARTMENT OF REVENUE DEED TAX

#### 8123.0100 SCOPE; DEFINITIONS.

- Subpart 1. Scope. Parts 8123.0100 and 8123.0200 are applicable only to deed tax. As used in parts 8123.0100 and 8123.0200, the following words, terms, and phrases have the meanings given them in this part.
  - Subp. 2. Affiliated person. "Affiliated person" means either a related party, a legal representative, or a controlled group.
- A. "Related party" means a person in one of the following relationships to a person engaged in the business of land sales or to a person engaged in the business of construction of buildings and other improvements: a spouse, child, parent, or sibling; or spouse of a child, parent, or sibling.
- B. "Legal representative" means a person who is empowered to act for a person engaged in the business of land sales or for a person engaged in the business of construction of buildings or other improvements. A legal representative includes, but is not limited to:
  - (1) an agent, officer, or partner;
  - (2) a trustee of a trust;
  - (3) a personal representative or an administrator of an estate;
  - (4) a trustee in bankruptcy; and
  - (5) a receiver, guardian, custodian, or conservator of a person or an estate.
- C. "Controlled group" means any type of business entity of which more than 50 percent in value of the outstanding stock, capital interest, or general partnership interest, is owned, directly or indirectly, by a person engaged in the business of land sales or by a person engaged in the business of construction of buildings and other improvements.

- <u>Subp. 3.</u> Engaged in the business of construction of buildings and other improvements. "Engaged in the business of construction of buildings and other improvements" means a person in the business of building or improving real property or of contracting or offering to contract with an owner of real property to build on or improve the real property; including a person licensed as a residential building contractor or a residential remodeler under *Minnesota Statutes*, chapter 326.
- <u>Subp. 4.</u> Engaged in the business of land sales. "Engaged in the business of land sales" means a person who sells, conveys, or exchanges real property in the ordinary course of a trade or business; or, a person who sells, conveys, or exchanges more than three real property parcels or lots within any five-year period.
  - Subp. 5. **Person.** "Person" has the meaning given in *Minnesota Statutes*, chapter 287, for the deed tax.

#### 8123.0200 DETERMINATION OF TAX.

- Subpart 1. In general. Generally, when a deed is issued upon fulfillment of a contract for deed, the deed tax is computed based on the price for the real property as reflected in the contract. This part sets forth the situations where the deed tax must be based on the price reflected in the contract plus the consideration for any improvements added to the real property after the contract for deed is entered into and before the deed required by the contract is issued. These situations occur when the conveyance is made by:
  - A. a person engaged in the business of land sales and the conveyance is a part of that business;
- B. a person engaged in the business of constructing buildings or other improvements to real property, and the conveyance is a part of that business; or
- C. an affiliated person as defined in part 8123.0100, subpart 2, and the conveyance is a part of the land sales or construction business.
- <u>Subp. 2.</u> Conveyance as part of a land sales or construction business. The commissioner shall base the determination of whether or not a particular conveyance is part of a land sales or construction business on all of the relevant facts and circumstances.
  - Subp. 3. Examples. The following examples are illustrative of the application of parts 8123.0100 and 8123.0200.
- A. A, who is in the business of land sales, sells an undeveloped lot by contract for deed to stranger B as part of that business. Stranger B acts as his own general contractor to have a home built on the lot. Upon payment of the contract balance, A conveys the lot by a deed to stranger B. The deed tax is computed based upon the price for the real property reflected in the contract for deed plus the consideration for the improvements added by B.
- B. A, who is in the business of construction of buildings and other improvements, sells an undeveloped lot by contract for deed to stranger B as part of that business. B acts as his own general contractor to have a home built on the lot. Upon payment of the contract balance, A conveys the lot by a deed to B. The deed tax is computed based upon the price for the real property reflected in the contract for deed plus the consideration for the improvements added by B.
- C. A, whose spouse is in the business of land sales, sells an undeveloped lot by contract for deed to stranger B as part of that business. Stranger B acts as her own general contractor and builds a home on the lot. Upon payment of the contract balance, A conveys the lot by a deed to B. The deed tax is computed based upon the price for the real property reflected in the contract for deed plus the consideration for the improvements added by B.
- D. A, a limited liability company, LLC, owned entirely by B, who is in the business of construction of buildings and other improvements, sells an undeveloped lot by contract for deed to stranger C as a part of the home construction business operated by B. Pursuant to the sales agreement, B acts as a general contractor and builds a home on the lot for C. Upon payment of the contract balance, A conveys the lot that now has a house on it by a deed to stranger C. The deed tax is computed based upon the price for the real property reflected in the contract for deed plus the consideration for the improvements added by B.



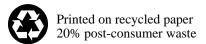
