

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. 

Adopted Rules

A rule becomes effective after the requirements of *Minnesota Statutes* §§14.05-14.28 have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule.

If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed.

If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

Exempt Rules

An exempt rule adopted under Minnesota Statutes §§ 14.386 or 14.388 is effective upon its publication in the State Register.

Emergency Expedited Rules

Provisions for the Commissioner of Natural Resources to adopt emergency expedited Game and Fish Rules are specified in *Minnesota Statutes* §§ 84.027. The commissioner may adopt emergency expedited rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Emergency expedited rules are effective upon publication in the *State Register*, and may be effective up to seven days before publication under certain emergency conditions. Emergency expedited rules are effective for the period stated or up to 18 months.

Department of Agriculture

Adopted Permanent Rules Relating to Cheese and Cheese Products

The rules proposed and published at *State Register*, Volume 25, Number 26, pages 1169-1171, December 26, 2000 (25 SR 1169), are adopted as proposed.

Commissioners' Orders

Various agency commissioners are authorized to issue "commissioner's orders" on specified activities governed by their agency's enabling laws. See the *Minnesota Statutes* governing each agency to determine the specific applicable statutes. Commissioners' orders are approved by assistant attorneys general as to form and execution and published in the *State Register*. These commissioners' orders are compiled in the year-end subject matter index for each volume of the *State Register*.

Minnesota Pollution Control Agency

Findings of Fact, Conclusions, and Order In the Matter of the Petition to Create the Knife River-Larsmont Sanitary District

The Lake County Board of Commissioners filed a petition with the Minnesota Pollution Control Agency (MPCA) requesting the formation of the Knife River-Larsmont Sanitary District. The Lake County Board Chair was authorized to sign the petition pursuant to a resolution passed by the County Board.

The MPCA published notification of the intent to approve the creation of the Knife River-Larsmont Sanitary District in the *State Register* on July 24, 2000. The MPCA also notified all property owners in the affected area by mail of the notification published in the *State Register*.

The MPCA, after having considered the petition, publishing notice of intent to approve creation of the sanitary district in the *State Register*, having notified the property owners of the intent to create the sanitary district, having reviewed the comment letters received during the notice period, having not received twenty-five (25) or more hearing requests requisite for a hearing, having contact with those who did request a hearing, and being fully advised in this matter, hereby makes the following:

FINDINGS OF FACT

1. The Larsmont unorganized territory and the Knife River Sanitary District are located within Lake County, Minnesota. The proposed sanitary district includes both the Larsmont and Knife River areas. The territory of the proposed sanitary district is

- the strip of land bounded on the west by the Lake County line, spanning up the shore of Lake Superior some 8.5 miles to the city limits of Two Harbors, and encompassing the area from Minnesota State Highway 61 to the shoreline of Lake Superior.
- 2. The territory of the proposed sanitary district is within that portion of Lake County, Minnesota, lying in Township 52 North, Range 11 West of the Fourth Principal Meridian. The territory of the proposed sanitary district is legally described as: that part of Sections 31, 30, 29, 20, 21, 16, 15, and 10 lying between the Southeasterly right of way of Minnesota State Highway 61 and the Lake Superior shoreline; and that part of the Westerly One-half (W 1/2) of Sections 11 and 2 lying between the Southeasterly right of way of Minnesota State Highway 61 and the Lake Superior shoreline; and that part of the Easterly One-Half (E1/2) of Section 2 lying between the Southeasterly right of way of Minnesota State Highway 61 and the Northwesterly right of way of Lake County Highway 61.

- 3. On March 1, 2000, a public meeting was held at the Lake County Courthouse to consider the proposed creation of a sanitary district. Notification of the public meeting was published February 11, 2000, and February 18, 2000, in the *Lake County News Chronicle*, a qualified newspaper published in the area. Notices of the public meeting were published by Lake County and posted at five public locations on February 11, 2000. Attendees of the meeting were given information on the proposed creation of the sanitary district, including a description of the sanitary district's proposed structure, bylaws, territory, ordinances, budget and charges.
- 4. On March 7, 2000, the Lake County Board of Commissioners adopted a resolution authorizing Derrick Goutermont, Vice Chair of the Lake County Board of Commissioners to petition the MPCA for establishment of the Knife River-Larsmont Sanitary District. The resolution was published in the *Lake County News Chronicle* on March 10, 2000, and became effective forty (40) days after the date of publication.
- 5. On May 2, 2000, a petition was filed with the MPCA requesting approval of the formation of the Knife River-Larsmont Sanitary District. Clair Nelson, Chair of the Lake County Board of Commissioners, signed the petition for creation of the sanitary district as authorized by the resolution. The petition requesting approval for formation of the sanitary district has met all the requirements of *Minnesota Statute* §115.20, subd. 1(a).
- 6. The proposed sanitary district will be within twenty-five (25) miles of the boundary of the city of Duluth, which is a city of the first class. On February 29, 2000, the Duluth City Council adopted a resolution supporting creation of the sanitary district.
- 7. On July 24, 2000, the MPCA published the Notice of Intent to Approve Creation of the Knife River-Larsmont Sanitary District in the *State Register* at 25 SR 122 and mailed the notice to each of the property owners in the area of the proposed sanitary district using addresses provided by the county auditors. The public notice period lasted for thirty (30) days and ended August 24, 2000.
- 8. By August 24, 2000, the end of the public notice period, the MPCA had received one (1) letter requesting a public hearing on the matter. *Minnesota Statute* §115.20, subd. 4(b) requires the MPCA to hold a contested case hearing if twenty-five (25) or more written requests are received by the end of the public notice period. In addition to one (1) hearing request, the MPCA received two (2) letters expressing opposition to the district, and ten (10) telephone calls concerning the proposed creation of the sanitary district.
- 9. Currently, all homes and businesses located within the Larsmont area (within the proposed sanitary district boundaries) utilize a form of on-site wastewater treatment system. Many of these systems are failing, creating environmental and public health hazards. Homes and businesses within the Knife River area utilize a mechanical wastewater treatment facility that is approaching its 20-year design life and periodically experiences equipment failure.
- 10. There is a need throughout the proposed sanitary district for an adequate and efficient means of treating and disposing of domestic sewage. The tight clay soils and proximity to bedrock in the area limit the potential effectiveness of individual on-site wastewater treatment systems. Poorly functioning on-site systems may provide little or no treatment of domestic wastewater and may cause degradation of the ground water and the water resources in the area. Of primary concern, with poorly functioning on-site systems, is the potential for contamination of drinking water wells.
- 11. The creation and maintenance of the sanitary district will be administratively feasible, and will further the public health, safety and welfare. The sanitary district will be administered by a five member governing board who are voters within the sanitary district and who will be selected by the Lake County Board of Commissioners. When formed, the Knife River-Larsmont Sanitary District will adopt sewer use ordinances and a sewer service charge system to adequately and equitably fund the wastewater treatment operation throughout the sanitary district. The record contains a proposed ordinance establishing sewer use regulations and proposed by-laws of the sanitary district.

CONCLUSIONS

- 1. The Commissioner has subject matter jurisdiction over the petition and proposed establishment of the sanitary district pursuant to *Minnesota Statute* §§ 115.18 to 115.37 (1998).
- 2. The petitioners have complied with all the procedural requirements of *Minnesota Statute* §115.20 (1998), as well as other substantive and procedural requirements of law and rule. This matter is, therefore properly before the Commissioner.
- 3. The conditions described in *Minnesota Statute* §115.19 (1998) for the creation of a sanitary district do exist within the area identified in the legal description.
- 4. Any of the foregoing Findings of Fact that might properly be termed Conclusions and Conclusions that might properly be termed Findings are hereby adopted as such.

NOW THEREFORE, the Commissioner hereby makes the following:

ORDER

It is **ORDERED** that the Knife River-Larsmont Sanitary District is hereby created to include the Knife River and Larsmont areas as described in the legal description attached to the petition filed with the MPCA.

Description of Grant:

Effective with this current grant cycle, the Minnesota Department of Health (MDH) plans to move the Maternal and Child Health Special Projects (MCHSP) onto a four-year grant cycle consistent with that of the Community Health Services (CHS) Subsidy, calendar years 2000-2003. For continuation funding of the years 2002-2003, all that would be needed of Community Health Boards is a completion of forms for calendar years 2002 and 2003 and a description of any substantive program changes. The following four-year grant cycle, calendar years 2004-2007, will be consistent with the CHS subsidy application cycle.

The following description is based upon existing state law which may be revised during the current legislative session. Updated information will be provided to Community Health Boards as changes are proposed and enacted.

Eligibility is limited to community health boards as defined in *Minnesota Statute* 145A.01, subdivision 5. Other public and private providers **may not** apply directly to the department for funding through this category.

MCHSP funds provide core funding for support of local public health infrastructure focused on the improved health of mothers, children, and their families. The program also targets funds to serve high-risk and low-income persons and in statewide priorities:

1) Improved Pregnancy Outcome Program, 2) Family Planning Program, 3) Handicapped/Chronically Ill Children's Program, and 4) Childhood Injury Control Program.* State law also requires that maternal and child health projects established prior to the statewide formula MCHSP program be continued. The affected Community Health Boards, (North Country, Carlton-Cook-St. Louis, Minneapolis, St. Paul and Goodhue-Wabasha) are required as part of their formula MCHSP grant programs to maintain the same kinds of services to the same populations as previously served unless they can provide equivalent alternative funding or demonstrate that the need for the specific services provided by the project has significantly decreased.**

The level of funding available for the MCH Special Projects for the two-year period, calendar years 2002-2003, is yet to be determined through congressional and legislative actions. For calendar years 2000-2001, a total of \$14,840,000 was available. As soon as appropriation amounts can be determined, a table of agency-specific allocations will be distributed.***

Proposed Changes:

- * A proposed change would allow funding to be used for other child and adolescent health problems in addition to childhood injury.
- ** A proposed change would make continuation of these projects a discretionary matter for the affected Community Health Boards.
- *** A proposed change would set a minimum funding level for all community health boards at 95 percent of their calendar years 1998-1999 awards.

The WIC Program is a state and federally funded grant program administered through the Minnesota Department of Health; grants are made available to qualified local agencies to deliver program services. WIC provides nutrition education services and vouchers for the purchase of specified nutritious food supplements to pregnant, postpartum, and nursing women, and to infants and children up to five years of age who are judged by health professionals to be at nutritional risk and who have family incomes at or below 185 percent of poverty income guidelines prescribed by the United States Department of Agriculture or who qualify for Medical Assistance (MA) or other specified programs. The WIC Program serves as an adjunct to good health care during critical times of growth and development, in order to prevent the occurrence of health problems and to improve the health status of those persons. All current WIC agreements will terminate on 09/30/2001.

The types of local agencies which may apply for the WIC Grant are listed as follows in order of their priority for application approval:

- First priority is given to a Community Health Board.
- Second priority is given to a public or private non-profit health service agency.
- Third priority is given to a public human service agency.
- Fourth priority is given to a private non-profit human service agency.

An agency will be classified as either a health service agency or a human service agency, based on the type of services it primarily provides during its current fiscal year. The priority system applies to agencies that are applying for the first time, that have applied before, and that have previously administered the WIC Program.

Only one application will be approved for each geographic area or special population. If two or more competing applicants have the same priority a subpriority will be assigned as follows:

- First subpriority will be given to an agency whose employees can provide ongoing routine pediatric and obstetric care, and administrative services.
- Second subpriority will be given to an agency that must enter into a written agreement with another agency for either ongoing, routine pediatric and obstetric care, or administrative services.
- Third subpriority will be given to an agency that must enter into a written agreement with private physicians to provide ongoing, routine pediatric and obstetric care for women, infants, or children, or for participants not eligible for health services at the agency.
- Fourth subpriority will be given to an agency that must enter into a written agreement with private physicians to provide ongoing, routine pediatric and obstetric care for all participants.
- Fifth subpriority will be given to an agency that must provide ongoing routine pediatric and obstetric care through referral to a health care provider.

If additional information or revisions are needed to the application after it is submitted, a request shall be made within 15 days of receipt. A revised application must be received within 15 days of the date of the request.

Proposed Legislative Initiatives which are Contingent upon State Legislature or Federal Agency Approval

The Governor's 2002-2003 budget includes grant funding for the following activities. Please note that if funding becomes available in these areas, the Minnesota Department of Health (MDH) will send out more information this summer.

Health Disparities:

- \$5,000,000 for competitive grants to public, private non-profits and Indian tribal governments for effective prevention strategies to reduce health disparities in one or more of the following areas: infant mortality, breast and cervical cancer screening, HIV/AIDS/STD prevention, immunizations, cardiovascular disease prevention, diabetes, and injury and violence prevention.
- \$4,450,000 for non-competitive grants to Community Health Boards to provide services targeted at reducing maternal and child health disparities.
- \$1,000,000 for non-competitive grants to Indian tribal governments for community interventions to reduce health disparities among American Indians.
- \$450,000 for non-competitive grants to Community Health Boards to improve access to health screening and follow-up services to foreign born populations.

Immunizations:

 \$3,000,000 for non-competitive grants to all Community Health Boards to support the development and maintenance of a statewide immunization information service.

Suicide Prevention:

• \$1,650,000 for competitive grants to public, private non-profits and Indian tribal governments for community-based planning and evidence-based suicide prevention strategies targeting high risk populations.

Teen Pregnancy Prevention:

- \$4,800,000 for competitive grants to public, private non-profits and Indian tribal governments to focus on reducing disparities in teen pregnancy rates between whites, American Indians, and populations of color.
- \$2,800,000 for non-competitive grants to Community Health Boards or Indian tribal governments whose communities have
 the greatest risks for teen pregnancy. Grants will be awarded to enhance or expand existing culturally appropriate youth programs.
- \$4,000,000 for non-competitive grants to Community Health Boards.
- \$1,000,000 for non-competitive grants to Indian tribal governments.
- \$2,800,000 for competitive grants for the implementation of statewide media campaigns that are culturally appropriate and designed with a focus on using positive approaches to prevent teen pregnancy.

Health Workforce Development:

\$891,000 for competitive community/regional grants to respond to health care worker shortages. Communities and regions
that receive grants will be expected to employ strategies to attract and retain members of minority communities in the health
workforce.

The MDH's federal application for a Community-Based Abstinence Education Grant Program:

MDH has submitted a federal application for a new source of funds to support community-based abstinence education
efforts. If the federal application is approved, the MDH will issue a new solicitation for local projects.

Procedures and Information for Applying for Grants

STEP 1: Applicants Must Provide Notice of Intent to Apply for Funds

Any organization interested in applying for funds should complete the "Notice of Intent to Apply for 2002-2003 Grant Funds Checklist." The Checklist is included in this publication.

The "Notice of Intent to Apply for 2002-2003 Grant Funds Checklist" must be received by the Department of Health no later than 4:30 p.m., Friday, April 20, 2001. If an organization receives the "2002-2003 Available Grant Funds Notice" after this date, contact the Minnesota Department of Health staff person identified for each grant for current information on the application process.

The Minnesota Department of Health and local Community Health Boards carry out Minnesota's public health activities in partnership. Agencies that are not Community Health Boards must submit a copy of the "Notice of Intent to Apply for 2002-2003 Grant Funds Checklist" to the community health board in their geographical service area. A list of Community Health Boards is attached.

NOTE:

If interested parties intend to submit a proposal that the Department of Health judges is of statewide significance, the department will provide one copy of the "Notice of the Intent to Apply for 2002-2003 Grant Funds Checklist" to each community health board in the state. Any Community Health Board may subsequently request one copy of the completed application from the applicant for review and comment.

STEP 2: The Department Will Provide Application Materials

The department will provide an organization, which has expressed intent to apply for funds, with pertinent application materials, information on the review and award process, and technical assistance information as it becomes available.

STEP 3: Submission of Completed Applications

Completed applications must be received by the Minnesota Department of Health office listed in the application materials you receive (Step 2 above) no later than 4:30 p.m. on the date identified for each grant. Agencies who are not Community Health Boards must also submit the completed application to the Community Health Board in the applicant's proposed geographic service area no later than the deadline of receipt of the application at the Minnesota Department of Health.

Applications not received by the deadline will be reviewed and considered for funding only after all other applications are reviewed and funded (in accordance with available funds).

STEP 4: Awarding of Funds

Applications will be reviewed as submitted except that, at its discretion, the department may request further clarification. Grants will be awarded in accordance with priority areas and criteria identified in the application materials. Applicant organizations will be notified in writing of the grant award decisions and contracts will be completed to begin according to the schedule for each grant.

Duration of Funding

Funding for the full award period of all grants will be dependent upon federal and state appropriations.



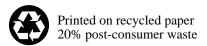
