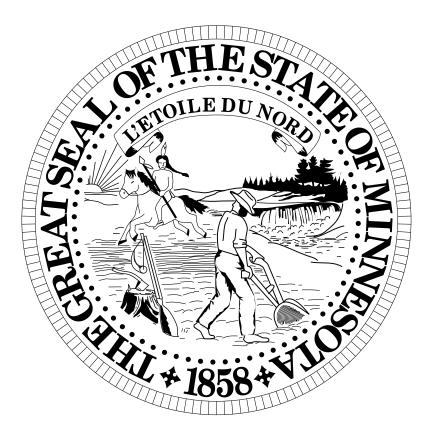

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Adopted Rules

A rule becomes effective after the requirements of *Minnesota Statutes* §§14.05-14.28 have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule.

If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed.

If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

Exempt Rules

An exempt rule adopted under Minnesota Statutes §§ 14.386 or 14.388 is effective upon its publication in the State Register.

Emergency Expedited Rules

Provisions for the Commissioner of Natural Resources to adopt emergency expedited Game and Fish Rules are specified in *Minnesota Statutes* §§ 84.027. The commissioner may adopt emergency expedited rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Emergency expedited rules are effective upon publication in the *State Register*, and may be effective up to seven days before publication under certain emergency conditions. Emergency expedited rules are effective for the period stated or up to 18 months.

Adopted Permanent Rules Relating to Competitive Local Telecommunications Providers

The rules proposed and published at *State Register*, Volume 25, Number 8, pages 546-554, August 21, 2000 (25 SR 546), are adopted with the following modifications:

7811.0700 GENERAL SERVICE QUALITY REQUIREMENTS.

Subp. 5. Service to CLECs. A LEC providing wholesale services to a CLEC shall notify the CLEC at least two days before implementing a change in service providers to an end user customer of the CLEC.

7811.2210 COMPETITIVE LOCAL EXCHANGE CARRIERS (CLECs).

- Subpart 1. General scope of regulation. Competitive local exchange carriers (CLECs) are regulated as provided in this part.
- A. The commission shall exercise its regulatory authority over the local services provided by CLECs only to the extent provided for in, or necessary to implement the requirements of, <u>all applicable statutes or</u> this chapter. Except as provided otherwise in this part or other commission rules, the commission shall exercise its authority over a CLEC's local services only upon complaint under subpart 17 and will not require prior approval of a CLEC's tariffs or service offerings.
- B. This part applies to a CLEC affiliate of an incumbent local exchange carrier (LEC) only with respect to its operations in geographic areas outside the service area of the affiliated LEC. A CLEC's local service operations inside the service area of its affiliated LEC must be regulated in the same manner as the LEC's local service operations, unless specified otherwise in *Minnesota Statutes*, chapter 237, specifies otherwise or the commission grants a variance in the public interest. For the purpose of this subpart, the definition of an "affiliated CLEC" or "affiliated LEC" follows the definition of an "affiliated company" in *Minnesota Statutes*, section 237.65, subdivision 1.
- Subp. 16. **Mergers and acquisitions.** In accordance with *Minnesota Statutes*, section 237.74, subdivision 12, before acquiring ownership or control of any provider of local service in Minnesota, either directly or indirectly, a CLEC must demonstrate to the commission that the present or future public convenience and necessity require or will require the acquisition. To make this determination, a CLEC must show that the merger is consistent with the public interest, based on such factors as the potential impact of the merger on consumers, competition, rates, and service quality.

7812.0700 GENERAL SERVICE QUALITY REQUIREMENTS.

Subp. 5. Service to CLECs. A LEC providing wholesale services to a CLEC shall notify the CLEC at least two days before implementing a change in service providers to an end user customer of the CLEC.

7812.2210 COMPETITIVE LOCAL EXCHANGE CARRIERS (CLECs).

To make this determination, a CLEC must show that the merger is consistent with the public interest, based on such factors as the potential impact of the merger on consumers, competition, rates, and service quality.

Correction to Dollar Amount Published April 16 in Request for Proposal for a Grant Contract Relating to a Culturally Competent Outreach and Leadership Training Program

The Governor's Council on Developmental Disabilities is pleased to announce that it is seeking proposals from culturally competent nonstate agencies or organizations to carry out an outreach and leadership training/leadership development program for parents of young children with developmental disabilities and adults with disabilities. The applicant agency or organization must have an established and credible community presence, understand the significance and effects of cultural diversity and disability, and commit to increasing the knowledge and leadership skills among families of children with developmental disabilities and adults with disabilities in the African American, Hispanic, or Native American community. Experience in leadership training, community organizing, and direct experience with racial and ethnic communities is also required.

Federal funds are available under provisions of the Developmental Disabilities Assistance and Bill of Rights Act of 2000 (P.L. 106-402). An award of up to \$45,000 will be made for a successful proposal for an outreach and training program in each of the three minority communities. The project period is for approximately one year beginning as soon as possible after July 1, 2001.

Applicants may submit a proposal for a culturally competent outreach and leadership training program in the African American community, the Hispanic community, or the Native American community, or any combination including all three. **PLEASE NOTE: a separate proposal is required for each program.**

The Health Technology Advisory Committee (HTAC) has recently completed the preliminary evaluation report, "MMR Vaccination and its Association to Autism".

Brief Summary of the Preliminary HTAC Report: MMR Vaccination and its Association to Autism.

Recently, there has been public interest in a theory that suggests the MMR vaccine, may be linked to autism. In 1998, one study reported an initial observation that linked autism and the MMR vaccine. The study from the United Kingdom consisted of 12 children with autism¹¹.

Conclusion

There is no scientific evidence that supports the hypothesis that the MMR vaccine, or any combination of vaccines, causes the development of autism. Both the CDC and the British Committee on Safety of Medicines found no association between the MMR vaccine and autism.

Brief Summary of the Preliminary HTAC Report: Intracoronary Brachytherapy.

In an attempt to reduce the rate of restenosis, researchers have pursued the use of local ionizing radiation that has significantly reduced neointimal proliferation in animal models. Presumably, the theoretical benefit of radiation resides in its killing effect of rapidly dividing smooth muscle cells and the inhibition of the recruitment and proliferation of adventitial myofibroblasts. Intracoronary radiotherapy involves treating coronary stenoses with a radioactive source from within the artery. Radiation, either gamma (γ) or beta (β) is delivered to the affected vessel via a radioactive stent or catheter-based system.

Conclusion

Catheter-based γ -brachytherapy in patients with de novo or non-stented restenotic lesions is not yet supported due absence of data from well-designed longitudinal randomized clinical studies and lack of sufficiently strong, long-term scientific data.

Catheter-based β -brachytherapy for the treatment of native coronary arteries to prevent restenosis in de novo lesions is an evolving technology that shows considerable promise; however, more scientific evidence needs to be published to support this technology as safe and efficacious in this patient population.

Brief Summary of the Preliminary HTAC Report: Cardiovascular Risk in Women.

About 9 million American women of all ages suffer from heart disease. Each year, a half million women suffer heart attacks and about 370,000 women die of heart diseases, making coronary heart disease (CHD) is the single leading cause of death and a significant cause of morbidity among American women.

Risk factors for CHD in women are well documented. The major risk factors for cardiovascular diseases amongst women include: cigarette smoking, high blood pressure, high blood cholesterol and diabetes.

Conclusion

Substantial data support aggressive risk factor management in the setting of secondary prevention. Women usually see their Ob/Gyn on a regular basis. Efforts must be made for women to receive basic CVD screening, such as cholesterol, homocysteine, diabetes, and blood pressure testing.

The Health Technology Advisory Committee (HTAC) is charged under *Minnesota Statutes* 62J.152 with conducting evaluations of specific technologies and their specific use and application. For the purposes of evaluation, the definition of technologies in statute includes "... drugs, devices, procedures, or processes applied to human health care" As part of the evaluation process, HTAC is required to submit a report to the Legislative Oversight Commission on Health Care Access and to solicit written comments on the report. Before completing its final comments and recommendations on the HTAC technology evaluation report, HTAC solicits public comment on the report.

The Health Technology Advisory Committee (HTAC) has recently completed the preliminary evaluation report, "Botulinum Toxin Treatment Of Neuromuscular Pain".

Brief Summary of the Preliminary HTAC Report: Botulinum Toxin Treatment Of Neuromuscular Pain.

Botulinum toxin (BTX) exerts its effect at the neuromuscular junction by inhibiting the release of acetylcholine thus causing flaccid paralysis. Botulinum toxin type A (BTX-A) causes chemical denervation by preventing synaptic transmission and effectively weakening the muscle.

BTX-A binds rapidly and with high affinity to the nerve, but its maximal paralytic effect peaks only 5 to 7 days after the injection. Very little toxin reaches the systemic circulation. Recovery occurs when new portions of the nerve, sprout and reinnervate the muscle. Recovery from BTX-A injections usually takes 6 to 9 months, and repeated treatments are often necessary to control abnormal muscle functioning. Treatment with BTX-A does not cause a return to normal muscle functioning since the underlying cause is still present. BTX-A treatment weakens specific muscles, allowing graded movements, unlike other pharmacological treatments that weaken all muscles.

Conclusion

BTX has been found to be safe and effective for a number of clinical conditions whereas the data regarding safety and efficacy are not firmly established for other indications. Listed are those indications where sufficient data exists to support the safety and efficacy of BTX:Tension headache; Cerebrovascular accident/stroke within 1 year of onset; Dynamic contractures in cerebral palsy patients; Cervical dystonia; Blepharospasm; Torticollis; Mixed cervical dystonia; Writer's cramp with significant wrist-joint deviation; and Dysphonia.

Listed are the indications for which the data has not yet firmly established the safety and efficacy of BTX: Cerebrovascular accident/stroke after 1 year of onset; Multiple sclerosis; "Off" painful dystonia in Parkinson's disease patients; Perinatal hypoxia; Progressive supranuclear palsy; Cortical basal degeneration; Focal dystonia; Extensor hallucis longus dystonia; and Fixed contractures in cerebral palsy patients


