Minnesota Rules: Amendments and Additions =

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Expedited Emergency Rules

Provisions exist for the Commissioners of some state agencies to adopt emergency expedited rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Emergency expedited rules are effective upon publication in the *State Register*, and may be effective up to seven days before publication under certain emergency conditions. Emergency expedited rules are effective for the period stated or up to 18 months. Specific *Minnesota Statutes* citations accompanying these emergency expedited rules detail the agency's rulemaking authority.

6232.2800 GENERAL REGULATIONS FOR TAKING BEARS.

Subpart 1. **Bag limit.** A person may not take more than one bear <u>in quota zones and two bears in no-quota zones</u> during any calendar year whether by firearm or archery. Bears taken may be of either sex or any age except that bear cubs may not be taken.

REQUEST FOR COMMENTS on Possible Amendment to Rules Governing Lead Hazard Reduction, Including Standards for Lead Content of Dust and Work and Training Standards for Persons Who Do Regulated Lead Work, *Minnesota Rules*, Parts 4761.1000 to 4761.1220

Subject of Rules. The Minnesota Department of Health requests comments on its possible amendment to rules governing lead hazard identification and reduction. The main focus of the amendments will be the standards for the lead content of dust on floor surfaces and window troughs and establishing training criteria for interim control workers and lead sampling technicians. The Department is considering amending the rules to:

- ensure they conform to the requirements of *Minnesota Statutes*, section 144.9501 to 144.9509, as amended through 2001;
- ensure they conform with federal regulations that were adopted since the current state rules were adopted; and
- make technical changes for clarification purposes.

Minnesota Statutes, section 144.9505, subdivision 1f, requires the Department to establish rules for training requirements and the registration of lead sampling technicians. *Minnesota Statutes*, section 144.9508, subdivision 4, requires the Department to establish the training content and length of the training course for the interim control worker. The Department will amend the rules to meet these requirements.

The Environmental Protection Agency (EPA) has lowered the lead content standard for dust on floor surfaces and window troughs. The Department will amend its dust standards to equal the EPA's dust standards for these surfaces.

The Department plans to amend the notification requirements for lead hazard identification as specified in *Minnesota Statutes*, section 144.9505, subdivision 4. The Department is also considering amending the notification requirements for lead hazard reduction and making changes to the lead hazard reduction methods for interior small and large areas, exterior painted surfaces, and soil. The Department is seeking public comment on all these proposed rule changes. The Department may consider additional changes based on public response to this Request for Comments.

Persons Affected. The amendment to the rules would likely affect local housing authorities; licensed lead workers, supervisors, inspectors, risk assessors and project designers; certified lead firms; lead training course providers; and those performing interim control work and lead sampling technician services.

Statutory Authority. Minnesota Statutes, section 144.9508, requires the Department to adopt rules that:

- establish procedures for lead hazard identification;
- establish lead abatement and lead hazard reduction methods;
- set standards for lead in paint, dust, bare soil, and drinking water; and
- establish criteria for the licensure, registration and training of the lead disciplines and the certification of lead contracting firms.

Public Comment. Interested persons or groups may submit written comments or information on the current or proposed rules until further notice is published in the *State Register* that the Department intends to adopt or to withdraw the amended rules. Depending on comments received, the Department will determine if it is necessary to hold public meetings to discuss the proposed rules and receive additional comments. The Department will also consider forming an advisory committee to discuss the rule changes more formally, if necessary. Please include with your comments whether you wish the Department to hold a public meeting, if you would be interested in being part of an advisory committee, or if you want to receive the minutes from any advisory committee meetings, if an advisory committee is formed.

Please note that comments received in response to this notice will not necessarily be included in the formal rulemaking record submitted to the administrative law judge. A formal comment period will be held once the department publishes a notice that it intends to adopt the rules.

After the conclusion of the sale, the Commissioner shall request each high bidder to provide evidence the bidder is qualified to hold state mineral leases pursuant to *Minnesota Rules*, part 6125.0410. The rules state that a lease will only be issued to an applicant qualified to do business in Minnesota and qualified to conduct exploratory borings in Minnesota. Loans to political subdivisions are available from the Minnesota Department of Natural Resources (DNR) to protect or improve streams, as authorized by *Minnesota Statutes*, section 103G.705. Loans may cover up to 90% of the cost of a project that will protect or improve a stream, and may be repaid over a period not to exceed ten years. Loans are interest free, but DNR may charge an administrative fee. DNR must apportion loans according to the potential for prevention of immediate harm to the stream, the relative need for maintenance or improvements, the date of the loan application, and the amount of funds available.

DNR will apply the following resource criteria in evaluating loan applications (number 1 is highest rated):

1) Projects to protect designated trout streams from the adverse effects of development. Examples include installation of stormwater systems that mitigate warm-water runoff, diversion of warm-water ditches, and development of infiltration areas.

2) Projects to improve designated trout streams. Examples include planting of cover to shade a stream, and restoring meanders to a straightened stream.

3) Projects to protect or improve the water quality of warm-water streams. Examples include routing of stormwater to treatment ponds, and establishment of buffer areas along stream banks.

4) Projects to prevent or repair stream bank erosion. An example is the use of bioengineering methods to stabilize eroded banks.

5) Projects that protect or improve streams in other ways.
