

### NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. ### **Adopted Rules**

A rule becomes effective after the requirements of *Minnesota Statutes* §§ 14.05-14.28 have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule.

If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed.

If an adopted rules differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

### **Adopted Permanent Rules Relating to Acupuncture Registration**

The rules proposed and published at *State Register*, Volume 28, Number 24, pages 775-777, December 15, 2003 (28 SR 775), are adopted as proposed.

### **Pollution Control Agency**

### Adopted Permanent Rules Relating to Technical Changes

The rules proposed and published at *State Register*, Volume 28, Number 26, pages 840-854, December 29, 2003 (28 SR 840), are adopted with the following modifications:

### 7019.3000 EMISSION INVENTORY.

Subp. 2. **Owner or operator error in reporting data.** If an owner or operator discovers an error in the data after having submitted it to the agency, the owner or operator shall submit corrected data, with a written explanation of the mistake and why it occurred. If the commissioner agrees that the correction is appropriate, the commissioner shall correct the data in the inventory. However, for purposes of assessing the emission fee under part 7002.0025, the commissioner shall not accept any correction submitted by an owner or operator which would result in a reduction of tons emitted if the correction is submitted more than 45 days after the annual emissions inventory mailing date of the previous year's air emissions summary.

### **Minnesota Racing Commission**

### Adopted Permanent Rules Relating to Horse Racing

The rules proposed and published at *State Register*, Volume 28, Number 30, pages 923-932, January 26, 2004 (28 SR 923), are adopted with the following modifications:

### 7873.0193 PLACE PICK ALL.

Subp. 4. **Place pick all pool.** The place pick all pari-mutuel pool consists of amounts contributed for a selection finishing first or second in each of the races designated by the association with the approval of the commission. Each person purchasing a place pick all ticket shall designate a horse that officially finishes first or second in each of the races comprising that days day's racing program.

### Subp. 6. Calculation of pool.

- B. One hundred percent of the net amount in the pari-mutuel pool subject to distribution among winning ticket holders shall be distributed among the holders of pari-mutuel tickets which correctly designate the most winning selections officially finishing first or second in each of the races comprising that days day's racing program.
- C. (1) One hundred percent of the net amount in the pari-mutuel pool subject to distribution among winning ticket holders shall be distributed among the holders of pari-mutuel tickets which correctly designate a horse that officially finishes first or second in each of the races comprising that <u>days day's</u> racing program.
- (2) In the event there is no pari-mutuel ticket properly issued which correctly designates a horse that officially finishes first or second in each of the races comprising that days day's racing program, 75 percent of the pari-mutuel pool shall not be distributed but shall be retained by the association as a distributable amount and shall be carried over and included in the place pick all pari-mutuel pool for the next succeeding racing date as an additional net amount to be distributed among the holders of pari-mutuel tickets which correctly designate the official winner in each of the four races comprising the pick four pool that day.

The remaining 25 percent shall be distributed among the holders of place pick all tickets that correctly designate the most horses officially finishing first or second in each of the races comprising that days day's racing program.

### 7873.0199 PICK FOUR.

Subp. 6a. Calculation of pool with a pick four pool designated to have a carryover.

A. The association, with the approval of the commission <u>according to the criteria in part 7873.0195</u>, may add a carryover to the pick four wager. In that case, the pick four pari-mutuel pool must be calculated according to one of the two methods provided in item B or C, as approved by the commission.

### 7877.0170 DUTIES AND RESPONSIBILITIES OF CLASS C LICENSEES.

Subp. 2a. **Assistant trainers.** An assistant trainer shall be charged with the same responsibilities as a trainer. If warranted after full consideration by the stewards of all facts and circumstances as contained in chapter 7879 by the stewards, the assistant trainer shall be held equally culpable with the trainer by whom he or she the assistant trainer is employed for any acts to which the assistant trainer has prior knowledge or involvement.

Subp. 9. Veterinarians. The following shall apply to veterinarians licensed by the commission:

C. A veterinarian may possess substances that are FDA approved, but not specifically for use on the horse, only with the <u>by providing</u> prior approval of <u>notice to</u> the commission's veterinarian and the Board of Stewards. Veterinarians shall not possess medications or substances without a specific manufacturer's name, lot number, and expiration date.

### **Expedited Emergency Rules**

Provisions exist for the Commissioners of some state agencies to adopt emergency expedited rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Emergency expedited rules are effective upon publication in the *State Register*, and may be effective up to seven days before publication under certain emergency conditions. Emergency expedited rules are effective for the period stated or up to 18 months. Specific *Minnesota Statutes* citations accompanying these emergency expedited rules detail the agency's rulemaking authority.

### Adopted Expedited Emergency Rules: Designated Infested Waters

**NOTICE IS HEREBY GIVEN THAT** the above entitled rule has been adopted through the process prescribed by *Minnesota Statutes*, section 84.027, subdivision 13 (b). The statutory authority for the contents of the rule is *Minnesota Statutes*, sections 84D.03, subdivision 1, and 84D.12, subdivision 3.

The emergency conditions that do not allow compliance with Minnesota Statutes, sections 97A.0451 to 97A.0459, are that:

- 1) Zebra mussels have been confirmed in Ossawinnamakee Lake, Crow Wing County, and in Pelican Brook, the outlet stream of the lake. These waters are in the middle of the Brainerd lakes area and are popular for fishing and the commercial harvest of bait.
- 2) Fishing and bait harvest are "high risk" activities with respect to the potential to spread zebra mussels to new non-infested, waters. Adult zebra mussels can be inadvertently caught on anchors or nets, or be attached to plant fragments, and be carried to other lakes/rivers by boaters or bait harvesters. The greatest risk may exist when zebra mussels are in their early larval life stage. The larvae are microscopic, free-floating, and not visible to water users. They cannot be removed by carefully sorting fish or a thorough inspection of boating equipment. Zebra mussel larvae will be present in Ossawinnamakee Lake and Pelican Brook from approximately late May through the end of September.
- 3) Minnesota has applicable statutes and rules that address this situation and would reduce the risk of zebra mussel spread. These statutes and rules become applicable once the lake is designated as "infested waters". Once designated as infested with zebra mussels, bait harvest is prohibited, water is required to be drained from boats and equipment prior to their travel on public roads, transport of the water for other uses is prohibited, and other restrictions apply (per *Minnesota Rules*, chapter 6216).
- 4) The expedited rules process would allow the "infested waters" designation to be in place by about June 1, the approximate time when zebra mussel larvae will be present in the lake and potential bait harvest would be peaking if the waters are not

designated. Designation through exempt emergency rules would take longer and would extend beyond the critical time when bait harvest would be expected to occur in Pelican Brook and Ossawinnamakee Lake.

The remaining four parties shall be issued antlerless licenses for Season B. The remaining landowner parties and ten parties from the general pool shall also be selected in case successful parties decide not to purchase their permit. Alternate parties shall not be notified unless they may purchase an elk license. If no qualified landowners apply, all five licenses shall be drawn from the general pool of applicants.

## Revenue Notice # 04-05: Sales and Use Tax - Lawn Care - Revocation of Revenue Notices # 91-02, # 94-04, and # 02-18

The application of sales and use tax to lawn, garden, and arborist services is governed by *Minnesota Statutes*, section 297A.61, subdivisions 3(g)(6)(vi) and 4(f). Under *Minnesota Statutes*, section 297A.67, subdivision 25, lawn care services used in the maintenance of cemetery grounds are exempt.

### **Lawn Care**

Under *Minnesota Statutes*, section 297A.61, subdivision 3(g)(6)(vi), lawn care services are subject to tax. For purposes of this provision the following definitions apply:

"Lawn" is a tended area of ground covered with grass or other ground cover, and can include, for example, yards, parks and golf courses. However, ditches and medians along roads, freeways, and railroad right-of-ways are not considered lawns.

"Lawn care service" means any business service related to the maintenance of lawns. Lawn care services include services such as: mowing; raking; trimming; watering; fertilizing; killing weeds, insects, rodents, pests, or fungi; spraying; sprigging; and diagnosing the condition of lawns by physical examination of the lawn or of other physical evidence.

### **Improvement of Real Property**

Under *Minnesota Statutes*, section 297.61, subdivisions 3(g)(6)(vi) and 4(f), the installation of shrubbery, plants, sod, trees, bushes, and similar items is not taxable because it is considered an improvement to real property. In these situations, the contractor must pay sales or use tax on the cost of all plants, trees, bushes, shrubs, sod, and other materials, supplies, and equipment used to complete the contract.

Tree, bush, shrub, and stump removal services remain subject to sales and use tax when they are sold to a contractor and used by the contractor to complete a construction contract involving the new construction, reconstruction, or remodeling of a building or residence.

### **Examples of Taxable Services**

- Garden tilling and soil preparation;
- · Killing lawn or garden weeds, insects, rodents, or fungi;
- · Aerating;
- · Initial seeding of garden flowers and vegetables;
- · Dethatching;
- Stump grinding for home or business;
- · Picking up pet droppings;
- · Reseeding lawns.

### **Examples of Non-Taxable Services**

- · Moving trees or shrubs from one location to another location;
- · Cleaning of an outdoor pond;
- · Snow shoveling or plowing;
- Applying ice-melt or sand to driveways, sidewalks, or parking lots;
- Planting flower or vegetable plants;
- Initial seeding of lawns.

## Revenue Notice # 04-06: Administration and Compliance - Reimbursement of Third Party Record Keepers for their Costs of Furnishing Subpoenaed Records

Minnesota Statutes, sections 289A.36, subdivision 8; 296A.20, subdivision 8; 297E.08, subdivision 8; 297F.15, subdivision 8; 297G.14, subdivision 8; and 297I.55, subdivision 8; all provide that when the Commissioner of Revenue ("commissioner") serves a subpoena for records upon a third party ". . . the commissioner shall pay the reasonable costs of producing the records." The purpose of this revenue notice is to set forth what is considered reasonable for purposes of reimbursing third party record keepers for their costs of furnishing subpoenaed records.

The rate established for search costs is \$10.00 per hour and is limited to the total amount of personnel time spent in locating and retrieving documents or information requested by the subpoena. If it is necessary to hire outside help in locating and retrieving the requested information, the commissioner will pay the actual cost incurred for the additional help.

Search costs do not include salaries, fees, or similar costs for analysis of material, or for managerial or legal advice, expertise, research, or time spent for any of these activities. If itemized separately, search costs may include the actual costs of extracting information stored by computer in the format in which it is normally produced, based on computer time and necessary supplies; however, personnel time for computer search may be paid for only at the \$10.00 rate specified above.

The rate for reproduction costs for making photocopies or duplicates of subpoenaed documents, transcripts, and other similar material is 25 cents per page. Photographs, films, and other such items that are not photocopies are reimbursed at cost. The \$10.00 rate specified above does not include time spent making or assembling the copies, because those costs are included in the photocopying rate of 25 cents per page.

The rate for transportation costs is the same as the actual costs necessary to transport personnel to locate and retrieve subpoenaed records or information, or costs incurred solely to transport the subpoenaed material to the location where testimony regarding the subpoena, if any, is going to be given.

Third party record keepers will be reimbursed for the reasonable cost of mailing subpoenaed records to the commissioner.

### Revenue Notices =

The prior consent of the commissioner must be obtained if the total cost of furnishing subpoenaed records is expected to exceed \$250.00. All invoices for reimbursement of subpoena costs must separately state each item of costs incurred by a third party record keeper.

## Request for Comments on Extension of Federal Prepaid Medical Assistance Plus (PMAP+) §1115 Waiver

For more than fifteen years, Minnesota's Medicaid Program (Medical Assistance or MA) has administered a § 1115 waiver, now named the "Minnesota Prepaid Medical Assistance Project Plus" or PMAP+ waiver, allowing for:

- Purchase of coverage from health plans or managed care organizations (MCOs) on a capitated basis in the MA and MinnesotaCare programs.
- Expansion of populations covered with Medicaid funding to MinnesotaCare children, pregnant women and parents with incomes up to 275% of federal poverty guidelines (FPG).
- Mandatory enrollment of: elderly, including dual eligibles; American Indians; and children with special needs in managed care.
- Administrative simplification: annual reviews for medically needy individuals with unvarying income, post-partum reviews postponed in MA until next household review.
- All pregnant women to receive the full MA benefit set.
- Different cost sharing and benefits for parents and caretakers in MinnesotaCare than in MA.
- Coverage of one-year olds in MA up to 275% FPG.
- Premiums for MinnesotaCare enrollees.
- MinnesotaCare uninsured rules (crowd out provisions): 4 month no-insurance barrier; 18 month employer-subsidized insurance barrier.

Authority for the PMAP+ purchasing project will expire July 1, 2005. The State has a two-fold plan. First the State will request authority from CMS to provide services to seniors under a §1915(b)/(c) waiver and move this population out of the §1115 waiver. Under this plan, home and community-based services for the elderly (now provided under the Elderly Waiver) would be included, phased-in by county over time. The State hopes to accomplish the transition to the §1915(b) portion of the waiver by January 1, 2005, or before the expiration date of the existing PMAP+ purchasing project.

In the second part of the plan the State will seek renewal of coverage under the PMAP+ purchasing project for families, children, and pregnant women in MA and MinnesotaCare. The department is developing a new eligibility system, HealthMatch, which is currently projected to become operational on July 1, 2005. Because certain program coordination changes can only be made when this system is fully operational, the department is planning two phases for renewal of the PMAP+ purchasing project for families and children: Pre-HealthMatch and Post-Health Match.

While the federal Managed Care Regulations now make it possible to serve most populations through a managed care delivery system described in the Medicaid State Plan without a waiver, the department will still need to include managed care service delivery in the waiver renewal for some populations not included in the Medicaid State Plan.

Currently, there are approximately 649,560 people served in Minnesota Health Care Programs. This chart shows the programs, the eligibility groups and number of eligibles, delivery system, waiver type, and the funding source for each:

## Notice of Proposed Update of the Permanent List of Priorities (PLP) Among Releases or Threatened Releases of Hazardous Substances or Pollutants or Contaminants

**NOTICE IS HEREBY GIVEN** that the Minnesota Pollution Control Agency (MPCA), and the Minnesota Department of Agriculture (MDA), is publishing for public comment proposed deletions from the PLP which lists releases or threatened releases of hazardous substances, pollutants, or contaminants for which the MPCA or MDA may take removal or remedial actions under the Minnesota Environmental Response and Liability Act (MERLA), *Minnesota Statutes* § 115B.

Pursuant to *Minnesota Statutes* § 115B.17 (2002) and *Minnesota Rules* 7044.0950 (2001), the MPCA is proposing the following changes to the PLP.

The MPCA is proposing to delete the following four sites from the PLP: Interplastics Corporation, Hennepin County; Conoco Wrenshall Refinery, Carlton County; Sargent Creek Dump, St. Louis County; and Jerry's Tank Service, Carlton County.

The MPCA has determined that either all MERLA Response Actions have been completed at these sites or that the sites do not pose a threat to public health or welfare or the environment.

A Consent Agreement is in place between the MPCA and Interplastic Corporation. All appropriate response actions are being implemented and the consent agreement specifies requirements for long-term operation of the implemented remedy. No MERLA funded response actions will be necessary at this site.

An enforceable agreement exists between the MPCA and Conoco Phillips for the Conoco Wrenshall site. This agreement requires a restrictive covenant be in place for the site and a remedial action plan be implemented. The MPCA Large Aboveground Storage Tank Program will oversee all future response actions at the site, therefore no further MERLA response actions will be necessary.

All appropriate MERLA response actions have been completed at the Sargent Creek Dump and Jerry's Tank Service sites. Appropriate institutional controls will need to be in place prior to final deletion.

The MDA is not proposing to delete a site from the PLP at this time.

The MPCA and MDA invite members of the public to submit written comments on these proposed deletions from the PLP. All written comments with regard to these proposed changes to the PLP must be received no later than 4:30 p.m. on June 24, 2004.
