# Minnesota Rules: Amendments and Additions =

#### NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the *Rulesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. ### **Continuing Care for Persons with Disabilities – Adult Mental Health Division Public Notice of New Medical Assistance Adult Rehabilitative Mental Health Service and Rates**

**NOTICE IS HEREBY GIVEN** to recipients, providers of services under the Medical Assistance (MA) Program, and to the public of two new MA Program adult intensive rehabilitative mental health services and rates. This notice is published pursuant to 42 CFR §447.205, which requires public notice of significant proposed changes in methods and standards for setting payment rates for MA services.

*Laws of Minnesota 2003, First Special Session,* chapter 14, article 3, section 19 (new *Minnesota Statutes,* §256B.0622) requires the Department to add two intensive rehabilitative mental health services to its MA fee-for-service program for adults diagnosed with a mental illness, assertive community treatment services and intensive residential services. Notice of the two services was first published on June 30, 2003 at 27 SR 1877.

Besides the requirement of mental illness diagnosis, adult MA recipients must have:

- substantial disability and functional impairment in several areas;
- one or more of the following:
  - a history of two or more inpatient hospitalizations in the past year
  - significant independent living instability
  - homelessness
  - very frequent use of mental health and related services that result in poor outcomes; and
- in the written opinion of a licensed mental health professional, mental health needs that cannot be met with other available community-based services or likely to experience a mental health crisis or require a more restrictive setting if intensive rehabilitative services are not provided

#### 1. Assertive Community Treatment (ACT) Services

ACT is an evidence-based practice that delivers intensive mental health rehabilitative services, proven to reduce homelessness and the need for long term inpatient or residential treatment. This intensive rehabilitative service is provided by a multi-disciplinary team and may include the following components: integrated dual diagnosis treatment; medication monitoring and training in medication self-management, illness management and recovery, case management, psychological support and skills training, crisis services, and consultation with relatives and other significant people.

Eligible providers of ACT services are: 1) entities certified by the Department and operated by counties; 2) entities certified by

the Department based on program reviews by host counties with which they have contracts; 3) entities seeking to serve a subpopulation of clients through specialized programs; and 4) Indian Health Service facilities or facilities operating as "638" facilities.

#### 2) Intensive Residential Rehabilitative Services

These rehabilitation services are provided to recipients requiring the level of care and supervision provided in a licensed, residential setting (in Department parlance, a Rule 36 facility). The components may include those provided for ACT services, excluding case management. Resident supervision and direction, and inter-agency coordination may also be provided.

Eligible providers of intensive residential rehabilitative services are: 1) entities operated by counties; 2) entities with host county contracts; 3) entities seeking to serve a subpopulation of clients through specialized programs; and 4) Indian Health Service facilities or facilities operating as "638" facilities.

#### **Rates for Adult Intensive Rehabilitative Mental Health Services**

Effective July 1, 2004 and upon federal approval, ACT services and intensive residential rehabilitative services provided by entities with county contracts will be paid a per day, county negotiated rate inclusive of all ACT or residential rehabilitative services, staff travel time to provide ACT or residential rehabilitative services, and crisis services.

To determine the rate, host counties must consider and document the:

- cost for similar services in the local trade area;
- actual costs incurred by entities providing the services;
- intensity and frequency of services to be provided to each recipient;
- · degree to which recipients will receive services other than ACT or residential rehabilitative services;
- costs of other services that will be paid separately; and
- input from county or regional mental health planning initiatives regrading recipient's service needs

Effective July 1, 2004 and upon federal approval, ACT services and intensive residential rehabilitative services provided by county entities and entities with county contracts furnishing specialized ACT or residential rehabilitative services to a subpopulation of recipients will be paid a Department-negotiated per day rate. The Department must consider the six factors, above.

Effective July 1, 2004 and upon federal approval, ACT services and intensive residential rehabilitative services provided by Indian Health Service or 638 facilities will be paid the federal "encounter" rate, a rate negotiated between the Indian Health Service and the federal Centers for Medicare & Medicaid Services (U.S. Department of Health and Human Services).

ACT Services include case management services. Therefore, ACT services providers do not receive payment for other MA targeted case management services in the same month ACT services are provided, except for the first and last months of ACT services.
