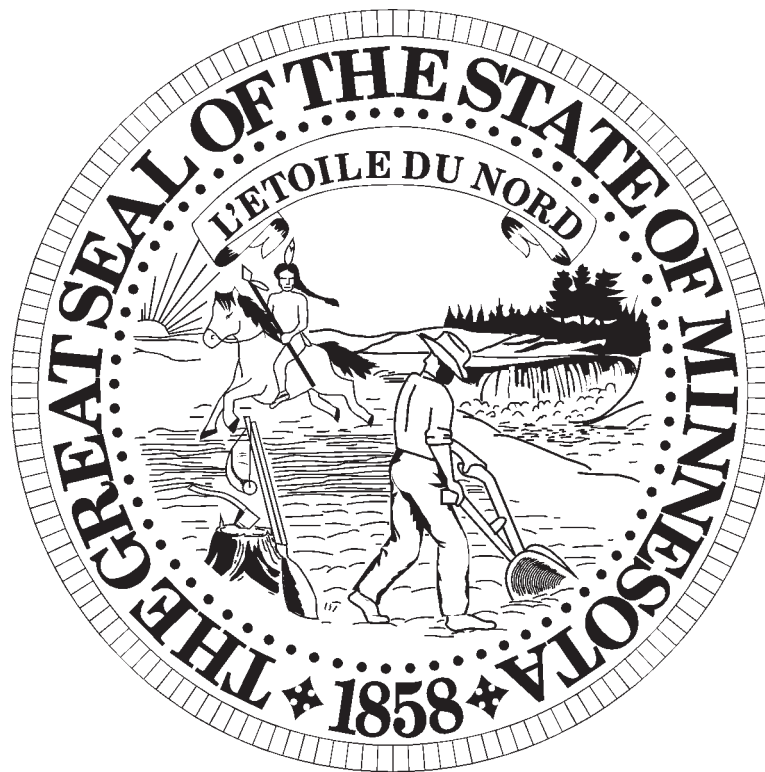

Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Minnesota Board of Accountancy

REQUEST FOR COMMENTS on Possible Amendment to Rules Relating to Licensure and Regulation of Accountants, *Minnesota Rules* chapter 1105

Subject of Rule. The Board of Accountancy requests comments on its planned amendment to rules relating to the licensure and regulation of accountants. The Board is considering rule amendments that will clarify several rule provisions which were adopted in early 2003 and further amended in 2004. Further, the amendments may modify the requirements for continuing professional education applicable to licensees, impose additional requirements relating to the education needed before taking the CPA examination, clarify certain rules and make other changes.

Persons Affected. The amendment to the rules would likely affect all persons regulated by the Board. The Board does not contemplate appointing an advisory committee to comment on the possible rule amendments.

Statutory Authority. *Minnesota Statutes*, section 326A.02 authorizes the Board to adopt rules governing its administration and enforcement of *Minnesota Statutes*, section 326A, and the conduct of licensees and persons registered under *Minnesota Statutes*, sections 326A.06, paragraph (b).

Public Comment. Interested persons or groups may submit comments or information on possible rule amendments in writing or orally until 4:30 p.m. on March 21, 2005. The Board requests that written comments be made on the Board's "Request for Rule Addition/Modification or Other Rule Change" Form which is available on the Board's website site at <http://www.boa.state.mn.us/>. The Board does not anticipate that a draft of the rule amendments will be available before the publication of the proposed rules. Written or oral comments, questions, requests to receive a draft of the rule amendments when they have been prepared, and requests for more information on these possible rule amendments should be addressed to: Dennis J. Decision on Trimont Wind I, LLC Proposed 100.5 Megawatt Large Wind Energy Conversion System in Martin and Jackson Counties

The Minnesota Environmental Quality Board (EQB) on July 17, 2004, unanimously voted to issue a site permit for a large wind energy project in Martin and Jackson counties in southern Minnesota. Trimont Wind I, LLC was granted a site permit for an 100.5 megawatt (MW) project, consisting of up to 67 turbines. The project will be built in Cedar Township in Martin County and Kimball Township in Jackson County. The project is expected to be completed by the final quarter of 2005.

The site permit for the project contains conditions for site preparation, construction, cleanup, restoration, operation, maintenance, abandonment, decommissioning and all other phases of the large wind energy conversion system. The Trimont Wind Project will have up to 67 General Electric 1.5 MW wind turbine generators. These generators will be mounted on freestanding tubular towers measuring 80 meters in height, with a rotor diameter of 82 meters. At the base of each turbine will be a "step-

up” transformer. A network of access roads and underground power and communication cables and overhead 34.5 kV feeder lines will also be installed. The project will be connected to the electrical grid at Xcel Energy’s Martin County Substation, located at the Great River Energy Lakefield Junction Generating Station.

NOTICE OF ADDITIONAL DAYS OF HEARING on Proposed Amendment to Rules Governing the Environmental Review Program, *Minnesota Rules*, chapter 4410, Adopting Mandatory Environmental Assessment Worksheet and Exemption Categories for Recreational Trails

Additional Days of Hearing. The Environmental Quality Board (EQB) has previously announced a public hearing on the above-entitled rules to be held in Bemidji, Hermantown, and at Fort Snelling in the Twin Cities on January 11, 12, and 19, respectively (see *State Register*, Volume 29, Number 21, pages 571-573, November 22, 2004 (29 SR 571)). This notice is to inform you of two additional dates and locations of the hearing that have been added by the EQB. The additional times of hearing and their locations will be:

- Monday, February 14, 2:00 p.m. to 5:00 p.m. and 7:00 p.m. to 10:00 p.m., at the South Central Technical College, 1920 Lee Boulevard, North Mankato; and
- Thursday, February 17, 2:00 p.m. to 5:00 p.m. and 7:00 p.m. to 10:00 p.m., at the Rainy River Community College, 1501 Highway 71, International Falls.

To find out if a hearing has been postponed due to adverse weather conditions, please call the EQB contact person listed below or check the EQB website: www.eqb.state.mn.us.

Subject of Rules. The proposed rules would amend the lists of mandatory Environmental Assessment Worksheet (EAW) categories (at *Minnesota Rules*, part 4410.4300) and Exemption categories (at *Minnesota Rules*, part 4410.4600) to add categories specific to certain types of recreational trails. The proposed rules would not establish categories for mandatory Environmental Impact Statements (EISs) for recreational trails. If the EQB adopts the mandatory EAW and Exemption categories, review will become automatic for some trail projects, while discretionary review (including review initiated by citizen petition) will no longer be possible for others.

A copy of the proposed rules was published in the *State Register* issue referenced above and is also available at the EQB website: www.eqb.state.mn.us. A free copy of the rules is available upon request from the agency contact person. A Statement of Need and Reasonableness (SONAR) is also available for review at the EQB offices and website and at the Office of Administrative Hearings. This statement contains a summary of the justification for the proposed rules, including a description of who will be affected by the proposed rules and an estimate of the probable cost of the proposed rules.

Public Comment. You may present your views either orally at the hearing or in writing at any time before the close of the hearing record. All evidence presented should relate to the proposed rules. You may also submit written material to the Administrative Law Judge to be recorded in the hearing record for five working days after the public hearing ends. This five day comment period may be extended for a longer period not to exceed 20 calendar days if ordered by the Administrative Law Judge at the hearing. All comments and responses submitted to the Administrative Law Judge must be received at the Office of Administrative Hearings no later than 4:30 p.m. on the due date. All comments or responses received will be available for review at the Office of Administrative Hearings.

Administrative Law Judge. The hearing will be conducted by Administrative Law Judge Steve M. Mihalchick, who can be reached at the Office of Administrative Hearings, 100 Washington Square, Suite 1700, Minneapolis, Minnesota 554012138, telephone (612) 349-2544, and FAX (612) 349-2665. The rule hearing procedure is governed by *Minnesota Statutes*, sections 14.131 to 14.20, and by the rules of the Office of Administrative Hearings, *Minnesota Rules*, parts 1400.2000 to 1400.2240. Questions concerning the hearing procedure should be directed to the Administrative Law Judge.

Modifications. The proposed rules may be modified as a result of the rule hearing process. Modifications must be supported by data and views presented during the rule hearing process, and the adopted rules may not be substantially different than these proposed rules, unless the procedure under *Minnesota Rules*, part 1400.2110, has been followed. If the proposed rules affect you in any way, you are encouraged to participate.

List of Health Services Requiring Prior Authorization as a Condition of Minnesota Health Care Program (MHCP) Payment

The following is the current authorization list, which replaces any other list published in the *State Register*. This authorization list is effective on or after January 1, 2005.

As authorized by *Minnesota Statutes*, section 256B.0625, subd 25, the following list includes all health services that require authorization as a condition of MHCP payment. The list is presented in sections: Dental Services, Vision Care Services, Medical Supplies and Equipment, Prosthetics and Orthotics, Hearing Aids, Drugs, Rehabilitative Services, and All Other Services. The criteria used to develop this list are as follows:

- A. The health service could be considered, under some circumstances, to be of questionable medical necessity.
- B. Use of the health service needs monitoring to control the expenditure of program funds.
- C. Less costly, appropriate alternatives to the health service are generally available.
- D. The health service is investigative.
- E. The health service is newly developed or modified.
- F. The health service is of a continuing nature and requires monitoring to prevent its continuation when it ceases to be beneficial.
- G. The health service is comparable to a service provided in a skilled nursing facility or hospital but is provided in a recipient's home.
- H. The health service could be considered cosmetic.

DENTAL SERVICES

It is essential that requests submitted for authorization consideration be accompanied by adequate case information and appropriate diagnostic materials (i.e., x-rays, prosthesis information, teeth to be replaced, prognosis for remaining dentition, complete 6 point period charting for cast metal partials).
