# Minnesota Rules: Amendments and Additions

#### NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Provisions exist for the Commissioners of some state agencies to adopt expedited emergency rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Expedited emergency rules are effective upon publication in the State Register, and may be effective up to seven days before publication under certain emergency conditions. Expedited emergency rules are effective for the period stated or up to 18 months. Specific *Minnesota Statute* citations accompanying these expedited emergency rules detail the agency's rulemaking authority.

If a proposed rule is totally new, it is designated "all new material." **Adopted Rules** - <u>Underlining</u> indicates additions to proposed rule language. ### **Department of Natural Resources** Adopted Expedited Emergency Game and Fish Rules: Designated Infested Waters

**NOTICE IS HEREBY GIVEN** that the above entitled rule has been adopted through the process prescribed by *Minnesota Statutes*, section 84.027, subdivision 13 (b). The statutory authority for the contents of the rule is *Minnesota Statutes*, sections 84D.03, subdivision 1, and 84D.12, subdivision 3.

The emergency conditions that do not allow compliance with *Minnesota Statutes*, sections 97A.0451 to 97A.0459, are that eight additional waters have been confirmed to contain Eurasian water milfoil and four additional waters have been confirmed to contain spiny waterflea since the previous designations of infested waters in permanent and emergency rules. It is necessary to designate these waters promptly to help prevent the further spread of these invasive species and be able to enforce the laws related to infested waters on these waters.

### Department of Natural Resources Adopted Expedited Emergency Game and Fish Rules: Designated Special Management Waters

**NOTICE IS HEREBY GIVEN** that the above entitled rules have been adopted through the process prescribed by *Minnesota Statutes*, section 84.027, subdivision 13 (b). The statutory authority for the contents of the rule is *Minnesota Statutes*, Sections 97A.045, subdivision 2.

The emergency conditions that do not allow compliance with *Minnesota Statutes*, sections 97A.0451 to 97A.0459, are as follows. The Department of Natural Resources recently used the exempt rulemaking process to adopt in Minnesota Rules, part 6264.0400, a walleye and sauger protected size limit of 19.5-28 inches effective December 1, 2004. The rule that set the size limit for walleye was needed to meet safe harvest allocations and protect the high quality walleye fishery. The sauger was included in combination with the walleye protected size limit to simplify the rule, but the rule change was not needed to reduce sauger harvest or to protect the sauger population.

Removal of sauger from the protected size limit would have a beneficial effect on the business community in the Lake of the Woods and Rainy River area without damage to the resource. It would partially offset any economic setback that will occur due to the change to a more restrictive walleye harvest rule and help them attract more people to their area. To avoid any negative impacts to local businesses that rely on this fishery and to minimize any confusion by the anglers during this winter season, this change needs to be done by January 1, 2005

**a. PROJECT DESCRIPTION:** The proposed project is a two phased project over two consecutive Federal fiscal years to build a new Army National Guard Aviation facility at the St. Cloud, Minnesota Airport. This facility will house and support Chinook and Blackhawk helicopters.

Phase II of the project will be 75,033 square feet and will consist of two (2) rotary wing maintenance bays, Flight Operations, administrative areas, Aviation Life Support Equipment Shop, simulations area, Ground Support Equipment Storage, aircraft wash facility, aircraft storage facility and the supporting facilities to complete a modern aircraft maintenance facility.

A possible future phase III will need to be considered in the overall design that would include aircraft maintenance bays, some allied shops and supporting facilities.

**b. REQUIRED CONSULTANT SERVICES:** The selected design team shall: Contain full service Architect and Engineering services to include structural, mechanical, electrical, civil, fire suppression engineering. In addition the design team should include persons with expertise in aviation and airport design.

In addition, soils testing and topographic surveying will be part of the consultant services for this project.

The Minnesota State Services for the Blind Communication Center (SSB), in conjunction with Minnesota Public Radio (MPR), seeks to improve the quality of service presently provided by the statewide Radio Talking Book broadcast network (RTB). This improvement will be accomplished by the purchase of 10,000 to 15,000 new state-of-the-art digital or digitally enhanced analog FM sub-carrier radio receivers. #### Background

Reading services are presently delivered by analog FM subcarriers on 14 MPR stations, two other non-commercial stations, and two commercial stations statewide. Approximately 7,500 RTB subcarrier radio receivers are in use in Minnesota. The quality of service received by any listener is dependent on several variables, including the received signal strength, the presence of some degree of multipath interference, and the quality of the receiver. The service has a characteristically narrow audio bandwidth that is greater than telephone quality and comparable to AM broadcast quality. There are also characteristic background noise phenomena and interference artifacts that can be audible under some reception circumstances. These characteristics vary throughout the installed user base due to the variety of reception conditions.

As the SSB audio production and delivery services are converted to digital media and the broadcast industry on the whole converts to digital transmission, the time has come to leverage the benefits of digitization to improve the quality of RTB, if it can be done economically.

SSB expects that as long as FM radio broadcasting transmits its analog signals, the use of FM subcarrier technology will remain a cost effective and viable means of transmitting RTB services. As digital broadcasting is implemented on the FM band, the analog signal is expected to remain mainly viable for subcarrier transmission. With hundreds of millions of analog radio receivers in the US marketplace it will likely take decades to make a transition to all-digital broadcasting, at which time FM subcarrier broadcasting will no longer be possible. For the purposes of conservative planning, it is assumed that a new subcarrier service has a minimum useful life of ten years, and is likely to last longer unless a disruptive technology arrives.

#### Goal

The Minnesota State Services for the Blind Communication Center (SSB), in conjunction with Minnesota Public Radio (MPR), seeks to improve the quality of service presently provided by the statewide RTB broadcast network. (It is believed that this improvement will most likely take the form of a sub-carrier radio receiver using a digital sub-carrier located in the space traditionally occupied by analog sub-carriers. SSB desires to purchase 10,000 to 15,000 receivers to meet its current and future needs, depending on price.
