Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Adopted Rules

A rule becomes effective after the requirements of *Minnesota Statutes* §§ 14.05-14.28 have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule. If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed. If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

KEY: Proposed Rules - <u>Underlining</u> indicates additions to existing rule language. <u>Strikeouts</u> indicate deletions from existing rule language. If a proposed rule is totally new, it is designated "all new material." **Adopted Rules** - <u>Underlining</u> indicates additions to proposed rule language. <u>Strikeout</u> indicates deletions from proposed rule language.

Department of Public Safety Adopted Permanent Rules Relating to Pipeline Safety

The rules proposed and published at *State Register*, Volume 29, Number 25, pages 697-700, December 20, 2004 (29 SR 697), are adopted with the following modifications:

7560.0100 DEFINITIONS.

Subp. 4. Locate. "Locate" means to provide an operator's markings of an underground facility.

Subp. 12. Service lateral. "Service lateral" means an underground facility that is used to transmit, distribute, or furnish gas, electricity, communications, or water from a common source to an enduse customer. A service lateral is also an underground facility that is used in the removal of sewage wastewater from a customer's premises.

7560.0150 PUBLIC RIGHTOFWAY MAPPING AND INSTALLATION.

Subp. 2. **Duty to install locating wire.** After December 31, 2005, an operator shall install a locating wire or have an equally effective means of marking the location of each nonconductive underground facility within a public rightofway installed after that date. This requirement does not apply when making minor repairs to an existing nonconductive facility. As applied to this chapter, "minor repairs" means repairs to or partial replacement of portions of existing service laterals located within a public rightofway for purposes of routine maintenance and upkeep.

7560.0225 EXCAVATOR RESPONSIBILITIES REGARDING A LOCATE.

Subpart 1. See repealer.

7560.0250 LOCATE STANDARDS.

Subp. 4. Duties of notification center. After December 31, 2005, the notification center shall make the information received under

subpart 2 available to the excavator before the start date and time on the notice. The notification center may fulfill this requirement by making the information accessible through one or more Internet addresses, by transmitting the information to a continuously working facsimile machine maintained by the excavator, or by other methodology developed by the notification center. The notification center shall make at least one attempt to notify the excavator at the email address or facsimile number provided by the excavator on the notice available the information received by operators pursuant to this section through an electronic means. The notification center is not required by this subpart to contact an excavator verbally via telephone.

7560.0325 EMERGENCY EXCAVATION NOTICES.

Subpart 1. **Duty of excavator to provide notice.** An excavator shall provide notice <u>to the notification center</u> before commencing an emergency excavation, unless subpart 2 applies. All emergency notices, regardless whether made prior to excavation, must be verbal or in a manner accepted by the notification center. In addition to the information required by the notification center, the notice must also contain:

Subp. 3. **Emergency notice requesting immediate response.** Upon receiving an emergency excavation notice requesting an immediate response, an operator shall:

B. locate and mark the underground facility within three hours of notice unless:

Subp. 4. **Emergency notice requesting scheduled response.** Upon receiving an emergency excavation notice that does not require an immediate response, and before the scheduled excavation start date and time, an operator shall:

A. locate and mark the underground facility, unless otherwise agreed between the parties; or

7560.0350 EXCAVATION NOTICE REQUESTING MEET.

Subpart 1. Excavator duties. When requesting a meet through the notification center, an excavator must provide at least one contact name and telephone number to assist in facilitating the meet. An excavator shall contact the notification center to cancel or reschedule the meet and the notification center shall relay this information to the affected operators. When a meet is requested, an excavator's notice must include the entire geographic area of the proposed excavation and the specific location of the meet. This part does not relieve an excavator from the duty to provide a precise geographic location of the proposed area of excavation, or to use white markings except where it can be shown that to do so is not practical.

Subp. 3. Excavation start date and time. When a meet is requested, the meet date and time must be at least 48 hours after notice is provided, excluding Saturdays, Sundays, and holidays, and the excavation start date and time must be at least 24 hours after the proposed meet date and time specified on the notice, excluding Saturdays, Sundays, and holidays. This subpart does not apply if these matters are provided for in a written agreement with all affected operators.

7560.0375 LOCATINGA SERVICE LATERAL.

Subpart 1. **Operator duties.** Unless otherwise agreed, an underground facility operator shall locate a service lateral before the start date and time on the notice and in accordance with items A through C:

A. An operator of a natural gas, propane, or electric facility shall locate a service lateral up to the meter or the connection to a customer's underground facility, whichever is closer to the enduse customer. If the meter or connection to the customer's underground facility is within a public rightofway, at a minimum the operator shall locate that portion of the service lateral within the public rightofway <u>up to the point where the service lateral first leaves the public rightofway</u>.

C. After December 31, 2005, an operator of a sewage or water facility, at a minimum, shall locate that portion of the service lateral within a public rightofway installed after that date <u>up to the point where the service lateral first leaves the public rightofway</u>. The operator shall either locate or provide information as shown on maps, drawings, diagrams, or other records, on the location of a sewer or water service lateral installed before January 1, 2006. If no information is available on a sewer or water service lateral installed before January 1, 2006, then notifying the excavator that no information exists fulfills the requirements of this section.

Subp. 2. **Exception.** An operator is not required to locate a service lateral of a customer who currently participates in the statewide notification system, provided the customer is notified in writing of the duty to locate the service lateral and operator mutually agree that the customer will assume locate responsibilities. The agreement must be in writing.

REPEALER. *Minnesota Rules*, part 7560.0225, subpart 1, is repealed.

Revenue Notices

Pursuant to *Minnesota Statutes* §§ 14.101, an agency must first solicit comments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, and within 60 days of the effective date of any new statutory grant of required rulemaking.

The State Register also publishes other official notices of state agencies and non-state agencies, including notices of meetings and matters of public interest.

Environmental Analysis and Outcomes Division REQUEST FOR COMMENTS on Possible Amendments to the Minnesota Pollution Control Agency's Rules, Chapters 7005, 7007 and 7011 Governing Municipal Waste Combustors, Medical Waste Incinerators, and Commercial/Industrial Solid Waste Incinerators

Subject of Rule: The Minnesota Pollution Control Agency (MPCA) requests comments on its planned rule amendments governing emissions and operations of solid waste combustors.

This rulemaking is being undertaken to incorporate current federal rules into state rules for small municipal waste combustors, hospital, medical and infectious waste incinerators, air curtain incinerators, and commercial/industrial waste combustors. The rulemaking will also address conflicts between federal rules and existing state rules, as well as correct errors in current state rules. Incorporating the federal standards into Minnesota's state rules will allow the MPCA to request delegation authority from the United States Environmental Protection Agency for implementation and enforcement of these standards through a mechanism referred to as a "111(d) plan".

Further, the MPCA will examine the applicability of Minnesota's waste combustor rule to fuels that are biomass-based. The MPCA is contemplating whether the existing rule should be modified to exempt certain biomass-based wastes from being subject to the waste combustor rules, and if so, under what conditions.

Persons Affected: The proposed amendments may affect persons and facilities that operate solid waste incinerators: local units of government and state agencies that operate municipal waste combustors, facilities that burn hospital, medical, and infectious waste, industries and commercial facilities that burn solid wastes, and owners and operators of facilities that are capable of burning biomass fuels. Changes to these rules could directly or indirectly affect all citizens of the state because the changes are contemplated to affect permitting requirements for burning solid wastes.

Statutory Authority: The MPCA's authority to adopt and implement these rule amendments is found in *Minnesota Statutes* § 116.07, subd. 4. This provision authorizes the MPCA to adopt rules "for the prevention, abatement, or control of air pollution." The portion of Section 116.07, subd. 4, relevant to air quality regulation reads as follows:

Subd. 4. Rules and Regulations. Pursuant and subject to the provisions of chapter 14, and the provisions hereof, the pollution control agency may adopt, amend and rescind rules and standards having the force of law relating to any purpose within the provisions of *Laws 1967*, chapter 882, for the prevention, abatement, or control of air pollution. Any such rule or standard may be of general application throughout the state, or may be limited as to times, places, circumstances, or conditions in order to make due allowance for variations therein. Without limitation, rules or standards may relate to sources or emissions of air contamination or air pollution, to the quality or composition of such emissions, or to the quality of or composition of the ambient air or outdoor atmosphere or to any other matter relevant to the prevention, abatement, or control of air pollution.

Public Comment: Interested persons or groups may submit comments or information on this planned rule in writing or orally until 4:30 p.m. on July 6, 2005. The MPCA does not anticipate appointing an advisory committee to comment on the possible rule amendments.

Rule Drafts: The MPCA has not yet prepared a draft of the possible rule amendments.
