### Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. ### **Adopted Rules**

A rule becomes effective after the requirements of *Minnesota Statutes* §§ 14.05-14.28 have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule. If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed. If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

**KEY: Proposed Rules** - <u>Underlining</u> indicates additions to existing rule language. <u>Strikeouts</u> indicate deletions from existing rule language. If a proposed rule is totally new, it is designated "all new material." **Adopted Rules** - <u>Underlining</u> indicates additions to proposed rule language. <u>Strikeout</u> indicates deletions from proposed rule language.

### Department of Employee Relations Adopted Permanent Rules Relating to State Employment; Personnel

The rules proposed and published at *State Register*, Volume 30, Number 15, pages 365-372, October 10, 2005 (30 SR 365), and Volume 30, Number 16, page 393, October 17, 2005 (30 SR 393), are adopted as proposed.

### **Executive Orders**

The governor has the authority to issue written statements or orders, called Executive Orders. as well as Emergency Executive Orders. The governor's authority is specified in the *Constitution of the State of Minnesota*, Article V, and in *Minnesota Statutes* § 4.035. Emergency Executive Orders, for protection from an imminent threat to health and safety, become effective immediately, are filed with the secretary of state, and published in the *State Register* as soon as possible after they are issued. Other Executive Orders become effective 15 days after publication in the *State Register* and filing with the secretary of state. Unless otherwise specified, an executive order expires 90 days after the date the governor who issued the order vacates office.

### EMERGENCY EXECUTIVE ORDER NO. 06-01: Providing for a Declaration of Peacetime Emergency and the Provision of Emergency Relief

I, Tim Pawlenty, Governor of Minnesota, by virtue of the Authority vested in me by the Constitution and applicable statutes, including but not limited to 2005 *Minnesota Statutes* Chapter 12, hereby issue this Executive Order:

WHEREAS, beginning January 1, 2006, the federal government took over responsibility for the prescription drug coverage for dual eligible beneficiaries consistent with the Medicare Modernization Act of 2003; and

**WHEREAS**, there are approximately 100,000 Minnesotans who are dually eligible for Medicare and Minnesota Medical Assistance benefits ("dual eligible beneficiaries"); and

**WHEREAS**, dual eligible beneficiaries are low income and disabled individuals who qualify under the law for prescription drug benefits with low or no premiums, deductibles and co-payments; and

WHEREAS, during the transition to the new Medicare prescription drug benefit, many dual eligible beneficiaries have experienced barriers to obtaining prescription drug coverage due to malfunctions, problems and failures in the computer systems designed by the federal government; and

WHEREAS, the technological failures and malfunctions in the federal system has resulted in dual eligible beneficiaries, who cannot otherwise obtain their prescription medicines, being denied access to needed medicines and endanger the life, health and well-being of these individuals; and

WHEREAS, the Minnesota Department of Human Services has made every effort to mitigate the impact of the transition upon dual eligible beneficiaries, has supplied the Medicare program with accurate enrollment data for the dual eligible beneficiaries transitioning to Medicare, assisted thousands of beneficiaries and pharmacists confused about inconsistencies in the federal computer system and

coordinated data with federal agencies to resolve beneficiary problems; despite these efforts, an unacceptable number of eligible beneficiaries are still not receiving their needed prescriptions; and

WHEREAS, efforts by the federal government to correct the systems failures in a timely manner have not been successful.

NOW, THEREFORE, I do hereby order:

1. That a peacetime emergency exists in the State of Minnesota pursuant to *Minnesota Statutes* 2005, Section 12.31, Subdivision 2 due to the technological failures and malfunctions of the federal systems responsible for providing prescription drug coverage for dual eligible beneficiaries and the emergency powers of the state are needed to provide emergency relief.

2. The Commissioner for the Department of Human Services is authorized to use staff and resources to continue agency efforts to ensure dual eligible beneficiaries in Minnesota are enrolled accurately in the federal benefit system.

3. The Commissioners of Human Services and Finance are authorized to establish procedures to have the State of Minnesota, through the Department of Human Services, become the payer of last resort for the purpose of paying on behalf of dual eligible beneficiaries cost-sharing and prescription drugs costs coverable by the Medicare prescription drug benefit.

4. The Commissioners of Human Services and Finance are authorized to enter into contracts necessary to carry out this order.

5. The Commissioners of Human Services and Finance must account for all payments and obligations incurred as a result of this Order.

6. The Commissioners of Human Services is directed to seek reimbursement from any available sources including the federal government, insurers, health plans or other responsible persons or entities for all state expenditures incurred pursuant to this order.

Pursuant to *Minnesota Statutes* 2005, Sections 12.31 and 4.035, Subdivision 2, this emergency executive order shall be effective immediately and will remain in effect until the conclusion of the emergency, but for no more than five (5) days unless the peacetime emergency is extended by the Executive Council or the Legislature in accordance with Minnesota law.

Pursuant to *Minnesota Statutes* §§ 14.101, an agency must first solicit comments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, and within 60 days of the effective date of any new statutory grant of required rulemaking.

### Presumed Legal Cigarette Prices Available as of January 19th, 2006

The presumed prices for wholesalers and retailers, as provided for by *Minnesota Statutes*, chapter 325D, are shown in this schedule. The computations are based on manufacturers' list prices and the products listed are a SAMPLING of the total cigarette market in Minnesota including cigarette brands that ARE affected by the "Non-Settlement Fee" as well as brands that ARE NOT. Minimum prices may be calculated for unlisted products as follows:

#### **Wholesale Carton Price:**

Manufacturer Price + \$14.85 (cigarette stamps) + \$3.50 (Non-Settlement Fee as applicable) + \$0.54 (Wholesale Cost of Doing Business) = Wholesale Price.

#### **Retail Carton Price:**

Wholesale Price + 8% (Retail Cost of Doing Business) = Retail Price.

All cigarettes in a wholesaler's or retailer's inventory must be priced to reflect these presumed prices. A wholesaler or retailer may sell for less if they can show that their actual costs of doing business are lower than the presumed minimum. In accordance with the requirements of Section 303(d) of the Federal Clean Water Act (CWA), the Minnesota Pollution Control Agency (MPCA) is today publishing its Year 2006 draft list of stream segments and lakes which have impaired designated uses and for which the MPCA proposes to complete total maximum daily load (TMDL) reports. TMDLs define the maximum amount of each pollutant that can be released and assimilated in the receiving water from point and nonpoint sources and allow water quality standards to be met in the receiving water. Each TMDL is pollutant-specific.

The CWA 303d list of impaired waters contains stream reaches and lakes that are not fully supporting designated uses, based on numeric or narrative water quality standards exceedences, for which a TMDL report is required. The MPCA is required to list, prioritize, and attach a schedule which estimates starting dates and completion dates for each TMDL for each affected reach or lake. Schedules are estimated because pollutants vary in complexity and schedules must be consistent with Basin Planning development.

### REQUEST FOR COMMENTS on Planned Amendment to Rules Governing Hazardous Waste Exports and Imports, *Minnesota Rules*, Chapter 7045

**Subject of Rules.** The Minnesota Pollution Control Agency (Agency) requests comments on its planned amendment to rules governing the adoption of federal requirements relating to the export and import of hazardous waste. The Agency is considering adopting federal requirements associated with the transfrontier shipment of wastes destined for recovery in countries that participate in Organization for Economic Cooperation and Development (OECD). These regulations were published in the April 12, 1996, *Federal Register*. The amendments published in the April 12, 1996, *Federal Register* have been in effect nationally since July, 11, 1996. The amendments to the state rules will only adopt the existing federal requirements and will not change the current practices that apply to transfrontier shipment of hazardous wastes.

**Persons Affected.** The federal amendments regarding transfrontier shipments currently govern hazardous waste generators, transporters and the owners and operators of facilities that export or import hazardous wastes to or from OECD countries. The planned amendments to the state rules are being made to maintain consistency with the federal regulations but will have no effect on current hazardous waste management practices.

**Statutory Authority.** *Minnesota Statutes*, section 116.07, subd. 2, rules and standards, authorizes the Agency to "adopt, amend, and rescind rules and standards having the force of law relating to any purpose within the provisions of this chapter for generators of hazardous waste, the management, identification, labeling, classification, storage, collection, treatment, transportation, processing, and disposal of hazardous waste."

REQUEST FOR COMMENTS: Possible Amendments to Rules Governing the Crime Victims Reparations Board, *Minnesota Rules*, parts 3050.2900, 3050.3100, 3050.3400, 3050.3600, 3050.3700, 3050.3750, and 3050.3800.

**Subject of Rules.** The Minnesota Department of Public Safety requests comments on its possible amendments to rules governing the Crime Victims Reparations Board. The Department is considering the following rule amendments to clarify existing rules relating to claims procedures and eligibility for reparations:

*Minnesota Rule*, part 3050.2900 Contributory Misconduct. This amendment clarifies the definition of contributory misconduct to specifically include gang and drug related activity on the part of the victim. The amendment also makes the rule consistent with statutory language which allows the board to deny claims for contributory misconduct.

*Minnesota Rule*, part 3050.3100 Loss of Support. This amendment changes the requirements for eligibility for loss of support, as well as the method of calculating benefits. Children of the deceased would be eligible for benefits which would be payable for up to 3 years.

*Minnesota Rule*, part 3050.3400 Secondary Victims. This amendment eliminates the cap on the number of counseling sessions for secondary victims.

*Minnesota Rule*, part 3050.3600 Household Services. This amendment requires that household service providers be licensed professionals in order to be eligible for reimbursement by the board.

Minnesota Rule, part 3050.3700 Cost Ceiling on Hospital and Physician Expenses. This amendment would allow the Board to process payments for mental health in the same manner as the rule allows for paying medical expenses at a reduced rate to be set by the Crime Victims Reparations Board annually. The amendment also makes it clear that the board will only pay a percentage of the remaining charges, if any, after discounts are applied pursuant to any agreements with insurers, HMOs, or other state or local government agencies.

*Minnesota Rule*, part 3050.3500 Funeral Rate Limits. This amendment allows claimants to use up to \$1000 of their maximum funeral benefit for lodging for family members to attend the funeral.

*Minnesota Rule*, part 3050.3750 Mental Health Treatment Rate Limits. This amendment would allow the board to set a maximum amount for the total accumulated expenses for a victim's medical care, as they do currently for mental health expenses. It also repeals language allowing the board to set a maximum hourly rate for mental health therapy.

**Persons Affected.** The amendments to the rules would likely affect victims of crime seeking reparations benefits and providers of services.

**Statutory Authority.** *Minnesota Statutes*, section 611A.56, subdivision 1, paragraph (b), requires the Crime Victims Reparations Board to adopt rules to implement and administer sections 611A.51 to 611A.68. In addition, *Minnesota Statutes*, Section 611A.60 provides authority for these amendments.

#### I. INTRODUCTION

#### A. Purpose of Request

The Minnesota Department of Human Services, through its Chemical Health Division is seeking proposals from qualified responders to increase treatment capacity for women that will provide housing for pregnant women and women with their dependent children throughout the mother's substance abuse treatment.

#### B. Goal of this RFP

The goal of this RFP is to increase residential capacity to provide the full range of chemical health treatment and ancillary services for pregnant women and women with dependent children. The Chemical Health Division (CHD) wants to increase access and geographic availability to substance abuse treatment, improve treatment completion rates, and improve treatment outcomes for this population by providing funds for start-up/expansion costs to house women with their dependent children during the mother's substance abuse treatment. [Substance Abuse Prevention and Treatment (SAPT) Block Grant funds may not be used to make capital or major equipment improvements.]

Given the increase in the number of women entering treatment who identify methamphetamine as their primary drug, and the associated Child Protection issues, we are particularly interested in treatment strategies to improve recovery outcomes for these clients.

Need and geographic distribution of programs will be a consideration in the final selection of proposals.

The term of any resulting contract is anticipated to be for **21 months**, from **October 1, 2006 – July 1, 2007**, and **July 1, 2007 - June 30, 2008**, with the potential for a **3-year** extension. The funded entities may re-apply to continue beyond the initial 21 month award period, based on satisfactory performance and the availability of funds.

An estimated total of \$1.5 million per year is available from the Federal Block Grant for this RFP.
