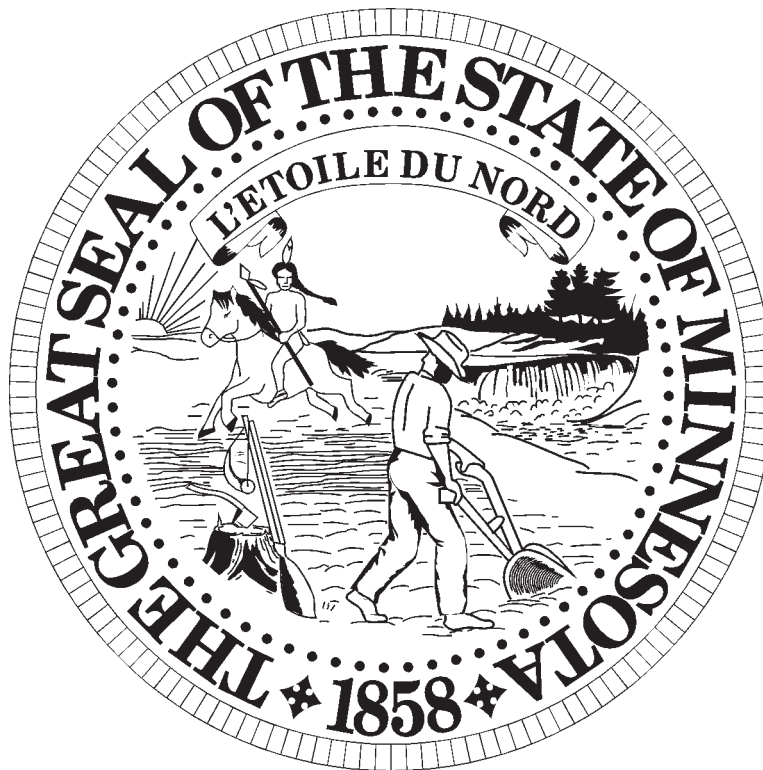

Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Adopted Rules

A rule becomes effective after the requirements of *Minnesota Statutes* §§ 14.05-14.28 have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule. If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed. If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

Adopted Permanent Rules Relating to Family Planning

The rules proposed and published at *State Register*, Volume 30, Number 52, pages 1405-1410, June 26, 2006 (30 SR 1405), are adopted with the following modifications:

9505.5310 DEMONSTRATION PROJECT ELIGIBILITY, APPLICATION, ENROLLMENT, AND DOCUMENTATION.

Subp. 4. **Application and documentation.** The application and documentation requirements in this subpart apply to all applicants and enrollees.

E. Applicants and enrollees must report a change in an eligibility factor to the department or county agency within ten days of learning about the change. Applicants and enrollees who fail to report a change that would have resulted in ineligibility for the demonstration project will be disenrolled from the demonstration project and will be ineligible for the demonstration project for a period of 12 months following the date of disenrollment. If the only unreported change is a pregnancy, applicants and enrollees will not be subject to the 12 months ineligibility period, but pregnant applicants and enrollees will be disenrolled from the demonstration project and may reapply for the demonstration project following the end of the pregnancy.

Exempt Rules

Exempt rules are excluded from the normal rulemaking procedures (*Minnesota Statutes* §§ 14.386 and 14.388). They are most often of two kinds. One kind is specifically exempted by the Legislature from rulemaking procedures, but approved for form by the Revisor of Statutes, reviewed for legality by the Office of Administrative Hearings, and then published in the *State Register*. These exempt rules are effective for two years only.

The second kind of exempt rule is one adopted where an agency for good cause finds that the rulemaking provisions of *Minnesota Statutes*, Chapter 14 are unnecessary, impracticable, or contrary to the public interest. This exemption can be used only where the rules:

- (1) address a serious and immediate threat to the public health, safety, or welfare, or
- (2) comply with a court order or a requirement in federal law in a manner that does not allow for compliance with *Minnesota Statutes* Sections 14.14-14.28, or
- (3) incorporate specific changes set forth in applicable statutes when no interpretation of law is required, or
- (4) make changes that do not alter the sense, meaning, or effect of the rules.

These exempt rules are also reviewed for form by the Revisor of Statutes, for legality by the Office of Administrative Hearings and then published in the *State Register*. In addition, the Office of Administrative Hearings must determine whether the agency has provided adequate justification for the use of this exemption. Rules adopted under clauses (1) or (2) above are effective for two years only. The Legislature may also exempt an agency from the normal rulemaking procedures and establish other procedural and substantive requirements unique to that exemption.

Proposed Exempt Permanent Rules Relating to Occupational Safety and Health; Adoption of Federal Standards by Reference

NOTICE IS HEREBY GIVEN that the Department of Labor and Industry, Occupational Safety and Health Division (Minnesota OSHA) proposes to adopt the following revisions to the Department of Labor and Industry, Occupational Safety and Health Rules, as authorized under *Minnesota Statutes* §182.655. This notice proposes the adoption by reference of amendments to Occupational Safety and Health Standards that have already been proposed and adopted by the Federal Occupational Safety and Health Administration (Federal OSHA).

All interested or affected persons have 30 days from the date this notice is published in the *State Register* to submit, in writing, data and views on the proposed amendments to the rule. Comments in support of or in opposition to the proposed amendments are encouraged. Each comment should identify the portion of the proposed amendment addressed, the reason for the comment, and any proposed change.

Any person may file with the Commissioner written objections to the proposed amendments stating the grounds for those objections and may request a public hearing. A public hearing will be held if 25 or more persons submit written requests for a public hearing on the proposed amendments within the 30-day comment period. Requests for hearing must include the name and address of the person submitting the request, define the reasons for the request, and discuss any proposed changes. If a public hearing is required, the Department will proceed according to the provisions of *Minnesota Statutes* §182.655 and *Minnesota Rules* 5210.0020 to 5210.0100.

SUMMARY OF CHANGES

The following is a brief summary of the proposed amendments. The list of federal standards being proposed for adoption follows this summary. To review the complete *Federal Register* notices referenced below, visit www.osha.gov.

(A) **"Roll-Over Protective Structures; final rule; corrections and technical amendments."** On July 20, 2006, federal OSHA published in the *Federal Register*, a final rule with corrections and technical amendments to its roll-over protection structures (ROPS) standards for the construction and agriculture industries. A comment received regarding OSHA's December 29, 2005, direct final rule recommended a number of clarifications to the original ROPS standards as published. In the present notice, OSHA is making corrections and technical amendments to the ROPS standards: a) in response to this comment, b) as a result of editorial errors found in the ROPS standards published in the direct final rule, and c) to improve consistency among the figures generated for these standards. OSHA finds that these corrections and technical amendments do not change the substantive requirements of the ROPS standards.

By this notice, Minnesota OSHA proposes to adopt the final rule, corrections and technical amendments as published in the *Federal Register* on July 20, 2006.

(B) “Assigned Protection Factors; final rule.” On August 24, 2006, federal OSHA published in the *Federal Register*, a final rule for new Assigned Protection Factors (APFs) for respiratory protection programs, which are being incorporated into the OSHA respiratory protection standard. APFs are numbers that indicate the level of workplace respiratory protection that a respirator or class of respirators is expected to provide to employees when used as part of an effective respiratory protection program. This APF final rule completes the revision of the reserve sections of OSHA’s Respiratory Protection Standard as published in 1998. The Respiratory Protection Standard will now contain provisions necessary for a comprehensive respiratory protection program, including selection and use of respirators, training, medical evaluation, and fit testing.

By this notice, Minnesota OSHA proposes to adopt the final rule as published in the *Federal Register* on August 24, 2006.

This notice is published pursuant to 42 *United States Code* section 1396a(a)(13), which requires the Department to publish hospital payment rates, the methodologies underlying the establishment of such rates, and the justification of such rates.

This notice informs the public that the payment rates for inpatient hospital services for admissions on or after January 1, 2007 have been calculated and that individual hospitals will be notified of their applicable rates. These payment rates were determined pursuant to *Minnesota Statutes*, sections 256.9685, 256.9686 and 256.969 and *Minnesota Rules*, parts 9500.1090 to 9500.1140.

The MA Program uses a diagnosis related groups payment system. Under this system, inpatient hospital services are divided into diagnostic categories. Each diagnostic category represents a broad clinical category differentiated from all others based on the body system and cause of disease. Changes to the diagnostic categories, effective January 1, 2007, are published in this same edition of the *State Register*. In addition to the changes in the diagnostic categories, the relative values for the categories have also been changed. The Department intends to submit an amendment to its MA State plan during the first quarter of 2007 to incorporate the changes to the diagnostic categories.

The inpatient hospital rates effective January 1, 2007 have been rebased forward four years based on the MA inpatient cost increases of individual hospitals. These rates have increased by an average of 31 percent.

Public Notice of Disproportionate Population Adjustment Paid for Inpatient Hospital Services under Minnesota Health Care Programs

NOTICE IS HEREBY GIVEN to recipients, providers, and to the public concerning the disproportionate population adjustment (DPA, also known as Disproportionate Share Hospital or DSH) that is paid for inpatient hospital services under Minnesota Health Care Programs (Medical Assistance, MinnesotaCare, and General Assistance Medical Care). The listed DPA factors are effective for admissions occurring on January 1, 2007 through December 31, 2007. The DPA is based on the Medical Assistance inpatient days utilization rate of a hospital compared to the mean utilization rate of all Minnesota non-state owned or operated hospitals and Minnesota local trade area hospitals. The utilization rate of each hospital is calculated by dividing Medical Assistance patient days by total patient days as derived from Medicare cost report data from the base year that is used for all rate setting.

In order to qualify for a DPA payment, hospitals must comply with section 1923(d) of the Social Security Act (42 *United States Code* section 1396r-4(d)) at the time of an admission. Section 1923(d) requires hospitals to meet criteria regarding the provision of obstetric services or specific exemptions. However, state law provides for a hospital payment adjustment that is equal to the DPA for hospitals that do not meet the federal criteria. Because all hospitals meet the federal criteria, the hospital payment adjustment is not listed. The federal requirements do not affect DPA payments under General Assistance Medical Care (GAMC).

The Medical Assistance and the MinnesotaCare DPA is calculated as the difference between a hospital's utilization rate and the mean utilization rate. The DPA for hospitals with utilization rates that are above the mean plus one standard deviation is increased by 10 percent. The Medical Assistance and the MinnesotaCare inpatient total rate of each hospital is increased by the indicated percentage.

The GAMC DPA is calculated as the difference between a hospital's utilization rate and the mean plus one standard deviation utilization rate. The inpatient operating rate of each hospital is increased by the indicated percentage.

- Installing a second force main interceptor sewer parallel to the existing one that generally goes easterly along George St. and Excelsior Blvd. from lift station L19 and connects to an existing gravity interceptor sewer along Covington Road south of Carrie Lane in Shorewood
- Eliminating lift station L20 on Galpin Lake Rd. just south of Highway 7 in Shorewood and installing a gravity interceptor sewer from this location to lift station L19
- Upgrading lift station L18 at the intersection of 3rd Ave. and Christmas Lake Rd. in Shorewood, and adding a second force main interceptor sewer parallel to the existing one along Christmas Lake Road from 3rd Ave. to Highway 7
- Upgrading lift station L47 at the intersection of Channel Dr. and Manor Rd. in Greenwood, and adding a second force main interceptor sewer parallel to the existing one along Manor Rd. from the lift station to Excelsior Blvd.

The recommended improvements would provide sewer capacity to serve growth in this part of the region and increase the level of service of the facilities. Construction of the facilities would be scheduled for 2010-2012.
