## Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. ## **Proposed Rules**

Comments on Planned Rules or Rule Amendments. An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, and within 60 days of the effective date of any new statutory grant of required rulemaking.

Rules to be Adopted After a Hearing. After receiving comments and deciding to hold a public hearing on the rule, an agency drafts its rule. It then publishes its rules with a notice of hearing. All persons wishing to make a statement must register at the hearing. Anyone who wishes to submit written comments may do so at the hearing, or within five working days of the close of the hearing. Administrative law judges may, during the hearing, extend the period for receiving comments up to 20 calendar days. For five business days after the submission period the agency and interested persons may respond to any new information submitted during the written submission period and the record then is closed. The administrative law judge prepares a report within 30 days, stating findings of fact, conclusions and recommendations. After receiving the report, the agency decides whether to adopt, withdraw or modify the proposed rule based on consideration of the comments made during the rule hearing procedure and the report of the administrative law judge. The agency must wait five days after receiving the report before taking any action.

Rules to be Adopted Without a Hearing. Pursuant to *Minnesota Statutes* § 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing. An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public. The agency then publishes a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the *State Register*. If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.14-14.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the *State Register*.

Proposed Amendment to Rules Governing the Administration of the State Building Code, *Minnesota Rules*, Chapter 1300

DUAL NOTICE: Notice of Intent to Adopt Rules Without a Public Hearing Unless 25 or More Persons Request a Hearing, And Notice of Hearing If 25 or More Requests For Hearing Are Received

**Introduction.** The Department of Labor and Industry intends to adopt rules without a public hearing following the procedures set forth in the rules of the Office of Administrative Hearings, *Minnesota Rules*, parts 1400.2300 to 1400.2310, and the Administrative Procedure Act, *Minnesota Statutes*, sections 14.22 to 14.28. If, however, 25 or more persons submit a written request for a hearing on the rules by 4:30 p.m. on Wednesday, March 7, 2007, a public hearing will be held in the Minnesota Room, Department of Labor and Industry, 443 Lafayette Road North, St. Paul, Minnesota 55155, starting at 12:00 p.m. on Friday, March 23, 2007, and ending at 4:00 p.m. To find out whether the rules will be adopted without a hearing or if the hearing will be held, you should contact the agency contact person after March 7, 2007, and before March 23, 2007.

**Agency Contact Person.** Comments or questions on the rules and written requests for a public hearing on the rules must be submitted to the agency contact person. Subject of Rules and Statutory Authority. The proposed rules are about updating the rules regulating the administration of the State Building Code to coordinate the administration of all the rule chapters that comprise the State Building Code. The proposed rules amend language so that the rules governing the administration of the State Building Code are consistent between the model code documents that are incorporated by reference, as amended, into the various rule chapters that comprise the State Building Code. The proposed rules accomplish this by clarifying that work authorized by a permit is governed by the code that was in effect at the time the permit was issued, what constitutes a story, and exemptions for pools, swings and playground equipment. The proposed rules properly call out appendices where necessary; identifies occupancy classifications that can be constructed under the International Residential Code as adopted by the Department; and coordination with other statutes. The proposed rules also address how permit rejections, notices, and orders are issued by building officials, where those records are housed, along with requirements pertaining to the approval of construction documents. The proposed rules also clarify that an annual permit applies to an already approved electrical, gas, mechanical, or plumbing installation. The proposed rules also address certificates of occupancy for manufactured homes, municipal fee schedules, footing inspections and foundation inspections. Finally, the proposed rules address inadvertent errors from a previous rulemaking and improve the overall organization of the chapter.

## Proposed Rules =

The statutory authority to adopt the rules is *Minnesota Statutes*, sections 16B.59, 16B.61, and 16B.64. On August 15, 2006, the Office of Administrative Hearings waived the publication of the proposed rules in the *State Register*. The proposed rules are available on the Department's website at *www.doli.state.mn.us*. A **free copy of the rules** is also available upon request from the agency contact person listed above.

**Comments.** You have until 4:30 p.m. on Wednesday, March 7, 2007 to submit written comment in support of or in opposition to the proposed rules or any part or subpart of the rules. Your comment must be in writing and received by the agency contact person by the due date. Comment is encouraged. Your comments should identify the portion of the proposed rules addressed, the reason for the comment, and any change proposed. You are encouraged to propose any change desired. Any comments that you would like to make on the legality of the proposed rules must also be made during this comment period.

Request for a Hearing. In addition to submitting comments, you may also request that a hearing be held on the rules. Your request for a public hearing must be in writing and must be received by the agency contact person by 4:30 p.m. on Wednesday, March 7, 2007. Your written request for a public hearing must include your name and address. You must identify the portion of the proposed rules to which you object or state that you oppose the entire set of rules. Any request that does not comply with these requirements is not valid and cannot be counted by the agency when determining whether a public hearing must be held. You are also encouraged to state the reason for the request and any changes you want made to the proposed rules.

**Withdrawal of Requests.** If 25 or more persons submit a valid written request for a hearing, a public hearing will be held unless a sufficient number withdraw their requests in writing. If enough requests for hearing are withdrawn to reduce the number below 25, the agency must give written notice of this to all persons who requested a hearing, explain the actions the agency took to effect the withdrawal, and ask for written comments on this action. If a public hearing is required, the agency will follow the procedures in *Minnesota Statutes*, sections 14.131 to 14.20.

**Alternative Format/Accommodation.** Upon request, this Notice can be made available in an alternative format, such as large print, Braille, or cassette tape. To make such a request or if you need an accommodation to make this hearing accessible, please contact the agency contact person at the address or telephone number listed above.

**Modifications.** The proposed rules may be modified, either as a result of public comment or as a result of the rule hearing process. Modifications must be supported by data and views submitted to the agency or presented at the hearing and the adopted rules may not be substantially different than these proposed rules, unless the procedure under *Minnesota Rules*, part 1400.2110, has been followed. If the proposed rules affect you in any way, you are encouraged to participate in the rulemaking process.

**Cancellation of Hearing.** The hearing scheduled for Friday, March 23, 2007, will be canceled if the agency does not receive requests from 25 or more persons that a hearing be held on the rules. If you requested a public hearing, the agency will notify you before the scheduled hearing whether or not the hearing will be held. You may also call the agency contact person at (651) 284-5217 after March 7, 2007 to find out whether the hearing will be held.

**Notice of Hearing.** If 25 or more persons submit valid written requests for a public hearing on the rules, a hearing will be held following the procedures in *Minnesota Statutes*, sections 14.131 to 14.20. The hearing will be held on the date and at the time and place listed above. The hearing will continue until all interested persons have been heard. Administrative Law Judge Richard C. Luis is assigned to conduct the hearing. Judge Luis can be reached at the Office of Administrative Hearings, 100 Washington Square, Suite 1700, Minneapolis, Minnesota 55401-2138, **telephone:** (612) 341-7666, and **fax:** (612) 349-2665.

**Hearing Procedure.** If a hearing is held, you and all interested or affected persons, including representatives of associations or other interested groups, will have an opportunity to participate. You may present your views either orally at the hearing or in writing at any time before the close of the hearing record. All evidence presented should relate to the proposed rules. You may also submit written material to the Administrative Law Judge to be recorded in the hearing record for five working days after the public hearing ends. This fiveday comment period may be extended for a longer period not to exceed 20 calendar days if ordered by the Administrative Law Judge at the hearing. Following the comment period, there is a fiveworkingday rebuttal period during which the agency and any interested person may respond in writing to any new information submitted. No additional evidence may be submitted during the fiveday rebuttal period. All comments and responses submitted to the Administrative Law Judge must be received at the Office of Administrative Hearings no later than 4:30 p.m. on the due date. All comments or responses received will be available for review at the Office of Administrative Hearings. This rule hearing procedure is governed by *Minnesota Rules*, parts 1400.2000 to 1400.2240, and *Minnesota Statutes*, sections 14.131 to 14.20. Questions about procedure may be directed to the Administrative Law Judge.

The agency requests that any person submitting written views or data to the Administrative Law Judge prior to the hearing or during the comment or rebuttal period also submit a copy of the written views or data to the agency contact person at the address stated above.

**Statement of Need and Reasonableness.** A statement of need and reasonableness is now available from the agency contact person. This statement contains a summary of the justification for the proposed rules, including a description of who will be affected by the proposed rules and an estimate of the probable cost of the proposed rules. The statement is available on the Department's website at **www.doli.state.mn.us**, and may also be reviewed and copies obtained at the cost of reproduction from the agency.

## Proposed Rules

**Lobbyist Registration.** *Minnesota Statutes*, chapter 10A, requires each lobbyist to register with the State Campaign Finance and Public Disclosure Board. **Adoption Procedure if No Hearing.** If no hearing is required, the agency may adopt the rules after the end of the comment period. The rules and supporting documents will then be submitted to the Office of Administrative Hearings for review for legality. You may ask to be notified of the date the rules are submitted to the office. If you want to be so notified, or want to receive a copy of the adopted rules, or want to register with the agency to receive notice of future rule proceedings, submit your request to the agency contact person listed above.

Adoption Procedure After a Hearing. If a hearing is held, after the close of the hearing record, the Administrative Law Judge will issue a report on the proposed rules. You may ask to be notified of the date when the Administrative Law Judge's report will become available, and can make this request at the hearing or in writing to the Administrative Law Judge. You may also ask to be notified of the date on which the agency adopts the rules and the rules are filed with the Secretary of State, and can make this request at the hearing or in writing to the agency contact person stated above.

**Introduction.** The Department of Revenue intends to adopt rules without a public hearing following the procedures set forth in the rules of the Office of Administrative Hearings, *Minnesota Rules*, parts 1400.2300 to 1400.2310, and the Administrative Procedure Act, *Minnesota Statutes*, sections 14.22 to 14.28. **Subject of Rules and Statutory Authority.** The proposed rules are about application of sales and use tax on soft water equipment and service dealers, particularly the tax treatment of installation charges. The proposed amendment to *Minnesota Rules*, Part 8130.9000, with possible repeal of a subpart, make the rule conform to statutory changes made during the 2001 and 2002 legislative sessions that rendered a portion of the current rule obsolete, and improve readability and internal consistency. The statutory authority to adopt the rules is *Minnesota Statutes*, section 270C.06. A copy of the proposed rules is published in the *State Register* and attached to this notice as mailed.

**Comments.** You have until 4:30 p.m. on Wednesday, March 7, 2007, to submit written comment in support of or in opposition to the proposed rules or any part or subpart of the rules. #### 8130.9000 SOFT WATER EQUIPMENT AND SERVICE DEALERS.

Subpart 1. Sales. Receipts from Sales of water softening equipment and tanks which are permanently affixed attached by the <u>a</u> dealer to real property leased or owned by the purchaser are considered sales of equipment for the improvement of real property and are exempt from the Minnesota sales tax <u>as sales of improvements to real property</u>. Sales to dealers of such water softening equipment and tanks are considered retail sales and are subject to the tax at the time of sale to the dealer, who is considered the user thereof. Sales of equipment, tanks, replacement parts, salts and other chemicals directly to customers are taxable at the retail price if not installed by the dealer.

Subp. 2. **Rentals.** Receipts from rentals the rental of automatic and semiautomatic water softening equipment and tanks, regardless of how attached to the premises of the lessee, are subject to the sales and use tax. The rental, lease, or lease coupled with an option to purchase such equipment and tanks constitutes a sale at retail of tangible personal property, and all persons regularly engaged in such business are retailers. The tax does not apply applies to the installation charges if for the delivery and installation of rented equipment and tanks, including charges to replace or exchange such equipment or tanks, regardless of whether those charges are separately stated on the initial invoice or billing, or whether the installation is performed by the lessor of the equipment and tanks. Sales to dealers of automatic and semiautomatic equipment and tanks intended to be used only for leasing to customers are considered sales for resale.

Subp. 3. See repealer.

REPEALER. Minnesota Rules, part 8130.9000, subpart 3, is repealed.

The rules proposed and published at *State Register*, Volume 31, Number 4, pages 92-100, July 24, 2006 (31 SR 92), are adopted with the following modifications:

#### 7046.0040 METROPOLITAN AREA GENERATOR FEE.

Subp. 2. **Annual fees.** The annual fee is the sum of the base fee in item A and the quantity fee in item B. Very small quantity generators pay the minimum base fee and are exempt from the quantity fee.

#### 7046.0060 FEE FORMULA.

- Subpart 1. **Formula.** Beginning February 1, 2006, the commissioner shall follow the steps in this part to determine the fee assessment under this chapter for facilities and generators.
- Step 1. The total amount appropriated by the legislature for the new fiscal year (fiscal year target) is obtained.
- Step 2. \$2,000,000 is added to the amount appropriated by the legislature according to Laws 2003, chapter 128, article 2, section 55 54.
- Subp. 2. Phasein effects of revised fee formula.

A. For a period of four billing cycles after the effective date of this part, the agency must adjust the annual fees charged to metropolitan and nonmetropolitan area small and large quantity generators to ensure that no individual small or large quantity generator's fee increases by more than 100 percent per year, from the initial year's base baseline fee, as a result of the revised fee formula and collect the resulting shortfall from generators whose fees were reduced by 25 percent or more as a result of the revised formula. The following steps shall be followed to collect the resulting shortfall from generators whose fees were reduced by 25 percent or more as a result of the revised fee formula:

## **Expedited Emergency Rules**

Provisions exist for the Commissioners of some state agencies to adopt expedited emergency rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. **NOTICE IS HEREBY GIVEN** that the above entitled rules have been adopted through the process prescribed by *Minnesota Statutes*, section 84.027, subdivision 13 (b). The statutory authority for the contents of the rule is *Minnesota Statutes*, Section 97C.005, 97A.045, subd. 2, and 97C 401.

The emergency conditions that do not allow compliance with *Minnesota Statutes*, sections 97A.0451 to 97A.0459, are as follows. The Red Lake proposed walleye regulations are based on a safe harvest level that is proportioned 50/50 between the winter and open water season. Final harvest threshold levels to be included in the proposed rules were not available until November, and the new regulations need to be in place before the end of the winter fishing season in case harvest levels exceed the safe harvest threshold which would trigger a fishing season closure for walleye.

B. Except as provided in item C, While a person is on or fishing in the waters listed under item D, the following walleye regulations apply:

## Expedited Emergency Rules

- (1) Unless otherwise provided in this subpart, the walleye daily and possession limits are as follows:
- (a) the daily and possession limit for walleye is two fish, of which not more than one walleye shall be over 26 inches in length;
- (2) (b) all walleye in possession must be less than 17 inches or greater than 26 inches in length; and
- (3) (c) all walleye that are 17 inches to 26 inches in length, inclusive, must be immediately returned to the water; and.
- (2) The waters listed in item D will be closed to the taking of or angling for walleye at all times:
- (a) if the walleye cumulative kill estimate figured from December 1, 2006, to February 25, 2007, at any time equals or exceeds 120,000 pounds. This unit is effective five days after notice through February 25, 2007; and
- (b) if the walleye cumulative kill estimate figured from December 1, 2006, to November 30, 2007, at any time equals or exceeds 240,000 pounds. This unit is effective five days after notice through November 30, 2007. If this subitem is implemented, the notice will consist of a posting on the Department of Natural Resources Web site and atwater access sites.
- (3) Notwithstanding subitem (1), unit (a), if the cumulative walleye kill estimate from December 1, 2006, through June 30, 2007, is less than 134,000 pounds, then the daily and possession limit for walleye in waters listed in item D is four fish, of which not more than one walleye shall be over 26 inches in length. If this subitem is implemented, it is effective July 14, 2007, through November 30, 2007. Notice of the change will be posted on the Department of Natural Resources Web site and at water access sites.
- (4) <u>C.</u> A person's statewide <u>bag possession</u> limit <u>shall not include more than two for</u> walleye taken from Upper Red Lake and the tributaries listed under item D shall not exceed the possession limit that is in effect as described under item B, subitem (1) or (3).
- C. Notwithstanding item B, if walleye kill estimates at any time from May 13 to November 30, 2006, equal or exceed 108,000 pounds, then the walleye regulation changes according to this item: the waters listed in item D are closed to the taking of or angling for walleye at all times. If this item is implemented, it is effective five days after notice of the change is posted on the Department of Natural Resources Web site and at water access sites until December 1, 2006.
