# Minnesota Rules: Amendments and Additions

#### NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. # **Adopted Rules**

A rule becomes effective after the requirements of *Minnesota Statutes* §§ 14.05-14.28 have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule. If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed. If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

## **Department of Labor and Industry** Adopted Permanent Rules Relating to the Minnesota State Fire Code

The rules proposed and published at *State Register*, Volume 31, Number 19, pages 609-611, November 6, 2006 (31 SR 609), are adopted with the following modifications:

#### 7510.5520 DEFINITIONS.

Subp. 2. **Child day care center.** "Child day care center" means a child day care facility required to be licensed by the Department of Human Services under parts 9503.0005 to 9503.0175 and classified as a Group E<del>, Division 3,</del> Occupancy under section 202 of the Minnesota State Fire Code, as adopted in part 7511.0090.

#### 7511.0705 SECTION 705, SEPARATION OF OCCUPANCIES AND HAZARDOUS AREAS.

IFC Chapter 7 is amended by adding a section to read:

#### SECTION 705

#### SEPARATION OF OCCUPANCIES AND HAZARDOUS AREAS

**705.2 Occupancy separations.** Occupancy separations shall be provided in buildings containing Group I and Group R occupancies as specified in Sections 705.2.1 through 705.2.3. These separations shall be constructed and maintained in accordance with the Building Code. Existing wood lath and plaster in good condition or 1/2-inch (12.7 mm) gypsum wallboard may be is acceptable where one-hour occupancy separations are required.

#### 7511.0903 SECTION 903, AUTOMATIC SPRINKLER SYSTEMS.

Subp. 2. IFC Section 903.2.12.1. IFC Section 903.2.12.1 is amended to read:

**903.2.12.1 Fire protection for exhaust systems.** Any portion of an exhaust system utilizing combustible components or having the potential for combustible residue build-up on the inside or where required by other sections of this code, where the duct cross-sectional area is greater than or equal to 75 square inches (480 cm<sup>2</sup>), shall be provided with an automatic extinguishing system within the duct and at the duct intake, hood, enclosure or canopy, or shall be constructed of material listed for use without sprinkler protection. When sprinkler protection is installed, means shall be provided to prevent water accumulation in the duct or <u>the</u> flow of water back to a process <del>subject that could be damaged by water</del> where the application of water constitutes a serious life or fire hazard.

#### 7511.1015 SECTION 1015, EXIT AND EXIT ACCESS DOORWAYS.

IFC Section 1015.1 is amended to read:

**1015.1 Exit or exit access doorways required.** Two exits or exit access doorways from any space shall be provided where one of the following conditions exists:

 The occupant load of the space exceeds the values in Table 1015.1.
 Exception: In Groups R-2 and R-3 occupancies, one means of egress is permitted within and from individual dwelling units with a maximum occupant load of 16 if the dwelling unit is equipped throughout with an automatic sprinkler system in accordance with Section 903.3.1.1 or 903.3.1.2.

#### 7511.1027 SECTION 1027, MEANS OF EGRESS FOR EXISTING BUILDINGS.

IFC Section 1027 is deleted in its entirety and replaced with the following:

## **Adopted Rules**<sup>1</sup>

#### SECTION 1027

#### MEANS OF EGRESS FOR EXISTING BUILDINGS

**1027.17 Corridors.** Corridors and the openings therein shall provide an effective barrier to resist the movement of smoke. Corridors, common path of travel, and travel distance shall comply with Sections 1027.17.1 through 1027.17.6. Corridors complying with Section 1017.1 need not be fire-resistance rated.

**1027.17.1 Construction.** Corridors shall be fireresistance rated in accordance with this section and Table 1027.17.1. Existing walls surfaced with wood lath and plaster in good condition or 1/2-inch gypsum wallboard are <u>permitted acceptable</u> for corridor walls and ceilings. Where Table 1027.17.1 allows a sprinkler system in lieu of fire-resistance-rated construction, the building shall be protected throughout with an automatic sprinkler system in accordance with Section 903.3.1.1 or 903.3.1.2 (where allowed).

**1027.17.4 Dead ends.** Where more than one exit or exit access doorway is required, the exit access shall be arranged such that dead ends do not exceed the limits specified in Sections 1027.17.4.1 through 1027.17.4.2 and Table 1027.17.4.

**1027.17.4.2 Existing Group E corridors.** In Group E occupancies constructed prior to October 3, 1975, dead ends of up to 35 feet (10 668 mm) in length are allowed, provided the building is protected with an approved automatic sprinkler system throughout.

#### 7510.3401 7511.3401 SECTION 3401, GENERAL.

**EFFECTIVE DATE.** These amendments are effective May 31, 2007, or five working days after publication of the notice of adoption, whichever is later.

# **Expedited Emergency Rules**

Provisions exist for the Commissioners of some state agencies to adopt expedited emergency rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Expedited emergency rules are effective upon publication in the State Register, and may be effective up to seven days before publication under certain emergency conditions.

Expedited emergency rules are effective for the period stated or up to 18 months. Specific *Minnesota Statute* citations accompanying these expedited emergency rules detail the agency's rulemaking authority.

# Department of Natural Resources

## Adopted Expedited Emergency Game and Fish Rules: 2007 Bear Season and Permit Procedures

**NOTICE IS HEREBY GIVEN** that the above entitled rules have been adopted through the process prescribed by *Minnesota Statutes*, section 84.027, subdivision 13 (b). The statutory authority for the contents of the rule is *Minnesota Statutes*, sections 97B.405 and 97B.411.

The emergency conditions that do not allow compliance with *Minnesota Statutes*, sections 97A.0451 to 97A.0459, are that population and harvest data needed prior to setting quotas and bag limits are not available until February, and applications for licenses are accepted beginning in late March and the application deadline is the first Friday in May. Quota numbers and bag limits are necessary so that harvests and populations can be managed and to allow applicants to evaluate where they want to apply.

#### 6232.2800 GENERAL REGULATIONS FOR TAKING BEARS.

Subpart 1. **Bag limit.** A person may not take more than one bear <u>in quota areas and two bears in no-quota areas</u> during any calendar year whether by firearm or archery. Bears taken may be of either sex or any age except that bear cubs may not be taken.

### 6232.2900 BEAR PERMIT PROCEDURES.

[For text of subpart 1, see M.R.]

Subp. 2. **Drawings.** Drawings will be conducted by the department to determine those eligible to purchase a bear license within the bear quota areas. Preference in the drawings will be given to applicants based upon the number of times they have correctly applied for a license in a quota area in previous years but have not been selected or the number of times they have correctly applied in the preference only area in previous years but have not been selected. Upon issuance of a quota area license, all accumulated preference will be lost. Obtaining a no-quota bear license will have no effect upon eligibility or preference in the drawings. In quota areas with fewer applicants than available licenses, the remaining available licenses may be first offered to unsuccessful applicants for other quota areas on a first-come, first-served basis beginning at 12:00 p.m. on the first Monday in August. To obtain a remaining available license, an eligible person must apply individually and in person at an electronic license system agent location or individually through the ELS-Internet or ELS-Telephone system. Any remaining available licenses not purchased by unsuccessful applicants may then be issued to any eligible person as prescribed by the commissioner on a first-come, first-served basis beginning at 12:00 p.m. on the second Monday in August. Individuals who purchase these remaining available licenses will retain their accumulated preference.

## Public Notice Regarding Proposed Payment Rate Changes For Hospitals, Nursing Facilities and Intermediate Care Facilities for Persons with Mental Retardation (ICFs/MR) Participating in the Medical Assistance Program

**NOTICE IS HEREBY GIVEN** to recipients, providers of services under the Medical Assistance Program, and to the public, of proposed payment rate changes for hospitals, nursing facilities and intermediate care facilities for persons with mental retardation (ICFs/ MR) participating in the Medical Assistance Program.

This notice is published pursuant to 42 *United States Code* §1396a(a)(13)(A) (§1902(a)(13)(A) of the Social Security Act), which requires the Department to publish proposed facility payment rates, the methodologies underlying the establishment of such rates, and the justification for such rates. It is also published pursuant to *Code of Federal Regulations*, title 42, part 447, section 205 (42 CFR §447.205), which requires publication of a notice when there is a proposed rate change in the methods and standards for setting payment rates for Medical Assistance services.

The Department is notifying interested parties that the Governor's biennial budget for State Fiscal Years 2008 and 2009 contains the following proposed changes to inpatient hospital, nursing facilities and intermediate care facilities for persons with mental retardation (ICFs/MR) payment rates.

Current law at *Minnesota Statutes* §256.969, subd. 9(f), provides that General Assistance Medical Care hospital payments will be considered a Medicaid disproportionate share payment to the extent of federal aggregate and hospital specific disproportionate share limits through June 30, 2007. The budget proposal would repeal the June 30, 2007 sunset, in order to continue this after June 30, 2007.

Beginning June 1, 2007, Hennepin County Medical Center would report quarterly to the commissioner, payments made during the second previous quarter that may qualify for disproportionate share hospital payments. The reporting requirements for payments as described at *Minnesota Statutes* §256B.199, made by Regions Hospital, and Fairview University Medical Center are eliminated.

Pursuant to *Minnesota Statutes* §256.969, subd. 9 (f), effective June 1, 2007, and upon federal approval, the SFY 2006 uncompensated care cost expenditures of Hennepin County Medical Center will be considered Medicaid disproportionate share payments.

Effective July 1, 2007, quarterly payment adjustments of 13, 10 and 4 percent ,which are based on hospitals Medicaid inpatient utilization rates, and the 4 percent offsetting reduction, as described at *Minnesota Statutes* §256.969 subdivision 27,-are repealed.

Effective July 1, 2007 and upon federal approval, the fee-for-service portion of the Medical Education and Research Committee (MERC) Trust Fund payments described at *Minnesota Statutes* §62J.692 will be distributed to teaching sites based on each site's proportion of Medicaid payments in relation to total Medicaid payments to all teaching sites.

On January 18, 2007 the United States Department of Health and Human Services, Centers for Medicare & Medicaid Services published a notice of proposed rulemaking that outlined several changes to the treatment of payments to providers that are owned and operated by units of government. One of the provisions of the proposed rule would limit annual Medicaid payments to public providers to their actual costs for providing Medicaid services. The proposed effective date for this provision is September 1, 2007. In order to ensure that Minnesota is able comply with the cost limit provision should the rule go into effect, the Governor's Budget includes the following recommendation.

Effective July 1, 2007 and contingent upon promulgation of federal regulations regarding payments to public providers, the Department is authorized to:

- · Require providers that are units of government to report costs in a format determined by the Department;
- · Limit annual payments to each Medicaid provider that is a unit of government to their Medicaid costs; and
- · Discontinue certain transfers and certification of funds if federal funds become unavailable for that purpose.

The net effect of the proposed payment inpatient hospital rate changes would be a decrease in state Medical Assistance inpatient expenditures of \$3,183,000 for State Fiscal Year 2008 and \$11,211,000 for State Fiscal Year 2009.

The budget proposes to increase ICF/MR payment rates by 2%, effective October 1, 2007 and 2% effective July 1, 2008.

The net effect of the proposed ICF/MR rate changes would be an increase in state Medical Assistance expenditures for ICF/MR services. The state general fund cost increase is projected to be \$888,000 in State Fiscal Year 2008; \$2,455,000 in State Fiscal Year 2009; \$2,437,000 in State Fiscal Year 2010; and \$2,310,000 in State Fiscal Year 2011.

The budget proposes to increase nursing facility payment rates by:

• 1.5% effective October 1, 2007 and 1.5% effective October 1, 2008;

• an additional amount based on each facility's performance. These performance-based payment rate increases would average 0.5% each year of the biennium and would be effective October 1, 2007 and October 1, 2008;

• an additional \$200,000, state share, effective October 1, 2008 to provide additional funding to pay for increased county long-term care consultation costs.

The net effect of the proposed nursing facility rate changes would be an increase in state Medical Assistance expenditures for nursing facility services. The state general fund cost increase is projected to be \$5,554,000 in State Fiscal Year 2008; \$14,084,000 in State Fiscal Year 2009; \$16,789,000 in State Fiscal Year 2010; and \$16,787,000 in State Fiscal Year 2011.

## Notice of Proposed Classification of State Forest Lands in Crow Wing County with Respect to Motor Vehicle Use

**NOTICE IS HEREBY GIVEN** that the Commissioner of the Minnesota Department of Natural Resources (DNR) proposes to classify state forest lands in Crow Wing County with respect to operation of motor vehicles. The proposal is to classify most state forest lands under the authority of the Commissioner that are located in Crow Wing County to one of the following classes:

1. "Limited" in which forest roads are open to motor vehicle use unless posted closed and forest trails are closed to motor vehicle use unless posted open, or

2. "*Closed*" in which forest roads are open to motor vehicles licensed for highway use. No OHVs are permitted, except that OHVs may operate on frozen public waters. Snowmobiles may operate on designated trails.

Minnesota Laws 2003, Chapter 128, Article 1, Section 167 as amended and Minnesota Rules Chapter 6100.1950 govern the classification of state forests with respect to motor vehicle use.

The proposal covers the Crow Wing State Forest, the Emily State Forest, and other forest lands under the authority of the Commissioner located outside of state forest boundaries in Crow Wing County. The proposal does not cover the portion of the Land O' Lakes State Forest located in Crow Wing County. In total, about 25,000 acres of land will be classified with respect to motor vehicle use.

In conjunction with the proposed motor vehicle use classification the DNR has developed a plan that identifies which roads and trails on state forest lands in Crow Wing County will be open to use by various types of motor vehicles. **NOTICE IS HEREBY GIVEN** that the Commissioner of the Minnesota Department of Natural Resources (DNR) proposes to classify all State Forest Lands within Southern St. Louis County, including lands within the Cloquet Valley State Forest, and state forest lands in Carlton County, with respect to motor vehicle operation. The proposal is to assign all state lands lands under the authority of the Commissioner, to one of the following classes: (pursuant to *MN Rules Chapter 6100.1950*).

1. "Managed", in which forest roads and trails are open for motor vehicle use unless posted closed;

2. "Limited", in which forest roads are open to motor vehicle use unless posted closed, and forest trails are closed to motor vehicle use unless posted open, or

3. "Closed", in which forest roads are open only to motor vehicles licensed for highway use. No off-highway vehicles are permitted, except for operation on frozen public waters. Snowmobiles may operate on designated trails only in closed forests.

This proposal covers the Cloquet Valley State Forest, and scattered forest lands under the authority of the Commissioner located *OUTSIDE* of State Forest boundaries in both Southern St. Louis and Carlton Counties. In total, just over 144,000 acres of state forest land, and 300 miles of roads, trails and non-designated routes were evaluated with respect to motor vehicle use. In conjunction with the proposed classification, the DNR has developed a road and trail designation proposal that identifies those routes on state forest lands that will remain open to motorized vehicle use.

The DNR will hold *TWO* public meetings on this proposal, the first on Wednesday June 20 at the Cotton Community Center located approximately 30 miles north of Duluth near the intersection of Arkola Road and Highway 53 (west frontage road) in Cotton, and the second on Thursday, June 21 at the Rice Lake Town Hall located at 4107 West Beyer Road in Duluth. Both meetings will run from 6:00 p.m. to 8:30 p.m.

The first hour of each meeting will allow people to informally review the plan, maps and other summary materials. DNR and St. Louis County Land Department representatives will be on hand to answer questions regarding motorized access planning for public forest lands in the county. During the remainder of the meeting, the DNR will present its proposal and respond to questions and comments. Written comments will also be accepted.
