Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Comments on Planned Rules or Rule Amendments. An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, and within 60 days of the effective date of any new statutory grant of required rulemaking

Rules to be Adopted After a Hearing. After receiving comments and deciding to hold a public hearing on the rule, an agency drafts its rule. It then publishes its rules with a notice of hearing. All persons wishing to make a statement must register at the hearing. Anyone who wishes to submit written comments may do so at the hearing, or within five working days of the close of the hearing. Administrative law judges may, during the hearing, extend the period for receiving comments up to 20 calendar days. For five business days after the submission period the agency and interested persons may respond to any new information submitted during the written submission period and the record then is closed. The administrative law judge prepares a report within 30 days, stating findings of fact, conclusions and recommendations. After receiving the report, the agency decides whether to adopt, withdraw or modify the proposed rule based on consideration of the comments made during the rule hearing procedure and the report of the administrative law judge. The agency must wait five days after receiving the report before taking any action.

Rules to be Adopted Without a Hearing. Pursuant to Minnesota Statutes § 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing. An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public. The agency then publishes a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the State Register. If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.14-14.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the State Register.

Department of Labor and Industry **Occupational Safety and Health Division** Proposed Exempt Permanent Rules Relating to Occupational Safety and Health; Standard Industrial Classification List for AWAIR

NOTICE IS HEREBY GIVEN that the Department of Labor and Industry, Occupational Safety and Health Division (Minnesota OSHA), proposes to adopt the following amendments to the Department of Labor and Industry, Occupational Safety and Health Rules. Statutory authority to adopt these amendments is in Minnesota Statutes §182.655.

This notice proposes the adoption of modification to Minnesota Rules 5205.0030 and Minnesota Rules 5207.0100 High Visibility Personal Protective Equipment; Minnesota Rules 5207.1000 Operation of Mobile Earth-Moving Equipment; Minnesota Rules 5207.0005 and Minnesota Rules 5208.1500 Standard Industrial Classification List for AWAIR. Please see "Summary of Changes" below.

All interested or affected persons have 30 days from the date this notice is published in the State Register to submit, in writing, data and views on the proposed amendments to the rule. Comments in support of or in opposition to the proposed amendments are encouraged. Each comment should identify the portion of the proposed amendment addressed, the reason for the comment, and any change proposed. Any person may file with the Commissioner written objections to the proposed amendments stating the grounds for those objections, and may request a public hearing. A public hearing will be held if 25 or more persons submit written requests for a public hearing on the proposed amendments within the 30-day comment period. Requests for hearing must include the name and address of the person

submitting the request, define the reasons for the request, and discuss any proposed changes. If a public hearing is required, the Department will proceed according to the provisions of *Minnesota Statutes* §182.655 and *Minnesota Rules* 5210.0020 to 5210.0100.

SUMMARY OF CHANGES

The following is a brief summary of the proposed changes. The complete text of the proposed revisions follows this summary.

Proposed changes to *Minnesota Rules* 5205.0030 and *Minnesota Rules* 5207.0100 High Visibility Personal Protective Equipment; *Minnesota Rules* 5207.1000 Operation of Mobile Earth-Moving Equipment. This proposal seeks to: 1) update the ANSI edition reference in the above-mentioned rules from 107-1999 to 107-2004; 2) make a non-substantive technical correction to an NFPA reference; and 2) delete past effective dates. The 2004 version of the ANSI standard has been expanded to stay in line with state-of-the-art in fabrics technology and design, and now provides users with documentation that a garment meets all the requirements of the standard. Also, product coverage now includes high-visibility headwear, and all reference to selection based on vehicle speeds has been removed, instead emphasizing garment selection based on the color and complexity of the work environment.

Proposed changes to *Minnesota Rules* 5207.0005 and *Minnesota Rules* 5208.1500 Standard Industrial Classification List for AWAIR. This proposal seeks to replace the current Standard Industrial Classification (SIC) list with an updated list using North American industrial classifications (NAICS).

"A Workplace Accident and Injury Reduction Act" (AWAIR) was passed by the Minnesota Legislature during the 1990 session (*Laws of Minnesota, 1990*, Chapter 508). The legislation amended the Occupational Safety and Health Act of 1973 (*Minnesota Statutes* Chapter 182) by adding new subdivisions 8, 9, and 10 to §182.653. Subdivision 8 requires that a covered employer establish a written work place accident and injury reduction program that promotes safe and healthful working conditions and is based on clearly stated goals and objectives for meeting those goals.

Subdivision 9 of §182.653 requires the Commissioner of Labor and Industry to adopt a list of standard industrial classifications (SIC) or North American industrial classifications (NAICS) of employers who must comply with subdivision 8, and the list must be updated every two years. The list must be based on the safety record or worker's compensation record of the industries. During 2003-2004, OSHA transitioned to using NAICS data, an industry grouping system. BLS data is now reported using NAICS data. During 2005, the Minnesota Legislature amended the statute to allow the list to be compiled using North American Industry Classification System (NAICS) data. Therefore, this proposal seeks to update the language in the rules to follow the statute, and replace the current list of SICs with a new list based on NAICS data. Employers within the NAICS classifications on the list must comply with subdivision 8 within six months following the date the NAICS classification that applies to them is placed on the adopted list.

To meet the mandate of §182.653, subdivision 9, Minnesota and national injury and illness statistics were reviewed. The proposed revisions to the list are based on the "Minnesota Occupational Injuries and Illnesses Survey, 2004" which was conducted by the Minnesota Department of Labor and Industry in cooperation with the Bureau of Labor Statistics (BLS).

The survey results are reported as occupational injuries and illnesses incidence rates by industry (NAICS). For all industries combined, the 2004 Minnesota survey results indicate an injury and illness incidence rate (recordable injuries and illnesses per 100 full-time workers) of 5.3 and a lost workday incidence rate (lost workday cases per 100 full-time workers) of 2.6. These rates reflect the combined or "average" rates for all reporting industries, including state and local government. Those industries (NAICS) with an incidence rate higher than 5.3 or a severity rate higher than 2.6 are considered to have a higher-than-average rate of injuries and illnesses and, therefore, are required to comply with the AWAIR Act.

Proposed amendments to M.R. 5208.1500 include deleting the current SIC list and replacing it with a NAICS listing for industries with an incidence rate at or above 5.3 or a severity rate at or above 2.6 on the 2004 Minnesota survey. To view the correspondence tables matching 1987 SICs to 2002 NAICS, visit the U.S. Census Bureau's website at: http://www.census.gov/epcd/naics02/S87TON02.HTM. Classifications that are not on the proposed list may be added to the list in two years if the incidence or severity rates for the industry go above the Minnesota average rates for that year. Updates to this list will be based on the most current injury and illness data available at the time of the update.

The inclusion of a North American Industry Classification Code on the AWAIR list is determined strictly on the basis of BLS reported data for the industry; jurisdictional issues are not considered when adding or deleting an industry from the list. However, Minnesota OSHA does observe jurisdictional boundaries when conducting inspections and will enforce AWAIR only in those areas of an operation that fall within the jurisdiction of Minnesota OSHA. Operations under the sole jurisdiction of another government regulatory agency will not be affected.

5205.0030 HIGH VISIBILITY PERSONAL PROTECTIVE EQUIPMENT.

Subpart 1. General requirement. Each employee, other than police and fire protection personnel covered by subpart 3, exposed to or working adjacent to moving motor vehicle traffic as part of the employee's assigned job shall be provided with and required to wear a high visibility warning vest or other high visibility garment. A high visibility garment is defined as being a <u>Performance</u> Class 2 garment or greater as specified by ANSI/ISEA Standard 107-1999 <u>107-2004</u>. Executive Orders

Office of the Governor Executive Order # 06-09: Providing for Creation of a Methamphetamine Offender Registry

I, TIM PAWLENTY, GOVERNOR OF THE STATE OF MINNESOTA, by virtue of the authority vested in me by the Constitution and the applicable statutes, do hereby issue this Executive Order:

WHEREAS, methamphetamine is one of the most addictive and dangerous drugs available; and

WHEREAS, methamphetamine manufacturing, trafficking and use have become a national and state scourge with more counties reporting methamphetamine as the number one drug problem, than counties listing cocaine, marijuana, and heroin combined; and

WHEREAS, methamphetamine can cause dangerous health conditions including increased heart rate and blood pressure, strokes, respiratory problems, irregular heartbeat, extreme anorexia, permanent dental damage, cardiovascular collapse and death, as well as paranoia, delusions and violent behavior; and

WHEREAS, the chemicals used in manufacturing methamphetamine are also extremely dangerous and toxic, causing significant harm to people and the environment; and

WHEREAS, children and other members of society are often unwittingly exposed to the extremely dangerous and toxic conditions caused by the production and use of methamphetamine; and

WHEREAS, methamphetamine has resulted in particularly high criminal, environmental and social costs and the dangers related to methamphetamine are not limited to the users and other criminal participants, but also to children, law enforcement personnel and other members of the community; and

WHEREAS, a centralized registry of persons convicted of manufacturing and/or selling methamphetamine would assist law enforcement; and

WHEREAS, a publicly-accessible registry of the most serious methamphetamine offenders, will provide citizens with useful information on persons convicted of manufacturing or selling methamphetamine in their communities and allow members of the public to better protect themselves and their communities; and

WHEREAS, public exposure of methamphetamine manufacturers and dealers is likely to have a deterrent effect on prospective manufacturers and sellers of this harmful and toxic drug.

NOW, THEREFORE, I hereby order that:

1. As of the effective date of this order, the Commissioner of Public Safety and the Chief Information Officer are directed to begin creating a Methamphetamine Offender Registry that identifies persons convicted in Minnesota for felony level crimes involving the manufacture or sale of methamphetamine.

2. The Commissioner of Public Safety and the Chief Information Officer will create the Methamphetamine Offender Registry using public criminal history data and other data that is classified as public data under state law and will include on the registry information regarding individuals convicted of felony level methamphetamine production or sale including, but not limited to, information regarding the identity of the person, the conviction, the arresting agency, the county of conviction, the sentence imposed and the status of the offender.

3. The Commissioner of Public Safety and Chief Information Officer will make the Methamphetamine Offender Registry available to the public at no cost by request and by internet based access. Access will be available to the public through a website maintained by the Department of Public Safety.

4. The Commissioner of Public Safety and Chief Information Officer will comply with the requirements of the Minnesota Data Practices Act and other applicable state law in relation to the data used to create, maintain and provide public access to the Methamphetamine Offender Registry.

5. The Commissioner of Public Safety and Chief Information Officer will report to the Governor on July 1, 2008 regarding the use and effectiveness of the database.

Office of the Governor Executive Order #06-10: Providing for Creation of the "QCare" Health Care Program

I, TIM PAWLENTY, GOVERNOR OF THE STATE OF MINNESOTA, by virtue of the authority vested in me by the Constitution and the applicable statutes, do hereby issue this Executive Order:

WHEREAS, the quality and cost of health care affects every Minnesota resident; and

WHEREAS, The Midwest Business Group on Health, one of the nation's leading coalitions of private and public employers, estimates that 30 percent of all direct health care expenditures are the result of care that is poor in quality; and

WHEREAS, the Institute of Medicine ("IOM") estimates that between 44,000 and 98,000 Americans – 700 to 1,600 Minnesotans - die each year from preventable medical errors in hospitals; and

WHEREAS, The New England Journal of Medicine published a study in which patients received only 55 percent of the care recommended for their respective health conditions; and

WHEREAS, diabetes in Minnesota costs \$2 billion in medical expenses, disability, and lost time on the job and the prevalence of diabetes in Minnesota has increased by nearly 50 percent over the past decade, yet only 6 percent of Minnesotans who are diagnosed with diabetes receive the optimal care for their condition; and

WHEREAS, purchasing health care based primarily on volume cost factors does not provide incentives to improve the quality of health care services provided; and

WHEREAS, QCare – Quality Care and Rewarding Excellence – is a new quality standard program that will be used by the State of Minnesota in its health care purchasing policies to reward top performing providers while saving millions of dollars in health care costs; and

WHEREAS, the QCare program implements quality of care standards, sets aggressive targets for health care providers, makes measures available to the public online, and changes the health care payment system to reward quality rather than quantity; and

WHEREAS, QCare will transform the way healthcare is purchased in Minnesota by shifting focus away from looking solely on the costs charged by providers to the quality of the care provided to patients; and

WHEREAS, improved quality in health care will help save lives, increase the quality of life for people living with chronic illness, and help to keep health care affordable.

NOW, THEREFORE, I hereby order that:

1. As of the effective date of this order, the Commissioner of Human Services and the Commissioner of Employee Relations are directed to adopt and apply the QCare standards and align payments and incentives for all state purchased health care.

2. To the extent permitted by law, the Commissioner of Human Services and the Commissioner of Employee Relations must apply QCare standard to all state purchased health care including, but not limited to, programs such as Medical Assistance, Minnesota Care, and Minnesota Advantage.

3. All future state contracts with health plans and health care providers must include new incentives and requirements for greater reporting of costs and quality of care delivered based on the QCare standard. In addition, these contracts must contain incentives and requirements for meeting targets and goals, for improvements in key areas, and for greater overall accountability for results.

Executive Orders

4. Where applicable, a waiver will be sought from federal agencies to allow QCare standards and incentives to be included in any contract with health plans and health care providers for state purchased health care services.

5. The Commissioner of Human Services and the Commissioner of Employee Relations will report to the Governor prior to agreement in principle regarding any state purchased health care to ensure that QCare standards are included, as appropriate, in any such agreement.
