# Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. # **Proposed Rules**

Comments on Planned Rules or Rule Amendments. An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, and within 60 days of the effective date of any new statutory grant of required rulemaking.

Rules to be Adopted After a Hearing. After receiving comments and deciding to hold a public hearing on the rule, an agency drafts its rule. It then publishes its rules with a notice of hearing. All persons wishing to make a statement must register at the hearing. Anyone who wishes to submit written comments may do so at the hearing, or within five working days of the close of the hearing. Administrative law judges may, during the hearing, extend the period for receiving comments up to 20 calendar days. For five business days after the submission period the agency and interested persons may respond to any new information submitted during the written submission period and the record then is closed. The administrative law judge prepares a report within 30 days, stating findings of fact, conclusions and recommendations. After receiving the report, the agency decides whether to adopt, withdraw or modify the proposed rule based on consideration of the comments made during the rule hearing procedure and the report of the administrative law judge. The agency must wait five days after receiving the report before taking any action.

Rules to be Adopted Without a Hearing. Pursuant to *Minnesota Statutes* § 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing. An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public. The agency then publishes a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the *State Register*. If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.14-14.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the *State Register*.

Proposed Amendment to Rules Governing the Minnesota Commercial Energy Code, *Minnesota Rules*, [Proposed] Chapter 1323; and Repeal of *Minnesota Rules*, Chapters 7676 and 7678

DUAL NOTICE: Notice of Intent to Adopt Rules Without a Public Hearing Unless 25 or More Persons Request a Hearing, And Notice of Hearing If 25 or More Requests For Hearing Are Received

**Introduction.** The Department of Labor and Industry intends to adopt rules without a public hearing following the procedures set forth in the rules of the Office of Administrative Hearings, *Minnesota Rules*, parts 1400.2300 to 1400.2310, and the Administrative Procedure Act, *Minnesota Statutes*, sections 14.22 to 14.28. If, however, 25 or more persons submit a written request for a hearing on the rules by 4:30 p.m. on August 6, 2008, a public hearing will be held in the Minnesota Room, Department of Labor and Industry, 443 Lafayette Road North, St. Paul, Minnesota 55155, starting at 9:30 a.m. on Monday, September 29, 2008. To find out whether the rules will be adopted without a hearing or if the hearing will be held, you should contact the agency contact person after August 6, 2008 and before September 29, 2008.

**Agency Contact Person.** Comments or questions on the rules and written requests for a public hearing on the rules must be submitted to the Department contact person. **Subject of Rules and Statutory Authority.** The proposed rules are about regulating energy efficiency for the design and construction of new and remodeled commercial structures regulated by *Minnesota Rules*, chapter 1305. The proposed rules are also about energy efficiency for the design and construction of new and remodeled residential buildings regulated by *Minnesota Rules*, chapter 1309, which are four or more stories in height, contain shared conditioned common space between dwellings, or where each dwelling unit contains a shared means of egress.

The proposed rules incorporate the ANSI/ASHRAE/IESNA Standard 90.1-2004, version PC 1.06, which is promulgated by the American Society of Heating, Refrigerating and Air-Conditioning Engineers, Inc., as amended. The proposed rules include general definitions; building envelope requirements; heating, ventilating, and air-conditioning requirements; service water heating requirements; building power and lighting requirements; and an energy cost budget alternative method.

# Proposed Rules =

The proposed rules are intended to replace *Minnesota Rules*, Chapters 7676 and 7678, which have comprised the commercial portions of Minnesota's energy code since July 1999 and are repealed by the proposed rules. The proposed rules also update the appliance and equipment efficiencies to reflect applicable federal regulations that are currently embodied in Chapter 7678.

The statutory authority to adopt the rules is *Minnesota Statutes*, sections 16B.59, 16B.61, 16B.64, and 326B.02.

By August 15, 2006 letter, Chief Administrative Law Judge Raymond R. Krause waived the requirement that the proposed rules be published in the *State Register*. A free copy of the rules is available upon request from the agency contact person listed above.

**Comments.** You have until 4:30 p.m. on Wednesday, August 6, 2008, to submit written comment in support of or in opposition to the proposed rules or any part or subpart of the rules. Your comment must be in writing and received by the Department contact person by the due date. Comment is encouraged. Your comments should identify the portion of the proposed rules addressed, the reason for the comment, and any change proposed. You are encouraged to propose any change desired. Any comments that you would like to make on the legality of the proposed rules must also be made during this comment period.

Request for a Hearing. In addition to submitting comments, you may also request that a hearing be held on the rules. Your request for a public hearing must be in writing and must be received by the Department contact person by 4:30 p.m. on Wednesday, August 6, 2008. Your written request for a public hearing must include your name and address. You must identify the portion of the proposed rules to which you object or state that you oppose the entire set of rules. Any request that does not comply with these requirements is not valid and cannot be counted by the Department when determining whether a public hearing must be held. You are also encouraged to state the reason for the request and any changes you want made to the proposed rules.

**Withdrawal of Requests.** If 25 or more persons submit a valid written request for a hearing, a public hearing will be held unless a sufficient number withdraw their requests in writing. If enough requests for hearing are withdrawn to reduce the number below 25, the Department must give written notice of this to all persons who requested a hearing, explain the actions the agency took to effect the withdrawal, and ask for written comments on this action. If a public hearing is required, the Department will follow the procedures in *Minnesota Statutes*, sections 14.131 to 14.20.

**Alternative Format/Accommodation.** Upon request, this Notice can be made available in an alternative format, such as large print, Braille, or cassette tape. To make such a request or if you need an accommodation to make this hearing accessible, please contact the Department contact person at the address or telephone number listed above.

**Modifications.** The proposed rules may be modified either as a result of public comment or as a result of the rule hearing process. Modifications must be supported by data and views submitted to the Department or presented at the hearing and the adopted rules may not be substantially different than these proposed rules, unless the procedure under *Minnesota Rules*, part 1400.2110, has been followed. If the proposed rules affect you in any way, you are encouraged to participate in the rulemaking process.

Cancellation of Hearing. The hearing scheduled for September 29, 2008, will be canceled if the Department does not receive requests from 25 or more persons that a hearing be held on the rules. If you requested a public hearing, the Department will notify you before the scheduled hearing whether or not the hearing will be held. You may also call the agency contact person at (651) 284-5217 after August 6, 2008, to find out whether the hearing will be held.

**Notice of Hearing.** If 25 or more persons submit valid written requests for a public hearing on the rules, a hearing will be held following the procedures in *Minnesota Statutes*, sections 14.131 to 14.20. The hearing will be held on the date and at the time and place listed above. The hearing will continue until all interested persons have been heard. Administrative Law Judge Beverly Jones Heydinger is assigned to conduct the hearing. Judge Heydinger can be reached at the Office of Administrative Hearings, P.O. Box 64620, St. Paul, Minnesota 55164-0620, telephone: (651) 361-7838, and fax: (651) 361-7841.

**Hearing Procedure.** If a hearing is held, you and all interested or affected persons, including representatives of associations or other interested groups, will have an opportunity to participate. You may present your views either orally at the hearing or in writing at any time before the close of the hearing record. All evidence presented should relate to the proposed rules. You may also submit written material to the Administrative Law Judge to be recorded in the hearing record for five working days after the public hearing ends. This fiveday comment period may be extended for a longer period not to exceed 20 calendar days if ordered by the Administrative Law Judge at the hearing. Following the comment period, there is a fiveworkingday rebuttal period during which the Department and any interested person

may respond in writing to any new information submitted. No additional evidence may be submitted during the fiveday rebuttal period. All comments and responses submitted to the Administrative Law Judge must be received at the Office of Administrative Hearings no later than 4:30 p.m. on the due date. All comments or responses received will be available for review at the Office of Administrative Hearings. This rule hearing procedure is governed by *Minnesota Rules*, parts 1400.2000 to 1400.2240, and *Minnesota Statutes*, sections 14.131 to 14.20. Questions about procedure may be directed to the Administrative Law Judge.

The Department requests that any person submitting written views or data to the Administrative Law Judge prior to the hearing or during the comment or rebuttal period also submit a copy of the written views or data to the Department contact person at the address stated above.

**Statement of Need and Reasonableness.** A statement of need and reasonableness is now available from the Department contact person. This statement contains a summary of the justification for the proposed rules, including a description of who will be affected by the proposed rules and an estimate of the probable cost of the proposed rules. The statement may also be reviewed and copies obtained at the cost of reproduction from the Department.

**Lobbyist Registration.** *Minnesota Statutes*, chapter 10A, requires each lobbyist to register with the State Campaign Finance and Public Disclosure Board. You may ask to be notified of the date the rules are submitted to the office. If you want to be so notified, or want to receive a copy of the adopted rules, or want to register with the Department to receive notice of future rule proceedings, submit your request to the Department contact person listed above.

Adoption Procedure After a Hearing. If a hearing is held, after the close of the hearing record, the Administrative Law Judge will issue a report on the proposed rules. You may ask to be notified of the date when the Administrative Law Judge's report will become available, and can make this request at the hearing or in writing to the Administrative Law Judge. You may also ask to be notified of the date on which the Department adopts the rules and the rules are filed with the Secretary of State, and can make this request at the hearing or in writing to the Department contact person stated above.

#### **Adopted Permanent Rules Relating to Horse Racing**

The rules proposed and published at *State Register*, Volume 32, Number 33, pages 1511-1522, February 11, 2008 (32 SR 1511), are adopted with the following modifications:

#### 7871.0080 TIP SHEETS.

Subpart 1. **Number of tip sheets.** Should the licensee elect to allow the availability of tip sheets, at least one independently handicapped tip sheets shall be available at a racetrack. Each handicapper must sign and deliver the sheet at least one hour before post time for the first race to the presiding official at the licensee's racetrack.

#### 7873.0240 TIP SHEETS.

Subpart 1. **Number of tip sheets.** At least one independently handicapped tip sheets shall be available at a racetrack. Each handicapper must sign and deliver the sheet at least one hour before post time for the first race to a commission representative at the racetrack.

#### **7875.0100 FACILITIES.**

#### Subp. 6. Jockey's room and driver's rooms.

A. The use of <u>public</u>, <u>portable</u>, <u>or cellular telephones</u>, <u>or transmitters</u>, <u>or other</u> electronic communications devices<del>, including but not limited to cellular telephones</del>, is prohibited in the jockey's and driver's room for one-half hour prior to the first post and until the last race is official.

#### 7875.0200 EQUIPMENT.

Subp. 9. **External communications.** An association may have telephone systems on the premises during a race meeting for the benefit of the public, the press, or for transacting ordinary business.

No information regarding the results of any race shall be transmitted out of the racetrack until the results are official except for races that are broadcast or televised live. Under no circumstances shall any message be sent over said wires systems transmitting money, or other

things of value, or directing the placing of any wager on the result of a race.

The use of public or portable telephones, transmitters, electronic communications devices, or any other instrument that can be used for transmitting or receiving messages off the grounds to transmit wagering information of any kind is strictly prohibited. Anyone deemed to have used such an instrument to transmit or receive wagering information is subject to ejection and the equipment is subject to confiscation. No telephone calls or messages of any kind for any person attending or participating in the conduct of a race meeting shall be accepted, nor shall any notice be given pertaining to such message or telephone call during the hours indicated unless permission is first given by the stewards or the authorized representative of the commission.

A telephone on a private line shall be provided in the offices of the commission. All costs of the telephone service shall be borne by the association and the service shall not be interrupted at any time. At the request of the commission, TDD devices shall be installed on all commission telephones at the track, and costs associated with the devices shall be borne by the association.

At least one of the public telephones allowed at an association shall be equipped with a TDD device.

#### 7877.0170 DUTIES AND RESPONSIBILITIES OF CLASS C LICENSEES.

Subp. 4. **Drivers.** In every race a driver shall drive so as to win or to finish as near as possible to first. The driver shall not ease a horse without adequate cause, even if the horse has no apparent chance to earn a portion of the purse.

Each driver shall make a best effort to control and guide the horse in such a way so as not to endanger other drivers or horses, and so as not to cause a foul.

A driver shall fulfill a commitment to drive, unless excused by the stewards. A driver unable to fulfill a commitment because of illness or injury must pass a physical examination before resuming race driving.

Each driver shall wear the traditional driver's costume in any prerace pre-race warm-up, post parade, race, or time trial. The costume shall consist of racing colors, white pants, and a fully padded fiberglass helmet buckled whenever the driver is in a sulky.

A driver reporting to the driver's room must remain there until the driver has fulfilled all of that day's driving engagements. While in the performance of the driver's duties, the driver must have no contact or communication with any person outside the driver's room, without the permission of the stewards, other than with an owner or trainer for whom the driver is driving that day, or other commission officials.

#### 7877.0180 CONFLICTS.

Subpart 1. **Racing officials.** No racing official, other than a general manager, shall own any interest in a privately held Minnesota racetrack at which the person is serving as an official. In the case of a publicly held corporation, no racing official, other than a general manager, shall own more than five percent of the outstanding shares of stock. No racing official shall:

D. buy or sell for another person any right to a contract of any jockey, apprentice jockey, or, in the case of standardbred racing, as of a driver riding or driving at a meeting at which the racing official serves;

E. be permitted to compete as a jockey or, in the case of standardbred racing, as of a driver, in any race at a licensed racetrack in Minnesota during the term of the racing official's employment;

#### 7883.0100 ENTRIES AND SUBSCRIPTIONS.

Subp. 7. **Coupled entries.** Except in stakes races and races which are conditioned for horses eligible for specified stakes, not more than two horses of the same licensed ownership or interest shall be entered and started in a race.

B. <u>All horses owned wholly or in part by the same person, or his or her spouse, shall be coupled and run as an entry.</u> The association may uncouple entries on any race with the permission of the stewards.

#### **7890.0100DEFINITIONS.**

Subp. 13. **Medication.** "Medication" is a substance, compound, or element, or combination thereof, which is or can be administered to a horse for the purpose of preventing, curing, or alleviating the effects of any disease, condition, ailment, or infirmity, or symptom thereof, or for altering in any way the behavior, attitude, temperament, or performance of a horse, including athletic performance. The term medication includes all analgesics, anesthetics, depressants, narcotics, stimulants, tranquilizers, and other classifications of medications. Nothing herein shall be deemed to include:

B. Furosemide, provided, however, that it is administered pursuant to the provisions of part 7890.0140, subpart 7a, and further provided that: the specific gravity of the <u>postrace post-race</u> urine sample is not below 1.010 or, if the specific gravity is below 1.010 or a urine sample is unavailable for testing, the concentration of Furosemide must not exceed 100 nanograms per milliliter of serum or plasma in the <u>postrace post-race</u> blood sample.

#### 7890.0110 MEDICATIONS AND PRACTICES PROHIBITED.

Subpart 1. **Administration.** No person shall administer or cause to be administered to a horse within 48 hours of a race in which it is scheduled to run any medication (except as permitted by part 7890.0100, subpart 13, items A to D) by injection, oral or topical

administration, rectal infusion or suppository, or by inhalation and no horse participating in a race shall carry in its body any substance foreign to the natural horse, except as permitted by part 7890.0100, subpart 13, items A to D. Postrace Post-race samples of plasma, serum, or urine must not contain any substances, drugs, medications, or metabolites of substances, drugs, or medications not specifically permitted by commission rule or law.

- Subp. 5. **Presence.** The presence of more than one of the three approved NSAIDs or any unapproved NSAID in the postrace postrace serum, plasma, or urine sample is not permitted.
- Subp. 7. Use. The use of agents that elevate the horse's bicarbonate level, TCO<sub>2</sub>, or pH level above those existing naturally in the untreated horse at normal physiological concentrations is prohibited. The following also apply to TCO<sub>2</sub>:
  - C. The prerace pre-race or postrace post-race TCO, level in the blood shall not exceed 37 millimoles per liter of blood.

#### 7890.0130 FINDINGS OF CHEMIST.

Subpart 1. **Prima facie evidence.** A finding by a chemist of any medication or metabolite, substance foreign to the natural horse, or NSAIDs or furosemide exceeding the allowable test levels provided in part 7890.0100, subpart 13, item A, in the test sample of a horse shall be considered prima facie evidence that the medication, substance, NSAIDs or furosemide was administered to the horse prior to the race and carried in the body of the horse while participating in a race. Horses racing on NSAIDs or furosemide must show a detectable concentration of the drug or metabolites in the **postrace** post-race serum, plasma, or urine sample. A finding by a chemist of any venom or blood doping agent in the test sample of a horse shall be considered prima facie evidence that the venom or blood doping agent was administered to the horse prior to the race and carried in the body of the horse while participating in a race. A finding by a chemist of a level of TCO<sub>2</sub> greater than 37 millimoles per liter of blood in the test sample of a horse shall be considered prima facie evidence that an alkalinizing agent was administered to the horse prior to the race.

#### 7890.0140 BLEEDERS.

Subp. 7a. **Conditions required for furosemide administration.** Furosemide shall be administered intravenously by a veterinarian employed by the owner or trainer of the horse. The furosemide must be administered a minimum of four hours before scheduled post time for any bleeder entered to race and the dose level of furosemide must be no less than 150 milligrams and must not exceed 250 milligrams (no less than three nor more than five milliliters of a 50 milligram/milliliter or five percent solution) per administration, except in cases where the horse has been determined by the commission veterinarian and the treating veterinarian to be a severe bleeder. In these cases, doses of up to 500 milligrams (no more than ten milliliters of a 50 milligram/milliliter or five percent solution) may be permitted.

The practicing veterinarian must deposit with the commission veterinarian an unopened supply of furosemide and sterile hypodermic needles and syringes to be used for the administration. The furosemide must be administered under the supervision of a person employed by the commission.

A horse on the official furosemide list must show a detectable concentration of the drug in the postrace post-race serum, plasma, or urine sample.

REPEALER. Minnesota Rules, part 7883.0100 7883.0140, subparts 20 and 29, are repealed.

# **Expedited Emergency Rules**

Provisions exist for the Commissioners of some state agencies to adopt expedited emergency rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Expedited emergency rules are effective upon publication in the State Register, and may be effective up to seven days before publication under certain emergency conditions.

Expedited emergency rules are effective for the period stated or up to 18 months. Specific *Minnesota Statute* citations accompanying these expedited emergency rules detail the agency's rulemaking authority.

The statutory authority for the contents of the rule is *Minnesota Statutes*, sections 97A.434, 97A.435, 97B.711, 97B.716, and 97B.723.

The emergency conditions that do not allow compliance with *Minnesota Statutes*, sections 97A.0451 to 97A.0459, are that population and harvest data needed for setting quotas and areas are only available on an annual basis. Population and harvest data collected thorough prairie chicken registration is no longer necessary. Prairie chicken populations are stable and can be managed using data collected through annual mail surveys.

#### Request for Public Input on State Plan to Expand Community-Based System for Providing Mental Health Services for Adults with Serious Mental Illness and Children with Severe Emotional Disturbances

The Minnesota Department of Human Services (DHS) is seeking public comment into the update and implementation of the State plan for 2009 to expand the community-based system for providing mental health services for adults with serious mental illness and children with severe emotional disturbances.

As an ongoing process, the federal Secretary of the Department of Health and Human Services, through the Center for Mental Health Services, Substance Abuse and Mental Health Services Administration (SAMHSA), awards Block Grants to States to establish or expand this community-based system. DHS is required to submit a grant application that includes the State plan. The annual federal grant to Minnesota is currently about \$7 million. The funds are to be used to carry out the State plan contained in the application, to evaluate programs and services set in place under the plan, and to conduct planning, administration and educational activities related to the provision of services under the plan.

The key goals of the plan and the grant funding are:

- Access to a comprehensive system of care, including employment, housing, case management, rehabilitation, dental and health services, along with mental health services and supports;
  - · Participation of consumers/survivors and their families in planning and evaluation of state systems;
  - · Access for underserved populations, including homeless people and rural populations;
  - · Promoting recovery, resiliency for children, and community integration of people with psychiatric disabilities; and,
  - · Accountability through uniform reporting on access, quality, and outcomes of services.

- 1. Americans understand that mental health is essential to overall health;
- 2. Mental health care is consumer and family-driven;
- 3. Disparities in mental health services are eliminated;
- 4. Early mental health screening, assessment and referral are common practice;
- 5. Excellent mental health care is delivered and research is accelerated; and,
- 6. Technology is used to access mental health care and information.

**NOTICE IS HEREBY GIVEN** that the Commissioner of the Minnesota Department of Natural Resources (DNR) proposes to classify all State Forest Lands within Southern Minnesota, including lands within the Sand Dunes State Forest, Birch Lakes State Forest, Richard J. Dorer Memorial Hardwood State Forest and state forest lands in Benton, Dakota, Fillmore, Goodhue, Hennepin, Houston, Kandiyohi, Le Sueur, Martin, Meeker, Morrison, Nicollet, Olmsted, Rice, Sherburne, Sibley, Stearns, Wabasha, Winona, Yellow Medicine Counties, with respect to motor vehicle operation. The proposal is to assign all state lands under the authority of the Commissioner, to one of the following classes: (pursuant to *MN Rules Chapter 6100.1950*).

"Managed", in which forest roads and trails are open for motor vehicle use unless posted closed;

"Limited", in which forest roads are open to motor vehicle use unless posted closed, and forest trails are closed to motor vehicle use unless posted open, or

"Closed", in which forest roads are open only to motor vehicles licensed for highway use. No offhighway vehicles are permitted, except for operation on frozen public waters. Snowmobiles may operate on designated trails only in closed forests.

This proposal covers the Sand Dunes State Forest, Birch Lakes State Forest, Richard J. Dorer Memorial Hardwood State Forest, and scattered forest lands under the authority of the Commissioner located outside of State Forest boundaries in the Southern Minnesota Forest Access Planning Unit. In total, just over 59,000 acres of state forest land, and 384 miles of roads, trails and non-designated routes were evaluated with respect to motor vehicle use. In conjunction with the proposed classification, the DNR has developed a road and trail designation proposal that identifies those routes on state forest lands that will remain open to motorized vehicle use and those that will be designated for equestrian and mountain biking use.

The DNR will hold two public meetings on this proposal, the first on Wednesday, September 10, 2008 at the Sherburne County Government Center located at 13880 Highway 10, Elk River, MN 55330 and the second on Thursday, September 11, 2008 at the People's Co-op located at 3935 Highway 14 East, Rochester, MN 55904. Both meetings will run from 6:00 p.m. to 8:30 p.m.

The first hour of each meeting will allow people to informally review the plan, maps and other summary materials. DNR representatives will be on hand to answer questions regarding motorized and non-motorized access planning for public forest lands in the county. During the remainder of the meeting, the DNR will present its proposal and respond to questions and comments. Written comments will also be accepted.

## **Minnesota Pollution Control Agency**

Advanced Notice of Planned Rulemaking and Request for Comments on Planned Amendments to *Minnesota Rules*, Chapters 7001 and 7035, to Reduce Ground Water Risks and Financial Risks When Locating Solid Waste Land Management Units (Landfills) by Applying Improved Siting Criteria and Enhanced Financial Assurance

**Subject of Rules.** Pursuant to a May 2008 directive from the Minnesota Legislature (Legislature), the Minnesota Pollution Control Agency (Agency) requests comments on its planned amendment to rules to reduce ground water risks and financial risks when locating solid waste landfills. The Agency plans to address, in these rules, where solid waste landfills may be located based on geologic, hydrologic and other relevant physical site conditions (together called "intrinsic suitability"); other considerations relevant to risk management may include waste characteristics and site infrastructure. The Agency also will address financial assurance for solid waste landfills, as directed by the Legislature. Subject to further direction from the Legislature, the Agency plans to coordinate the following steps:

- The Agency will organize a work group (the Construction, Demolition and Industrial (CDI) Wastes Landfill Work Group) with the legislatively specified sector representation on July 14, 2008. This work group is to study the land disposal of CDI wastes and is to report its findings and recommendations to the Legislature by January 15, 2009 (see 2008 *Minn. Laws* ch. 363, art. 5, sec. 34).
- After January 15, 2009, the Agency expects the CDI Landfill Work Group to continue as a stakeholder/advisory work group advising the Agency on this related rulemaking. The Agency may augment membership of the work group at that time to support its revised role because the rule scope as defined by the Legislature includes solid wastes beyond the CDI categories.
- The Agency will draft rules regarding solid waste landfill siting and financial assurance to reduce risks to ground water (see 2008 *Minnesota Laws* ch. 363, art. 5, sec. 24).
- By January 15, 2010, the Agency must deliver a report to the Legislature "on proposed rules, under *Minnesota Statutes* § 116.07, subd. 4, to prohibit the disposal of solid waste in specific areas due to the sensitivity of the area to ground water contamination" (see 2008 *Minnesota Laws* ch. 363, art. 5, sec. 33).
- Following its January 15, 2010, rules report to the Legislature, the Agency plans to proceed to develop and propose rules consistent with the rules report.

**Persons Affected.** The amendment to the rules would likely affect all groups or citizens in Minnesota who utilize landfills or ground water, or that could be harmed by an improperly located or engineered landfill.

**Statutory Authority.** *Minnesota Statutes* § 116.07, subd. 4 authorizes the Agency to adopt rules relating to the disposal of solid waste. *Minnesota Statutes* § 115.03, subd. 1 authorizes the Agency to adopt or modify rules to prevent water pollution. *2008 Minnesota Laws* ch. 363, art. 5, sec. 33 and 34 also provide the Agency with authority for this planned rulemaking.

**Public Comment.** Interested persons or groups may submit comments or information on these planned rule amendments to the listed Agency contact until 4:30 p.m. on Thursday, January 15, 2009. In addition to this request, the Agency has established a page on its Web site, *www.pca.state.mn.us*, to provide further information about this possible rulemaking and to provide further information about the stakeholder process. Although you may submit comments to the Agency contact person at any time during this comment period, please also feel welcome to visit the Agency Web site for project updates.

The Agency invited mandated sectors and other interested parties to send representatives to participate in a preliminary organizational meeting of the CDI Landfill Work Group that will convene at the Agency on July 14, 2008. After that preliminary meeting, the Agency will name members of the work group, consistent with the sector participation mandated by the Legislature, and the work group will set up a schedule of further meetings.

With this request, the Agency is initiating the rulemaking process by seeking general comments and by seeking those parties who wish to receive future notification regarding this rule. When the stakeholder process has been completed, proposed rules will be drafted and
