Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Adopted Rules

A rule becomes effective after the requirements of *Minnesota Statutes* §§ 14.05-14.28 have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule. If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed. If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

Department of Education

Adopted Permanent Rules Relating to Graduation-Required Assessment for Diploma (GRAD)

The rules proposed and published at *State Register*, Volume 33, Number 3, pages 161-167, July 21, 2008 (33 SR 161), are adopted with the following modifications:

3501.1030 **DEFINITIONS.**

Subp. 13. **Test specifications design.** "Test specifications design" means statements of the requirements that tests must include and how tests are designed. The specifications These design documents define the required content, format, level of difficulty, types of items, and length of the tests.

3501.1120 REQUIRED NOTIFICATION TO PARENTS AND STUDENTS.

Subp. 3. **Notice of test results and remediation opportunities.** The district must provide written notice to parents and the student of GRAD results no later than 60 days after a student takes the district receives the results of a GRAD. After the date of receiving test results, students must have a minimum of six weeks for remediation before the next testing opportunity.

3501.1130 STUDENT RECORD KEEPING.

Subp. 2. **Student progress.** Individual student progress must be reported on a student record as described in items A and B this part.

A. "Pass-state level" or "PS" "Pass" or "p" must be noted on the record of a student who passes a GRAD under standard conditions or with an accommodation. The records for students passing with an accommodation must not differ from the records of students passing the test under standard conditions.

B: "Pass-individual level" or "Pt" "Pass" or "p" must also be noted on the record of a student who passes a GRAD with a modification established in the IEP or section 504 accommodation plan in accordance with part 3501.1190. This notation is also used as a GRAD notation for any other modified or alternate assessment used for accountability purposes for students with disabilities. The records for students passing with an accommodation or a modification or who pass an alternate assessment must not differ from the records of students passing the test under standard conditions.

3501.1180 STUDENTS IN UNIQUE SITUATIONS.

Subp. 2. **English language learners (ELL).** English language learners (ELL) who are public school students and are designated in the Minnesota Automated Reporting Student System (MARSS) as Limited English Proficiency (LEP) are not required to pass the GRAD for up to four years from their date of enrollment in any school in which the primary language of instruction is English if they have been enrolled in any Minnesota school for at least four consecutive years. An ELL student who <u>first</u> enrolls in a <u>Minnesota school in grade</u> 9 or above at or after the start of the academic year and who completes the course work and any other state and district requirements to graduate within a four-year period is not required to pass the GRAD.

Subp. 8. **Transfer students who passed a graduation examination in another state.** A district may submit a passing score report for a transfer student and a copy of the test specifications to the department will request test design documents from the other state for review. As graduation examinations from other states are submitted received, the department will maintain a list of states with acceptable substitute graduation examinations. The department will seek reciprocity for the GRAD in other states when it accepts their assessments.

Adopted Rules =

3501.1190 STUDENTS WITH IEP PLANS OR SECTION 504 ACCOMMODATION PLANS.

Subpart 1. Considerations for students with IEPs or section 504 accommodation plans. The individualized education program or section 504 accommodation plan for a student with a disability must identify one of the following decisions for each subject area of the GRAD:

A. the student is expected to achieve the statewide standard with or without testing accommodations, resulting in a <u>PS "pass" or "p"</u> notation on the record when achieving a passing score; or

B. the student is expected to achieve the statewide standard at an individually modified level of difficulty, resulting in a PI "pass" or "p" notation on the record when achieving the modified level. A Minnesota alternate assessment must be used when an IEP team chooses to replace the GRAD. Adoption of modifications for a student must occur concurrently with the adoption of transition goals and objectives as required by *Minnesota Statutes*, section 125A.08, paragraph (a), clause (1).

Department of Health

Adopted Permanent Rules Relating to Radiation Control

The rules proposed and published at *State Register*, Volume 33, Number 21, pages 909-911, November 24, 2008 (33 SR 909), are adopted as proposed.

Exempt rules are excluded from the normal rulemaking procedures (*Minnesota Statutes* §§ 14.386 and 14.388). They are most often of two kinds. One kind is specifically exempted by the Legislature from rulemaking procedures, but approved for form by the Revisor of Statutes, reviewed for legality by the Office of Administrative Hearings, and then published in the *State Register*. These exempt rules are effective for two years only.

The second kind of exempt rule is one adopted where an agency for good cause finds that the rulemaking provisions of *Minnesota Statutes*, Chapter 14 are unnecessary, impracticable, or contrary to the public interest. This exemption can be used only where the rules:

- (1) address a serious and immediate threat to the public health, safety, or welfare, or
- (2) comply with a court order or a requirement in federal law in a manner that does not allow for compliance with *Minnesota Statutes* Sections 14.14-14.28, or
 - (3) incorporate specific changes set forth in applicable statutes when no interpretation of law is required, or
 - (4) make changes that do not alter the sense, meaning, or effect of the rules.

These exempt rules are also reviewed for form by the Revisor of Statutes, for legality by the Office of Administrative Hearings and then published in the *State Register*. In addition, the Office of Administrative Hearings must determine whether the agency has provided adequate justification for the use of this exemption. Rules adopted under clauses (1) or (2) above are effective for two years only. The Legislature may also exempt an agency from the normal rulemaking procedures and establish other procedural and substantive requirements unique to that exemption.

Modification of Revenue Notice # 06-08: Sales and Use Tax – Motor Vehicle Leases – Taxes and Fee

Background

Leases or rentals of most passenger automobiles, vans, and pickup trucks to customers in Minnesota for periods of no more than 28 days are subject to the 6.5 percent state sales tax and an additional 6.2 percent motor vehicle rental tax. The transaction may also be subject to a 3.5 percent motor vehicle rental fee if the lessor does not meet a statutory exemption based upon sales activity in the previous calendar year. These leases may also be subject to a local sales tax if the vehicles are leased in a political subdivision with a local sales tax. This revenue notice sets forth the department's position on which amounts must be included in the tax base on which state and local sales taxes and the motor vehicle rental fee are computed.

Department Position

The taxes and fee on short-term vehicle leases and rentals are imposed upon the total amount of consideration paid by the customer to the lessor subject to any exclusions from the sales price as defined under *Minnesota Statutes*, section 297A.61, subdivision 7. When computing state and local sales taxes, the rental motor vehicle tax, and the 3 5 percent motor vehicle rental fee, the lessor would compute the taxes and fees on the same base amount for each transaction that is subject to taxation.

The sales price includes any charges by the lessor for goods or services that are necessary to complete the transaction. Any mandatory charges are part of the sales price when computing the taxes and fee. However, damage waiver fees and optional personal accident liability insurance are not part of the sales price.

The sales price also includes any taxes, charges, fees, or assessments that are legally imposed upon the lessor but that are passed on to the lessee, even when separately stated on the invoice or bill to the lessee. Any fees or charges, such as a facility usage fee or a franchise fee, that are imposed upon the lessor are part of the lessor's cost of doing business and are therefore part of the sales price. Examples of charges that are imposed upon the lessor are the Concession Recovery Fee and the Rental Auto Facility Charge imposed by the Metropolitan Airports Commission. Any taxes imposed directly on the lessee are excluded from the sales price if they are separately stated on the billing or invoice to the lessee.

Examples

A car rental firm leases a vehicle to a customer at its Minneapolis location. The lease is for a period of four days at the rate of \$30 per day. The total lease payment of \$120 would be subject to the 6.5 percent state sales tax, the 6.2 percent motor vehicle rental tax, the .15 percent Hennepin County tax, the .25 percent transit improvement tax, the 3 5 percent motor vehicle rental fee and the 0.5 percent Minneapolis city sales tax.

A car rental firm leases a vehicle to a customer at the Mpls.St.Paul airport for a day. The oneday rental rate is \$30. In addition to the daily rental charge there is a \$2 per day facility usage fee or Rental Auto Facility Charge and a Concession Recovery Fee of 9.5 percent which equals \$2.85. The total rental charge to the customer of \$34.85 is subject to the 6.5 percent state sales tax, the 6.2 percent motor vehicle rental tax, the .15 percent Hennepin County tax, the .25 percent transit improvement tax and the 3 5 percent motor vehicle rental fee.

Note should be made that the motor vehicle rental fee was increased from 3 to 5 percent effective July 1, 2008 and as of July 1, 2009, the 6.5 percent state sales tax rate will be increased to 6.875 percent.

Public Notice Regarding Proposed Payment Rate Changes For Hospitals, Nursing Facilities and Intermediate Care Facilities for Persons with Mental Retardation (ICFs/MR) Participating in the Medical Assistance Program

NOTICE IS HEREBY GIVEN to recipients, providers of services under the Medical Assistance Program, and to the public, of proposed payment rate changes for hospitals, nursing facilities and intermediate care facilities for persons with mental retardation (ICFs/MR) participating in the Medical Assistance Program.

This notice is published pursuant to 42 *United States Code* §1396a(a)(13)(A) (§1902(a)(13)(A) of the Social Security Act), which requires the Department to publish proposed facility payment rates, the methodologies underlying the establishment of such rates, and the justification for such rates. It is also published pursuant to *Code of Federal Regulations*, title 42, part 447, section 205 (42 CFR §447.205), which requires publication of a notice when there is a proposed rate change in the methods and standards for setting payment rates for Medical Assistance services.

The Department is notifying interested parties that the Governor's supplemental budget for State Fiscal Year 2010 contains the following proposed changes to inpatient hospital, nursing facilities and intermediate care facilities for persons with mental retardation (ICFs/MR) payment rates.

Effective July 1, 2009, Hennepin County Medical Center would report annually instead of quarterly the payments that may qualify for disproportionate share payments. The reporting requirements under *Minnesota Statutes* §256B.199, made by Regions Hospital, and Fairview University Medical Center would be eliminated.

Payments made by governmental entities under Minnesota Statutes §256B.195, would be annual instead of monthly.

Effective July 1, 2009, quarterly payment adjustments of 13, 10 and 4 percent which are based on hospitals' Medicaid inpatient utilization rates and the 4 percent offsetting reduction under *Minnesota Statutes* §256.969 subdivision 27, would be repealed.

Effective July 1, 2009, inpatient hospital rates would not be rebased to more current cost and utilization data for the first three months of the rebasing period beginning January 1, 2011. Rates would be rebased effective April 1, 2011.

Payments for inpatient hospital services that would otherwise be made in June 2010 would be delayed and made in July 2010 and payments that would otherwise be made in June 2011 would be delayed and made in July 2011.

Effective July 1, 2009, payments for inpatient hospital services would be reduced three percent and payments for inpatient mental health services would be reduced an additional 5.2 percent.

Effective July 1, 2009, the inpatient hospital payment increase for 16 diagnostic groups to the greater of a hospital's rate or 90% of the seven county metro average rate under *Minnesota Statutes* §256.969, subdivision 26, would be eliminated.

The net effect of the proposed payment inpatient hospital rate changes would be a decrease in state Medical Assistance inpatient expenditures of \$46,530,000 for State Fiscal Year 2010 and \$45,516,000 for State Fiscal Year 2011.

Effective October 1, 2009, the rebasing of nursing facility rates would be eliminated. The first year of the rebasing phase-in occurred on October 1, 2008 and the phase-in was scheduled to take place over eight years. This proposal would not affect the first year rate adjustment that has already been granted; however, no further rebasing rate adjustments would occur in future years.

Effective July 1, 2009, the rates for intermediate care facilities serving people with developmental disabilities (ICF/MR) would be reduced by 3%.

Effective July 1, 2009, Minnesota statute would no longer require a physician to deem that a person needs a nursing facility single-bed room as a medical necessity in order for Medical Assistance to provide a higher payment for the single-bed room. However, the rate increase the state would pay to a nursing facility for a single-bed room over that paid for a shared room would be decreased from 15% to 10%.

Effective July 1, 2009, nursing facility planned closure rate adjustments would no longer be negotiated and would instead be a fixed payment adjustment of \$2,080 for each bed closed.

Effective May 1, 2009, one-time annual payment adjustments to county-owned nursing facilities would be eliminated. An intergovernmental transfer provision from certain counties would also be eliminated.

The net effect of the proposed nursing facility rate changes would be a decrease in state Medical Assistance expenditures for nursing facility services. The state general fund cost decrease is projected to be \$22,620,000 in State Fiscal Year 2010 and \$25,484,000 in State Fiscal Year 2011.

The net effect of the proposed ICF/MR rate changes would be a decrease in state Medical Assistance expenditures for ICF/MR services. The state general fund cost decrease is projected to be \$1,856,000 in State Fiscal Year 2010 and \$2,021,000 in State Fiscal Year 2011.
