# Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. # Notice of Permit Decision for the South Bend-Stoney Creek Transmission and Substations Project in Blue Earth County

In the Matter of the Application to the Minnesota Public Utilities Commission for a Route Permit for the South Bend-Stoney Creek Transmission and Substations Project in Blue Earth County (PUC Docket No. ET2, E002/TL-08-734)

At a meeting on April 16, 2009, and in an Order issued April 21, 2009, the Minnesota Public Utilities Commission determined that the Environmental Assessment and the record created at the public hearing had adequately addressed the issues identified in the Scoping Decision. The Commission also designated and issued a High Voltage Transmission Line Route Permit to Xcel Energy and Great River Energy for the South Bend-Stoney Creek Project, authorizing the Permittee to:

Build a new 115-161/69 kilovolt (kV) South Bend Substation in Rapidan Township and a new 115-69 kV Stoney Creek Substation with a 69 kV breaker in Mankato Township; and rebuild a 69 kV transmission line within the existing easement to a 115 kV transmission line to loop around Mankato, including:

- Four miles of an existing NSP-Minnesota 69 kV transmission line rebuilt to 115 kV from South Bend Substation to Ballard Corner switches;
- Two miles of an existing NSP-Minnesota 69 kV transmission line rebuilt to 115/69 kV double-circuits from Ballard Corner switches to Stoney Creek Substation; and

 Two miles of an existing NSP-Minnesota and Great River Energy 69 kV transmission line rebuilt to 115 kV from the Stoney Creek Substation to the Pohl Substation.
