Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Proposed Rules

Comments on Planned Rules or Rule Amendments. An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, and within 60 days of the effective date of any new statutory grant of required rulemaking.

Rules to be Adopted After a Hearing. After receiving comments and deciding to hold a public hearing on the rule, an agency drafts its rule. It then publishes its rules with a notice of hearing. All persons wishing to make a statement must register at the hearing. Anyone who wishes to submit written comments may do so at the hearing, or within five working days of the close of the hearing. Administrative law judges may, during the hearing, extend the period for receiving comments up to 20 calendar days. For five business days after the submission period the agency and interested persons may respond to any new information submitted during the written submission period and the record then is closed. The administrative law judge prepares a report within 30 days, stating findings of fact, conclusions and recommendations. After receiving the report, the agency decides whether to adopt, withdraw or modify the proposed rule based on consideration of the comments made during the rule hearing procedure and the report of the administrative law judge. The agency must wait five days after receiving the report before taking any action.

Rules to be Adopted Without a Hearing. Pursuant to *Minnesota Statutes* § 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing. An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public. The agency then publishes a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the *State Register*. If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.14-14.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the *State Register*.

Proposed Amendment to Rules Governing the Minnesota Residential Energy Code, *Minnesota Rules*, [Proposed] Chapter 1322; and Repeal of *Minnesota Rules*, Chapters 7670, 7672 and 7674.

DUAL NOTICE: Notice of Intent to Adopt Rules Without a Public Hearing Unless 25 or More Persons Request a Hearing, And Notice of Hearing If 25 or More Requests For Hearing Are Received

Introduction. The Department of Labor and Industry intends to adopt rules without a public hearing following the procedures set forth in the rules of the Office of Administrative Hearings, *Minnesota Rules*, parts 1400.2300 to 1400.2310, and the Administrative Procedure Act, *Minnesota Statutes*, sections 14.22 to 14.28. If, however, 25 or more persons submit a written request for a hearing on the rules by 4:30 p.m. on September 3, 2008, a public hearing will be held in the Minnesota Room, Department of Labor and Industry, 443 Lafayette Road North, St. Paul, Minnesota 55155, starting at 9:30 AM on Monday, October 13, 2008. To find out whether the rules will be adopted without a hearing or if the hearing will be held, you should contact the agency contact person after September 3, 2008 and before October 13, 2008.

Subject of Rules and Statutory Authority. The proposed rules are about regulating energy efficiency for the design and construction of new and remodeled residential buildings regulated by *Minnesota Rules*, Chapter 1305 and 1309, and the repeal of *Minnesota Rules*, Chapters 7670, 7672, and 7674. The proposed rules adopt chapter 11 of the 2006 International Residential Code by reference and as amended by the proposed rules. The proposed rules also contain Appendix F, Radon Control Methods, as amended, in response to legislation that requires the State Building Code to include radon control in new residential buildings.

Generally, the proposed rules include provisions applicable to single-family and multi-family (three stories or less) residential structures. Specifically, the proposed rules include provisions for exterior envelope requirements (including components and conditions of the envelope); moisture (vapor) control; durability; energy efficiency; indoor air quality (ventilation) for people living in the structure and

conditions where other ventilation requirements are necessary; and requirements related to radon and water vapor from soil gases.

The statutory authority to adopt the rules is *Minnesota Statutes*, sections 16B.59, 16B.61, 16B.64, and 326B.02.

By August 15, 2006 letter, Chief Administrative Law Judge Raymond R. Krause waived the requirement that the proposed rules be published in the *State Register*. A free copy of the rules is available upon request from the agency contact person listed above.

Comments. You have until 4:30 p.m. on Wednesday, September 3, 2008, to submit written comment in support of or in opposition to the proposed rules or any part or subpart of the rules. Your comment must be in writing and received by the agency contact person by the due date. Comment is encouraged. Your comments should identify the portion of the proposed rules addressed, the reason for the comment, and any change proposed. You are encouraged to propose any change desired. Any comments that you would like to make on the legality of the proposed rules must also be made during this comment period.

Each person on the list must be knowledgeable about collective bargaining and labor relations in the public sector, well versed in state and federal labor law, and experienced in and knowledgeable about labor arbitration. To the extent practicable, the commissioner shall appoint members to the list so that the list is gender and racially diverse.

The following standards for appointment to the Arbitration Roster are required:

- A. knowledge and understanding of labor relations and collective bargaining processes and dynamics;
- B. knowledge and understanding of applicable contract, employment, and labor relations law and rules;
- C. ability to hear and decide complex labor relations issues in a fair and objective manner;
- D. ability to communicate, both orally and in writing, in a clear and concise manner;
- ability to conduct orderly and effective arbitration hearings in a variety of settings and locations throughout Minnesota;
 and
- F. reputation in the labor-management community for high professional standards of competence, ethics, and integrity.

Evidence of an applicant's qualifications may be advanced in one or a combination of the following ways:

- A. submission of six or more arbitration awards or contested case decisions that were authored and signed by the applicant in the 24-month period preceding application;
- B. a minimum of six years' experience as a full-time labor relations advocate (with direct contract negotiations experience) and submission of six arbitration awards in which the applicant acted as the principal representative for either labor or management;
- C. a minimum of six years' experience as a full-time labor mediator, including substantial grievance mediation experience;
- a minimum of six years' experience as a practitioner or full-time instructor of labor law or industrial relations, including substantial content in the area of collective bargaining, labor agreements, and contract ministration;
- E. membership in the National Academy of Arbitrators; and
- F. completion of an internship program that has been approved by the commissioner.

No applicant or roster member may have served within the preceding 12 months as an advocate for any public or private sector employer, employee, or employee organization in any phase of labor-management relations. This prohibition applies to employee discharge or disciplinary appeal proceedings, whether or not the employee is represented by an exclusive representative.

Minnesota Department of Natural Resources Notice of Proposed Classification of State Forest Lands in Eight Northwestern Minnesota Counties with Respect to Motor Vehicle Use

NOTICE IS HEREBY GIVEN that the Commissioner of the Minnesota Department of Natural Resources (DNR) proposes to classify State Forest lands located in Beltrami, Clearwater, Lake of the Woods, Marshall, Pennington, Polk, Red Lake, and Roseau counties with respect to operation of motor vehicles. The proposal is to assign all State Forest lands and other forest lands under the authority of the Commissioner to one of the following classes:

- 1. "Managed" (in which existing routes on forest lands are open for motor vehicle use unless posted closed),
- 2. "Limited" (in which existing routes on forest lands are closed to motor vehicle use unless posted open), or
- 3. "Closed" (Forest roads are open to motor vehicles licensed for highway use. No OHVs are permitted, except that OHVs may operate on frozen public waters (e.g., across lakes for ice fishing.)

Minnesota Rules Chapter 6100.1950 governs the classification of State Forests with respect to motor vehicle use.

The commissioner also proposes to designate some State Forest lands as areas with limitations on off-trail and undesignated trail use as authorized by *Minnesota Statutes Chapter 84.926*, *Subdivision 5*.

The proposal covers the Lake of the Woods, Lost River, Northwest Angle, and Red Lake State Forests and forest lands under the authority of the Commissioner located outside of State Forest boundaries in portions of eight northwestern Minnesota counties. In total, about 301,000 acres of land will be classified with respect to motor vehicle use.

In conjunction with the proposed classification the Department of Natural Resources has developed a plan that identifies which roads and trails on DNR-administered forest lands in the planning area will be open to use by various types of motor vehicles. There are about 500 miles of roads, trails, and other routes on State Forest land in the area.

The DNR will hold public meetings on the proposed classification and road and trail use designations at:

- North Beltrami Community Center, at County Road 36 and Could Avenue (Main Street) in Kelliher, MN on Monday, October 6, 2008 from 4:00 to 8:00 PM.
- Warroad Public Service Building, 804 Cherne Drive NW, Warroad, MN on Wednesday, October 8, 2008 from 3:00 to 7:00 PM.
- 3. Lake of the Woods County Courthouse Board Room, 206 SE 8th Avenue, Baudette, MN on Thursday, October 9, 2008 from 4:00 to 8:00 PM.

For the 2010 integrated assessment reporting cycle, data considered for new impairment listing must fall in a ten year window ending September 30, 2008, and will only be used if it is entered properly and confirmed by the monitoring project staff before January 15, 2009. Please note that, typically, a span of several months is required to complete the process of submitting descriptive data and measurement results from a monitoring project, reviewing, and finalizing the data. The STORET management team recommends a data submission deadline of November 1, 2008.

The Commission also designated and issued an HVTL route permit for the Chisago Transmission Project authorizing the Permittee to 1) replace the existing 69 kV transmission line located between the Chisago County substation and the proposed Lawrence Creek Substation near Taylors Falls, Minnesota with a new 115 kV transmission line; 2) replace the 69 kV transmission line with a new 161 kV transmission line between the new Lawrence Creek Substation and the St. Croix River crossing in Taylors Falls; and 3) modify the existing Chisago County, Lindstrom, and Shafer substations and construct a new Lawrence Creek Substation.

The original decision withheld a permit for the segment through downtown Lindstrom pending an agreement between the city of Lindstrom and Xcel Energy.
