NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to speaking, proposed and adopted exempt rules do not appear in this set because of their short-term rules, but are published in the *State* agencies have the authority to issue rules. Generally set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to speaking, proposed and adopted exempt rules do not appear in this set because of their short-term rules, but are published in the *State* agencies have the authority to issue rules.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the commen period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issue #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). Adopted Rules

A rule becomes effective after the requirements of *Minnesota Statutes* §§ 14.05-14.28 have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule. If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed. If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

Minnesota Management and Budget (MMB) Department of Finance Adopted Permanent Rules Governing Consideration of Applicants for Individual Vacancies

The rules proposed and published at State Register, Volume 34, Number 1, pages 8-9, July 06, 2009 (34 SR 8), are adopted as proposed.

Board of Electricity

Adopted Permanent Rules Relating to Electrical Licensing and Training

The rules proposed and published at *State Register*, Volume 33, Number 25, pages 1101-1104, December 24, 2008 (33 SR 1101), are adopted with the following modifications:

3800.3525 REGISTRATION OF UNLICENSED INDIVIDUAL.

Subp. 2. **Information required on initial registration application.** Applicants for registration must provide the following information on the initial application form provided by the department:

E. a different designated address to become public information, if the applicant wishes the home address to remain private;

 $E_{\underline{F}}$ area code and telephone number, if it exists;

FG. e-mail address, if any;

GH. date of application;

HI. class of work being performed; and

ŁJ. name, address, and telephone number of employer.

Subp. 5. **Continuing education required.** Registered unlicensed individuals must earn <u>eight two</u> hours of continuing education credit as a condition of renewal of their registration. Registrants who do not renew the registration prior to 12 months after expiration must submit an initial registration application in accordance with subpart 2.

3800.3602 REQUIREMENTS FOR RENEWAL OF ELECTRICIAN AND POWER LIMITED TECHNICIAN LICENSE AND RENEWAL OF REGISTERED UNLICENSED INDIVIDUAL REGISTRATION.

Subp. 4. **Registration renewal.** The department shall not renew the registration of a registered unlicensed individual unless the applicant received credit for eight two hours of instruction on the NEC through one or more educational programs as required by this part. Credit for an educational program may only be used once for renewal of registration. At least two hours of instruction must be on the NEC with the remainder on the statutes and rules governing electrical installations, this chapter, chapter 3801, *Minnesota Statutes*, sections 326B.31 to 326B.399, or technical topics related to electrical installations and equipment.

3800.3603 CREDIT FOR INSTRUCTION.

Subpart 1. **Approval of educational programs.** To qualify for credit under part 3800.3602, educational programs shall be approved by the department. The provider shall submit an application for approval on a form provided by the department, which shall include an outline of the educational program; the number of hours of instruction provided; and the names, addresses, telephone and facsimile numbers, and qualifications of the instructors. The provider shall submit a new application for approval if the instruction provided deviates substantively from the outline previously submitted or the hours of instruction provided is changed. Applications for approval

shall be received by the department at least 30 days prior to the first presentation of an educational program. Approval of individual educational programs expires 36 months from the date of approval. An interactive educational program may also be approved for presentation through electronic media. In addition to the requirements of parts 3800.3600 to 3800.3603, a program presented through electronic media that does not include real-time interaction between the presenter and the licensee <u>or registrant</u> must include an examination process that ensures a licensee <u>or registrant</u> has successfully completed the program.

Subp. 5. **Qualifications of instructors.** All educational programs shall be conducted by department-approved instructors who have the qualifications described in at least one of the following items:

A. a personal electrical license and at least four years' experience in electrical inspection, supervising electrical installations, or teaching subjects within the scope of electrical work permitted by the instructor's license;

Subp. 7. **Report of credits earned.** Within 14 days after presentation of an educational program for credit under part 3800.3602, the provider shall provide a certificate of completion to each licensee <u>or registrant</u> in attendance and shall forward an attendance list and original attendance sign-in document to the department on a form supplied by the department, or in a format approved by the department. Each certificate of completion and attendance list shall include the name of the provider, date and location of the presentation, educational program identification that was provided to the department, hours of instruction or continuing education units, and the licensee's <u>or registrant's</u> name and license <u>or registration</u> number or the last four digits of the applicant's Social Security number. The attendance list must be typewritten and provide a summary of each attendee's hours for each course attended.

Commissioner's Order Closing State Forest Trails to Recreational Riding During the 2009 Firearms Deer Hunting Season

WHEREAS, public safety is the Department's highest priority for Minnesota citizens during the deer hunting season; and

WHEREAS, recreational Off-Highway Vehicle (OHV) riding could expose both deer hunters and OHV riders to potentially hazardous conditions or conflict during the 2009 firearm deer hunting season; and

WHEREAS, the Legislature has directed the Commissioner of Natural Resources to establish seasons for OHV use;

NOW, THEREFORE, pursuant to authority vested in me by law, including but not limited to *Minnesota Statutes*, Sections 84.777 Subd. 2.

IT IS HEREBY ORDERED, in deer hunting Statewide (A) 100 series, for the period commencing at 12:01 A.M. November 7, 2008 and continuing until 11:59 P.M. November 22, 2009, and in deer hunting Statewide (A) 200 series, for the period commencing at 12:01 A.M. November 7, 2008 and continuing until 11:59 P.M. November 15, 2009 that:

- 1) recreational OHV riding by persons that do not possess a valid deer license is prohibited on state forest recreational trails and undesignated routes on state land, and
 - 2) the use of off-highway vehicles is allowed only by persons possessing a valid deer license and is restricted to
 - a) the period one-half hour before sunrise, and
 - b) from 11 a.m. until 2 p.m., and
 - c) after legal shooting hours (one-half hour after sunset).

*** These restrictions do not apply within the legal boundaries of municipalities, villages and cities.

Description of the Rules. Minnesota Statutes, section 62J.536, requires the Minnesota Commissioner of Health, in consultation with the Minnesota Administrative Uniformity Committee (AUC), to promulgate rules pursuant to section 62J.61 establishing and requiring group purchasers and health care providers to use electronic claims and eligibility transactions with a single, uniform companion guide to the implementation guides described under Code of Federal Regulations, title 45, part 162. The statute requires that beginning December 15, 2009 all health care providers must accept from group purchasers the health care claim payment and remittance advice transaction described under Code of Federal Regulations, title 45, part 162, subpart P. The statute also requires that beginning December 15, 2009 all group purchasers must transmit to providers the health care claim payment and remittance advice transaction described under Code of Federal Regulations, title 45, part 162, subpart P. The statute further requires that each transaction described above will use a single, uniform companion guide to the implementation guide described under the Code of Federal Regulations, title 45, part 162. In addition, the statute requires all group purchasers and health care providers to exchange claims and eligibility information electronically using the transactions, companion guides, implementation guides, and timelines set forth in subdivision 1 of the statute. The statute requires the Commissioner of Health to promulgate rules pursuant to section Minnesota Statutes, section 62J.61, at least 12 months prior to the timelines required in subdivision 1 of Minnesota Statutes, section 62J.536. A Notice of Adoption of the above referenced rules was published in the Minnesota State Register, Volume 33, Number 18, November 3, 2008, page 776. Under Minnesota Statutes, section 62J.61, the Commissioner of Health is exempt from chapter 14, including section 14.386, in implementing sections 62J.50 to 62J.54, subdivision 3, and 62J.56 to 62J.59. Because the Commissioner of Health has determined that it is unduly cumbersome to publish the entire text of the adopted technical changes to the rules, the Commissioner of Health is publishing this notice of adoption of technical changes to the rules with a detailed description of the changes.

Development of Technical Changes: The Commissioner of Health, in consultation with the AUC and its Explanation of Benefits/Remittance Advice Technical Advisory Group (TAG), determined that it was necessary to make technical changes to the previously promulgated rule in order to provide additional clarification. The Commissioner of Health consulted with this AUC TAG in developing proposed technical changes. An announcement of the proposed changes was published as a Notice of Intent to Adopt Technical Changes to the above referenced rules in the *State Register*, Volume 33, Number 49, page 2013, June 8, 2009. The notice also announced a thirty-day period for public comment on the proposed changes, from June 8, 2009 through July 8, 2009. The Minnesota Department of Health collected the public comments, which were received from six organizations. The Minnesota Department of Health reviewed the comments and consulted with the AUC Explanation of Benefits/Remittance Advice Technical Advisory Group (TAG) to make modifications to the rules as listed following this notice.

Joint Notice of [1] the Draft 20-2010 TMDL List of Impaired Waters for Stream Segments & Lakes Which Have Impaired Uses, and [2] Revisions to Appendix A of the Statewide Mercury TMDL – 30 Day Formal Written Comment Period

Every two years, the Minnesota Pollution Control Agency (MPCA) is required by the US Environmental Protection Agency (EPA), through the Clean Water Act, to submit a list of impaired waters to EPA for their review and approval. In addition, Appendix A, which contains the lakes and rivers covered by the EPA-approved Mercury TMDL, is being modified.

[1] The draft 2010 List of Impaired Waters and supporting documentation

In accordance with the requirements of Section 303(d) of the Federal Clean Water Act (CWA), the MPCA conducted a series of public informational meetings across the state between September 28, 2009 and October 7, 2009 to discuss its Year 2010 draft list of stream segments and lakes that have impaired designated uses and for which the MPCA proposes to complete total maximum daily load (TMDL) reports. Each TMDL is pollutant-specific, defining the maximum amount of each pollutant that can be released and assimilated in the receiving water from point and nonpoint sources, thereby allowing the receiving water to meet water quality standards.

The MPCA is required to list and prioritize by including a schedule which estimates starting dates and completion dates for developing the TMDL for each affected reach or lake. Schedules are estimated because pollutants vary in complexity and schedules must be consistent with basin planning. Please note this is not a schedule of when the water body will no longer be impaired.

The draft 2010 List contains 1774 impairments, including 378 new TMDL listings, including impairments for excess nutrients in lakes, perfluorooctane sulfonate (PFOS) in fish in streams and lakes, and excess nitrates in waters protected for drinking water.

The Inventory & Listing EXCEL file on the Agency TMDL List website: [http://www.pca.state.mn.us/water/tmdl/tmdl-303dlist.html] contains many tabs; the first seven are the most pertinent. This file and the Guidance Manual file are scheduled to be available for review by **September 24, 2009**.

The EXCEL file tabs are as follows:

- The 2010 draft TMDL List of impaired waters these waters are not meeting water quality standards and need a TMDL pollution reduction study plan
- The Inventory of all impaired waters this tab is a compilation of all impaired waters, including the draft TMDL List, those waters for which a TMDL has already been approved by EPA but are not yet meeting water quality standards, and those waters naturally impaired and therefore not requiring a TMDL plan
 - · A tab with just the new listing to the 2010 draft TMDL List this is a subset of the first bullet
- A tab with **all new impairments** these include the new listings to the TMDL list [see the bullet just above] plus new impairment listings for which a TMDL is not required. An example would be an addition to Appendix A of the already approved Mercury TMDL (see Section [2] below for more details)
- A tab with **corrections** resulting in removals or list corrections from the EPA approved 2008 TMDL List these are not delistings [i.e. waters meeting water quality standards; see the next bullet below] but all other actions that change the 2010 TMDL List
- A tab showing **delistings** between 2008 & 2010 these are waterbodies that are determined to be meeting water quality standards and are, thus, removed from the Inventory
 - · A tab showing changes to Appendix A of the US EPA approved Mercury TMDL see Section [2] below for more details

Another document placed on the Agency TMDL List website is the Guidance Manual for assessing the quality of Minnesota surface waters for determination of impairment: 305(b) report and 303(d) list. This document describes state water quality standards, the data collection and quality requirements, and assessment tools used when developing the 303(d) TMDL List.

There are still some potential changes to this initial draft that could arise from comments received during the public comment period, from recommendations of the Agency delisting study group, and from data analyses of PFOS in fish tissue that are presently on-going. If significant changes occur, you will be informed through a notice in the *State Register* before the draft TMDL List is submitted to EPA for their review and approval.

[2] The Revisions to Appendix A of the approved statewide mercury TMDL

The MPCA Mercury TMDL is comprised of the reduction goal for mercury atmospheric deposition in the main body of the TMDL report and two appendices. Appendix A contains the list of lakes and river segments covered by the Mercury TMDL and Appendix B contains the list of NPDES permittees covered by the mercury TMDL.

The TMDL was originally approved on March 27, 2007 and revisions to Appendix A were approved on April 3, 2008.

The 2008 Mercury TMDL Appendix A totaled 998 water bodies. Subsequently, three AUIDs were split, resulting in a total of 1001 water bodies. An additional 95 waterbodies are being added in the 2010 cycle, resulting in a grand total of 1096 water bodies in the 2010 revision to Appendix A of the EPA-approved Mercury TMDL.

The water bodies in Appendix A have fish tissue concentrations greater than 0.2 mg/kg [the water quality standard] and equal to or less than 0.572 mg/kg. Fish tissue concentrations that exceed 0.572 mg/kg are not eligible to be included in the Mercury TMDL and will be added to the 2010 draft TMDL List. Those mercury impairments that are on the 2010 TMDL List are subject to a future TMDL study.

It is important to note that the Hg TMDL documentation and reduction goals, etc., are NOT being changed; only Appendix A is being modified.

Notice of Availability of Draft Knife River Turbidity TMDL Report and Request for Comment

Public Notice Period Begins: October 12, 2009 Public Notice Period Ends: November 11, 2009

The Minnesota Pollution Control Agency (MPCA) is requesting comments on the draft Report for the Knife River Turbidity Total Maximum Daily Load (TMDL). The draft TMDL Report for the Knife River is available for review at http://www.pca.state.mn.us/water/tmdl/tmdl-draft.html. Following the comments, the MPCA will revise the draft TMDL Report and submit it to the U.S. Environmental Protection Agency (EPA) for approval. Comments must be sent to the MPCA contact person listed below by November 11, 2009.

Required by the federal Clean Water Act, a TMDL is a scientific study that calculates the maximum amount of a pollutant that a waterbody can receive and still meet water quality standards for that pollutant. It is a process that identifies all the sources of the pollutant causing an impairment and allocates necessary reductions among them. This multi-year effort results in a pollution reduction plan and engages stakeholders and the general public. An approved TMDL is followed by implementation activities for achieving the necessary reductions.

The Knife River watershed is a heavily forested watershed along the North Shore of Lake Superior, 15 miles northeast of Duluth, MN. The watershed is almost 84 square miles in size and the river is about 25 miles long. There are three main tributaries to the river. The state placed the Knife River on the 1998 impaired waters list for aquatic life because it exceeds the water quality standard for turbidity. Using a total suspended solids (TSS) surrogate for the turbidity standard of 10 NTU, sediment load reductions between 70 and 90 percent at moist and high flow conditions will be needed to meet the standard. The TMDL study provides a source assessment for sediment causing turbidity in the river, the relative impacts of human-related activities (primarily development, agriculture, and forestry) within the Knife River watershed and a sediment reduction strategy that will achieve the load goals. The reduction strategy is currently being completed and will be presented in an implementation plan separate from the TMDL report. The ultimate goal of the TMDL is to return the water quality of the stream to the levels identified by the State of Minnesota as water quality standards that protect the beneficial uses of the Knife River Watershed.

Preliminary Determination on the draft TMDL Report: The MPCA Commissioner has made a preliminary determination to submit this TMDL Report to the EPA for final approval. A draft TMDL Report and fact sheet are available for review at the MPCA office at the address listed above, and at the MPCA Web site: http://www.pca.state.mn.us/water/tmdl/html. Suggested changes will be considered before the final TMDL Report is sent to the EPA for approval.

Written Comments: You may submit written comments on the conditions of the draft TMDL Report or on the Commissioner's preliminary determination.

Written comments must include the following:

- 1. A statement of your interest in the draft TMDL Report;
- 2. A statement of the action you wish the MPCA to take, including specific references to sections of the draft TMDL that you believe should be changed; and
- 3. The reasons supporting your position, stated with sufficient specificity as to allow the Commissioner to investigate the merits of your position.

Petition for Public Informational Meeting: You also may request that the MPCA Commissioner hold a public informational meeting. A public informational meeting is an informal meeting that the MPCA may hold to solicit public comment and statements on matters before the MPCA, and to help clarify and resolve issues.

A petition requesting a public informational meeting must include the following information:

- 1. A statement identifying the matter of concern;
- 2. The information required under items 1 through 3 of "Written Comments," identified above;
- 3. A statement of the reasons the MPCA should hold a public informational meeting; and
- 4. The issues that you would like the MPCA to address at the public informational meeting.

Petition for Contested Case Hearing: You also may submit a petition for a contested case hearing. A contested case hearing is a formal evidentiary hearing before an administrative law judge. In accordance with *Minnesota Rules* 7000.1900, the MPCA will grant a petition to hold a contested case hearing if it finds that: (1) there is a material issue of fact in dispute concerning the application or draft TMDL Report; (2) the MPCA has the jurisdiction to make a determination on the disputed material issue of fact; and (3) there is a reasonable basis underlying the disputed material issue of fact or facts such that the holding of the contested case hearing would allow the introduction of information that would aid the MPCA in resolving the disputed facts in making a final decision on the draft TMDL Report. A material issue of fact means a fact question, as distinguished from a policy question, whose resolution could have a direct bearing on a final MPCA decision.

A petition for a contested case hearing must include the following information:

- 1. A statement of reasons or proposed findings supporting the MPCA decision to hold a contested case hearing according to the criteria in *Minnesota Rules* 7000.1900, as discussed above; and
- A statement of the issues proposed to be addressed by a contested case hearing and the specific relief requested or resolution of the matter.

In addition and to the extent known, a petition for a contested case hearing should also include the following information:

- A proposed list of prospective witnesses to be called, including experts, with a brief description of proposed testimony or summary of evidence to be presented at a contested case hearing;
- 2. A proposed list of publications, references, or studies to be introduced and relied upon at a contested case hearing; and
- 3. An estimate of time required for you to present the matter at a contested case hearing.

MPCA Decision: You may submit a petition to the Commissioner requesting that the MPCA Citizens' Board (Board) consider the TDML Report approval. To be considered timely, the petition must be received by the MPCA by 4:30 p.m. on the date the public comment period ends, identified on page 1 of this notice. Under the provisions of *Minnesota Statutes* § 116.02, subd 6(4), the decision whether to submit the TMDL Report and, if so, under what terms will be presented to the Board for decision if: (1) the Commissioner grants the petition requesting the matter be presented to the Board; (2) one or more Board members request to hear the matter before the time the Commissioner makes a final decision on the TMDL Report; or (3) a timely request for a contested case hearing is pending. You may participate in the activities of the MPCA Board as provided in *Minnesota Rules* 7000.0650.

The written comments, requests, and petitions submitted on or before the last day of the public comment period will be considered in the final decision on this TMDL Report. If the MPCA does not receive written comments, requests, or petitions during the public comment period, MPCA staff as authorized by the Board, will make the final decision on the draft TMDL Report.
