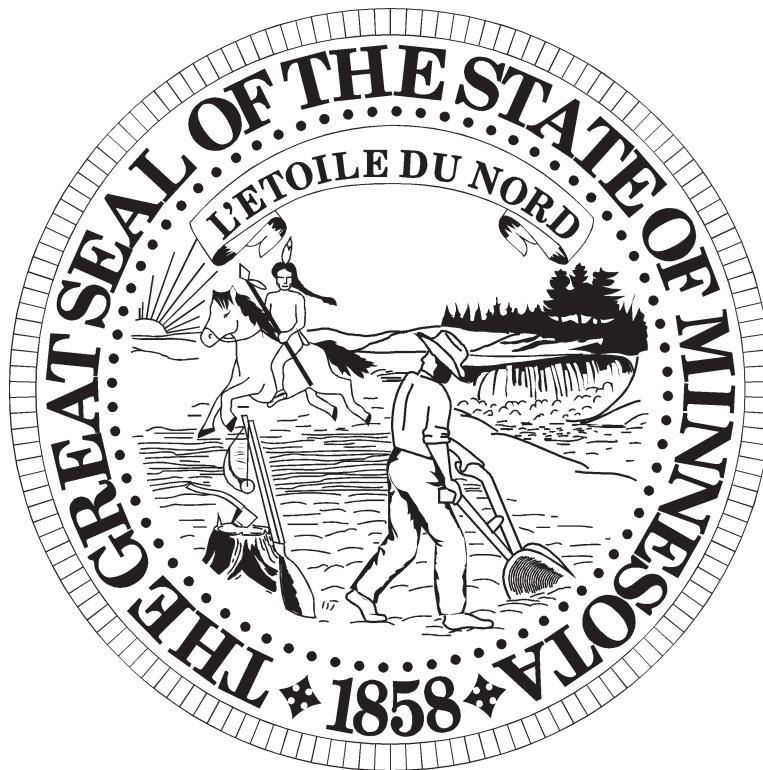

Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Adopted Rules

A rule becomes effective after the requirements of *Minnesota Statutes* §§ 14.05-14.28 have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule. If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed. If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

Adopted Permanent Rules Relating to Horse Racing

The rules proposed and published at *State Register*, Volume 33, Number 31, pages 1331-1333, February 2, 2009 (33 SR 1331), are adopted as proposed.

Expedited Emergency Rules

Provisions exist for the Commissioners of some state agencies to adopt expedited emergency rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Expedited emergency rules are effective upon publication in the *State Register*, and may be effective up to seven days before publication under certain emergency conditions.

Expedited emergency rules are effective for the period stated or up to 18 months. Specific *Minnesota Statute* citations accompanying these expedited emergency rules detail the agency's rulemaking authority.

Adopted Expedited Emergency Game and Fish Rules: 2009 Camp Ripley Archery Deer Hunt; 2009 Youth Deer Hunts and Seasons

NOTICE IS HEREBY GIVEN that the above-entitled rules have been adopted through the process prescribed by *Minnesota Statutes*, Section 84.027, subdivision 13(b). The statutory authority for the contents of the rule is *Minnesota Statutes*, Sections 97A.091, 97A.401, subd. 4, 97B.112, 97B.305, 97B.311.

The emergency conditions that do not allow compliance with *Minnesota Statutes*, Sections 97A.0451 to 97A.0459, are that data on deer populations necessary to establish special hunts, including youth hunts and Camp Ripley are not available until May. Additionally, hunt cooperators have not determined their participation plans or recommended hunt dates until May.

Expedited Emergency Rules

6232.0900 CAMPRIPLEY ARCHERY HUNT.

[For text of subps 1 and 2, see M.R.]

Subp. 3. **Antlerless deer and legal bucks.** In 2009, Camp Ripley is open for taking antlerless deer and legal bucks. Not more than 2,500 permits shall be issued for each two-day hunting period.

Subp. 4. **Bag limits.** The bag limit for the Camp Ripley archery hunt is two deer. Hunters may use bonus permits to take antlerless deer and may take a deer of either sex on a regular license. Only one legal buck may be taken during this hunt.

6232.1100 SPECIAL RESTRICTIONS FOR CAMPRIPLEY ARCHERY HUNT.

Subpart 1. **Access to Camp Ripley.** This subpart applies to access into Camp Ripley during the archery hunt.

A. Archers with valid permits must enter and leave Camp Ripley only by way of the southeast railroad gate and only from ~~noon~~ 5:00 a.m. on the day before the hunt to 8:00 p.m. on the last day of the hunt.

6232.2560 YOUTH SPECIAL DEER SEASONS.

Subpart 1. **Season requirements.** Youths participating in youth special deer seasons must obtain a license for taking deer by firearms, valid for any season option, by the beginning date of the special season. A youth special season participant may take one deer, which must be antlerless. One bonus permit may be used. An adult mentor age 18 or older authorized by the youth's parent or guardian must accompany the youth hunter at all times during the hunt. The accompanying adult may not hunt. Party hunting is not allowed. The blaze orange requirements in *Minnesota Statutes*, section 97B.071, paragraph (a), apply to all hunters and trappers, and all adult mentors of youth hunters, in the areas open to firearms deer hunting during the youth special seasons established in this part.

Subp. 2. **Open areas.** Open areas and dates for youth special deer seasons shall be established annually by the commissioner. For 2009, Kittson, Lake of the Woods, Marshall, Pennington, and Roseau Counties are open October 17 and 18 for taking antlerless deer by firearms for youth who are at least age 12 and under age 15 at the time of the hunt. Old Mill State Park, Lake Bronson State Park, Hayes Lake State Park, and Zippel Bay State Park are open to taking antlerless deer by eligible youth during the 2009 youth special deer season. One bonus permit may be used, but a hunter may not take more than one deer.

EFFECTIVE PERIOD. The emergency amendments to *Minnesota Rules*, parts 6232.0900, 6232.1100, 6232.2550, and 6232.2560, expire December 31, 2009. After the emergency amendments expire, the permanent rules as they read prior to those amendments again take effect, except as they may be amended by permanent rule.

6232.4300 SEASONS AND 2009 SEASON DATES AND QUOTAS FOR TAKING ELK.

Subpart 1. Taking elk. Elk may be taken by a licensed hunter using a legal firearm or a legal bow and arrow during seasons authorized by the commissioner.

- C. season C: November 21 to 29.

Subp. 3. Quotas. The number of available licenses for the 2009 elk hunting season is 15 in the Primary Grygla Elk Zone, ten in the Kittson County-Lancaster Elk Zone, and five in the Kittson County-Water Tower Elk Zone, distributed as follows:

- A. season A: two licenses each in the Primary Grygla and Kittson County-Lancaster Elk Zones and one license in the Kittson County-Water Tower Elk Zone valid for either-sex elk and three licenses in the Primary Grygla Elk Zone valid for legal antlerless elk only;
- B. season B: five licenses in the Primary Grygla Elk Zone, four licenses in the Kittson County-Lancaster Elk Zone, and two licenses in the Kittson County-Water Tower Elk Zone valid for either-sex elk; and
- C. season C: five licenses in the Primary Grygla Elk Zone, four licenses in the Kittson County-Lancaster Elk Zone, and two licenses in the Kittson County-Water Tower Elk Zone valid for either-sex elk.

Subp. 4. Open areas.

- A. Primary Grygla Elk Zone licenses are valid for taking elk within the Primary Grygla Elk Zone prescribed in part 6232.4600, subpart 1, and the Secondary Grygla Elk Zone as described in part 6232.4600, subpart 2.
- B. Kittson County-Lancaster Elk Zone licenses are valid for taking elk within the elk zone prescribed in part 6232.4600, subpart 3.
- C. Kittson County-Water Tower Elk Zone licenses are valid for taking elk within the elk zone prescribed in part 6232.4600, subpart 4.

Subp. 5. Extension of hunt. If harvest is not sufficient to lower elk populations, the commissioner may reopen any elk zone to elk hunting from January 2 to 10, 2010, by notifying individuals who purchased a 2009 elk license but did not tag an elk during the regular season or who unsuccessfully applied for an elk license in 2009.

NOTICE IS HEREBY GIVEN that the Commissioner has determined that a State Implementation Plan (SIP) revision must be submitted to meet Minnesota's requirements under the federal Regional Haze Rule (40 CFR 51.300 - 51.309). A draft SIP was placed on public notice on February 25, 2008; a revised draft Regional Haze SIP is now available for public comment.

Background. Under the authority of Section 169(a) of the Clean Air Act (the Act), the United States Environmental Protection Agency (EPA) on July 1, 1999 promulgated visibility goals for mandatory Class I Federal areas in the federal Regional Haze Rule. The Regional Haze Rule was further amended in 2005 and 2006. Section 169(a) of the Act and the Regional Haze Rule requires each state to adopt and submit a plan to EPA that addresses the state's contribution to visibility impairment at the mandatory Class I Federal areas.

Purpose of the SIP Revision. The purpose of this SIP revision is to address visibility protection at national parks, wildernesses, and scenic areas, also referred to as mandatory Class I Federal areas. Class I areas within Minnesota are the Boundary Waters Canoe Area Wilderness and Voyageurs National Park. The SIP lays out how Minnesota intends to implement the Regional Haze Rule. The SIP revision includes information on the following core requirements of the Regional Haze Rule: reasonable progress goals, baseline and natural visibility conditions, long-term strategy for regional haze, monitoring strategy, and Best Available Retrofit Technology (BART).

A draft SIP was placed on notice in February 2008; in response to comments received and the potential for changes in the application of the federal Clean Air Interstate Rule to Minnesota, the SIP has been revised. The revised SIP is now available for public comment. Comments will be taken only on those portions of the SIP that have changed since the initial draft. Revised portions include:

- Best Available Retrofit Technology for Electric Generating Units
- Administrative Orders by Consent for taconite facilities
- Long Term Strategy

Information on these items is found in Chapters 8, 9, and 10 of the revised SIP. For context, the entire SIP is available for review, but comments will be taken only on Chapter 8, 9, 10 and the associated Appendices, and any changes made in response to comments on the initial draft.

The MPCA will consider changing the contents of the proposed SIP revision based on comments received during the comment period. Following the end of the comment period, the Commissioner will decide whether to submit the proposed SIP revision to the EPA unless, as provided by *Minnesota Statutes* § 116.02, the MPCA Citizens' Board makes this decision.

Subject of Rules. The Office of the Secretary of State requests comments on its possible amendment to rules governing absentee balloting, voting system testing, optical scan voting systems, recounts, election judge training programs and redistricting. The Office is considering rule amendments that would address: conforming rules to recent legislation; the format, availability and place of filing of petitions; the format, content and instructions for and administration of absentee ballot applications and envelopes, absentee ballots, certificates and statements of voters; procedures for obtaining replacement ballots; instructions and procedures for uniformed and overseas (UOCAVA) voters, UOCAVA records; federal write in ballot and federal post card application procedures; procedures used in, obtaining replacement ballots for, schedule of mailing of and authorization of, mail balloting; voting system certification; electronic ballot marker instructions; handling and security of voting system memory cards; voting system public accuracy and other testing; voting systems required per precinct; experimental use of equipment; managing voting systems on election day; ballot sticker use; deletion of obsolete rule provisions regarding punch-card voting and machine recounts; recount notices and cost deposits; prohibited relationships of recount officials and candidates; securing ballot materials and voting systems during recounts; recount sorting, counting and observing procedures; scope of recount; ballot formats and preparation; election judge, municipal clerk, county auditor training and election judge trainee prerequisites; and redistricting.

The Minnesota Pollution Control Agency (MPCA) hereby announces that it will accept proposals for water resource project grants and loans through the State Clean Water Partnership Program (CWP). Proposals will be accepted from local governmental units interested in leading a nonpoint source pollution control project for protection and improvement of water bodies. The MPCA anticipates that over two million dollars of grant funds and about two million dollars of loan funds will be available this year.

The funding for these projects will come from either of two state sources: General Fund appropriation for the Clean Water Partnership or Clean Water Fund appropriation. The Clean Water Fund monies are generated from the constitutional amendment sales tax. Clean Water Fund dollars must balance the benefits across all state regions and residents of the state.

In 1987, the Minnesota Legislature established the CWP Program (*Minnesota Statutes* §§ 103F.701 through 103F.761) to protect and improve surface and ground water in Minnesota through financial and technical assistance to local units of government. The CWP appropriation language for the state 2010-2011 biennium and for the Clean Water Fund, established in 2009, further guides the MPCA that **priority shall be given for those projects preventing impairments and degradation of Minnesota waters** in accordance with *Minnesota Statutes* 114D.20, subd. 2, clause (4).

There are two types of proposals that will be accepted this round:

1. Resource investigation/diagnostic study projects monitor, assess and develop a diagnostic study on the status of a water body, and also develop an implementation plan to address the needs of the water body. Resource investigation projects are only eligible for grant funding.

2. Implementation projects will implement activities, such as best management practices, that are identified by a comprehensive assessment and planning process in the watershed or around the water body of concern. Such assessment must consist of an MPCA-approved CWP Phase I or equivalent diagnostic study and implementation plan. Implementation projects are eligible for both grant and/or loan funding.

Project proposals must provide measurable project outcomes.
