Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Proposed Rules

Comments on Planned Rules or Rule Amendments. An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, and within 60 days of the effective date of any new statutory grant of required rulemaking.

Rules to be Adopted After a Hearing. After receiving comments and deciding to hold a public hearing on the rule, an agency drafts its rule. It then publishes its rules with a notice of hearing. All persons wishing to make a statement must register at the hearing. Anyone who wishes to submit written comments may do so at the hearing, or within five working days of the close of the hearing. Administrative law judges may, during the hearing, extend the period for receiving comments up to 20 calendar days. For five business days after the submission period the agency and interested persons may respond to any new information submitted during the written submission period and the record then is closed. The administrative law judge prepares a report within 30 days, stating findings of fact, conclusions and recommendations. After receiving the report, the agency decides whether to adopt, withdraw or modify the proposed rule based on consideration of the comments made during the rule hearing procedure and the report of the administrative law judge. The agency must wait five days after receiving the report before taking any action.

Rules to be Adopted Without a Hearing. Pursuant to *Minnesota Statutes* § 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing. An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public. The agency then publishes a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the *State Register*. If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.14-14.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the *State Register*.

Proposed Permanent Rules Relating to Taking Bullheads

DUAL NOTICE: Notice of Intent to Adopt Rules Without a Public Hearing Unless 25 or More Persons Request a Hearing, And Notice of Hearing If 25 or More Requests For Hearing Are Received

Proposed Amendments to Rules Relating to Taking Bullheads, Minnesota Rules, chapter 6262

Introduction. The Department of Natural Resources (DNR) intends to adopt rules without a public hearing following the procedures set forth in the rules of the Office of Administrative Hearings, *Minnesota Rules*, parts 1400.2300 to 1400.2310, and the Administrative Procedure Act, *Minnesota Statutes*, sections 14.22 to 14.28. If, however, 25 or more persons submit a written request for a hearing on the rules by 4:30 p.m. on April 1, 2010, a public hearing will be held in the 6th floor conference room at the Minnesota Department of Natural Resources, 500 Lafayette Road, St. Paul, Minnesota 55155, starting at 2:00 p.m. on April 13, 2010. To find out whether the rules will be held, you should contact the agency contact person after April 1, 2010, and before April 13, 2010.

Agency Contact Person. Comments or questions on the rules and written requests for a public hearing on the rules must be submitted to the agency contact person. Subject of Rules and Statutory Authority. The proposed rules are about establishing transportation and possession requirements for live white suckers over 12 inches and using larger bullheads alive for bait. The statutory authority to adopt or repeal the rules is *Minnesota Statutes*, sections 97A.045, subd. 2; 97A.551; 97C.205, 97C.315, 97C.401, 97C.001, subd 3; 97C.041; and 97C.345. A copy of the proposed rules is published in the *State Register* and attached to this notice as mailed. A free copy of the rules is available upon request from the agency contact person listed above and is also available on the DNR website at:

Comments. You have until 4:30 p.m. on April 1, 2010, to submit written comment in support of or in opposition to the proposed rules

or any part or subpart of the rules. Your comment must be in writing and received by the agency contact person by the due date. Comment is encouraged. Your comments should identify the portion of the proposed rules addressed, the reason for the comment, and any change proposed. You are encouraged to propose any change desired. Any comments that you would like to make on the legality of the proposed rules must also be made during this comment period.

Request for a Hearing. In addition to submitting comments, you may also request that a hearing be held on the rules. Your request for a public hearing must be in writing and must be received by the agency contact person by 4:30 p.m. on April 1, 2010. Your written request for a public hearing must include your name and address. You must identify the portion of the proposed rules to which you object or state that you oppose the entire set of rules. Any request that does not comply with these requirements is not valid and cannot be counted by the agency when determining whether a public hearing must be held. You are also encouraged to state the reason for the request and any changes you want made to the proposed rules.

Withdrawal of Requests. If 25 or more persons submit a valid written request for a hearing, a public hearing will be held unless a sufficient number withdraw their requests in writing. If enough requests for hearing are withdrawn to reduce the number below 25, the agency must give written notice of this to all persons who requested a hearing, explain the actions the agency took to effect the withdrawal, and ask for written comments on this action. If a public hearing is required, the agency will follow the procedures in *Minnesota Statutes*, sections 14.131 to 14.20.

Alternative Format/Accommodation. Upon request, this Notice can be made available in an alternative format, such as large print, Braille, or cassette tape. To make such a request or if you need an accommodation to make this hearing accessible, please contact the agency contact person at the address or telephone number listed above.

Modifications. The proposed rules may be modified, either as a result of public comment or as a result of the rule hearing process. Modifications must be supported by data and views submitted to the agency or presented at the hearing and the adopted rules may not be substantially different than these proposed rules, unless the procedure under *Minnesota Rules*, part 1400.2110, has been followed. If the proposed rules affect you in any way, you are encouraged to participate in the rulemaking process.

Cancellation of Hearing. The hearing scheduled for April 13, 2010, will be canceled if the agency does not receive requests from 25 or more persons that a hearing be held on the rules. If you requested a public hearing, the agency will notify you before the scheduled hearing whether or not the hearing will be held. You may also call the agency contact person at 651-259-5106 after May 30, 2007 to find out whether the hearing will be held.

Notice of Hearing. If 25 or more persons submit valid written requests for a public hearing on the rules, a hearing will be held following the procedures in *Minnesota Statutes*, sections 14.131 to 14.20. The hearing will be held on the date and at the time and place listed above. The hearing will continue until all interested persons have been heard. Administrative Law Judge Richard C. Luis is assigned to conduct the hearing. Hearing Procedure. If a hearing is held, you and all interested or affected persons, including representatives of associations or other interested groups, will have an opportunity to participate. You may present your views either orally at the hearing or in writing at any time before the close of the hearing record. All evidence presented should relate to the proposed rules. You may also submit written material to the Administrative Law Judge to be recorded in the hearing record for five working days after the public hearing ends. This five-day comment period may be extended for a longer period not to exceed 20 calendar days if ordered by the Administrative Law Judge at the hearing. Following the comment period, there is a five-working-day rebuttal period during which the agency and any interested person may respond in writing to any new information submitted. No additional evidence may be submitted during the five-day rebuttal period. All comments and responses submitted to the Administrative Law Judge must be received at the Office of Administrative Hearings no later than 4:30 p.m. on the due date. All comments or responses received will be available for review at the Office of Administrative Hearings. This rule hearing procedure is governed by *Minnesota Rules*, parts 1400.2000 to 1400.2240, and *Minnesota Statutes*, sections 14.131 to 14.20. Questions about procedure may be directed to the Administrative Law Judge.

The agency requests that any person submitting written views or data to the Administrative Law Judge prior to the hearing or during the comment or rebuttal period also submit a copy of the written views or data to the agency contact person at the address stated above.

6262.0100 GENERAL RESTRICTIONS ON TAKING FISH.

Subp. 4. **Importation, transportation, or stocking of live fish.** Except as provided in <u>part_parts</u> 6212.2600, subpart 3, and <u>6262.0600, subpart 4, and *Minnesota Statutes*, sections 17.4985, subdivision 3; 97C.505, subdivision 1; 97C.515, subdivision 3; 97C.525, subdivision 1; and 97C.821, a person may not import, transport, or stock in any waters of the state live fish eggs, fish spawn, or immature or adult fish of any species without a permit issued by the commissioner. An angling license does not authorize a person to import, transport, or stock live fish.</u>

6262.0600 SEASONS AND METHODS FOR TAKING ROUGH FISH.

Subpart 1. **Generally.** Rough fish may be taken in accordance with according to *Minnesota Statutes*, sections 97C.345, 97C.371, and 97C.375. Rough fish may be taken by the following methods from May 1 through the last Sunday in February between sunrise and sunset in all inland waters and by archery at night on water bodies designated under subpart 2 from June 1 to the last day in August, except where the taking of fish is otherwise prohibited by law or rule. Nonresidents may not spear from a fish house or darkhouse.

Subp. 3. Possession and use of bullheads 7.0 to 10.0 inches for bait.

<u>A.</u> As described in this subpart, up to 100 bullheads greater than 7.0 inches and equal to or less than 10.0 inches may be taken, possessed, and held for use as live bait.

B. Bullheads taken under this subpart may be taken from the wild by:

<u>(1) dip net;</u>

(2) angling; or

(3) seines used as authorized for noncommercial taking of minnows as prescribed under part 6230.0250, subpart 6; chapter 6254; and *Minnesota Statutes*, sections 97C.505 and 97C.511, subdivision 1.

C. Bullheads taken under this subpart are considered part of the daily and possession limits in parts 6262.0200, subpart 1, item P,

and 6262.0650, item C.

D. Bullheads taken under this subpart must be transported in a container with a locking lid or other device to prevent escape. Release of the live bullheads into the wild is not allowed.

E. A person transporting or holding bullheads under this subpart must allow inspection of the bullheads by the commissioner at any time.

F. A person may not transport live bullheads under this subpart across the borders into Minnesota without an appropriate commercial license and transportation permit.

Subp. 4. Transportation restrictions. Live bullheads, regardless of size, may not be transported north of State Highway 210.

Subp. 5. Sale of fish over 12 inches. White suckers that are 12 inches and larger and have been legally purchased from a licensed commercial vendor may be transported alive. The person transporting these fish must have the sales receipt on their person. The sales receipt must show the date and time of purchase. Receipts for fish transported alive are valid for a maximum of four days (96 hours) from the date and time of purchase.

Exempt Rules

Exempt rules are excluded from the normal rulemaking procedures (*Minnesota Statutes* §§ 14.386 and 14.388). They are most often of two kinds. One kind is specifically exempted by the Legislature from rulemaking procedures, but approved for form by the Revisor of Statutes, reviewed for legality by the Office of Administrative Hearings, and then published in the *State Register*. These exempt rules are effective for two years only.

The second kind of exempt rule is one adopted where an agency for good cause finds that the rulemaking provisions of *Minnesota Statutes*, Chapter 14 are unnecessary, impracticable, or contrary to the public interest. This exemption can be used only where the rules:

(1) address a serious and immediate threat to the public health, safety, or welfare, or

(2) comply with a court order or a requirement in federal law in a manner that does not allow for compliance with *Minnesota Statutes* Sections 14.14-14.28, or

(3) incorporate specific changes set forth in applicable statutes when no interpretation of law is required, or

(4) make changes that do not alter the sense, meaning, or effect of the rules.

These exempt rules are also reviewed for form by the Revisor of Statutes, for legality by the Office of Administrative Hearings and then published in the *State Register*. In addition, the Office of Administrative Hearings must determine whether the agency has provided adequate justification for the use of this exemption. Rules adopted under clauses (1) or (2) above are effective for two years only. The Legislature may also exempt an agency from the normal rulemaking procedures and establish other procedural and substantive requirements unique to that exemption.

Currently, all Minnesota Uniform Companion Guides (Version ASC X12N 004010A1), are required for use by all group purchasers and providers for which *Minnesota Statutes*, section 62J.536 applies.

On January 16, 2009, the U.S. Department of Health and Human Services (HHS) published rules (CMS–0009–F) announcing the adoption of new versions of the federal transaction standards, known as ASC X12 Technical Reports Type 3 (TR3), Version 005010 (Version 5010). As a result, the Minnesota Department of Health (MDH), in consultation with the Minnesota Administrative Uniformity Committee (AUC), has developed the proposed Version 5010 Minnesota Uniform Companion Guide for the Implementation of the Health Care Claim Payment and Remittance Advice Electronic Transaction, in order to be consistent with the federal regulations as cited above. The Minnesota Uniform Companion Guides, when adopted, will be required for use no later than January 1, 2012.

Health care providers and group purchasers subject to *Minnesota Statutes*, section 62J.536 must exchange transactions covered by the statute as follows. From the date of each Version 5010 Uniform Companion Guides' final adoption until January 1, 2012, providers and group purchasers may use only: the Minnesota Uniform Companion Guides, Version ASC X12N 004010A1 (Version 4010), including any subsequent technical changes or updates; or, by mutual agreement between trading partners, the Minnesota Uniform Companion Guides, ANSI ASC X12 Technical Report Type 3, Version 5010. Beginning January 1, 2012, providers and group purchasers may only use the Minnesota Uniform Companion Guides, ANSI ASC X12 Technical Report Type 3, Version 5010.

Because the Commissioner of Health has determined that it is unduly cumbersome to publish the entire text of the proposed rules, the Commissioner of Health is publishing this notice of intent to adopt the proposed rules, which provides information directing users how to obtain free copies of those proposed rules.

Public Review Process: MDH will provide free copies of the proposed Version 5010 Minnesota Uniform Companion Guide for the Implementation of the Health Care Claim Payment and Remittance Advice Electronic Transactions in paper or electronic format, to persons and organizations interested in reviewing them. NOTICE IS HEREBY GIVEN to recipients, providers of services under the Medical Assistance Program, and to the public, of proposed payment rate changes for hospitals, nursing facilities and intermediate care facilities serving people with developmental disabilities (ICFs/MR) participating in the Medical Assistance Program.

This notice is published pursuant to 42 *United States Code* \$1396a(a)(13)(A) (\$1902(a)(13)(A) of the Social Security Act), which requires the Department to publish proposed facility payment rates, the methodologies underlying the establishment of such rates, and the justification for such rates. It is also published pursuant to *Code of Federal Regulations*, title 42, part 447, section 205 (42 CFR \$447.205), which requires publication of a notice when there is a proposed rate change in the methods and standards for setting payment rates for Medical Assistance services.

The Department is notifying interested parties that the Governor's supplemental budget for State Fiscal Year 2011 contains the following proposed changes to inpatient hospital, nursing facilities and intermediate care facilities serving people with developmental disabilities (ICFs/MR) payment rates.

Effective July 1, 2010, inpatient hospital rates would not be rebased to more current cost and utilization data for the first three months of the rebasing period beginning January 1, 2011. Rates would be rebased effective April 1, 2011 at current statutory allowed levels. Effective July 1, 2010, payments for inpatient hospital services would be reduced three percent.

Effective July 1, 2010, the inpatient hospital payment increase for 16 diagnostic groups to the greater of a hospital's rate or 90% of the

seven county metro average rate would be eliminated.

The net effect of the proposed payment inpatient hospital rate changes would be a decrease in state Medical Assistance inpatient expenditures of \$33,808,000 for State Fiscal Year 2011 and \$33,348,000 for State Fiscal Year 2012.

Medical education and research costs (MERC) payments for the State Fiscal Year 2011 formulaic distribution to medical education providers under *Minnesota Statutes* §62J.692, subdivision 7, clause (5) would be eliminated. *Minnesota Statutes* §256B.69 subdivision 5c(1) directs the Commissioner of Human Services to reduce the monthly capitation rates to PMAP providers by specific amounts and to transfer those funds to the Department of Health. *Minnesota Statutes* §62J.692 subdivision 7, directs the Department of Health to distribute those funds annually to eligible medical education providers in accordance with the formula described at *Minnesota Statutes* §62J.692 subdivision 4. The capitation rates for State Fiscal Year 2011 would continue to be reduced but the funds would not be made available for the PMAP MERC payments. The net effect of this change would be a decrease in total Medical Assistance expenditures of \$49.5 million in SFY 2011.

Fee-for-service medical education and research costs (MERC) payments for State Fiscal Year 2011 would be reduced. *Minnesota Statutes* 62J.692, subdivision 4 provides for a payment of \$1,475,000 to the University of Minnesota Medical Center – Fairview. For State Fiscal Year 2011 that payment would be reduced by \$498,000.

Effective retroactively from July 1, 2009, the October 1, 2009, nursing facility rebasing rate increase that was delayed until July 1, 2011, would be not be implemented on July 1, 2011. This does not reduce current rates paid to nursing facilities; the cost savings would occur from not providing rate increases that were otherwise expected to be given in FY 2012.

Effective July 1, 2010, the rates for nursing facilities would be reduced by 2.5%.

Effective July 1, 2010, the rates for intermediate care facilities serving people with developmental disabilities (ICF/MR) would be reduced by 2.5%.

Effective July 1, 2010, nursing facility rate equalization will be phased out over three years by allowing incremental rate increases. It would be fully phased out by October 1, 2013, and at that point, nursing facilities would not have a limit on the amount they are permitted to charge private pay residents.

The net effect of the proposed nursing facility rate changes would be a decrease in Medical Assistance expenditures for nursing facility services. The total decrease in expenditures is projected to be \$20,528,000 for State Fiscal Year 2011.

The net effect of the proposed ICF/MR rate changes would be a decrease in Medical Assistance expenditures for ICF/MR services. The total decrease in expenditures is projected to be \$3,157,000 for State Fiscal Year 2011.

Minnesota Office of Higher Education REQUEST FOR COMMENTS on Possible Amendment to Rules Governing Supplemental Student Loan SELF Program, *Minnesota Rules*, 4850.0010 to 4850.0018

Subject of Rules. The Minnesota Office of Higher Education requests comments on its possible amendment to rules governing its supplemental student loan SELF Program. The Office of Higher Education is considering rule amendments that would:

• Add SELF V and SELF VI language to enable new phases of the loan program if needed. Identify how interest would be calculated for SELF V and SELF VI phases of the program to facilitate new phases. Allow for a maximum interest rate to be included in the promissory note.

• Eliminate language to accommodate differences in school application procedures in the school agreements and student application procedures section. Procedures for the loan application vary by eligible school.

· Revise procedures to reflect the online application process and new federal application disclosure requirements.

• Modify the existing rule permitting students to borrow twice at the same academic grade level as long as 7 months have elapsed from the start of the previous loan period. Currently students must wait 11 months before they can take out a second loan at the same grade level.

• Permit schools to disburse funds up to 45 days after the end of the loan period. The current 30 day disbursement is being increased due to delays caused by the new federal regulations.

• Eliminate statement that if spouse has a SELF loan their combined payments must be at \$600. The program rules and statutes are designed on an individual basis and provision is not being utilized.

· Other changes clean up and clarify the loan disbursement and repayment procedures.

Persons Affected. Regarding changes to amount and terms of the loan. The amendment to the rules would likely have the following supporters:

- + Students who need a SELF loan before waiting 11 months to borrow another SELF loan.
- Students enrolling in a summer school program or enrolling in a year-round program.
- The proposed changes would help students who borrow loans and their cosigners.

Opponents may include people who oppose students being able to borrow additional funds at an earlier date.

Statutory Authority. *Minnesota Statutes*, 136A.16, Subd. 2., authorizes the Office of Higher Education to adopt rules to carry out the purposes of sections 136A.15 to 136A.1702.

Public Comment. Interested persons or groups may submit comments or information on these possible rules in writing until 4:00 p.m. on May 17, 2010. The Office of Higher Education does not contemplate appointing an advisory committee to comment on the possible rules.

The Minnesota Pollution Control Agency (MPCA) is requesting comments on the draft report for the Turbidity Total Maximum Daily Load (TMDL) assessment for the Pomme de Terre River. One reach on the Pomme de Terre River, from Muddy Creek to Marsh Lake, is impaired for not meeting the Minnesota water quality standards for turbidity. The draft TMDL report is available on the MPCA Web site at: *http://www.pca.state.mn.us/water/tmdl/tmdl-draft.html*.

Comments on the draft report should be addressed to the MPCA contact person listed below and must be received by the MPCA by 4:30 p.m. on March 31, 2010. The MPCA will review all comments received, determine possible revision to the draft TMDL report and prepare written responses to the comments. The MPCA will then submit the report to the U. S. Environmental Protection Agency (EPA) for approval.

The Pomme de Terre River is located in the Minnesota River Basin in west central Minnesota. It has a drainage area of about 875 square miles or 560,000 acres. The headwaters are located in Otter Tail County and flows south through Grant County, Stevens County, and enter the Minnesota River in Swift County at Marsh Lake. In 2002, the last reach of the Pomme de Terre River, from Muddy Creek to Marsh Lake (AUID 07020002-501), was placed on the impaired waters list for not meeting the Minnesota water quality standard for turbidity. Turbidity is a measure of water clarity. Turbidity in water is caused by suspended sediment; organic material, dissolved salts, and stains that scatter light in the water column making the water appear cloudy. Excess turbidity can degrade aesthetic qualities of water bodies, increase the cost of treatment for drinking or food processing uses and can harm aquatic life. According to the TMDL report, there is a linkage between high turbidity and rainfall events.

Strategies to reduce the amount of turbidity in the Pomme de Terre River will be developed in an implementation plan. This plan will be completed with the input from the stakeholders within the watershed, with input from the technical advisory committee formed with the TMDL, and with input from the Pomme de Terre River Association Joint Powers Board.

A public information meeting is an informal meeting the MPCA may hold to solicit public comment and statements on matters pertaining to the TMDL study and process, and to help clarify and resolve issues.

A petition requesting a public information meeting must include the following information:

- 1. A statement identifying the matter of concern;
- 2. The information required under items 1 through 3 of "Written Comments," identified above;
- 3. A statement of the reason the MPCA should hold a public information meeting; and
- 4. The issues that you would like the MPCA to address at the public information meeting.

Petition for Contested Case Hearing: A petition for a contested case hearing may be submitted. A contested case hearing is a formal evidentiary hearing before an administrative law judge. In accordance with *Minnesota Rules* 7000.1900, the MPCA will grant a petition to hold a contested case hearing if it finds that: (1) there is a material issue of fact in dispute concerning the application or draft TMDL report; (2) the MPCA has the jurisdiction to make a determination on the disputed material issue of fact; and (3) there is a reasonable basis underlying the disputed material issue of fact or facts such that the holding of the contested case hearing would allow the introduction of information that would aid the MPCA in resolving the disputed facts in making a final decision on the draft TMDL report. A material issue of fact means a fact question, as distinguished from a policy question, whose resolution could have a direct bearing on a final MPCA decision.

A petition for a contested case hearing must include the following information:

1. A statement of reasons or proposed findings supporting the MPCA decision to hold a contested case hearing according to the criteria in *Minnesota Rules* 7000.1900, as discussed above; and

2. A statement of the issues proposed to be addressed by a contested case hearing and the specific relief requested or resolution of the matter.

In addition and to the extent known, a petition for a contested case hearing should also include the following information:

1. A proposed list of prospective witnesses to be called, including experts, with a brief description of proposed testimony or summary of evidence to be presented at a contested case hearing;

- 2. A proposed list of publications, references, or studies to be introduced and relied upon at a contested case hearing; and
- 3. An estimate of time required for you to present the matter at a contested case hearing.

MPCA Citizens' Board Decision: You may also submit a petition to the Commissioner requesting that the MPCA Citizens' Board consider the TMDL report approval. To be considered timely, the petition must be received by the MPCA by 4:30 p.m. on March 31, 2010, the date the public comment period ends as identified on page 1 of this notice. According to *Minnesota Statutes* § 116.02, subd 6(4), the decision whether to submit the TMDL report and, if so, under what terms will be presented to the Board for decision if: (1) the Commissioner grants the petition requesting the matter be presented to the Board; (2) one or more Board members request to hear the matter the time the Commissioner makes a final decision on the TMDL report; or (3) a timely request for a contested case hearing is
