Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Description and Statutory Reference: *Minnesota Statutes*, section 62J.536, requires the Minnesota Commissioner of Health, in consultation with the Minnesota Administrative Uniformity Committee (AUC), to promulgate rules pursuant to section 62J.61 establishing and requiring group purchasers and health care providers to use electronic claims and eligibility transactions with a single, uniform companion guide to the implementation guides described under *Code of Federal Regulations*, title 45, part 162. At present, all Minnesota health care providers and group purchasers subject to *Minnesota Statutes*, section 62J.536 must use Version ASC X12/004010A1 ("Version 4010A1") of the Minnesota Uniform Companion Guides. As further discussed below, in order to comply with recent federal regulations, new versions of the Minnesota Uniform Companion Guides, (Version ASC X12/005010, also referred to as "Version 5010"), are being adopted for use no later than January 1, 2012.

On January 16, 2009, the U.S. Department of Health and Human Services (HHS) published rules (CMS-0009-F) announcing the adoption of new versions of federal transaction standards, known as ASC X12/005010 ("Version 5010"). As a result, the Minnesota Department of Health (MDH), in consultation with the AUC, has adopted the Minnesota Uniform Companion Guide for the Implementation of the ASC X12/005010X279 Health Care Eligibility Benefit Inquiry and Response (270/271), ASC X12/005010X222 Health Care Claim: Professional (837), ASC X12/005010X223A1 Health Care Claim: Institutional (837), and ASC X12/005010X224A1 Health Care Claim: Dental (837), in order to be consistent with the federal regulations as cited above.

The eligibility transaction is the transmission of either of the following:

- a. An inquiry from a health care provider to a group purchaser, or from one group purchaser to another group purchaser, to obtain any of the following information about a benefit plan for an enrollee:
 - 1. Eligibility to receive health care under the group purchaser.
 - 2. Coverage of health care under the group purchaser.
 - 3. Benefits associated with the benefit plan.
- A response from a group purchaser to a health care provider's (or another group purchaser's) inquiry described in paragraph
 (a).

The health care claims or equivalent encounter information transaction is the transmission of either of the following:

- a. A request to obtain payment, and the necessary accompanying information from a health care provider to a group purchaser, for health care.
- b. If there is no direct claim, because the reimbursement contract is based on mechanism other than charges or reimbursement rates for specific services, the transaction is the transmission of encounter information for the purpose of reporting health care.

Health care providers and group purchasers subject to *Minnesota Statutes*, section 62J.536 must exchange transactions covered by the statute as follows. From the date of each Version 5010 Uniform Companion Guides' final adoption until January 1, 2012, providers and group purchasers may use only: the Minnesota Uniform Companion Guides, Version ASC X12N/004010A1 (Version 4010), including any subsequent technical changes or updates; or, by mutual agreement between trading partners, the Minnesota Uniform Companion Guides, Version ASC X12/005010 (Version 5010). Beginning January 1, 2012, providers and group purchasers may only use the Minnesota Uniform Companion Guides, Version ASC X12/005010 (Version 5010), including the following Minnesota Uniform Companion Guides for the Implementation of the: *ASC X12/005010X279 Health Care Eligibility Benefit Inquiry and Response (270/271), ASC X12/005010X222 Health Care Claim: Professional (837), ASC X12/005010X223A1 Health Care Claim: Institutional (837), and ASC X12/005010X224A1 Health Care Claim: Dental (837).*

Development: The Commissioner of Health developed these rules in consultation with the AUC and its Eligibility, Claims Data Definition, and Medical Code Technical Advisory Groups (TAGs). Program (MFPP) §1115 Waiver

Minnesota's Medicaid program is currently administering a waiver under section 1115 of the Social Security Act entitled the Minnesota Family Planning Program (MFPP). Under the MFPP waiver, the State has the authority to expand Medicaid eligibility for family planning services to people who are not otherwise eligible. The MFPP waiver is about to enter its fifth year of operation. Federal authority for the waiver ends June 30, 2011, unless a request for extension is submitted at least a year in advance.

A provision in the newly enacted federal health care reform law gives states the option to expand Medicaid eligibility for family planning services as a Medicaid state plan option without obtaining a federal waiver. With the MFPP waiver up for renewal, the State will analyze this option as a possible alternative to extending federal authority under a waiver. To assure the continuation of the MFPP, while the state plan option is under consideration, DHS intends to submit a three year extension request to CMS in June 2010 under the same terms that the waiver is currently operating.

Request for Comments on Extension of Federal Prepaid Medical Assistance Plus (PMAP+) §1115 Waiver

For over twenty years, Minnesota's Medicaid program (Medical Assistance or MA) has administered a waiver under section 1115 of the Social Security Act, now named the "Minnesota Prepaid Medical Assistance Project Plus" or "PMAP+ Waiver," allowing for the purchase of coverage from managed care organizations on a prepaid capitated basis.

In the early-1990s a series of health care reform amendments to the PMAP+ Waiver allowed for the statewide expansion of PMAP, simplified certain MA eligibility requirements, and incorporated MinnesotaCare coverage for pregnant women and children, and later MinnesotaCare parents, into Minnesota's Medicaid Program.

With passage of the Balanced Budget Act of 1997, and subsequent promulgation of related regulations in 2002, most aspects of Minnesota's pre-paid MA managed health care programs can now operate under the MA State Plan. The majority of MA recipients receiving managed care under the authority of the PMAP+ Waiver moved to state plan authority for managed care effective July 2005. In June 2005 Minnesota moved all PMAP+ seniors to Minnesota Senior Care (MSC) under the authority of a new waiver, the MSC §1915(b) waiver. Nevertheless, the PMAP+ Waiver continues to support several important components of the State's programs, including but not limited to providing Medical Assistance services with federal financial participation to populations that would not otherwise be eligible and mandatory enrollment of certain MA populations in managed care.

The PMAP+ Waiver will expire June 30, 2011. To assure the continuation of the PMAP+ project, the Minnesota Department of Human Services (DHS) intends to submit a three-year extension request for the PMAP+ Waiver to the federal Centers for Medicare & Medicaid Services (CMS) in June 2010 under the terms requested in the September 30, 2009 waiver amendment package and subsequent correspondence, which is still pending with CMS.

Notice of Availability of Draft Fish Lake Nutrient TMDL Report and Schwanz Lake Nutrient Management Plan and Request for Comment

Public Notice Period Begins: May 24, 2010 Public Notice Period Ends: June 23, 2010

The Minnesota Pollution Control Agency (MPCA) is requesting comments on the draft Report for the Fish Lake Nutrient Total Maximum Daily Load (TMDL) and Schwanz Lake Nutrient Management Plan. The draft Report for Fish and Schwanz Lakes is available for review at http://www.pca.state.mn.us/water/tmdl/tmdl-draft.html. Following the comments, the MPCA will revise the draft TMDL Report and submit it to the U.S. Environmental Protection Agency (EPA) for approval. Comments must be sent to the MPCA contact person listed below by 4:30 P.M. on June 23, 2010.

Required by the federal Clean Water Act, a TMDL is a scientific study that calculates the maximum amount of a pollutant that a waterbody can receive and still meet water quality standards for that pollutant. It is a process that identifies all the sources of the pollutant causing an impairment and allocates necessary reductions among them. This multi-year effort results in a pollution reduction plan and engages stakeholders and the general public. An approved TMDL is followed by implementation activities for achieving the necessary reductions.

Fish and Schwanz Lakes, 29 and 12 acres respectively, and their surrounding drainage areas are in the Gun Club Watershed. Located in separate parts of Eagan, both shallow lakes are in prominent city parks, which provide good public access for fishing, non-motorized boating, aesthetic enjoyment, and some swimming and wading. In 2006, the MPCA listed Fish and Schwanz Lakes as impaired for aquatic recreation because the lakes exceeded the water quality standard for nutrients. Excess nutrients such as phosphorus from stormwater runoff create poor water quality conditions causing summer algal blooms, which limits recreational activities. Efforts by the city of Eagan have improved water quality to Schwanz Lake in recent years and the MPCA will likely remove the lake from the impaired waters list, although the city intends to implement additional water quality improvement projects. A reduction of 19 percent in phosphorus loading to Fish Lake would be required to consistently meet water quality standards under average precipitation conditions. Strategies to improve water quality in Fish and Schwanz lakes include implementing Best Management Practices to reduce phosphorus from stormwater runoff in the watershed and in-lake sources.

Suggested changes will be considered before the final TMDL Report is sent to the EPA for approval.

Written Comments: You may submit written comments on the conditions of the draft TMDL Report or on the Commissioner's preliminary determination.

Written comments must include the following:

- 1. A statement of your interest in the draft TMDL Report;
- 2. A statement of the action you wish the MPCA to take, including specific references to sections of the draft TMDL that you believe should be changed; and
- 3. The reasons supporting your position, stated with sufficient specificity as to allow the Commissioner to investigate the merits of your position.

Petition for Public Informational Meeting: You also may request that the MPCA Commissioner hold a public informational meeting. A public informational meeting is an informal meeting that the MPCA may hold to solicit public comment and statements on matters before the MPCA, and to help clarify and resolve issues.

A petition requesting a public informational meeting must include the following information:

- 1. A statement identifying the matter of concern;
- 2. The information required under items 1 through 3 of "Written Comments," identified above;
- 3. A statement of the reasons the MPCA should hold a public informational meeting; and
- 4. The issues that you would like the MPCA to address at the public informational meeting.

Petition for Contested Case Hearing: You also may submit a petition for a contested case hearing. A contested case hearing is a formal evidentiary hearing before an administrative law judge. In accordance with *Minnesota Rules* 7000.1900, the MPCA will grant a petition to hold a contested case hearing if it finds that: (1) there is a material issue of fact in dispute concerning the application or draft TMDL Report; (2) the MPCA has the jurisdiction to make a determination on the disputed material issue of fact; and (3) there is a reasonable basis underlying the disputed material issue of fact or facts such that the holding of the contested case hearing would allow the introduction of information that would aid the MPCA in resolving the disputed facts in making a final decision on the draft TMDL Report. A material issue of fact means a fact question, as distinguished from a policy question, whose resolution could have a direct bearing on a final MPCA decision.

A petition for a contested case hearing must include the following information:
