# Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. # **Adopted Rules**

A rule becomes effective after the requirements of *Minnesota Statutes* §§ 14.05-14.28 have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule. If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed. If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

Rules of the Department of Natural Resources relating to removing the spearing ban on Cass Lake, Beltrami Co, in the form set out in the Revisor's draft, file number 4038, dated September 1, 2011, are adopted under my authority in Laws of Minnesota 2011, First Special Session, chapter 2, article 5, section 68.

The rules proposed and published at *State Register*, Volume 35, Number 30, pages 1086-1091, January 24, 2011 (35 SR 1086), are adopted with the following modifications:

#### 6262.0100 GENERAL RESTRICTIONS ON TAKING FISH.

#### Subp. 5. Possession of fish while on state waters.

D. While on or fishing in state waters with size restrictions that differ from statewide regulations, including experimental waters, special management waters, boundary waters, or any other waters with size restrictions, all fish for which the different size restrictions apply must be undressed and measurable when in a person's possession, regardless of where taken, except under the following conditions:

(2) when a person is on an experimental or special management water and the fish were lawfully taken, have been packaged and labeled by a licensed fish packer, are to be prepared for a meal while on the ice or shore of that water body, and do not otherwise exceed the statewide possession limits.

When fish are consumed under subitem (1)  $\frac{\text{or (2)}}{\text{or (2)}}$ , the angler must maintain the carcass of a fish with size limits in such a way that the carcass may be readily unpacked, unwrapped, and separated so that the carcass may be examined, measured, and counted to ensure compliance with size restrictions for that day, as defined under *Minnesota Statutes*, section 645.45.

**EFFECTIVE DATE.** The amendments to *Minnesota Rules*, parts 6212.1400, 6262.0100, and 6262.0500, and the repealer are effective November 1, 2011

# **Exempt Rules**

Exempt rules are excluded from the normal rulemaking procedures (*Minnesota Statutes* §§ 14.386 and 14.388). They are most often of two kinds. One kind is specifically exempted by the Legislature from rulemaking procedures, but approved for form by the Revisor of Statutes, reviewed for legality by the Office of Administrative Hearings, and then published in the *State Register*. These exempt rules are effective for two years only.

The second kind of exempt rule is one adopted where an agency for good cause finds that the rulemaking provisions of *Minnesota Statutes*, Chapter 14 are unnecessary, impracticable, or contrary to the public interest. This exemption can be used only where the rules:

(1) address a serious and immediate threat to the public health, safety, or welfare, or

(2) comply with a court order or a requirement in federal law in a manner that does not allow for compliance with *Minnesota Statutes* Sections 14.14-14.28, or

(3) incorporate specific changes set forth in applicable statutes when no interpretation of law is required, or

(4) make changes that do not alter the sense, meaning, or effect of the rules.

These exempt rules are also reviewed for form by the Revisor of Statutes, for legality by the Office of Administrative Hearings and then published in the *State Register*. In addition, the Office of Administrative Hearings must determine whether the agency has provided adequate justification for the use of this exemption. Rules adopted under clauses (1) or (2) above are effective for two years only. The Legislature may also exempt an agency from the normal rulemaking procedures and establish other procedural and substantive requirements unique to that exemption.

# **Executive Orders**

The governor has the authority to issue written statements or orders, called Executive Orders. as well as Emergency Executive Orders. The governor's authority is specified in the *Constitution of the State of Minnesota*, Article V, and in *Minnesota Statutes* § 4.035. Emergency Executive Orders, for protection from an imminent threat to health and safety, become effective immediately, are filed with the secretary of state, and published in the *State Register* as soon as possible after they are issued. Other Executive Orders become effective 15 days after publication in the *State Register* and filing with the secretary of state. Unless otherwise specified, an executive order expires 90 days after the date the governor who issued the order vacates office.

### Office of the Governor Emergency Executive Order 11-29: Providing for Assistance to the Minnesota Interagency Fire Center

**I, MARK DAYTON, GOVERNOR OF THE STATE OF MINNESOTA**, by virtue of the authority vested in me by the Constitution and applicable statutes, do hereby issue this Emergency Executive Order:

WHEREAS, a wildfire over 8,000 acres in size in Roseau County is threatening property near Greenbush, Minnesota; and

WHEREAS, the fire danger rating is at red flag conditions statewide and is expected to remain very high for the next several days; and

**WHEREAS**, state agencies, the State Emergency Operations Center, the Minnesota Department of Natural Resources, and the Minnesota Interagency Fire Center (MIFC) do not have adequate aviation resources for widespread wildfire suppression; and

WHEREAS, MIFC has requested fire suppression assets from the Minnesota National Guard;

NOW, THEREFORE, I hereby order that:

- 1. The Adjutant General of Minnesota order to state active duty on or about October 6<sup>th</sup>, 2011, in the service of the State, such personnel and equipment of the military forces of the State as required and for such period of time as necessary to support wildfire suppression in Minnesota.
- 2. The Adjutant General is authorized to purchase, lease or contract for goods and services necessary to accomplish the mission.
- 3. The cost of subsistence, transportation, fuel, pay and allowances of said individuals shall be defrayed from the general fund of the State, as provided for in Minnesota Statutes, Sections 192.49, subdivisions 1 and 2; 192.52, 192.54 and as otherwise permitted by law.

Pursuant to *Minnesota Statutes*, Section 4.035, subdivision 2, this Emergency Order is effective immediately and must be filed with the Secretary of State and published in the *State Register* as soon as possible after its issuance and will remain in effect until such date as elements of the military forces of the State are no longer required.

#### Notice of Public Hearing on the Issuance of an Agricultural Development Revenue Bond under *Minnesota Statutes*, Chapter 41C on Behalf of Jacob and Jennifer Yost

**NOTICE IS HEREBY GIVEN** that a public hearing will be held on November 1, 2011, at 9:00 A.M., Department of Agriculture Building, Rural Finance Authority Division, 625 Robert Street North, Saint Paul, Minnesota, on a proposal that the Minnesota Rural Finance Authority (the Authority) issue its revenue bond under *Minnesota Statutes*, Chapter 41C, in order to finance the purchase of approximately 33 acres of bare land located two miles west of St. Peter, MN on State Highway 99 and then two miles south on 381<sup>st</sup> Avenue; Section 36, Oshawa Township, Nicollet County, Minnesota on behalf of Jacob and Jennifer Yost, (the Borrower/s). The maximum aggregate face amount of the proposed bond issue is \$143,000.00.

The revenue bond will be a limited obligation of the Authority, payable solely from the revenue pledged to the payment thereof. No holder of such revenue bond will ever have the right to compel any exercise of the taxing power of the State of Minnesota to pay the bond or the interest thereon, nor to enforce payment against any property of the Authority or the State of Minnesota, except the revenues specifically pledged to the payment thereof. ### Minnesota Pollution Control Agency (MPCA) Municipal Division REQUEST FOR COMMENTS on Possible Amendments to Rules Governing Compost Facilities, *Minnesota Rules*, Chapters 7001 and 7035

**Subject of Rules.** The Minnesota Pollution Control Agency (MPCA) requests comments on possible amendments to rules governing siting, design and operation of yard waste and solid waste compost facilities. The MPCA is considering amendments that would authorize and regulate the operation of a compost facility that is dedicated to source-separated food waste, yard waste, and other source-separated bulking agents such as nonrecyclable paper. This rulemaking is not intended to address the incorporation of manure or industrial by-products considered unsuitable for composting with source-separated food waste. This rulemaking will not address amendments that might be necessary to allow other types of composting including:

- · Anaerobic digestion; or
- Vermicomposting.

The amendments may include a restructuring of the existing rule to aid regulated parties in navigating requirements more efficiently, minor housekeeping changes, incorporation of an extended permit concept and possible expansion of the exempt category known as the backyard compost site.

**Persons Affected.** The amendments to the rules would likely affect local units of government which locate, operate, or regulate yard or solid waste compost facilities, private entities which operate yard waste compost and solid waste compost facilities, and local residents who live or work near yard waste or solid waste compost facilities.
