Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Expedited Emergency Rules

Provisions exist for the Commissioners of some state agencies to adopt expedited emergency rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Expedited emergency rules are effective upon publication in the State Register, and may be effective up to seven days before publication under certain emergency conditions.

Expedited emergency rules are effective for the period stated or up to 18 months. Specific *Minnesota Statute* citations accompanying these expedited emergency rules detail the agency's rulemaking authority.

Department of Natural Resources (DNR) Adopted Expedited Emergency Game and Fish Rules: Special Spring Turkey Hunt

NOTICE IS HEREBY GIVEN that the above entitled rules have been adopted through the process prescribed by *Minnesota Statutes*, section 84.027, subdivision 13 (b). The statutory authority for the contents of the rules is *Minnesota Statutes*, sections 97A.415, 97A.435, 97A.465, 97B.111, 97B.711, and 97B.723.

The emergency conditions that do not allow compliance with *Minnesota Statutes*, sections 97A.0451 to 97A.0459, are that provisions that allow the transfer of licenses to persons who are severely disabled or critically ill are required by statute and will be in effect for upcoming spring hunting and fishing seasons. Annual participant information needed for setting quotas and areas for special turkey hunts are not finalized by organizers until late December. In addition a correction to turkey zone boundaries is being made for the upcoming spring turkey season.

6213.0520 TRANSFER OF LICENSES.

A person may transfer a license to a person with a severe disability or critical illness as follows:

A. the license to be transferred must be accompanied by a letter signed by the commissioner that includes the license number and the name of the person transferring the license as well as the name of the person receiving the license; and

B. the person receiving the license must be participating in a hunting or fishing program sponsored by a nonprofit organization.

- Subp. 2. **Permits for disability hunts.** For the 2012 spring wild turkey season, the following permits are available for disability hunts:

 A. For wild turkey permit area 507, one additional permit per time periods A to D is available for individuals with disabilities participating in a special hunt on the Sand Prairie Wildlife Management Area. Capable Partners is the sponsoring nonprofit organization.
- B. For wild turkey permit area 510, four additional permits per time periods A to D are available for individuals with disabilities participating in a special hunt on the Becklin Homestead Park Wildlife Management Area. Capable Partners and the Isanti County Sportsman's Club are the sponsoring nonprofit organizations.
- C. For Camp Ripley Military Reservation, within wild turkey permit area 508, up to an additional 60 permits shall be issued for time period B for individuals with disabilities participating in a special hunt. One nonhunting mentor shall accompany each disabled hunter. The St. Cloud Veterans Administration is the sponsoring organization.
- D. For wild turkey permit area 507, two additional permits are available for both time periods A and C for individuals with disabilities participating in a special hunt at the Prairie Woods Environmental Learning Center. Midwest Outdoors Unlimited and Prairie Woods Environmental Learning Center are the sponsoring nonprofit organizations.
- E. For wild turkey permit area 505, two additional permits per time periods A to D are available for individuals with disabilities participating in a special hunt on the Minnesota Valley National Wildlife Refuge. Capable Partners is the sponsoring nonprofit organization.
- F. For wild turkey permit area 507, one additional permit per time periods A to D is available for individuals with disabilities participating in a special hunt on the Sherburne National Wildlife Refuge. Midwest Outdoors Unlimited is the sponsoring nonprofit organization.


Subp. 9. **Bag limit.** The bag limit of moose is one of any age or sex antlered moose per licensed party of hunters. Only one moose may be taken by a party.

EFFECTIVE PERIOD. The expedited emergency amendment to *Minnesota Rules*, part 6232.3700, expires December 31, 2012. After the emergency amendment expires, the permanent rule as it read prior to the amendment again takes effect, except as it may be amended by permanent rule. *Minnesota Rules*, part 6232.3855, expires December 31, 2012.

Pursuant to *Minnesota Statutes* §§ 14.101, an agency must first solicit comments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, and within 60 days of the effective date of any new statutory grant of required rulemaking.
