#### Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. **NOTICE IS HEREBY GIVEN** that the MNsure Board of Directors, exercising the authorities and responsibilities under Laws of Minnesota 2013, Chapter 9, Section 7, subdivision 8, is issuing notice of final rules on the policies and procedures available for appealing eligibility determinations made by MNsure.

MNsure may respond to issues, concerns, or suggestions from public comments not specifically addressed in the final rules in future communications, via the MNsure website and other formal channels.

#### **Exempt Rules**

Exempt rules are excluded from the normal rulemaking procedures (*Minnesota Statutes* §§ 14.386 and 14.388). They are most often of two kinds. One kind is specifically exempted by the Legislature from rulemaking procedures, but approved for form by the Revisor of Statutes, reviewed for legality by the Office of Administrative Hearings, and then published in the *State Register*. These exempt rules are effective for two years only.

The second kind of exempt rule is one adopted where an agency for good cause finds that the rulemaking provisions of *Minnesota Statutes*, Chapter 14 are unnecessary, impracticable, or contrary to the public interest. This exemption can be used only where the rules:

- (1) address a serious and immediate threat to the public health, safety, or welfare, or
- (2) comply with a court order or a requirement in federal law in a manner that does not allow for compliance with *Minnesota Statutes* Sections 14.14-14.28, or
- (3) incorporate specific changes set forth in applicable statutes when no interpretation of law is required, or
- (4) make changes that do not alter the sense, meaning, or effect of the rules.

These exempt rules are also reviewed for form by the Revisor of Statutes, for legality by the Office of Administrative Hearings and then published in the *State Register*. In addition, the Office of Administrative Hearings must determine whether the agency has provided adequate justification for the use of this exemption. Rules adopted under clauses (1) or (2) above are effective for two years only. The Legislature may also exempt an agency from the normal rulemaking procedures and establish other procedural and substantive requirements unique to that exemption.

## Minnesota Department of Labor and Industry (DLI) Occupational Safety and Health Division Proposed Exempt Permanent Rules Adopting Federal OSHA Standards Regarding Cranes and Derricks

**NOTICE IS HEREBY GIVEN** that the Department of Labor and Industry, Occupational Safety and Health Division (Minnesota OSHA) proposes to adopt the following revisions to the Department of Labor and Industry, Occupational Safety and Health Rules, as authorized under Minnesota Statutes §182.655. This notice proposes the adoption by reference of amendments to Occupational Safety and Health Standards that have already been proposed and adopted by the Federal Occupational Safety and Health Administration (Federal OSHA).

All interested or affected persons have 30 days from the date this notice is published in the *State Register* to submit, in writing, data and views on the proposed amendments to the rule. Comments in support of or in opposition to the proposed amendments are encouraged. Each comment should identify the portion of the proposed amendment addressed, the reason for the comment, and any proposed change. Any person may file with the Commissioner written objections to the proposed amendments stating the grounds for those objections and may request a public hearing. A public hearing will be held if 25 or more persons submit written requests for a public hearing on the proposed amendments within the 30-day comment period. Requests for hearing must include the name and address of the person submitting the request, define the reasons for the request, and discuss any proposed changes. If a public hearing is required, the Department will proceed according to the provisions of *Minnesota Statutes* §182.655 and *Minnesota Rules* 5210.0020 to 5210.0100.

#### SUMMARY OF CHANGES

The following is a brief summary of the proposed amendments. To review the complete *Federal Register* notices referenced below, visit www.osha.gov.

(A) Cranes and Derricks in Construction: Underground Construction and Demotion; Final rule. On April 23, 2013, Federal OSHA published in the *Federal Register* a final rule that applies the requirements of the August 2010 Cranes and Derricks in Construction standards to demolition work and underground construction. Applications of this rule will protect workers from hazards associated with hoisting equipment used during construction activities. The final rule applies the same crane rules to underground construction and

demolition that are already being used by other construction sectors, and streamlines OSHA's standards by eliminating the separate cranes and derricks standard currently used for underground and demolition work. The rule also correct errors made to the underground construction and demolition standards in the 2010 rulemaking. This final rule was effective May 23, 2013 at the federal level.

By this notice, MNOSHA proposes to adopt the final rule as published in the Federal Register April 23, 2013.

**(B)** Cranes and Derricks in Construction: Revising the Exemption for Digger Derricks; Final rule. On May 29, 2013, Federal OSHA published a final rule in the *Federal Register* that broadens the exemption for digger derricks used in the electric-utility industry. The exemption has been expanded to include telecommunications work in addition to electric-utility work. This final rule provides a complete exemption from having to follow the requirements of Subpart CC of the Cranes and Derricks in Construction standard. The digger derrick exemption is part of the Cranes and Derricks final standard that was issued August 9, 2010. The final rule was effective at the federal level on June 28, 2013.

By this notice, MNOSHA proposes to adopt the final rule as published in the Federal Register May 29, 2013.

To the extent practicable, the commissioner shall appoint members to the list so that the list is gender and racially diverse.

The following standards for appointment to the Arbitration Roster are required:

- A. knowledge and understanding of labor relations and collective bargaining processes and dynamics;
- B. knowledge and understanding of applicable contract, employment, and labor relations law and rules;
- ability to hear and decide complex labor relations issues in a fair and objective manner;
- D. ability to communicate, both orally and in writing, in a clear and concise manner;
- E. ability to conduct orderly and effective arbitration hearings in a variety of settings and locations throughout Minnesota; and
- F. reputation in the labor-management community for high professional standards of competence, ethics, and integrity.

Evidence of an applicant's qualifications may be advanced in one or a combination of the following ways:

- A. submission of six or more arbitration awards or contested case decisions that were authored and signed by the applicant in the 24-month period preceding application;
- B. a minimum of six years' experience as a full-time labor relations advocate (with direct contract negotiations experience) and submission of six arbitration awards in which the applicant acted as the principal representative for either labor or management;
- C. a minimum of six years' experience as a full-time labor mediator, including substantial grievance mediation experience;

- D. a minimum of six years' experience as a practitioner or full-time instructor of labor law or industrial relations, including substantial content in the area of collective bargaining, labor agreements, and contract administration;
- E. membership in the National Academy of Arbitrators; and
- F. completion of an internship program that has been approved by the commissioner.

No applicant or roster member may currently, or within the preceding 12 month, have functioned as an advocate for any public or private sector employer, employee, or employee organization in any phase of labor-management relations. This prohibition applies to employee discharge or disciplinary appeal proceedings, whether or not the employee is represented by an exclusive representative.

**Background:** On July 16, 2013, the Board considered en banc information regarding the design of a Penguin Toilet, which includes an overflow prevention device in the form of a secondary drain line. This new technology created an IGC, a special testing requirement, and is in compliance with IGC 252-08 and CSA B45-02(R08). Penguin Toilets have a FULL listing with IAPMO and complies with the most current code in accordance with ASME A112.19.1-2008/CSA B 45.1-2008 and bears the cUPC® certification mark. It is accepted in Canada, 49 states, and around the world.

The submitter agreed that this Final Interpretation could be issued more than 30 days after his request for interpretation was received (PB0077).

The Board considered information presented by Mr. Salazar and Mr. Pat Stack, President of Penguin Toilets. All parties were heard and had fair opportunity to present facts, thoughts, opinions, and challenges pertaining to each questions contained in this Final Interpretation. The Board also sought comment, thoughts, opinions, and questions from the persons in attendance.

As required by *Minnesota Statutes* § 326B.127, subd. 5, the Plumbing Board will consider this Final Interpretation for adoption as part of the Plumbing Code.

Following the comments, the MPCA will revise the draft TMDL Report and submit it to the Environmental Protection Agency (EPA) for approval. Required by the federal Clean Water Act, a TMDL is a scientific study that calculates the maximum amount of a pollutant that a waterbody can receive and still meet water quality standards for that pollutant. It is a process that identifies sources of the pollutant causing an impairment and allocates necessary reductions among them. This multi-year effort results in a pollution reduction plan and engages stakeholders and the general public. An approved TMDL is followed by implementation activities for achieving the necessary reductions.

This TMDL study covers Lura Lake, an approximately 1300 acre shallow lake located in the LeSueur River Basin and its contributing watershed of approximately 1300 acres. The watershed has local significance as a popular recreational resource and has been impacted by invasive species, in particular Curly-leaf pondweed, affecting utilization of the lake.

- 1. A statement of reasons or proposed findings supporting the MPCA decision to hold a contested case hearing according to the criteria in *Minnesota Rules* 7000.1900, as discussed above; and
- 2. A statement of the issues proposed to be addressed by a contested case hearing and the specific relief requested or resolution of the matter.

In addition and to the extent known, a petition for a contested case hearing should also include the following information:

- A proposed list of prospective witnesses to be called, including experts, with a brief description of proposed testimony or summary of evidence to be presented at a contested case hearing;
- 2. A proposed list of publications, references, or studies to be introduced and relied upon at a contested case hearing; and
- 3. An estimate of time required for you to present the matter at a contested case hearing.

MPCA Decision: You may submit a petition to the Commissioner requesting that the MPCA Citizens' Board consider the TDML Report approval. To be considered timely, the petition must be received by the MPCA by 4:30 p.m. on the date the public comment period ends, identified on page 1 of this notice. GRE is proposing to construct approximately 5.4 miles of new double circuit 115 kilovolt transmission line and to rebuild approximately 11.3 miles of existing 69 kV transmission line to 115 kV standards. The proposed project is located in the townships of Cedar Lake, Credit River, New Market, Spring Lake, Webster, and Wheatland and the cities of Elko New Market, Prior Lake, and Savage in Rice and Scott counties.

The purpose of the project is to provide support to the Scott-Faribault 69 kV transmission system to the west of the proposed project. GRE has indicated that the most efficient way to alleviate the identified deficiencies on the Scott-Faribault system is to connect to the Cleary Lake-Elko New Market 69 kV system in the proposed project area by way of a new double circuit line between Minnesota Valley Electric Cooperative's New Market substation and Xcel Energy's Veseli distribution substation.

Although operation of the two systems at 115 kV would not be needed until 2022 and 2030, GRE has indicated that it is in the interest of the Company, the Company's cooperatives, and the cooperatives' ratepayers to construct the lines to 115 kV standards at this time. The need for the proposed project has also been discussed in the Minnesota Biennial Transmission Projects Report since 2009. If permitted, GRE anticipates construction of the project to begin in spring 2015 and energized in summer 2016.

The proposed project is a large energy facility as defined by *Minnesota Statutes*, section 216B.2421, subdivision 2(3), because it is a high-voltage transmission line with a capacity greater than 100 kV and more than 10 miles in length.
