Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Expedited Emergency Rules

Provisions exist for the Commissioners of some state agencies to adopt expedited emergency rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Expedited emergency rules are effective upon publication in the State Register, and may be effective up to seven days before publication under certain emergency conditions.

Expedited emergency rules are effective for the period stated or up to 18 months. Specific *Minnesota Statute* citations accompanying these expedited emergency rules detail the agency's rulemaking authority.

Minnesota Department of Natural Resources (DNR) Adopted Expedited Emergency Game and Fish Rules: Fall Wild Turkey Hunting

NOTICE IS HEREBY GIVEN that the above entitled rules have been adopted through the process prescribed by *Minnesota Statutes*, section 84.027, subdivision 13 (b). The statutory authority for the contents of the rule is *Minnesota Statutes*, sections 97A.435 and 97B.711.

The conditions that do not allow compliance with *Minnesota Statutes*, sections 97A.0451 to 97A.0459, are that population and harvest data needed for setting quotas and areas are only available on an annual basis. Rule changes related to the elimination of the lottery for fall turkey licenses are in response to consistently undersubscribed permit areas.

Expedited Emergency Rules

6236.0300 TURKEY HUNT DRAWING.

Subpart 1. Spring license application drawings.

A. Applications for all spring hunts must be made according to this part and according to application instructions provided by the commissioner. Each person must apply at an electronic license system agent or the Department of Natural Resources License Center. Drawings will be conducted by the department to determine persons who will be eligible to purchase licenses for each season. The drawings will be subject to the quotas established by the commissioner. Preference in the respective drawings is given to applicants based upon the number of times they have correctly applied for a license for that hunt but have been unsuccessful. A person selected by the drawings is eligible to purchase a license to hunt turkey. Upon issuance of a turkey license for the spring or fall season, all accumulated preference for that season is lost, except as provided in subpart 6.

B. No application is needed to purchase a fall turkey license.

Subp. 2. **Participation in application drawings.** Applicants may complete an application for either the spring or fall turkey hunt or both. A person may not apply more than once for a hunt, whether as an individual or as a member of a group. Qualifying individuals may apply for the resident landowner-tenant turkey drawing. All of the information in items A to H must be supplied on the application forms.

 - (2) fall season: the last Friday in July.

6236.0400 OBTAINING LICENSE.

C. Persons may purchase fall turkey licenses without an application. A turkey permit area must be selected.

6236.0700 FALL TURKEY SEASON.

Subp. 4. **Open areas.** Wild turkey permit areas are open for the fall turkey season as prescribed by the commissioner. Turkey licenses are valid for taking turkeys only in the wild turkey permit area specified on the license. The following wild turkey permit areas are open for the 2014 fall season: 501, 502, 503, 504, 505, 506, 507, 508, 509, 510, 511, and 512.

6236.0810 WILD TURKEY PERMIT AREA DESCRIPTIONS.

Subpart 1. **Designations.** Wild turkey permit areas are comprised of registration blocks with the same numbers, as established in part 6232.4700, except as follows: designated and described by the permit area numbers and boundary descriptions in this part.

A. wild turkey permit area 425 consists of Registration Blocks 425 and 435;

B. wild turkey permit area 451 consists of Registration Blocks 451, 452, and 453; and

C. wild turkey permit area 454 consists of Registration Blocks 454 and 455.

Subp. 2. **Permit area 501.** Wild turkey permit area 501 consists of that portion of the state lying within the following described boundary:

Annual deer population and harvest data used for selecting hunters and setting quotas and areas is gathered annually and analyzed each winter. Adjustments to areas and quotas are based on annual and long-term population data as well as input from the public.

6232.2560 YOUTH SPECIAL DEER SEASONS.

<u>Subpart 1. Generally.</u> Youths participating in youth special deer seasons must obtain a license for taking deer by firearms, valid for any season option, by the beginning date of the special season. A youth special season participant may take one deer, which must be antlerless. One bonus permit may be used. An adult mentor age 18 or older authorized by the youth's parent or guardian must accompany the youth hunter at all times during the hunt. The accompanying adult may not hunt. Party hunting is not allowed. The blaze orange requirements in *Minnesota Statutes*, section 97B.071, paragraph (a), apply to all hunters and trappers, and all adult mentors of youth hunters, in the areas open to firearms deer hunting during the youth special seasons established in this part.

Subp. 2. **Open areas.** Open areas and dates for youth special deer seasons shall be established annually by the commissioner. For 2014, deer permit areas 101, 105, 111, 114, 201, 203, 208, 209, 256, 257, 260, 263, 264, 267, 268, 338, 339, 341, 342, 343, 344, 345, 346, 347, 348, 349, and 601 are open October 16 to 19 for taking either sex deer by firearms for youth who are at least age ten and under age 16 at the time of the hunt. Whitewater Game Refuge is open to taking either sex deer by eligible youth. One bonus permit may be used, but a hunter may not take more than one deer. Only one legal buck may be taken during this hunt.

Subp. 3. **Special archery season.** Sand Prairie Wildlife Management Area in Stearns County is open during the regular archery season for youth ages ten through 17. The youth archery season is closed from November 8 to 16, when a special deer hunt for disabled individuals will be held on the wildlife management area. The bag limit is one deer.

Minnesota Statutes § 115B.17, subd. 13 also require the MPCA to adopt the State Superfund List and to update the list annually according to the criteria set forth in the priority rules. Before any update of the State Superfund List is adopted by the MPCA, it must be published in the State Register and a 30-day public comment period must be provided. This notice is, therefore, published to inform the public that the MPCA is proposing to update the State Superfund List and to solicit public comment on the proposed additions.

Pursuant to *Minnesota Statutes* § 115B.17 and *Minnesota Rules* 7044.0950, the MPCA is proposing the following changes to the Superfund List.
