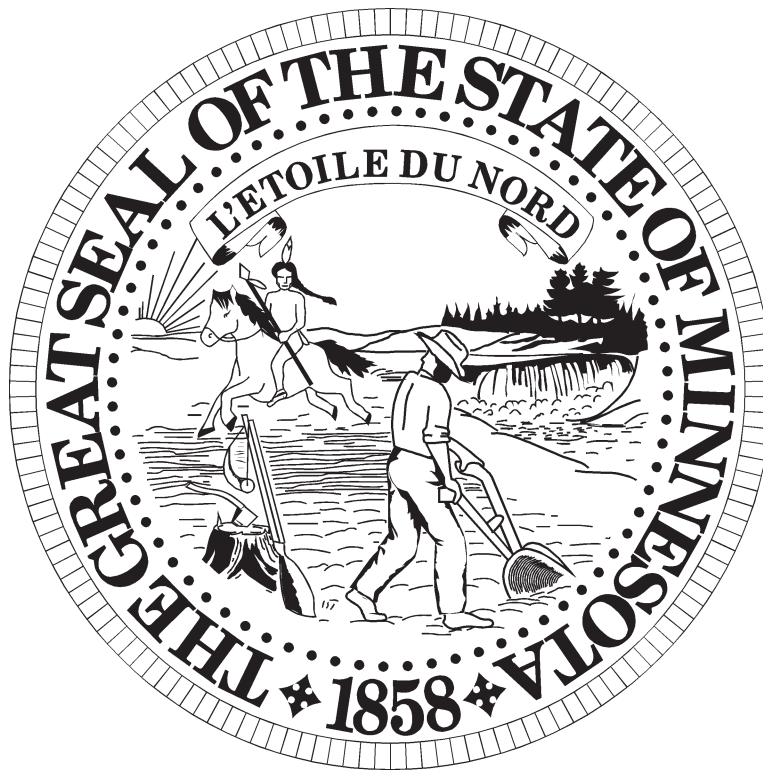

Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. NOTICE IS HEREBY GIVEN that the Department of Labor and Industry, Occupational Safety and Health Division (Minnesota OSHA), proposes to adopt the following amendment to the Department of Labor and Industry, Occupational Safety and Health Rules. Statutory authority to adopt the amendment is in *Minnesota Statutes* §182.655.

This notice proposes revisions to *Minnesota Rules* 5208.1500 "Standard Industrial Classification List for AWAIR." All interested or affected persons have 30 days from the date this notice is published in the *State Register* to submit, in writing, data and views on the proposed amendments to the rule. Comments in support of or in opposition to the proposed amendments are encouraged. Each comment should identify the portion of the proposed amendment addressed, the reason for the comment, and any change proposed.

Any person may file with the Commissioner written objections to the proposed amendments stating the grounds for those objections, and may request a public hearing. A public hearing will be held if 25 or more persons submit written requests for a public hearing on the proposed amendments within the 30-day comment period. Requests for hearing must include the name and address of the person submitting the request, define the reasons for the request, and discuss any proposed changes. If a public hearing is required, the Department will proceed according to the provisions of *Minnesota Statutes* §182.655 and *Minnesota Rules* 5210.0020 to 5210.0100.

Executive Orders

The governor has the authority to issue written statements or orders, called Executive Orders, as well as Emergency Executive Orders. The governor's authority is specified in the *Constitution of the State of Minnesota*, Article V, and in *Minnesota Statutes* § 4.035. Emergency Executive Orders, for protection from an imminent threat to health and safety, become effective immediately, are filed with the secretary of state, and published in the *State Register* as soon as possible after they are issued. Other Executive Orders become effective 15 days after publication in the *State Register* and filing with the secretary of state. Unless otherwise specified, an executive order expires 90 days after the date the governor who issued the order vacates office.

Emergency Executive Order 14-17: Providing for Relief from Regulations to Motor Carriers and Drivers Operating in the State of Minnesota for Delivery of Propane

I, MARK DAYTON, GOVERNOR OF THE STATE OF MINNESOTA, by virtue of the authority vested in me by the Constitution and applicable statutes, do hereby issue this Executive Order:

WHEREAS, due to late planting and maturing of corn crops in Minnesota, the propane industry is experiencing a distribution network shortage across the state, causing propane marketers to curtail deliveries to farmers due to transportation limitations; and

WHEREAS, localized terminal shortages are causing drivers to travel further to acquire product for marketers and farmers; and

WHEREAS, the pipeline system that provides propane service to Minnesota also serves Iowa, Nebraska, and Wisconsin where corn harvest has also begun, causing limited deliveries to multiple terminals; and

WHEREAS, long lines at terminals in southern Minnesota and drivers traveling longer distances to acquire product has depleted the available duty hours in accordance with Federal Motor Carrier Safety Regulations; and

WHEREAS, the same hazardous material drivers who transport propane also transport anhydrous ammonia; the anhydrous ammonia season is just beginning as well and will contribute to the hour shortage and driver availability; and

WHEREAS, getting behind in the transportation of propane could impact the propane industry's preparedness for the winter heating season.

NOW, THEREFORE, I hereby order that:

1. A state of emergency exists in Minnesota that requires relief from certain federal regulations incorporated in *Minnesota Statutes*, section 221.0314, subdivision 9, pertaining to hours of service for motor carriers and drivers providing direct assistance in emergency relief efforts.

2. Motor carriers and drivers transporting propane to affected areas of the state and providing direct assistance for emergency relief efforts, are exempted from paragraphs (b), under the *Code of Federal Regulations*, title 49, part 395.3 which are incorporated in *Minnesota Statutes*, section 221.0314, subdivision 9, pertaining to hours of service.

3. Nothing in this order shall be construed to relieve motor carriers and drivers transporting supplies and materials and providing direct assistance for emergency relief efforts from the requirements under paragraph (a) of the *Code of Federal Regulations*, title 49, part 395.3 which states, in part, a driver may drive only during a period of 14 consecutive hours after coming on duty following 10 consecutive hours off duty.

4. Nothing in this order shall be construed to relieve motor carriers and drivers transporting supplies and materials and providing direct assistance for emergency relief efforts from regulations pertaining to driver qualifications; driving of commercial motor vehicles; commercial drivers' licenses; drug and alcohol testing for drivers; or equipment, parts, and accessories necessary for the safe operation of vehicles.

5. No motor carrier or driver operating under the terms of this order shall require or allow an ill or fatigued driver to operate a motor vehicle. Any driver who informs a carrier that he or she needs immediate rest shall be given at least ten consecutive off-duty hours before the driver is required to return to service.

6. Upon the expiration of this order, or when a motor carrier or driver ceases to provide direct assistance to the emergency relief effort, a driver that has had at least thirty-four consecutive hours off-duty must be permitted to start his or her on-duty status hours and 60/70-hour clock at zero.

Pursuant to *Minnesota Statutes*, section 4.035, subdivision 2, this Emergency Executive Order is effective immediately and must be filed with the Secretary of State and published in the *State Register* as soon as possible after its issuance. Emergency relief from regulations for motor carriers and drivers transporting propane to affected areas of the state, shall remain in effect until November 23rd, 2014, or until the commercial motor carrier or driver ceases direct assistance in providing emergency relief, whichever occurs first. For purposes of this Emergency Executive Order, direct assistance is defined in *Minnesota Statutes*, section 221.0269, subdivision 3, paragraph (c). This Emergency Executive Order may be extended in accordance with *Minnesota Statutes*, section 221.0269, subdivision 2.

Subject of Rules. The Minnesota Board of Nursing requests comments on its proposed repeal and amending of rules governing program approval. Proposed program approval rules would include approval of advanced practice nursing education, and may include revision of definitions as needed to address best practices in nursing education and clarification of requirements related to approval when education is delivered via distance education from programs located in other states or jurisdictions, as well as other elements of rule that are identified as needing change during the rulemaking process. Rules would continue to include the necessary terminology to reflect the continuing need for Board oversight for compliance with all additional applicable program approval rules.

Persons Affected. The proposed revision of program approval rules would affect applicants for program approval and continuing program approval of nursing programs and nursing students in approved nursing programs.

Statutory Authority. The statutory authority for revision of program approval rules are:

- *Minnesota Statutes*, section 148.191, subdivision 2 authorizing the board to adopt and, from time to time, revise rules not inconsistent with the law, as may be necessary to enable it to carry into effect the provisions of sections 148.171 to 148.285. The board shall prescribe by rule curricula and standards for schools and courses preparing persons for licensure under sections 148.171 to 148.285. It shall conduct or provide for surveys of such schools and courses at such times as it may deem necessary. It shall approve such schools and courses as meet the requirements of sections 148.171 to 148.285 and board rules.
- *Minnesota Statutes*, section 148.251, subdivision 1 to subdivision 6 outlines the Board's authority to grant initial approval, continuing approval, loss of approval, reinstatement of approval, and require associate degree programs to provide for advanced standing for licensed practical nurses.

Subject of Rules. The Minnesota Racing Commission requests comments on its possible amendment to rules governing Horse Racing. The Commission is considering a rule amendment to 7869 that adds riding crop to the definition of "equipment". The change to 7871 would allow the vendor of a handicapper tip sheet sold at the track to electronically submit a copy to the Racing Commission office. The rule proposals to 7873 are all related to the rules governing exotic betting. Rule 7875 modifies the use of electronic communications devices in the jockeys' and drivers' room and posting of jockey insurance coverage. The first revision to 7877 is a housekeeping change that modifies the language regarding finger prints and age of the applicant to be consistent with other areas of the rules. The second change to 7877 is a revision to Jockey mount fees. The third modification to 7877 adds provisions to the requirement of a trainer's proof of compliance with workers' compensation laws. The remaining changes to 7877 are in regard to rights and duties of jockeys and jockey agents. The amendment to 7878 changes minimum selection standards for track association security officers. The next proposal is to 7883 and the number of horse a trainer can enter in an overnight event. The remaining changes to 7883 pertain to claiming races and racing equipment. The final changes, to 7884 Harness Races Chapter, are all related to harness racing and include housekeeping changes on language, requirements regarding qualifying races, claiming races, racing equipment, and driver conduct during the race.

Persons Affected. The amendment to the rules would likely affect the horse owners, trainers, jockeys, drivers, vendors, the racetracks, betting public, jockey agents, security officers, and judges.

Statutory Authority. *Minnesota Statutes*, sections 240.03, 240.13, 240.16, and 240.23 authorize the Racing Commission to amend rules which affect the integrity of racing or the public health, welfare, or safety.

The Minnesota Historical Society seeks candidates for service on the Historic Resources Advisory Committee (HRAC). Committee members provide policy and grant-making guidance for the Minnesota Historical and Cultural Heritage Grants program, funded by the Legacy Amendment's Arts and Cultural Heritage Fund. HRAC members also make recommendations to the Society's Executive Council regarding the awarding of Minnesota Historical and Cultural Heritage grants.

The Arts and Cultural Heritage Fund (ACHF) is one of four funds created by the Legacy Amendment, passed by voters in November 2008. For the current biennium (2014-2015), the Minnesota Legislature appropriated \$27.8 million from the Arts and Cultural Heritage Fund to the Minnesota Historical Society, including \$11.2 million for Minnesota Historical and Cultural Heritage grants to be awarded during the biennium. Expectations are high for what these grants can accomplish across Minnesota – they are supporting projects of enduring value for the cause of history and historic preservation.

The Minnesota Historical Society administers the competitive Minnesota Historical and Cultural Heritage Grants program and appoints members to the Historic Resources Advisory Committee. Legislation specifies that the committee have balanced statewide membership and include representatives of local, county, and statewide historic and cultural organizations and programs. It further requires that the committee include members representing interests such as historic preservation, local history, archaeology, archival programs and other cultural programs related to the history of Minnesota.

The anticipated time commitment for Historic Resources Advisory Committee (HRAC) members is substantial, but is focused around the yearly working meeting. The Minnesota Department of Agriculture (MDA) is responsible for the development and implementation of the Nitrogen Fertilizer Management Plan (NFMP). The NFMP outlines how the MDA will monitor, assess and address elevated nitrate levels in groundwater from agricultural crop production. The MDA Township Testing Program, which is an integral part of the NFMP, will help inform the identification of areas vulnerable to nitrate contamination of the groundwater. In the NFMP, agricultural producers continue to be encouraged to adopt best management practices (BMPs) based on the best science currently available. The NFMP also recognizes that existing BMPs may not adequately protect the groundwater in some geologic sensitive areas. To address this, the NFMP introduces the concept of alternative management tools (AMTs), which are advanced practices that may be required to protect the groundwater or mitigate groundwater contamination. It will be imperative that the MDA has appropriate tools and methods to help determine where the promotion of AMTs should occur.

The MDA expects that this request for proposals (RFP) covers the first segment of a multi-phase project. In their proposal, applicants are encouraged to lay out a plan for a 4-6 year project with a logical progression between individual project phases, each two years in duration, and a projected long-term budget. The project period for this first phase is approximately 18 months, ending on June 30, 2016.

PROJECT TASKS:

Task 1. Introduce and Specify why the Suggested Simulation Model(s) is(are) Appropriate for This Study

Conduct a literature review and provide an overall assessment of the modeling tools the applicant recommends using and discuss why these models are the most appropriate for each of the major groundwater sensitive areas of the state. The MDA recognizes that different production systems and areas require different models, and the maturity and applicability of the models may vary. The models should be able to accommodate anticipated advances in nutrient and water management, such as improved variable rate nitrogen fertilizer technologies and other BMPs, and climate variations. Production systems of interest to the MDA include (in prioritized order):

- 1) Irrigated crop production on outwash soils. The MDA is particularly interested in crop rotations which includes the major N demanding crops such as corn and potatoes;
- 2) Loess soils underlain by karst formations with emphasis on the dominant confounding factors such as manure and legume crediting;
- 3) Till or laustrine soils with subsurface drainage directly impacting drinking water supplies.

Of interest is also a quantification of the hydrologic impacts of subsurface drainage on shallow aquifer recharge rates.

Task 2. Assess Existing Field and Watershed Scale Projects for Inclusion into the Project

Evaluate existing research and monitoring locations in Minnesota and address the feasibility of incorporating site characteristics and monitoring data into the project. Evaluate and build upon past groundwater modeling work and past Clean Water Fund projects. Also,

additional monitoring needs to support the research or outreach components should be identified. Field locations may include University of Minnesota Research Centers and MDA research or demonstration sites. Applicants may identify and utilize additional monitoring sites to be included in the study.

Task 3. Generate Predictive Nitrate Loss Estimates

The project will develop, enhance and demonstrate tools or models for predicting nitrate loss estimates from common crop rotations and agricultural management practices (outlined under Task 1) in Minnesota.

Task 4. Education and outreach

The project should identify and include effective strategies for delivering the findings generated from the project to producers, farm organizations, fertilizer dealerships, state and local government staff and other stakeholders. Particular emphasis should be placed on effectively engaging agricultural producers. The MDA recognizes that effective education and outreach activities are fundamental for recommendations that lead to change.
