Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Required by the state Clean Water Legacy Act, a WRAPS Report is a document summarizing scientific studies of a major watershed no larger than a hydrologic unit code 8. The WRAPS Report includes the physical, chemical, and biological assessment of the water quality in the watershed; identification of impairments and water bodies needing protection; and identification of biotic stressors and sources of pollution, point and nonpoint. The science, analysis and strategy development described in this Report began before accountability provisions were added to the Clean Water Legacy Act in 2013 (*Minnesota Statutes* 114D); thus, this Report does not address all of those provisions. When this watershed is revisited (according to the 10-year cycle), the information will be updated according to the statutorily required elements of a Watershed Restoration and Protection Strategy Report. TMDLs are explained for the impairments and an implementation table is included with the strategies to achieve and maintain water quality standards and goals.

This TMDL Report focuses on pollution caused by excess nutrients in lakes and turbidity in streams. The TMDL Report is a scientific study that calculates the maximum amount of a pollutant that a water body can receive (known as the "loading capacity") without exceeding water quality standards. 1,100 square miles within Clay, Becker, Wilkin, and Otter Tail counties. The Watershed is located in the Red River of the North Basin and spans three ecoregions: the Lake Agassiz Plain (LAP), the North Central Hardwood Forests (NCHF), and the Northern Lakes and Forests (NLF). Land use within the Watershed is predominantly agricultural, occurring in the west and central portions; the eastern portion of the Watershed is mostly forested. Municipalities located within the BRW include Glyndon, Hawley, Lake Park, Audubon, Callaway, Georgetown, and Barnesville.

The MPCA has listed 38 waterbodies in the BRW as impaired for water quality (i.e., not meeting the standards that have been set for them) and needing a TMDL. The draft 2014 303(d) list contains a total of 61 impairment listings for the BRW's waterbodies: 22 for *E. coli*, 13 for turbidity, 16 for excess nutrients, 4 for aquatic macroinvertebrate bioassessment, 3 for fish bioassessment, 2 for dissolved oxygen (DO), and 1 for mercury. Of the 61 listings on the 303(d) list, 53 are addressed in this TMDL, i.e. a TMDL calculation is performed. They include the 22 *E. coli*, 13 turbidity, 15 excess nutrients, and 3 biologic impairments. The remaining 8 listings are not addressed because either they already have an approved TMDL (1 mercury impairment), are the result of non-conventional stressors like altered hydrology (4 biological impairments), are wholly located within a National Wildlife Refuge (1 excess nutrient impairment – North Tamarack Lake), or will be completed in the future because of a lack of necessary data (2 DO impairments).

Located in south central Minnesota, the Le Sueur River watershed covers 710,832 acres in the Western Corn Belt Plains (WCBP) and North Central Hardwood Forests (NCHF) ecoregions and drains portions of five counties (Blue Earth, Faribault, Freeborn, Steele and Waseca). The eastern portion of the watershed is a gently rolling landscape, while the western half of the watershed is dominated by the relatively flat remnant of glacial Lake Minnesota. As the Le Sueur River approaches its confluence with the Blue Earth River, the gradient increases as it cuts through high bluffs. Eagle Lake, Wells and Janesville are the largest towns in the largely rural watershed.
