Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Revenue Notices

Minnesota Department of Revenue (MDOR)

Revenue Notice # 15-03: Sales and Use Tax – Multiple Points of Use – Limitation on Purchaser Refund Claims and Amended Returns

Introduction

This Revenue Notice sets out the department's position that purchaser refund claims and amended returns are not valid when based on an apportionment of use tax among multiple jurisdictions.

Background

Enacted in 2013, *Minnesota Statutes*, section 297A.668, subdivision 6a, permits business purchasers of a service, digital good or computer software delivered electronically to apportion use tax among multiple taxing jurisdictions if:

1. the business purchaser knows at the time of purchase that the service, digital good or computer software delivered electronically will be concurrently available for use in multiple jurisdictions, and
2. the business purchaser delivers to the seller at the time of purchase a fully completed exemption certificate indicating multiple points of use.

Upon receipt of the fully completed exemption certificate, the seller is relieved of its obligation to collect, pay or remit the applicable tax and the business purchaser must apportion the tax in a reasonable, consistent, and uniform method that is supported by the purchaser's business records as they exist at the time the sale is consummated and report and pay the apportioned use tax to the department as required in *Minnesota Statutes*, sections 289A.11 and 289A.20, subdivision 4. When an exemption certificate provided and received on the date of sale is incomplete, sellers are afforded the good faith protections provided under *Minnesota Statutes*, section 297A.668, subdivision 6a(b).

Purchaser Refund Claims

If tax was paid on a transaction that is exempt from sales tax under chapter 297A, then the purchaser may file a refund claim under *Minnesota Statutes*, section 289A.50, subdivision 2a. The multiple points of use provision under *Minnesota Statutes*, section 297A.668, subdivision 6a, does not provide an exemption from sales and use tax; rather it only affords the business purchaser the option to apportion use tax to multiple taxing jurisdictions if all the requirements of the statute are met.

Because the option to apportion use tax indicating multiple points of use is only available at the time of purchase and is not an exemption from sales or use tax, a business purchaser cannot later — after the completion of the sale — apply for a purchaser refund claiming multiple points of use. Consequently, it is the department's position that purchaser refund claims under *Minnesota Statutes*, section 289A.50, subdivision 2a, asserting multiple points of use are not valid.

Amended Returns

Similarly, if use tax was paid on a transaction in excess of the taxes lawfully due under chapter 297A, then a purchaser may file an amended use tax return under *Minnesota Statutes*, section 289A.50, subdivision 1(b).

A business purchaser that purchases a service, digital good, or computer software delivered electronically and self-assesses use tax at the time of purchase cannot later amend their return and attempt to reapportion use tax based on multiple points of use. This is because multiple points of use is not an exemption, rather it is only a provision that permits the purchaser to apportion use tax if at the time of purchase all the statutory requirements are met. Consequently, it is the department's position that amended use tax returns asserting multiple points of use are also not valid.

Remove the requirement to submit clinical materials for HIV under 4605.7040.

Add a requirement to submit clinical materials for Mumps under 4605.7040.

Remove obsolete Varicella Zoster Disease provision, part 4605.7042

Making other similar or related changes as time allows.

NOTICE IS HEREBY GIVEN to direct providers, counties, Tribes, managed care organizations, advocates, consumers, and other interested parties that extensive changes will transpire in the diagnostic code list of recognized mental illnesses as a result of the State complying with a federal mandate to implement International Classification of Diseases, 10th Revision (ICD-10).

This notice is given to meet requirements of the aforementioned provisions of State Statutes.

Description of Change: The notice is required because of the expected transition from the International Classification of Diseases, Ninth Revision (ICD-9), to the International Classification of Diseases, 10th Revision (ICD-10), for dates of services on or after October 1, 2015. Currently mental health public programs statewide including Minnesota Health Care Programs (MHCP) use the definition of emotional disturbance or mental illness which included ICD-9-CM code ranges of 290.0 to 302.9 or 306.0 to 316.0 for determining service eligibility.

Implementation of ICD-10 will require providers to:

- Submit claims with ICD-10-CM codes for dates of services on or after October 1, 2015.
- Comply with the United States Department of Health and Human Services final rule published on July 2014, in the *Federal Register*, to implement Section 212 of the Protecting Access to Medicare Act of 2014 (PAMA) (Public Law 113-93). PAMA prohibited the Secretary of Health and Human Services from adopting the ICD-10 code sets prior to October 1, 2015. The final rule that went into effect on September 3, 2014, changed the compliance date for ICD-10 from October 1, 2014, to October 1, 2015. The final rule also required the continued use of the ICD-9, Clinical Modification (ICD-9-CM) through September 30, 2015.

Diagnostic Code List: Information on the mental health diagnostic code list, referenced in the Adult and Children's Mental Health Acts, is available in the Minnesota Health Care Program Provider Manual **Mental Health Section**.

Subject of Rules. The Minnesota Department of Labor and Industry requests comments on its possible amendment to rules governing high pressure boiler attendance and requirements necessary to administer and enforce rules related to high pressure boiler attendance. Specifically, the Department is considering rule amendments to modify the horsepower levels that determine the attendance requirements for high pressure boiler plants and to create new rules concerning remote monitoring of high pressure boilers that are unattended in unoccupied buildings.

Subject of Rules. The Minnesota Board of Pharmacy requests comments on its possible Adoption of Rules Governing Pharmacy Practice, including Pharmacy Work Conditions Related to the Safety of the Public. The Board is considering adopting a new rule that would prohibit a pharmacy that is licensed under *Minnesota Statutes* §151.19, subd. 1, and that is located within the State of Minnesota, from requiring a pharmacist, pharmacy intern or pharmacy technician to work for more than twelve continuous hours per day. The rule would also require that pharmacists, pharmacy interns and pharmacy technicians, working longer than six continuous hours per day, be allowed during that time period to take a 30 minute, uninterrupted meal break and one additional uninterrupted 15 minute break.

Persons Affected. The adoption of this rule would likely affect members of the general public who have prescriptions filled, pharmacies (including their owners), pharmacists, pharmacy technicians, and pharmacist interns.

Statutory Authority. *Minnesota Statutes*, section 151.06, subd. 1, authorizes the Board to regulate the practice of pharmacy and to adopt rules for carrying out and enforcing the provisions of Chapter 151.

The MPCA will prepare responses to comments received and make any necessary revisions of the two documents. Subsequent to the revision(s), the draft TMDLs will be submitted to the U.S. Environmental Protection Agency (EPA) for approval; the WRAPS Report will be forwarded to the MPCA Commissioner for approval.

Required by the state Clean Water Legacy Act, a WRAPS Report is a document summarizing scientific studies of a major watershed no larger than a hydrologic unit code 8. The WRAPS Report includes the physical, chemical, and biological assessment of the water quality in the watershed; identification of impairments and water bodies needing protection; and identification of biotic stressors and sources of pollution, point and nonpoint. The science, analysis and strategy development described in this Report began before accountability provisions were added to the Clean Water Legacy Act in 2013 (*Minnesota Statutes* 114D); thus, this Report may not address all of those provisions. When this watershed is revisited (according to the 10-year cycle), the information will be updated according to the statutorily

required elements of a Watershed Restoration and Protection Strategy Report. TMDLs are explained for the impairments and an implementation table is included with the strategies to achieve and maintain water quality standards and goals.

The TMDL Report focuses on pollution caused by excess bacteria and associated pathogens in Kelle's Creek, as well as excess nutrients in Sunfish Lake. Thus, the TMDL document builds on significant work already completed in the Lower St. Croix River watershed. The TMDL Report is a scientific study that calculates the maximum amount of a pollutant that a water body can receive (known as the "loading capacity") without exceeding water quality standards.

The Valley Branch Watershed is located in the Lower St. Croix River Basin on the eastern edge of the Minneapolis-St. Paul Metropolitan area and covers approximately 70 square miles. Land use in the watershed is variable, but generally a mix of agricultural, forested, and developed land.

The Watershed Restoration and Protection Strategies Report and TMDLs for the Valley Branch Watershed are being developed by a collaboration of state agencies and local watershed stakeholders.
