Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Proposed Rules

Comments on Planned Rules or Rule Amendments. An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, and within 60 days of the effective date of any new statutory grant of required rulemaking.

Rules to be Adopted After a Hearing. After receiving comments and deciding to hold a public hearing on the rule, an agency drafts its rule. It then publishes its rules with a notice of hearing. All persons wishing to make a statement must register at the hearing. Anyone who wishes to submit written comments may do so at the hearing, or within five working days of the close of the hearing. Administrative law judges may, during the hearing, extend the period for receiving comments up to 20 calendar days. For five business days after the submission period the agency and interested persons may respond to any new information submitted during the written submission period and the record then is closed. The administrative law judge prepares a report within 30 days, stating findings of fact, conclusions and recommendations. After receiving the report, the agency decides whether to adopt, withdraw or modify the proposed rule based on consideration of the comments made during the rule hearing procedure and the report of the administrative law judge. The agency must wait five days after receiving the report before taking any action.

Rules to be Adopted Without a Hearing. Pursuant to *Minnesota Statutes* § 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing. An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public. The agency then publishes a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the *State Register*. If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.14-14.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the *State Register*.

NOTICE OF EXTENSION OF COMMENT PERIOD AND DEADLINE FOR REQUESTING A HEARING. The Office of the Minnesota Secretary of State published a notice of intent to adopt rules without a public hearing on January 19, 2016. To comply with Minnesota Rules and the Administrative Procedure Act, the Office is extending the time to comment and time to request a hearing to 4:30 on Thursday, February 18, 2016. This revised dual notice reflects the new comment period deadline and new deadline to request a hearing.

Introduction. The Office intends to adopt rules without a public hearing following the procedures in the rules of the Office of Administrative Hearings, *Minnesota Rules*, parts 1400.2300 to 1400.2310, and the Administrative Procedure Act, *Minnesota Statutes*, sections 14.22 to 14.28. If, however, 25 or more persons submit a written request for a hearing on the rules by **4:30 p.m. on February 18**, **2016**, the Office will hold a public hearing in the Board Room of the Retirement Systems of Minnesota Building, 60 Empire Drive, Saint Paul, Minnesota, 55103, starting at 9:30 on Tuesday, March 1, 2016. To find out whether the Office will adopt the rules without a hearing or if it will hold the hearing, you should contact the agency contact person after **February 18**, **2016** and before March 1, 2016.

Expedited Emergency Rules

Provisions exist for the Commissioners of some state agencies to adopt expedited emergency rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Expedited emergency rules are effective upon publication in the State Register, and may be effective up to seven days before publication under certain emergency conditions.

Expedited emergency rules are effective for the period stated or up to 18 months. Specific *Minnesota Statute* citations accompanying these expedited emergency rules detail the agency's rulemaking authority.

Minnesota Department of Natural Resources (DNR) Adopted Expedited Emergency Game and Fish Rules: Light Goose Conservation Action

NOTICE IS HEREBY GIVEN that the above entitled rules have been adopted through the process prescribed by *Minnesota Statutes*, section 84.027, subdivision 13 (b). The statutory authority for the contents of the rule is *Minnesota Statutes*, sections 97B.731.

The conditions that do not allow compliance with *Minnesota Statutes*, sections 97A.0451 to 97A.0459, are as follows: The need for control of light geese is based on an ongoing effort to reduce their populations, as prescribed and authorized by the U.S. Fish and Wildlife Service.

6240.0600 SPECIAL PERMITS FOR LIGHT GOOSE POPULATION CONTROL.

- Subpart 1. **Definition.** For purposes of this part, "light goose" means a lesser snow goose including a blue phase lesser snow goose (Anser c. caerulescens) or Ross' goose (Anser rossii).
- Subp. 2. **Permit required.** A person may not take a light goose during the period prescribed in subpart 3 except under a valid permit and in full compliance with the conditions contained in the permit and in this part. Residents and nonresidents may apply for permits. No hunting license or stamps are required. A permit holder must have a permit in possession at all times when taking or transporting light geese taken under this part and must retain the permit for as long as the permit holder possesses light geese taken under this part.
- Subp. 3. Open harvest period. Light geese may be taken from March 1 to April 30 with permits issued under this part. Shooting hours are one-half hour before sunrise to one-half hour after sunset.
 - Subp. 4. Bag limits. No daily or bag limits apply to taking light geese under this part.
- Subp. 5. Game refuges and waterfowl refuges. All state refuges closed to migratory waterfowl hunting are closed to taking light geese under this part. All waterfowl refuges closed by posting to taking ducks or geese during any portion of the fall waterfowl seasons are closed to taking light geese under this part. All controlled hunting stations in the Lac qui Parle Game Refuge, Chippewa and Lac qui Parle Counties, are closed to taking light geese under this part.

Subp. 6. Permit conditions; applicability of other laws and rules.

- A. A permit issued under this part is effective on the date of issuance or on March 1, whichever occurs later. A permit expires on April 30 of the year of issuance.
- B. Except as provided in subparts 2 to 5, all applicable provisions of state statutes and federal law for taking migratory waterfowl apply to taking light geese under this part. All applicable rules for taking migratory waterfowl apply to taking light geese under this part, unless inconsistent with or otherwise provided in this part.

Expedited Emergency Rules

- C. Permittees must submit records of their light goose harvest by July 1 on forms provided by the commissioner.
- Subp. 7. **Permit application.** Application for a permit under this part must be made using the application processes established by the commissioner under *Minnesota Statutes*, section 84.027, subdivision 15.
- Subp. 8. Penalties. Violation of this part or the conditions of any permit issued under this part results in revocation of the permit and any other penalty provided by state or federal law.
- Subp. 9. Light goose permit eligibility. To be eligible for a light goose permit, a person must not have any small game hunting privileges revoked within one year prior to purchasing a light goose permit.

EFFECTIVE PERIOD. Minnesota Rules, part 6240.0600, is effective March 1, 2016.

REQUEST FOR COMMENTS on Possible Amendment to Rules Governing Horse Racing, *Minnesota Rules*, 7869 Definitions; 7871 Televised Racing Days; 7877 Class C Licenses; 7879 Stewards; 7883 Thoroughbred/Quarter Horse Races; 7884 Harness Races; 7897 Horse Racing; Prohibited Acts; Revisor's ID Number R-04394

Subject of Rules. The Minnesota Racing Commission requests comments on the possible amendment to rules governing Horse Racing. Included are the following:

Rule 7869, subp. 32—Industry requested this rule change to exclude cloned horses from horse racing. Chapter 240 already defines "horse racing" so the change was added to the definition of "horse" under MRC rules. This has the same practical effect—to exclude cloned horses from horse racing in Minnesota.

Rule 7869.0100, subp. 57—The definition of "simulcast" is being stricken from the rules because it is defined in statute.

Rule 7869.0200, subp. 1—USTA Rule 10 regarding claiming races is now USTA Rule 11. USTA Rule 18.25 defines permissible sulkies and is being incorporated by reference.

Rule 7869.0200, subp. 2 is required per the Revisor's Office to effectuate incorporation of industry model rules by reference. Subp. 3 clarifies the process by which MRC will adopt changes to the ARCI uniform rules.

Rule 7871.0010—These changes simplify and streamline the process for approval of pari-mutuel pools.

Rule 7877.0170, subp.1—Clarifies an owner's duty to provide racing colors.

Rule 7879.0200, subp. 1—extends the stewards' authority to 90 days beyond the race meet in order to address matters that arose during the course of the meet. The rule has been in effect for county fair racing.

Rule 7879.0200, subp. 2—Conforms the rule to existing practice of stewards making recommendations on qualifications of Class C license applicants to the executive director.

Rule 7879.0200, subp. 3—Conforms the criteria for stewards when making recommendations on licensure to those set forth in statute and rule. Existing criteria are vague and difficult to apply.

Rule 7883.0100, subp. 1—Puts in language that was inadvertently omitted in the final rule as previously published.

Rule 7883.0100, subp. 2—Non-substantive change.

Rule 7883.0100, subp. 6—The proposed rule makes clear that a person whose license is revoked or denied may not enter a horse in a race.

7883.0100, subp. 7—The proposed rule addresses the concern that allowing a trainer to enter four horses in a race can lead to concerns about the integrity of both the entry process and the running of the race. The interested parties agreed that limiting

trainer entries to three per race was reasonable.

Rule 7883.0100, subp. 11—Conforms the process for drawing entries to current practice.

Rule 7883.0100, subp. 16—Conforms Quarter horse workout requirements to those found in Iowa, Oklahoma, Texas, which are states from which many Quarter horses come to race at Canterbury.

Rule 7883.0140, subp. 15—This rule clarifies the procedures and the basis for voidance of a claim in those instances of a medication violation involving the claimed horse.

Rule 7883.0140, subp. 22—This rule change was suggested to accommodate owners of horses who may be restricted from racing in other states even though the Canterbury mixed meet has ended, except for final weekend stakes races.

Rule 7883.0160, subp. 6(D)-Rule change substitutes "suspended" for "set down".

Rule 7884.0125—The rule is changed to conform to current practice.

Rule 7884.0195—The word "stewards" is defined in statute to include "judge" and "presiding judge". Thus, there is no need to use the word "judges" in 7884.

Rule 7884.0230—Current Minnesota rules on sulkies are obsolete. The USTA rule on sulky requirements is being incorporated by reference to maintain currency in sulky requirements.

Rule 7884.0260, subp. 10—Industry uniform rules provide that disqualifications due to fouls or driving violations are not appealable.

Rule 7884,0260, subp. 11—The proposed rule is intended to clarify the driving rules and make the bases for disqualification more objective.

Rule 7897.0120, subp. 1—Conforms the scope of "persons" subject to enforcement action to the statutory section on prohibited acts, which covers both licensees and other persons.

Rule 7897.0120, subp. 3—Expands reciprocity to persons who have been denied a license in another jurisdiction. If the MRC can revoke or suspend a licensee under reciprocity rules (where the licensee has a property interest in the license), then it should be clear in rule that it has the power to deny a license, the granting of which is a privilege. Further, the authority to deny a license to an applicant previously denied in another state or to exclude such person under 240.27 is already in statute.

Rule 7897.0130, subp. 3—The proposed rule clarifies the factors used to determine whether a violation is "serious" and adds criteria that are consistent with Chapter 240-public health safety and welfare; integrity of racing, etc.

Rule 7897.0130, subp. 4—The proposed rule adds Class 1 foreign substance violations to the list of per se serious violations. Class 1 substances are those that have no generally accepted medical use in a race horse and their pharmacologic potential for altering the performance of a race horse is very high. All DEA schedule 1 substances are included in this class because they are potent stimulant or depressant substances with psychotropic and often habituative actions. Many of these agents are DEA schedule II substances such as opiates, synthetic opioids and psychoactive drugs, and amphetamines.

The Uniform Recommended penalties for Class I violations are one year suspension and \$10,000 for the first offense; three year suspension and \$25,000 for the second lifetime offense; and five years and \$50,000 for the third lifetime offense. Thus, they should be per se serious offenses under MRC rules.

Rule 7897.0130, subp. 5—MRC's proposed changes are intended to bring the outdated fine schedule into line with the Uniform penalty guidelines, which are being adopted in this proposed rule package. The current fine schedule is inadequate to function as a deterrent to serious offenders or to offset commission costs of enforcement actions.

Rule 7897.0130, subp. 6—The rule allows for additional penalties and sanctions for licensees who are delinquent in payment of fines to the State of Minnesota.

Rule 7897.0150, subp. 2—The proposed rule conforms the stewards' penalty authority to the statute, codifies the current practice of using the ARCI Uniform penalty guidelines for medication violations, clarifies the meaning of "aggravating" and "mitigating" circumstances in arriving at appropriate penalties, and articulates the goals to be considered in determining such penalties.

Persons Affected. The amendment to the rules would likely affect horse owners, trainers, drivers, stewards and judges.

Statutory Authority. *Minnesota Statutes*, sections 240.03, 240.23, 240.24, and 240.25 authorize the Racing Commission to amend rules which affect the integrity of racing or the public health, welfare, or safety.

Public Comment. Interested persons or groups may submit comments or information on these possible rules in writing or orally until further notice is published in the *State Register* that the Commission intends to adopt or to withdraw the rules. The Commission does not contemplate appointing an advisory committee to comment on the possible rules. Interested persons may also comment via the Office of Administrative Hearings Rulemaking e-Comments Website at https://minnesotaoah.granicusideas.com/.
