### Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. # **Proposed Rules**

**Comments on Planned Rules or Rule Amendments.** An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, and within 60 days of the effective date of any new statutory grant of required rulemaking.

**Rules to be Adopted After a Hearing.** After receiving comments and deciding to hold a public hearing on the rule, an agency drafts its rule. It then publishes its rules with a notice of hearing. All persons wishing to make a statement must register at the hearing. Anyone who wishes to submit written comments may do so at the hearing, or within five working days of the close of the hearing. Administrative law judges may, during the hearing, extend the period for receiving comments up to 20 calendar days. For five business days after the submission period the agency and interested persons may respond to any new information submitted during the written submission period and the record then is closed. The administrative law judge prepares a report within 30 days, stating findings of fact, conclusions and recommendations. After receiving the report, the agency decides whether to adopt, withdraw or modify the proposed rule based on consideration of the comments made during the rule hearing procedure and the report of the administrative law judge. The agency must wait five days after receiving the receiving the report before taking any action.

**Rules to be Adopted Without a Hearing.** Pursuant to *Minnesota Statutes* § 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing. An agency must first solicit **Comments on Planned Rule Amendments** from the public. The agency then publishes a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the *State Register*. If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.1414.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the *State Register*.

### **Minnesota Gambling Control Board** NOTICE OF INTENT TO ADOPT RULES WITHOUT A PUBLIC HEARING Proposed Amendment to Rules Governing Lawful Gambling, Primarily Raffle Boards, Bingo Boards, Multiple Chance Games, and Other Changes; *Minnesota Rules*, Chapters 7861, 7863, 7864, and 7865; Revisor ID #R-04389

**Introduction.** The Minnesota Gambling Control Board intends to adopt rules without a public hearing following the procedures in the rules of the Office of Administrative Hearings, *Minnesota Rules*, parts 1400.2300 to 1400.2310, and the Administrative Procedure Act, *Minnesota Statutes*, sections 14.22 to 14.28. You may submit written comments on the proposed rules and may also submit a written request that a hearing be held on the rules until June 8, 2016.

Agency Contact Person. You must submit comments or questions on the rules and written requests for a public hearing to the agency contact person. The agency contact person is: Peggy Mancuso at Minnesota Gambling Control Board, 1711 West County Road B, Suite 300 South, Roseville, MN 55113; phone 651-539-1951; fax 651-639-4032; *peggy.mancuso@gcb.state.mn.us*.

**Subject of Rules and Statutory Authority.** The proposed rules are about implementing changes based on *Minnesota Laws* 2015, chapters 45 and 52, and regulating and ensuring the integrity of raffle boards, bingo boards, and multiple chance games; prescribing specific conduct requirements and standards for raffle boards, bingo boards, and multiple chance games; addressing other statutory changes as well as updating requirements found either to be lacking, found to save a lawful gambling entity time and money, or found to be obsolete; updating and clarifying existing board rules; and making grammatical and cross reference corrections.

A copy of the proposed rules, subject described immediately above, is published on the Minnesota Gambling Control Board's website, *www.mn.gov/gcb*. A free copy of the rules is available upon request from the agency's contact person listed above.

# **Proposed Rules**

The statutory authority to adopt the rules is *Minnesota Statutes*, section 349.151, subdivision 4, paragraph (a), clauses (5) and (20), and subdivision 13.

**Comments.** You have until 4:30 p.m. on Wednesday, June 8, 2016, to submit written comment in support of or in opposition to the proposed rules and any part or subpart of the rules. Your comment must be in writing and the agency contact person must receive it by the due date. The agency encourages comment. Your comment should identify the portion of the proposed rules addressed and the reason for the comment. You are encouraged to propose any change desired. Any comments that you have about the legality of the proposed rules must also be made during this comment period.

**Request for a Hearing.** In addition to submitting comments, you may also request that the agency hold a hearing on the rules. Your request must be in writing and the agency contact person must receive it by 4:30 p.m. on Wednesday, June 8, 2016. Your written request for a public hearing must include your name and address. You must identify the portion of the proposed rules that you object to or state that you oppose the entire set of rules. Any request that does not comply with these requirements is not valid and the agency cannot count it when determining whether it must hold a public hearing. You are also encouraged to state the reason for the request and any changes you want made to the proposed rules.

**Withdrawal of Requests.** If 25 or more persons submit a valid written request for a hearing, the agency will hold a public hearing unless a sufficient number withdraw their requests in writing. If enough requests for hearing are withdrawn to reduce the number below 25, the agency must give written notice of this to all persons who requested a hearing, explain the actions the agency took to effect the withdrawal, and ask for written comments on this action. If a public hearing is required, the agency will follow the procedures in *Minnesota Statutes*, sections 14.131 to 14.20.

Alternative Format. Upon request, this information can be made available in an alternative format, such as large print, braille, or audio. To make such a request, please contact the agency contact person at the address or telephone number listed above.

**Modifications.** The agency may modify the proposed rules as a result of public comment. The modifications must be supported by comments and information submitted to the agency, and the adopted rules may not be substantially different than these proposed rules, unless the agency follows the procedure under *Minnesota Rules*, part 1400.2110. If the proposed rules affect you in any way, the agency encourages you to participate in the rulemaking process.

**Statement of Need and Reasonableness.** The statement of need and reasonableness statement contains a summary of the justification for the proposed rules, including a description of who will be affected by the proposed rules and an estimate of the probable cost of the proposed rules. It is now available from the agency contact person. You may review it or obtain copies for the cost of reproduction by contacting the agency contact person.

**Lobbyist Registration.** *Minnesota Statutes*, chapter 10A, requires each lobbyist to register with the State Campaign Finance and Public Disclosure Board. ### **Minnesota Racing Commission**

### Adopted Exempt Temporary Rules Relating to Equine Disease Outbreaks

#### 7876.0130 OUTBREAKS OF INFECTIOUS OR COMMUNICABLE EQUINE DISEASES.

Subpart 1. Limited application. This part applies only when the Racing Commission, its executive director, or its deputy director, in consultation with the commission veterinarian, has determined there have been cases in North America of an infectious or communicable equine disease that presents a serious and immediate threat to the health of horses at a licensed racetrack. When this part applies, it shall supersede any conflicting provisions elsewhere in rule.

Subp. 2. Notice. When this part applies, the commission shall post a notice on its Web site and shall also make other reasonable efforts to notify all affected racetracks and horse persons in a timely manner, which shall include sending notice via mail or e-mail when possible. The commission shall also promptly provide notice in the same manner as soon as the commission, its executive director, or its deputy director, in consultation with the commission veterinarian, has determined the threat has subsided and this part no longer applies.

Subp. 3. <u>Certificate of veterinary inspection</u>. A horse entering the enclosure of the licensed racetrack must be accompanied by an original certificate of veterinary inspection issued within the preceding 72 hours. No horse trailers, vans, or other equine transport vehicles will be allowed to enter the enclosure of a licensed racetrack if the driver does not present the required health certificate for each horse being transported. The certificate must contain the following:

A. documentation that an accredited veterinarian, as defined in part 1721.0010, physically examined the horse on the date the health certificate was issued;

<u>B.</u> a statement from the examining veterinarian that, at the time of examination, the horse did not exhibit any clinical signs of disease and the horse's temperature was normal;

C. a statement from the examining veterinarian that the examining veterinarian verified with the horse's owner or trainer that, to the best of the owner or trainer's knowledge, the horse has not been exposed to any other horse with a contagious or infectious disease in the past 30 days or other time period recommended by the Board of Animal Health;

D. complete equine infectious anemia (EIA) test results, including the date, laboratory, and accession number of the most recent negative EIA test; and

<u>E.</u> if required by the commission veterinarian, documentation that the horse has been vaccinated by an accredited veterinarian with a Food and Drug Administration-approved modified live or killed vaccine specific for EHV-1 not less than 14 days and not more than 60 days prior to arrival at the licensed racetrack. The vaccination date, brand name, serial number, and expiration date of vaccine must appear on the certificate.

# **Adopted Rules**

Subp. 4. Nonadmission of certain horses. No horse may be admitted to the grounds of a licensed racetrack if it has, within the preceding 30 days, been in a county or province, or adjacent county or province, where any racetrack, training facility, or stable is under quarantine due to an infectious or communicable equine disease.

Subp. 5. Isolation of certain horses. If a horse arrives at a licensed racetrack within 30 days of the most recently initiated quarantine date applicable to that horse, or if a horse has tested positive for any contagious or infectious disease within the preceding six months, the following requirements shall apply:

A. after arrival at the licensed racetrack, the horse's owner or trainer shall procure and pay for a blood test or nasal swab, or both, as required by the commission veterinarian; and

<u>B.</u> the horse shall be held in an isolation area or removed from the licensed racetrack until the horse's owner or trainer presents documentation indicating that the blood test or nasal swab, or both, as required by the commission veterinarian, shows no presence of infectious or communicable disease.

**EFFECTIVE PERIOD.** Minnesota Rules, part 7876.0130, is effective for a period of two years from its publication in the State Register.

# **Executive Orders**

The governor has the authority to issue written statements or orders, called Executive Orders. as well as Emergency Executive Orders. The governor's authority is specified in the Constitution of the State of Minnesota, Article V, and in *Minnesota Statutes* § 4.035. Emergency Executive Orders, for protection from an imminent threat to health and safety, become effective immediately, are filed with the secretary of state, and published in the *State Register* as soon as possible after they are issued. Other Executive Orders become effective 15 days after publication in the *State Register* and filing with the secretary of state. Unless otherwise specified, an executive order expires 90 days after the date the governor who issued the order vacates office.

#### **Office of the Governor** Executive Order 16-02: Establishing the Governor's Task Force on Mental Health

**I, Mark Dayton, Governor of the State of Minnesota**, by virtue of the authority vested in me by the Constitution and applicable statutes, do hereby issue this Executive Order:

Whereas, more than 200,000 adults and 75,000 children in Minnesota live with a mental illness;

Whereas, people wait an average of ten years between first experiencing mental health symptoms and accessing treatment;

Whereas, over 50 percent of children and adults in Minnesota who experience homelessness live with a mental illness;

Whereas, Minnesotans who seek mental health services experience gaps in the current mental health system, leading to inappropriate placement in mental health services, or to not receiving care altogether;

Whereas, adults with a serious and persistent mental illness are dying, on average, 25 years earlier than the general public due to heart disease, lung disease, diabetes and cancer;

Whereas, numerous reports have highlighted the cross-sector challenges faced by Minnesotans in need of mental health care, and recommended developing and implementing a more comprehensive continuum of mental health services; and

Whereas, Minnesotans who live with serious mental illnesses can live healthy and productive lives when high-quality and effective mental health services are available to them.

Now, Therefore, I hereby order that:

1. The Governor's Task Force on Mental Health is created to advise the Governor and Legislature on mental health system improvements within the State of Minnesota.

2. The purpose of the Task Force is to develop comprehensive recommendations to design, implement, and sustain a full continuum of mental health services throughout Minnesota.

3. In addition, the Task Force will make recommendations on:

a. Developing and sustaining a comprehensive and sustainable continuum of care for children and adults with mental illnesses in Minnesota, including policies, legislative changes, and funding;

b. Clear definition for the roles and responsibilities for the state, counties, hospitals, community mental health service providers, and other responsible entities in designing, developing, delivering, and sustaining Minnesota's continuum of mental health care;

c. Reforms needed to support timely and successful transition between levels of care, including early intervention services and substance abuse services; and

d. Expanding the capacity of Minnesota's mental health system to responsively serve people of diverse cultures and backgrounds.

4. The task force shall consist of members appointed by the Governor, including:

a. The Commissioner of the Department of Human Services;

b. 4 individuals or family members of individuals with lived experience of mental health issues;

c. 2 mental health advocates;

- d. 2 representatives of community mental health services;
- e. 2 representatives of hospital systems;
- f. 2 representatives from law enforcement;
- g. A representative from the counties; and
- h. A representative from the judicial branch.
- 5. The task force shall include four ex-officio leaders from state agencies, who shall be appointed by the Governor:
  - a. The Commissioner of the Department of Health;
  - b. The Commissioner of the Department of Corrections;
  - c. The State Director to Prevent and End Homelessness; and
  - d. The Ombudsperson for Mental Health and Developmental Disabilities.
- 6. The task force shall include four ex-officio legislative members, who shall be appointed by caucus leadership:
  - a. A Member of the Majority Party in the Senate;
  - b. A Member of the Minority Party in the Senate;
  - c. A Member of the Majority Party in the House of Representatives; and
  - d. A Member of the Minority Party in the House of Representatives.
- 7. The chair of the Task Force will be the Commissioner of the Department of Human Services.
- 8. The Task Force will report to the Governor's Office, the Legislature, and the public by November 15, 2016.

9. The Commissioner of the Department of Human Services will provide general administrative and technical support to the Task Force.

10. The Task Force will make its meetings open to the public and provide opportunities for public comment.

This Executive Order is effective fifteen days after publication in the State Register and filing with the Secretary of State, and shall remain in effect until rescinded by proper authority or until it expires in accordance with Minnesota Statutes, section 4.035, subdivision 3.

### Remediation Division Notice of Proposed Update of the State Superfund Priority List (State Superfund List) (also known as the Permanent List of Priorities (PLP)) Among Releases or Threatened Releases of

Hazardous Substances or Pollutants or Contaminants

**NOTICE IS HEREBY GIVEN** that the Minnesota Pollution Control Agency (MPCA) is publishing for public comment proposed additions to the State Superfund List which lists releases or threatened releases of hazardous substances, pollutants, or contaminants for which the MPCA may take removal or remedial actions under the Minnesota Environmental Response and Liability Act (MERLA), Minn. Stat. §§ 115B.01-115B.20.

Pursuant to Minn. Stat. § 115B.17, the MPCA is authorized to take any removal or remedial action which the MPCA deems necessary to protect the public health, welfare or the environment whenever there is a release, or substantial threat of release, from a facility of any pollutant or contaminant which presents an imminent and substantial danger to the public health, welfare, or the environment, or whenever a hazardous substance is released or there is a threatened release of a hazardous substance from a facility.

Minn. Stat. § 115B.17, subd. 13 required the MPCA to establish priority rules regarding releases or threatened releases of hazardous substances, and pollutants or contaminants. These rules, Minn. R. ch. 7044, became effective on April 5, 1993.

Minn. Stat. § 115B.17, subd. 13 also require the MPCA to adopt the State Superfund List and to update the list annually according to the criteria set forth in the priority rules. Before any update of the State Superfund List is adopted by the MPCA, it must be published in the State Register and a 30-day public comment period must be provided. This notice is, therefore, published to inform the public that the MPCA is proposing to update the State Superfund List and to solicit public comment on the proposed additions.

Pursuant to Minn. Stat. § 115B.17 and Minn. R. 7044.0950, the MPCA is proposing the following changes to the Superfund List.

The MPCA is proposing to add the following ten sites (Sites) to the State Superfund List (Hazard Ranking Score assigned pursuant to Minn. R. 7044.0350 follows the Site): 1) D's Fabric Care, Carlton County (5.81); 2) West 66th Street and Vincent Avenue, Hennepin County (50.19); 3) Hospital Linen, Ramsey County (50.19); 4) South East Hennepin Area Groundwater and Vapor Site, Hennepin County (33.91) 5); Lyndale Avenue Corridor, Hennepin County (38.93); 6) Arcade Street North and Haw-thorne Avenue East, Ramsey County (24.62); 7) 55th Street and Lyndale Avenue South, Hennepin County (17.38); 8) Universal Plating, Hennepin County (25.09); 9) Former Pure Oil Bulk Storage Facility, Hennepin County (7.13); 10) University Avenue and Pascal Street Area, Ramsey County (18.43).

These MPCA sites are being proposed for addition to the State Superfund List as in each case, State Superfund resources will likely be necessary to complete appropriate response actions.

Each MPCA Site has been assigned to Response Action Classes C and D (see Minn. R. 7044.0450). The four response action classes are defined as follows: Class A - Declared Emergency; Class B - Response Actions Completed and Operation and Maintenance/Long-Term Monitoring Ongoing; Class C - Response Actions Necessary or in Progress or First Year Operation and Maintenance at a Site; and Class D - Remedial Investigations and Feasibility Studies Necessary or in Progress.

The MPCA is also proposing to delist the following Site from the Superfund List: Boyer Lumber Superfund Site, Virginia, St. Louis County.

The 2.75 acre site was listed on the Permanent List of Priorities (PLP) February 25th, 2014. Several investigations were completed by various MPCA programs between 1990-2013 at the Boyer Lumber Site which identified volatile organic compounds (VOC's), polycyclic aromatic hydrocarbons (PAH's), pentachlorophenol (PCP), and dioxins in soil and VOC's, PAH's and PCP's in groundwater. In most cases, contaminated soils were removed to a landfill and backfill material was brought in from a clean, off-site sources. Groundwater impacts were only found on the site property and were not identified offsite during investigation activities. The impacted groundwater was also found to be stable and not moving offsite. The site investigations determined there was a low risk to human health associated with the contaminated groundwater from the Boyer Lumber site. The lack of nearby

water supply wells near the site along with the limited size and mobility of the groundwater contamination support this determination.

The Minnesota Decision Document (MDD) as amended March 31st, 2016 documents that the MPCA has determined the selected response actions are protective of public health and welfare and the environment. MPCA staff recommends that the Boyer Lumber site be removed from the PLP because Boyer Lumber has taken all reasonable and appropriate actions related to the identified releases. The PLP deletion criteria have been met by Boyer Lumber for the site and no further Minnesota Environmental Response and Liability Act (MERLA) response actions are necessary there. In addition, no further MERLA-funded response actions are necessary because there is no longer a threat to human health or the environment under the current land use.

The MPCA invites members of the public to submit written comments on the proposed ten additions and one deletion from the State Superfund Permanent List of Priorities. All written comments with regard to these proposed changes to the Superfund List must be received no later than 4:30 p.m. on June 10<sup>th</sup>, 2016.
