Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Provisions exist for the Commissioners of some state agencies to adopt expedited emergency rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Expedited emergency rules are effective upon publication in the State Register, and may be effective up to seven days before publication under certain emergency conditions.

Expedited emergency rules are effective for the period stated or up to 18 months. Specific *Minnesota Statute* citations accompanying these expedited emergency rules detail the agency's rulemaking authority.

Adopted Expedited Emergency Game and Fish Rules: 2015 State Game Refuges, Wildlife Management Areas, Small Game, Furbearer, and Fall Wild Turkey

NOTICE IS HEREBY GIVEN that the above entitled rules have been adopted through the process prescribed by *Minnesota Statutes*, section 84.027, subdivision 13 (b). The statutory authority for the contents of the rule is *Minnesota Statutes*, sections 86A.06, 97A.015, 97A.045, 97A.091, 97A.137, 97B.605, 97B.631, 97B.721, 97B.901.

Conditions that do not allow compliance with *Minnesota Statutes*, sections 97A.0451 to 97A.0459, are as follows: Changes to game refuges and wildlife management areas are made to reflect changing habitat conditions, the needs of individual species and to provide additional hunting opportunities where possible. Reductions to the white-tailed jackrabbit daily and possession limits reflect a reduced population due primarily to habitat loss. Changes to possession limits for various small game species provide additional flexibility for hunters and are not expected to result in population-level effects. Changes to registered furbearer bag limits and trapping areas are established based on population modeling completed in May of each year.

 - (1) from May 1 through September 14 for wild rice harvesting during the wild rice season, canoeing, and bird watching; and

(2) from November 25 through April 30 for hunting and trapping of any species for which there is an open season.

B. pheasant and Canada goose hunting starting on the day following the close of the muzzleloader deer season through the end of the respective statewide seasons;

D. spring turkey hunting.

Subp. 5. Clay County Game Refuge, Clay County. The Clay County Game Refuge in Clay County is open to:

A. prairie chickens small game hunting, except ducks and geese during the regular duck season;

Subp. 12. **Fish Lake-Ann River Game Refuge, Kanabec County.** The Fish Lake-Ann River Game Refuge in Kanabec County is open to all hunting and trapping, except waterfowl.

Subp. 49. Warroad Game Refuge, Roseau County. The Warroad Game Refuge in Roseau County is open to:

A. trapping:; and

B. archery deer hunting as described in part 6232.0600.

Subp. 55. Collegeville (St. John's) Game Refuge, Stearns County. The Collegeville (St. John's) Game Refuge in Stearns County is open to <u>archery deer hunting and</u> firearms deer and bear hunting during the established seasons, by written permission of the landowner.

Subp. 61. St. Cloud Game Refuge, Stearns County. The St. Cloud Game Refuge in Stearns County is open to taking deer and bear by archery.

A. small game hunting, except waterfowl, beginning November 1 through the end of the respective seasons;

B. trapping beginning November 1 through the end of the respective seasons;

C. deer and bear hunting by archery; and

D. deer hunting by firearms.

6234.0600 TAKING JACK RABBITS, COTTONTAIL RABBITS, AND SNOWSHOE HARES.

6232.1970 TAKING DEER BY ARCHERY, FIREARMS, OR MUZZLELOADER UNDER EARLY ANTLERLESS PERMITS.

Subpart 1. **Purchase.** A person who purchases and presents a license valid for the archery, firearm, or muzzleloader season may purchase up to two five early antlerless permits. C. a person may not take more than ten Canada geese per day and there is no possession limit.

Subp. 4. Permit requirements.

- A. A fall special goose permit is required to take geese under this part.
- B. Hunters must not have their small game privileges revoked to purchase a fall special goose permit.
- C. A hunter must have the permit in possession when taking or possessing Canada geese during the Canada goose management harvest under this part.
- Subp. 5. **Penalties.** A violation of this part or the conditions of any permit issued under this part results in revocation of the permit and any other penalties provided by state or federal law.
- Subp. 6. **Game refuges.** All state game refuges closed to migratory waterfowl hunting are closed to taking Canada geese under this part. All state game refuges closed by posting to taking ducks or geese during any portion of the fall waterfowl seasons are closed to taking Canada geese under this part.

The Minnesota Pollution Control Agency (MPCA) is requesting comments on the Draft Chloride Management Plan (CMP) and Total Maximum Daily Load (TMDL) for the Twin Cities Metropolitan Area (TCMA) (note that this includes the entire seven-county metropolitan area). The draft CMP and TMDL are available for review at: http://www.pca.state.mn.us/programs/roadsalt.html

Written comments on the draft CMP and TMDL must be sent to the MPCA contact person listed below by September 2, 2015, 4:30 p.m. The comments should indicate as to whether they are about the CMP or the TMDL. The MPCA will prepare responses to comments received and make any necessary revisions of the two documents. Subsequent to the revision(s), the draft TMDLs will be submitted to the

U.S. Environmental Protection Agency (EPA) for approval; the CMP will be forwarded to the MPCA Commissioner for approval.

Required by the federal Clean Water Act, a TMDL is a scientific study that calculates the maximum amount of a pollutant that a waterbody can receive and still meet water quality standards for that pollutant. It is a process that identifies all the sources of the pollutant causing an impairment and allocates necessary reductions among them. This TMDL Report focuses on pollution caused by chloride in the seven county metro area. Thus, the TMDL document builds on significant work already completed in the TCMA.

The Twin Cities 7-county metropolitan area (TCMA) includes 186 cities and townships and a population of approximately 3,000,000 people. It covers approximately 3,000 square miles with about one-third in urbanized areas. It is a vibrant and growing community. The area is fortunate to be home to nearly 1,000 lakes and wetlands, small streams and large rivers, as well as shallow and deep groundwater aquifers. Elevated chloride concentrations have been found in waterbodies throughout the TCMA. At high levels chloride is toxic to aquatic life. The primary source of chloride, particularly in more urban areas of the TCMA, is road salt applied to roads, parking lots and sidewalks. A secondary source of chloride, particularly in more rural areas of the TCMA, is residential water softeners that use salt.

The Minnesota Pollution Control Agency (MPCA) and stakeholders worked together to develop a plan to achieve the TCMA chloride TMDL which includes 37 chloride impairments. The CMP incorporates water quality assessment, source identification, implementation strategies, monitoring recommendations, and measurement and tracking of results into a performance-based adaptive approach for the 7-County TCMA. The goal of the plan is to develop the framework to assist local partners in minimizing salt (chloride) use and provide safe and desirable conditions for the public.

Suggested changes will be considered before the documents are finalized and the TMDL Report is sent to the EPA for approval.

Written Comments: You may submit written comments on the conditions of the draft CMP and TMDL Reports or on the Commissioner's preliminary determination. Written comments must include the following:

- 1. A statement of your interest in the draft CMP and/or TMDL Reports;
- A statement of the action you wish the MPCA to take, including specific references to sections of the draft documents that you believe should be changed; and
- The reasons supporting your position, stated with sufficient specificity as to allow the Commissioner to investigate the merits of your position.

Petition for Public Informational Meeting: You also may request that the MPCA Commissioner hold a public informational meeting. A public informational meeting is an informal meeting that may be held to solicit public comment and statements on matters before the MPCA, and help clarify parts of the document and resolve issues. A petition requesting a public informational meeting must include the following information:

- 1. A statement identifying the matter of concern;
- 2. The information required under items 1 through 3 of "Written Comments," identified above;
- 3. A statement of the reasons for holding a public informational meeting; and
- 4. The issues that you would like addressed at the public informational meeting.

Petition for Contested Case Hearing: You also may submit a petition for a contested case hearing. A contested case hearing is a formal hearing before an administrative law judge that provides evidence on issues requested to be change. In accordance with *Minnesota Rules* 7000.1900, the MPCA will grant a petition to hold a contested case hearing if it finds that: (1) there is a material issue of fact in dispute concerning the application or draft CMP and/or TMDL Reports; (2) the MPCA has the jurisdiction to make a determination on the disputed material issue of fact; and (3) there is a reasonable basis underlying the disputed material issue of fact or facts such that the holding of the contested case hearing would allow the introduction of information that would aid the MPCA in resolving the disputed facts in making a final decision on the draft CMP and/or TMDL Reports. A material issue of fact means a fact question, as distinguished from a policy question, whose resolution could have a direct bearing on a final MPCA decision. A petition for a contested case hearing must include the following information:

- A statement of reasons or proposed findings supporting the MPCA decision to hold a contested case hearing according to the criteria in *Minnesota Rules* 7000.1900, as discussed above; and
- A statement of the issues proposed to be addressed by a contested case hearing and the specific relief requested or resolution of the matter.

In addition and to the extent known, a petition for a contested case hearing should also include the following information:

- A proposed list of prospective witnesses to be called, including experts, with a brief description of proposed testimony or summary of evidence to be presented at a contested case hearing;
- 2. A proposed list of publications, references, or studies to be introduced and relied upon at a contested case hearing; and
- 3. An estimate of time required for you to present the matter at a contested case hearing.

MPCA Decision:

The written comments, requests, and petitions submitted on or before the last day of the public comment period will be considered in the final decision on the CMP and TMDL Reports. If the MPCA does not receive written comments, requests, or petitions during the public comment period, MPCA staff as authorized by the Commissioner, will make the final decision on the draft TMDL Report.

Minnesota Pollution Control Agency (MPCA) REQUEST FOR COMMENTS on Possible Rules for Minnesota's Compliance With the Clean Power Plan; Revisor's ID Number R-04265

Background and subject of rulemaking. In June 2014, the Environmental Protection Agency (EPA) proposed the Clean Power Plan (CPP), a rule that for the first time cuts carbon pollution from existing power plants, the single largest source of carbon pollution in the United States. The proposed EPA rule sets state-specific carbon dioxide emission targets and requires each state to submit a plan detailing its strategy for meeting the targets.

Although the EPA has not yet finalized the CPP's guidelines and targets, state plans are expected to be due by summer 2016. In an effort to be ready to meet that deadline, the Minnesota Pollution Control Agency (MPCA) is beginning to assess potential pathways for compliance with the anticipated guidelines. Our state plan will need to address carbon emissions from existing fossil fuel—burning facilities, low-carbon or zero-carbon methods for producing electricity, and ways to reduce consumer demand for electricity in order to achieve necessary emissions reductions while supporting reliable, affordable power for all Minnesotans.

The MPCA has not yet started drafting a plan because the EPA has not yet published the standards that Minnesota's plan will need to meet. The MPCA requests public input and comments to help guide our considerations of methods for meeting the EPA's CPP targets, as well as any other objectives that the state's plan might include. Specific topics on which we are seeking comment include the following:

- 1. Environmental results
- 2. Electricity system impact
 - · Effects of the plan on the existing electric infrastructure—markets, dispatch, retirements, etc.
 - · Fuel diversity
 - · Renewable energy and energy efficiency
 - · Cost and reliability
- 3. Flexibility, enforceability, and applicability

- · Federal enforceability while assuring state control over compliance
- · Flexibility for regulated entities
- · Methods to capture reductions from all sources
- 4. Multistate approach
 - Things to consider in a possible multistate plan
- 5. Equity
 - · Equity considerations across regulated entities—distribution, etc.
 - Impact on communities of environmental-justice concern—minority populations, neighborhoods bearing disproportionate financial or environmental burdens, etc.
 - Cost and reliability
 - · Geographic equity
- 6. General issues or other considerations not listed above

Parties affected. The rules the MPCA is considering would probably affect all Minnesotans in some form—most directly the power companies as regulated entities, but also the utility consumers who purchase electricity from them. Rule requirements to reduce carbon dioxide will support Minnesota's efforts to address climate change and should have a co-benefit of reducing pollutants such as sulfur dioxide and nitrogen oxides, which can provide health benefits to all Minnesotans, particularly sensitive receptors (e.g., children with asthma).

Statutory authority. *Minnesota Statutes*, § 116.07, subd. 4, authorizes the MPCA to adopt rules and standards for the prevention, abatement, and control of air pollution.

Rules drafts. The MPCA has not yet drafted the rules under consideration. If you are interested in being notified when a draft is available and of other activities relating to this or other MPCA rulemakings, we encourage you to register for GovDelivery notices at
