How to Follow State Agency Rulemaking Action in the State Register

State agencies must publish notice of their rulemaking action in the *State Register*. If an agency seeks outside opinion before promulgating new rules or rule amendments, it must publish a NOTICE OF INTENT TO SOLICIT OUTSIDE OPINION. Such notices are published in the OFFICIAL NOTICES section. Proposed rules and adopted rules are published in separate sections of the magazine.

The PROPOSED RULES section contains:

- Calendar of Public Hearings on Proposed Rules.
- Proposed new rules (including Notice of Hearing and/or Notice of Intent to Adopt Rules without A Hearing).
- Proposed amendments to rules already in existence in the Minnesota Code of Agency Rules (MCAR).
- Proposed temporary rules.

The ADOPTED RULES section contains:

- Notice of adoption of new rules and rule amendments (those which were adopted without change from the proposed version previously published).
- Adopted amendments to new rules or rule amendments (changes made since the proposed version was published).
- Notice of adoption of temporary rules.
- Adopted amendments to temporary rules (changes made since the proposed version was published).

All ADOPTED RULES and ADOPTED AMENDMENTS TO EXISTING RULES published in the *State Register* will be published in the Minnesota Code of Agency Rules (MCAR). Proposed and adopted TEMPORARY RULES appear in the *State Register* but are not published in the MCAR due to the short-term nature of their legal effectiveness.

ADOPTED RULES

The adoption of a rule becomes effective after the requirements of Minn. Stat. § 15.0412, subd. 4, have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule.

If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous State Register publication will be printed.

If an adopted rule differs from its proposed form, language which has been deleted will be printed with strike outs and new language will be underlined, and the rule's previous *State Register* publication will be cited.

Consolidated Order and Notice of Street and Highway Routes Designated and Permitted to Carry the Gross Weights Allowed under Minn. Stat. § 169.832

Order No. 66400

Whereas, the Commissioner of Transportation by Order No. 65851, dated June 29, 1981, which order has been amended by Orders Nos. 65929, 65932, 65963, 66058, 66221, and 66305, designates and permits certain street and highway routes, or segments of those routes, to carry the gross weights allowed under Minnesota Statutes § 169.832, and

Whereas, the commissioner has determined that the record of said designation has become cumbersome to maintain, and that the existing designations should be consolidated with needed amendments into one order and document,

The commissioner, as of the date of this Consolidated Order, hereby vacates, rescinds and sets aside Order No. 65851, as amended by Orders Nos. 65929, 65932, 65963, 66058, 66221, and 66305.

The Commissioner of Transportation as of this date orders and gives notice, pursuant to Minnesota Statutes § 169.832 (1981 Supp.), that the following street and highway routes, or segments of those routes, are designated and permitted to carry the gross weights allowed under Minnesota Statutes § 169.832. 81-22/Sp. State of Minnesota v. Wallace E. Hamling, Appellant. Ramsey County.

Evidence that defendant intentionally aided in the kidnapping of two people was sufficient to support the verdict.

Trial court did not commit prejudicial error in admitting in-court eyewitness identification testimony which defendant contends had been ordered suppressed by omnibus court, where defense counsel was unable to establish to the satisfaction of trial court that omnibus court had suppressed the evidence or that the identification evidence was unreliable.

Affirmed. Otis, J.

Decisions Filed Thursday, December 17, 1981

81-40/Sp. Robert K. Brown, Appellant, v. Dayton Hudson Corporation, et al., City of Minneapolis, et al. Hennepin County.

The discretionary decision whether to charge and whether to continue a prosecution is a quasi-judicial decision which lies at the very heart of the prosecutorial function.

A public prosecutor acting within the scope of his duties by filing and maintaining criminal charges is absolutely immune from civil liability, notwithstanding allegations of negligence, improper motive or lack of probable cause.

The trial court did not err in granting summary judgment.

Affirmed. Todd, J. Concurring specially, Otis, J.

51470 Winifred Haeussler, et al., v. Richard Braun, Commissioner of Transportation, State of Minnesota, Appellant. Hennepin County.

Landowners owning property abutting a public street possess as appurtenant to their lots implied easements for light, air and view over the public street.

SUPREME COURT

It is only when the street is put to an improper street use that an additional servitude is placed on the implied easements and a taking can be found.

Construction of sound barriers along an interstate to reduce the noises flowing from the interstate is a proper street use.

In an action in inverse condemnation, the petitioner need not prove with exactitude the diminution in market value caused by the substantial invasion of his property right, but he must show with certainty that a diminution has occurred.


