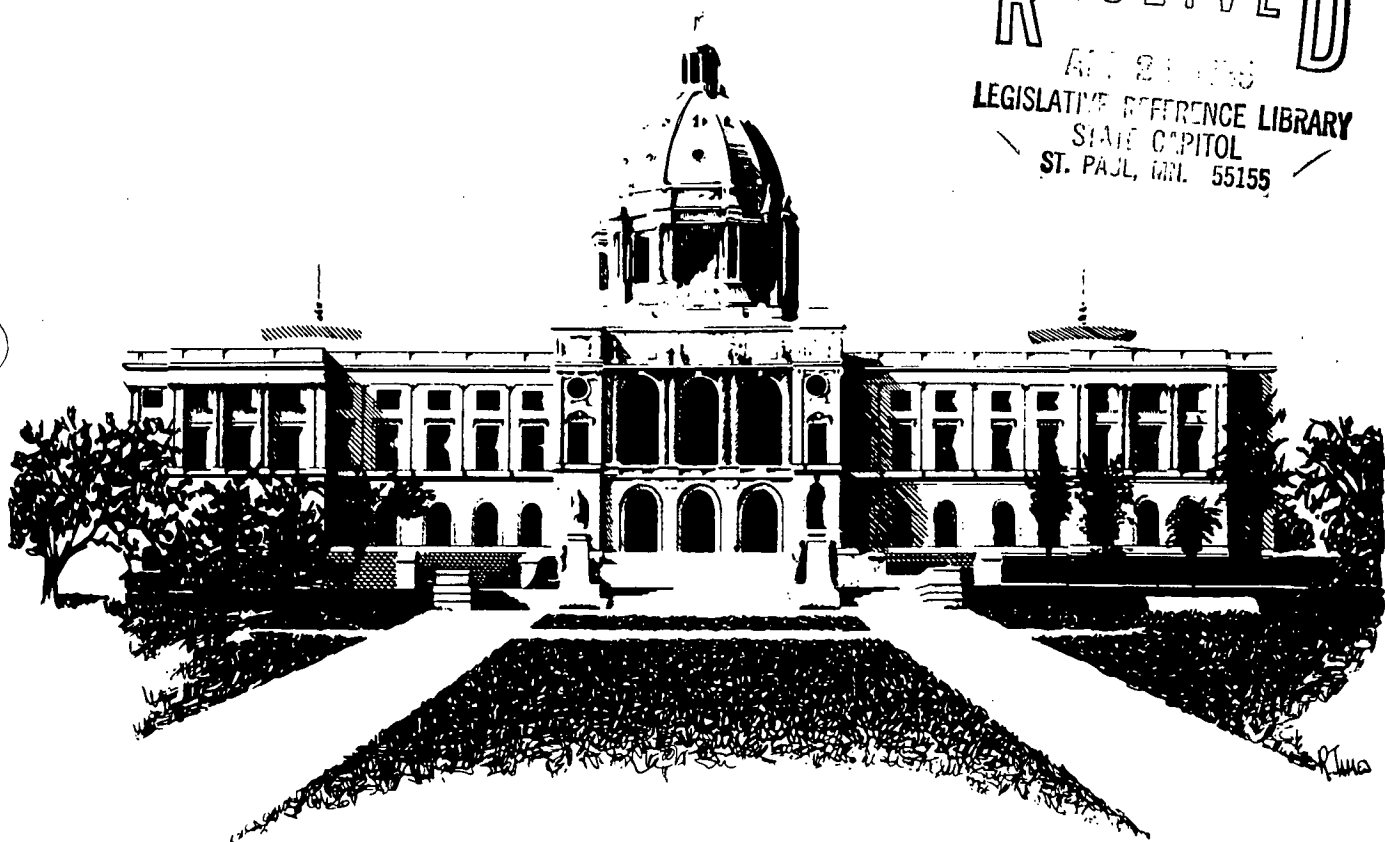

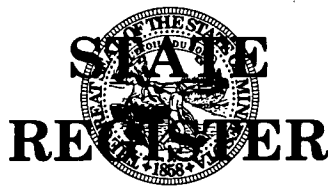

NOTICE

How to Follow State Agency Rulemaking Action in the *State Register*

State agencies must publish notice of their rulemaking action in the *State Register*. If an agency seeks outside opinion before promulgating new rules or rule amendments, it must publish a NOTICE OF INTENT TO SOLICIT OUTSIDE OPINION also.

The PROPOSED RULES section contains:

- Calendar of public hearings on proposed rules.
- Proposed new rules (including notice of hearing and/or notice of intent to adopt rules without a hearing).
- Proposed amendments to rules already in existence in the Minnesota Rules.
- Proposed emergency rules.
- Withdrawal of proposed rules (option; not required).

The ADOPTED RULES section contains:

- Notice of adoption of new rules and rule amendments adopted without change from the previously published proposed rules. (Unchanged adopted rules are not republished in full in the *State Register* unless an agency requests this.)
- Adopted amendments to new rules or rule amendments (adopted changes from the previously published proposed rules).
- Notice of adoption of emergency rules.
- Adopted amendments to emergency rules (changes made since the proposed version was published).
- Extensions of emergency rules beyond their original effective date.

The OFFICIAL NOTICES section includes (but is not limited to):

- Notice of intent to solicit outside opinion before promulgating rules.
- Additional hearings on proposed rules not listed in original proposed rules calendar.

ALL ADOPTED RULES and ADOPTED AMENDMENTS TO EXISTING RULES published in the *State Register* and filed with the Secretary of State before July 31, 1983 are published in the *Minnesota Rules 1983*. ADOPTED RULES and ADOPTED AMENDMENTS TO EXISTING RULES filed after July 31, 1983 will be included in a supplement scheduled for publication in mid-1984. Proposed and adopted EMERGENCY (formerly called TEMPORARY) RULES appear in the *State Register* but are generally not published in the *Minnesota Rules 1983* due to the short-term nature of their legal effectiveness. Those that are long-term may be published.

PROPOSED RULES

Pursuant to Minn. Stat. of 1982, §§ 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing, as long as the agency determines that the rules will be noncontroversial in nature. The agency must first publish a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the *State Register*. The notice must advise the public:

1. that they have 30 days in which to submit comment on the proposed rules;
2. that no public hearing will be held unless 25 or more persons make a written request for a hearing within the 30-day comment period;
3. of the manner in which persons shall request a hearing on the proposed rules; and
4. that the rule may be modified if the modifications are supported by the data and views submitted.

If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.14-14.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the *State Register*.

Pursuant to Minn. Stat. §§ 14.29 and 14.30, agencies may propose emergency rules under certain circumstances. Proposed emergency rules are published in the *State Register* and, for at least 25 days thereafter, interested persons may submit data and views in writing to the proposing agency.

Notice of Proposed Adoption of Emergency Rule (Second Notice)

Notice is hereby given that the Minnesota Higher Education Coordinating Board proposes to adopt the above-entitled emergency rule. The statutory authority to adopt the emergency rule is contained in Minnesota Statutes, Section 136A.111, Minnesota Laws 1983, Chapter 258, Section 49, and Minnesota Laws 1984, Article 4, Section 3. The agency, in adopting the rule, is following the procedures set forth in Minnesota Statutes, sections 14.29-14.36.

All persons have 25 days after publication to submit data and views on the proposed emergency rule or any part or subpart of the rule in writing. Any comments must be submitted to:

The rule proposed for adoption relates to a new supplemental loan program for students attending eligible post-secondary institutions. The rule as proposed appeared in the *State Register* on February 11, 1985 (9 S.R. 1783-1788).

The proposed rule may be modified if the modifications are supported by data and views and do not result in a substantial change in the proposed rule as noticed.

Upon adoption of the emergency rule by the agency, the rule as adopted and the required supporting documents will be delivered to the Attorney General for review as to legality and form to the extent form relates to legality. Any person may request notification of the date of submission to the Attorney General. Persons who wish to be advised of the submission of this material to the Attorney General, or who wish to receive a copy of the adopted rule, must submit the written request to Rose Herrera Hamerlinck.

The emergency rule will take effect five working days after approval by the Attorney General and be effective for up to a maximum of 180 days.

Proposed Rules Relating to Innovative Housing Loans

Notice of Intent to Adopt Rules without a Public Hearing

Notice is hereby given that the Minnesota Housing Finance Agency ("agency") proposes to adopt the above-entitled rules with-

out a public hearing. The agency has determined that the proposed adoption of these rules will be noncontroversial in nature and has elected to follow the procedures set forth in Minn. Stat. Sec. 14.21 to 14.28.

Persons interested in these rules shall have 30 days to submit comments in support of or in opposition to the proposed rules within the 30-day comment period. Such comments are encouraged, and should identify the portion of the proposed rule addressed, the reason for the comment, and any change proposed. The proposed rule may be modified as the result of comments received if the modifications are supported by the data and views submitted to the agency and do not result in a substantial change in the proposed language. Unless twenty-five or more persons submit written requests for a public hearing on the proposed rule within the 30-day comment period, a public hearing will not be held. In the event a public hearing is required, the agency will proceed according to the provisions of Minn. Stat. Sec. 14.14 et. seq. Any person requesting a public hearing should state his or her name and address, and is encouraged to identify the portion of the proposed rule addressed, the reason for the request, and any change proposed.

Authority for the adoption of these rules is contained in Minn. Stat. Sec. 462A.06, Subd. 4 and 11. Additionally, a Statement of Need and Reasonableness that describes the need for and reasonableness of each provision of the proposed rules, and that identifies the data and information relied upon to support the proposed rules has been prepared and is available from Kathleen J. Johnson upon request.

Upon adoption of the final rules without a public hearing, the proposed rules, this notice, the Statement of Need and Reasonableness, all written comments received, and the final rules as adopted will be delivered to a designee of the Attorney General for review as to form and legality, including the issue of substantial change, and to determine whether the agency has the authority to adopt the rules and whether the record demonstrates a rational basis for the need for and reasonableness of the proposed rules. Persons who wish to receive notice of the date of submission of these rules to the Attorney General for review, or who wish to receive a free copy of the final rules as adopted, should make such requests to Kathleen J. Johnson.

A copy of the proposed rule is attached to this notice. Additional copies may be obtained by contacting Kathleen J. Johnson.

Please be advised that Minn. Stat. Ch. 10A.03 requires each lobbyist to register with the State Ethical Practices Board within five (5) days after he or she commences lobbying. A lobbyist is defined in Minn. Stat. Sec. 10A.01, Subd. 11 as any individual:

(a) Engaged for pay or other consideration, or authorized by another individual or association to spend money, who spends more than five hours in any month or more than \$250.00, not including his own travel expenses and membership dues, in any year, for the purpose of attempting to influence legislative or administrative action by communicating or urging others to communicate with public officials; or

(b) Who spends more than \$250.00, not including his own traveling expenses and membership dues, in any year for the purpose of attempting to influence legislative or administrative action by communicating or urging others to communicate with public officials.

PROPOSED RULES

Rules as Proposed

4900.1200 APPLICATIONS FOR INNOVATIVE HOUSING LOANS.

To be eligible to be selected for an innovative housing loan, to be made from the fund established pursuant to Minnesota Statutes, sections 462A.05, subdivision 18 and 462A.21, subdivision 9, each applicant must satisfy the following requirements:

A. The applicant must be a nonprofit or for-profit entity ~~or a limited dividend entity~~.

B. to G. [Unchanged.]

4900.1210 SELECTION CRITERIA FOR INNOVATIVE HOUSING LOANS.

In determining whether or not to accept applications from nonprofit or for-profit entities for innovative housing loans, the members shall examine the following facts and make their determinations thereon:

A. to I. [Unchanged.]

ADOPTED RULES

The adoption of a rule becomes effective after the requirements of Minn. Stat. § 14.14-14.28 have been met and five working days after the rule is published in *State Register*, unless a later date is required by statutes or specified in the rule.

If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed.

If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

An emergency rule becomes effective five working days after the approval of the Attorney General as specified in Minn. Stat. § 14.33 and upon the approval of the Revisor of Statutes as specified in § 14.36. Notice of approval by the Attorney General will be published as soon as practicable, and the adopted emergency rule will be published in the manner provided for adopted rules under § 14.18.

ADVISORY TASK FORCE ON AMERICAN INDIAN LANGUAGE AND CULTURE EDUCATION PROGRAMS has 13 vacancies open for members. Members are appointed by the Board of Education. This includes representatives of the Minnesota Sioux Tribe, the Minnesota Red Lake Tribe, the Minnesota Chippewa Tribe, the metropolitan areas of Duluth, Minneapolis and St. Paul, and a member representing Indian alternative schools. Members include representatives of community groups, parents of children eligible to be served by the programs, American Indian administrators and teachers, and persons knowledgeable in the field of American Indian language and culture education. The task force advises the Board of Education on the administration of the American Indian Language and Culture Education Act; reviews proposals and makes recommendations to the board on approval and funding of bicultural programs in Minnesota schools. Between 3 and 5 meetings per year at various sites statewide; members are reimbursed for expenses. For specific information contact the Advisory Task Force on American Indian Language and Culture Education Programs, 303 Capitol Square Bldg., St. Paul 55101; (612) 296-6458.

MINNESOTA INDIAN SCHOLARSHIP TASK FORCE has 15 vacancies open for members. Members are appointed by the Board of Education and include representatives of the Duluth area, the Minneapolis area, the Bemidji area, the Bureau of Indian Affairs Higher Education Office, the Minnesota Chippewa Tribe, the Minnesota Sioux Tribe and the Red Lake Education Division. The task force advises the Board of Education on amounts and types of scholarships granted to American Indian post-secondary students. It also advises the board on the administration of the American Indian Post-Secondary Preparation Program; reviews proposals and makes recommendations to the board on approval and funding of Post-Secondary Preparation Programs in Minnesota schools. CX-83-1672 State of Minnesota v. Earthia Wiley, Appellant. Court of Appeals.

Evidence seized in reliance upon a search warrant was admissible at trial because the search warrant was based upon probable cause.

The evidence was sufficient to show that appellant constructively possessed marijuana.

The trial court did not err in denying appellant's motion to disclose the identity of an informant.

Affirmed. Amdahl, C.J. Dissenting, Wahl, J.

C5-82-581 Atwater Creamery Company, Appellant, v. Western National Mutual Insurance Company, and Strehlow Insurance Agency, et al. Kandiyohi County.

A conformity clause in an insurance policy operates to substitute a statutory provision for a policy provision only where the policy provision directly conflicts with the statute.

Where the technical definition of burglary in a burglary insurance policy is, in effect, an exclusion from coverage, it will not be interpreted so as to defeat the reasonable expectations of the purchaser of the policy.

The standard of care of an insurance agent must be established by expert testimony in an action against the agent for failure to act where there is no request by the insured or any evidence of a pattern of past practice.

Affirmed in part, reversed in part. Wahl, J. Concurring specially, Simonett, J., Peterson, J., Kelley, J., and Coyne, J.

C7-84-215, C6-84-366 Ordwin H. Hagen, d.b.a. Uptown Standard Station and Milwaukee Mutual Insurance Company, Relators, v. Todd A. Venem, and Gene D. Hirt, v. City of Minneapolis, Relator. Workers' Compensation Court of Appeals.

The Workers' Compensation Court of Appeals acted within its statutory authority when it construed "proceeds" under Minn. Stat. § 176.061, subd. 6(1984) to determine the proper valuation of an employee's recovery under a structured third party settlement.

The "proceeds received" by an injured employee under a structured settlement for the purposes of Minn. Stat. § 176.061, subd. 6(1984) is the total amount to be paid out to an employee reduced to its present value.

The discount rate to be applied in determining the present value of a structured settlement is that which is proven to reflect current interest rates at the time of the settlement agreement. The 10% discount rate applied in these cases adequately reflected current interest rates.

Venem v. Hagen affirmed; *Hirt v. City of Minneapolis* affirmed as modified. Wahl, J.

C6-83-2043 Robin Cook, Appellant, v. John S. Connolly, Court of Appeals.

The retainer of an attorney by the mother and natural guardian of a child to prosecute the child's personal injury action establishes an attorney-client relationship between the attorney and the child.

Court approval of settlement of a minor's personal injury claim does not preclude, by way of collateral estoppel, a subsequent claim that the settlement was inadequate due to attorney malpractice.

A legal malpractice claim is a separate, independent cause of action, so it is not a prerequisite to the malpractice claim that a prior court-approved minor's settlement be set aside.

Summary judgment seeks to relieve the court system from unfounded litigation. The rule protecting a professional from honest errors of judgment needs to be considered on motions for summary judgment.

Reversed and remanded. Simonett, J.
