


NOTICE

How to Follow State Agency Rulemaking Action in the State Register

State agencies must publish notice of their rulemaking action in the State Register. If an agency seeks outside opinion before promulgating new rules or rule amendments, it must publish a NOTICE OF INTENT TO SOLICIT OUTSIDE OPINION also.

The PROPOSED RULES section contains:

- Calendar of public hearings on proposed rules.
- Proposed new rules (including notice of hearing and/or notice of intent to adopt rules without a hearing).
- Proposed amendments to rules already in existence in the Minnesota Rules.
- Proposed emergency rules.
- Withdrawal of proposed rules (option; not required).

The ADOPTED RULES section contains:

- Notice of adoption of new rules and rule amendments adopted without change from the previously published proposed rules. (Unchanged adopted rules are not republished in full in the State Register unless an agency requests this.)
- Adopted amendments to new rules or rule amendments (adopted changes from the previously published proposed rules).
- Notice of adoption of emergency rules.
- Adopted amendments to emergency rules (changes made since the proposed version was published).
- Extensions of emergency rules beyond their original effective date.

The OFFICIAL NOTICES section includes (but is not limited to):

- Notice of intent to solicit outside opinion before promulgating rules.
- Additional hearings on proposed rules not listed in original proposed rules calendar.

ALL ADOPTED RULES and ADOPTED AMENDMENTS TO EXISTING RULES published in the *State Register* and filed with the Secretary of State before July 31, 1983 are published in the *Minnesota Rules 1983*. ADOPTED RULES and ADOPTED AMENDMENTS TO EXISTING RULES filed after July 31, 1983 will be included in a supplement scheduled for publication in mid-1984. Proposed and adopted EMERGENCY (formerly called TEMPORARY) RULES appear in the *State Register* but are generally not published in the *Minnesota Rules 1983* due to the short-term nature of their legal effectiveness. Those that are long-term may be published.

ADOPTED RULES

The adoption of a rule becomes effective after the requirements of Minn. Stat. § 14.14-14.28 have been met and five working days after the rule is published in State Register, unless a later date is required by statutes or specified in the rule.

If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous State Register publication will be printed.

If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous State Register publication will be cited.

An emergency rule becomes effective five working days after the approval of the Attorney General as specified in Minn. Stat. § 14.33 and upon the approval of the Revisor of Statutes as specified in § 14.36. Notice of approval by the Attorney General will be published as soon as practicable, and the adopted emergency rule will be published in the manner provided for adopted rules under § 14.18.

It has been determined that the HCI is 4.2 percent according to an independent source, Data Resources, Inc. for Health Care Costs for hospital whose fiscal years begin during the calendar quarter beginning July 1, 1985. The index is subject to change based on the special session. Notice will be given should legislation affect the index.

State trooper investigating possibly fatal head-on collision was justified in ordering blood removed from apparently intoxicated driver; although results of chemical analysis of driver's blood were admissible in any subsequent criminal proceeding, they could not serve as the basis of a revocation of the driver's license pursuant to the implied consent law.

TAX COURT

Pursuant to Minn. Stat. § 271.06, subd. 1, an appeal to the tax court may be taken from any official order of the Commissioner of Revenue regarding any tax, fee or assessment, or any matter concerning the tax laws listed in § 271.01, subd. 5, by an interested or affected person, by any political subdivision of the state, by the Attorney General in behalf of the state, or by any resident taxpayer of the state in behalf of the state in case the Attorney General, upon request, shall refuse to appeal. Decisions of the tax court are printed in the State Register, except in the case of appeals dealing with property valuation, assessment, or taxation for property tax purposes.

Syllabus

The Minneapolis Branch of the AAUW is not an "institution of purely public charity" and thus its clubhouse is not exempt from property taxes under Minn. Stat. § 272.02, subd. 1 (6).

The Court, having heard and considered the evidence adduced at trial and upon all of the files and records herein, now makes the following:

Findings of Fact

- 1. Petitioner is the owner of property at 2115 Stevens Avenue South in the City of Minneapolis, with Property Identification Number 34-029-24 12 0029.
 - 2. The subject property is land improved with an older three-story mansion used by petitioner as its clubhouse.
- 3. Petitioner seeks a determination by this Court that it is an institution of purely public charity and that the subject property is exempt from taxation under Minn. Stat. § 272.02, subd. 1 (6).
 - 4. The Court has jurisdiction over the subject matter in controversy and the parties hereto.
- 5. Membership in petitioner is limited to women holding a four-year college degree from an institution of higher education accredited by the American Council on Education.
- 6. Members are offered continuing learning opportunities through educational programs and participation in the petitioner's committees and offices.
 - 7. Members pay annual dues and are entitled to participation in all activities.
 - 8. The general public is invited to attend all educational programs without charge.
 - 9. The majority of the educational programs and organizational meetings and activities take place in the clubhouse.
- 10. The dining facilities, meeting rooms, auditorium and food service is frequently rented to outside organizations and individuals.
- 11. Income generated from dining room charges, food service and house rentals represent over fifty percent (50%) of petitioner's annual income.
 - 12. Income received from donations and fund raisers represent approximately one percent (1%) of petitioner's annual income.
 - 13. The attached Memorandum is made a part of these Findings of Fact.

Conclusions of Law

- 1. Petitioner does not come within the definition of an institution of purely public charity under Minn. Stat. § 272.02, subd. 1 (6).
 - 2. The subject property is not exempt from property taxes.
 - 3. Petitioner's request for tax exemption is denied.

LET JUDGMENT BE ENTERED ACCORDINGLY. A STAY OF 15 DAYS IS HEREBY ORDERED.
