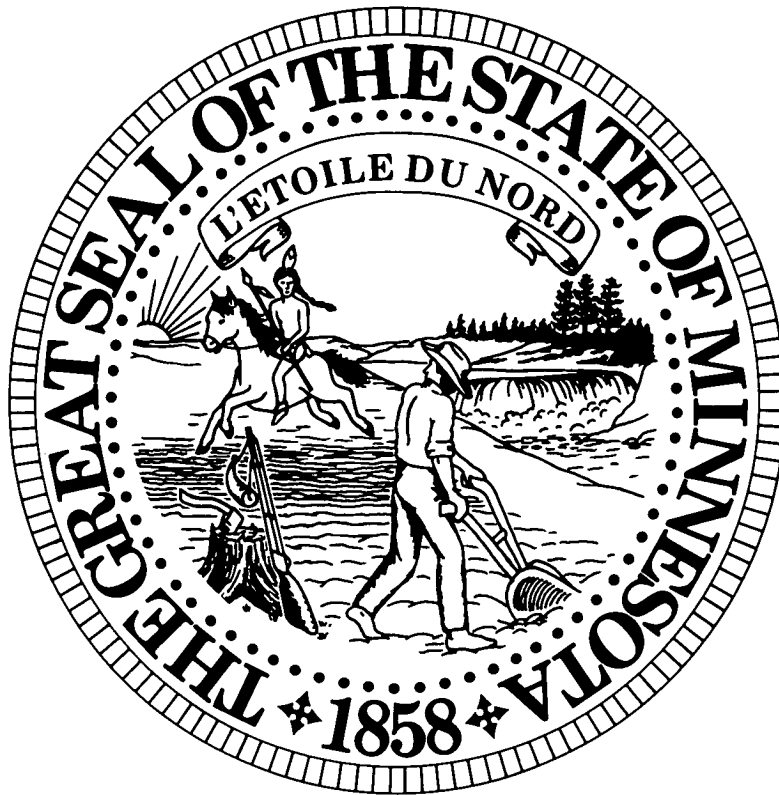

NOTICE

How to Follow State Agency Rulemaking Action in the State Register

State agencies must publish notice of their rulemaking action in the *State Register*. If an agency seeks outside opinion before promulgating new rules or rule amendments, it must publish a **NOTICE OF INTENT TO SOLICIT OUTSIDE OPINION** also.

The PROPOSED RULES section contains:

- Proposed new rules (including notice of hearing and/or notice of intent to adopt rules without a hearing).
- Proposed amendments to rules already in existence in the Minnesota Rules.
- Proposed emergency rules.
- Withdrawal of proposed rules (option; not required).

The ADOPTED RULES section contains:

- Notice of adoption of new rules and rule amendments adopted without change from the previously published proposed rules. (Unchanged adopted rules are not republished in full in the *State Register* unless requested by an agency.)
- Adopted amendments to new rules or rule amendments (adopted changes from the previously published proposed rules).
- Notice of adoption of emergency rules.
- Adopted amendments to emergency rules (changes made since the proposed version was published).
- Extensions of emergency rules beyond their original effective date.

The OFFICIAL NOTICES section includes (but is not limited to):

- Notice of intent to solicit outside opinion before promulgating rules.
- Additional hearings on proposed rules not listed in original proposed rules calendar.

ALL ADOPTED RULES and ADOPTED AMENDMENTS TO EXISTING RULES published in the *State Register* and filed with the Secretary of State before April 8, 1985 are published in the *Minnesota Rules 1985*. ADOPTED RULES and ADOPTED AMENDMENTS TO EXISTING RULES filed after April 8, 1985 are included in a supplement published in Spring, 1986. Proposed and adopted EMERGENCY (formerly called TEMPORARY) RULES appear in the *State Register* but are generally not published in the *Minnesota Rules* due to the short-term nature of their legal effectiveness. Those that are long-term may be published.

ADOPTED RULES

The adoption of a rule becomes effective after the requirements of Minn. Stat. § 14.14-14.28 have been met and five working days after the rule is published in *State Register*, unless a later date is required by statutes or specified in the rule.

If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed.

If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

ENVIRONMENTAL QUALITY BOARD: **Environmental Assessment Worksheets (EAWs)** due February 25: Lindahl Developments, Sherburne County; Logarto 3rd Addition, City of Lakeville; CR I—TH 10 to I-35W, Ramsey County Public Works Dept.; Addition to Miller Mall Expansion, MN Pollution Control Agency (MPCA); St. James Wastewater Treatment, MPCA; Springfield Wastewater Treatment Facility, MPCA; Motley Wastewater Treatment, MPCA; Amboy Wastewater Treatment, MPCA. **Scoping meeting** for the EAW for the Nicollet Mall Project (City of Minneapolis) will be held February 19 at 4 pm in Room 319 City Hall. **Comment period** is extended for the Lake Prairie Egg Company EAW until February 15. **No Environmental Impact Statements** are required for Regency Woods, Minnetonka; Pine Grove Resort, Crow Wing; and Sandstone Wastewater Facility, MPCA. HEALTH DEPARTMENT: Eight states in the northeastern and north central U.S. have issued a joint fish consumption advisory for the Great Lakes—including restrictions on lake trout taken from Lake Superior.

The advisory cautions Lake Superior anglers not to eat large trout more than 30 inches in length—whether they were taken from Minnesota, Wisconsin or Michigan waters. The restriction is based on test results—from both Minnesota and Wisconsin—indicating that the larger lake trout tend to contain unacceptably high levels of polychlorinated biphenyls (PCBs).

The advisory also notes that some states have recommended restrictions on lake trout smaller than 30 inches—but those restrictions vary from state to state, and apply to the waters of the state issuing the recommendations.

The joint Great Lakes advisory was based on the combined results of testing conducted by state agencies in each of the participating states. Minnesota's testing program is a joint effort of the Health Department, the Pollution Control Agency and the Department of Natural Resources.

The states issuing the advisory are Minnesota, Wisconsin, Illinois, Indiana, Michigan, Ohio, Pennsylvania and New York. Those states had earlier agreed to develop a joint fish consumption advisory for the Great Lakes in time for the 1987 fishing season.

NATURAL RESOURCES DEPARTMENT: Land owners who wish to establish or enhance year-around wildlife habitat can order Four-Season Shrub Packets containing 500 seedlings of 10 tree and shrub species. The packets can be ordered through any Department of Natural Resources Forestry office, Soil Conservation Service office or county extension agent. Each packet costs \$125 plus sales tax. The packet includes 50 seedlings of each of the following species: Nanking cherry, wild plum, western sandcherry, Juneberry, red osier dogwood, Russian olive, cotoneaster, ginnala maple, Manchurian crab, and red splendor crab. The packets were developed by the DNR Forestry and Wildlife divisions and the Minnesota Nurserymen's Association. The package includes planting suggestions. Stock is available for 400 packets. Orders will be taken until March 20 or until seedlings no longer are available. Call Thomas Kroll (612) 255-4971 or Miles Wiegend, (612) 297-2973 or (218) 372-3183.

Minnesota State Parks is sponsoring a contest for the design of the 1988 state park annual vehicle permit. This marks the first year for the contest, and the first park permit contest known of in the country. Rules for the permit contest are similar to those of the DNR's duck and pheasant contests. Copies of the rules are available from the DNR Information Center and will be sent to all parks in January. There is no financial prize for the winner, but winning artists will retain the rights to reproduce the artwork for sale. In addition, the artwork will appear on over 100,000 annual permits. Entries may be either an illustration or a graphic representation done with almost any conventional paper-based medium. Completed designs must fit into a 10 inch by 10 inch square format. The contest is open only to Minnesota residents (including DNR employees). Limit of one entry per person. Deadline for entries is Friday, March 13th. An independent panel of judges will select the winning entry on March 20th. For complete rules or more information call Bill Chiat in St. Paul (296-8162).

621.21 ACTIVATION OF MARKET ASSISTANCE PLAN AND JOINT UNDERWRITING ASSOCIATION.

At any time the commissioner of commerce deems it necessary to provide assistance with respect to the placement of general liability insurance coverage on Minnesota risks for a class of business, the commissioner shall by notice in the *State Register* activate the market assistance plan and the joint underwriting association. The plan and association are activated for a period of 180 days from publication of the notice. At the same time the notice is published, the commissioner shall prepare a written petition requesting that a hearing be held to determine whether activation of the market assistance plan and the joint underwriting association is necessary beyond the 180-day period. The hearing must be held in accordance with section 41. The commissioner by order shall deactivate a market assistance program and the joint underwriting association at any time the commissioner finds that the market assistance program and the joint underwriting association are not necessary.

621.22 HEARING.

Subdivision 1. **ADMINISTRATIVE LAW JUDGE.** The commissioner shall forward a copy of the petition to activate the market assistance plan and the joint underwriting association with respect to a class of business to the chief administrative law judge. The chief administrative law judge shall, within three business days of receipt of the copy of the petition, set a hearing date, assign an administrative law judge to hear the matter, and notify the commissioner of the hearing date and administrative law judge assigned to the matter. The hearing date must be no less than 60 days nor more than 90 days from the date of receipt of the petition by the chief administrative law judge.

OFFICIAL NOTICES

Subd. 2. **NOTICE.** The commissioner of commerce shall publish notice of the hearing in the *State Register* at least 30 days before the hearing date. The notice should be that used for rulemaking under chapter 14. Approval by the administrative law judge of the notice prior to publication is not required.

Subd. 3. **CONTESTED CASE; REPORT.** The hearing and all matters after the hearing are a contested case under chapter 14. Within 45 days from the commencement of the hearing and within 15 days of the completion of the hearing the administrative law judge shall submit a report to the commissioner of commerce. The parties, or the administrative law judge, if the parties cannot agree, shall adjust all time requirements under the contested case procedure to conform with the 45-day requirement.

Subd. 4. **DECISION.** The commissioner shall make a decision within ten days of the receipt of the administrative law judge's report.

Subd. 5. **WAIVER OR MODIFICATION.** If all parties to the proceeding agree, any of the requirements of this section may be waived or modified.

Maximum Interest Rate for Municipal Obligations in February

Pursuant to Minnesota Statutes, Section 475.55, Subdivision 4, Commissioner of Finance, Jay Kiedrowski, announced today that the maximum interest rate for municipal obligations in the month of February would be eight (8) percent per annum. Obligations which are payable wholly or in part from the proceeds of special assessments or which are not secured by General Obligations of the municipality may bear an interest rate of up to nine (9) percent per annum.

Publication of 1986 Minnesota Rules Supplement Number 2 and the 1986 Minnesota Statutes

Minnesota Rules 1986 Supplement Number 2 (Code 18-200B) is now available. This publication contains updates to Minnesota Rules 1985 and is composed of compiled rules of state agencies adopted between April 9, 1985 and July 28, 1986. *Minnesota Rules 1986 Supplement Number 2* replaces *Minnesota Rules 1986 Supplement Number 1*. The cost is \$17 for the set. The 10 volume set of *Minnesota Rules 1987* is scheduled for September, 1987 publication.

Also available are the *1986 Minnesota Statutes* (Code 18-8). This 10-volume set includes all the current laws in effect. STATE CONTRACTS AND ADVERTISED BIDS

Pursuant to the provisions of Minn. Stat. § 15.0412, subd. 6, an agency must make reasonable effort to publicize the availability of any services contract or professional and technical services contract which has an estimated cost of over \$2,000.

Department of Administration procedures require that notice of any consultant services contract or professional and technical services contract which has an estimated cost of over \$10,000 be printed in the *State Register*. These procedures also require that the following information be included in the notice: name of contact person, agency name and address, description of project and tasks, cost estimate, and final submission date of completed contract proposal. Certain quasi-state agencies are exempted from some of the provisions of this statute.

Commodities contracts with an estimated value of \$5,000 or more are listed under the Procurement Division, Department of Administration. All bids are open for 7-10 days before bidding deadline. 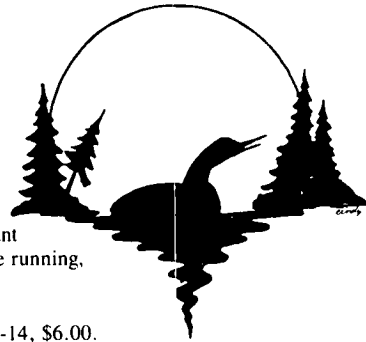
