#### NOTICE

#### How to Follow State Agency Rulemaking Action in the State Register

State agencies must publish notice of their rulemaking action in the *State Register*. If an agency seeks outside opinion before promulgating new rules or rule amendments, it must publish a NOTICE OF INTENT TO SOLICIT OUTSIDE OPINION also.

### The PROPOSED RULES section contains:

- Proposed new rules (including notice of hearing and/or notice of intent to adopt rules without a hearing).
- Proposed amendments to rules already in existence in the Minnesota Rules.
- Proposed emergency rules.
- Withdrawal of proposed rules (option; not required).

#### The ADOPTED RULES section contains:

- Notice of adoption of new rules and rule amendments adopted without change from the previously published proposed rules. (Unchanged adopted rules are not republished in full in the *State Register* unless requested by an agency.)
- · Adopted amendments to new rules or rule amendments (adopted changes from the previously published proposed rules).
- · Notice of adoption of emergency rules.
- · Adopted amendments to emergency rules (changes made since the proposed version was published).
- Extensions of emergency rules beyond their original effective date.

#### The OFFICIAL NOTICES section includes (but is not limited to):

- Notice of intent to solicit outside opinion before promulgating rules.
- Additional hearings on proposed rules not listed in original proposed rules calendar.

ALL ADOPTED RULES and ADOPTED AMENDMENTS TO EXISTING RULES published in the *State Register* and filed with the Secretary of State before April 8, 1985 are published in the *Minnesota Rules 1985*. ADOPTED RULES and ADOPTED AMENDMENTS TO EXISTING RULES filed after April 8, 1985 are included in a supplement published in Spring, 1986. Proposed and adopted EMERGENCY (formerly called TEMPORARY) RULES appear in the *State Register* but are generally not published in the *Minnesota Rules* due to the short-term nature of their legal effectiveness. Those that are long-term may be published.

Pursuant to Minn. Stat. of 1984, §§ 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing, as long as the agency determines that the rules will be noncontroversial in nature. The agency must first publish a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the State Register. The notice must advise the public:

- 1. that they have 30 days in which to submit comment on the proposed rules;
- 2. that no public hearing will be held unless 25 or more persons make a written request for a hearing within the 30-day comment period;
- 3. of the manner in which persons shall request a hearing on the proposed rules; and
- 4. that the rule may be modified if the modifications are supported by the data and views submitted.

If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.14-14.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the State Register.

Pursuant to Minn. Stat. §§ 14.29 and 14.30, agencies may propose emergency rules under certain circumstances. Proposed emergency rules are published in the *State Register* and, for at least 25 days thereafter, interested persons may submit data and views in writing to the proposing agency.

### **Proposed Permanent Rules Relating to Merit System**

# Notice of Intent to Adopt a Rule without a Public Hearing and Notice of Intent to Adopt a Rule with a Public Hearing if Twenty-Five or More Persons Request a Hearing

Notice is hereby given that the State Department of Health proposes to adopt the above-entitled rule without a public hearing following the procedures set forth in Minnesota Statutes, section 14.22 to 14.28. The specific statutory authority to adopt the rule is Minnesota Statutes, section 144.071.

Persons interested in this rule shall have 30 days in which to submit comment in support of or in opposition to the proposed rule or any part or subpart of the rule and comment is encouraged. Each comment should identify the portion of the proposed rule addressed, the reason for the comment, and any change proposed.

Any person may make a written request for a public hearing on the rule within the 30-day comment period. If 25 or more persons submit a written request for a public hearing within the 30-day comment period, a public hearing will be held unless a sufficient number withdraw their request in writing. Any person requesting a public hearing should state his or her name and address, and is encouraged to identify the portion of the proposed rule addressed, the reason for the request, and any change proposed. If a public hearing is required, the agency will proceed pursuant to Minnesota Statutes, section 14.131 to 14.20. PLEASE NOTE THAT IF TWENTY-FIVE OR MORE PERSONS SUBMIT WRITTEN REQUESTS FOR A PUBLIC HEARING WITHIN THE 30-DAY COMMENT PERIOD, A HEARING WILL BE HELD ON JULY 31, 1987, IN CONFERENCE ROOM D, VETERANS SERVICE BUILDING, 20 WEST 12TH STREET AND COLUMBUS AVENUE, ST. PAUL, MINNESOTA 55155, UNLESS A SUFFICIENT NUMBER WITHDRAW THEIR REQUEST, IN ACCORDANCE WITH THE NOTICE OF PUBLIC HEARING ON THESE SAME RULES PUBLISHED IN THIS STATE REGISTER AND MAILED TO PERSONS REGISTERED WITH THE DEPARTMENT OF HEALTH. To verify whether a hearing will be held, please call the Minnesota Merit System between July 23, 1987 and July 30, 1987 at (612) 296-3996.

Comments or requests for a public hearing must be received by the Department by 4:30 p.m. on July 22, 1987.

The proposed rule may be modified if the modifications are supported by data and views and do not result in a substantial change in the proposed rule as noticed.

The Minnesota Merit System rules provide for a system of personnel administration for local and county health and human services agencies. The rules apply to all positions funded in whole or in part by federal grants-in-aid requiring a merit system of personnel administration. The rules cover such areas as classification of positions, compensation, recruitment and examination, certification and appointment, leaves of absence, separation, tenure and reinstatement, and, in general, provide standards for agencies to follow

so as to ensure compliance with the Federal Standards for a Merit System of Personnel Administration (5 CFR Part 900).

If adopted, amendments to part 4670.2520 would change the maximum duration of an emergency appointment from 70 to 67 working days, making the Merit System rule language in this section consistent with the exclusion in the Public Employment Labor Relations Act (Minnesota Statutes, Chapter 179A) from the definition of employee.

Amendments to part 4670.2630 would change the current requirement that a request to extend a probationary period be received by the Merit System office at the beginning of the sixth month of the probationary period to fifteen days before the end of the probationary period, giving appointing authorities increased flexibility.

Amendments to parts 4670.2720 and 4670.2970 would delete the language in these parts entirely.

A Statement of Need and Reasonableness that describes the need for and reasonableness of each provision of the proposed rule and identifies the data and information relied upon to support the proposed rule has been prepared and is available from Ralph W. Corey upon request.

Adoption of these rules will not result in additional spending by local public bodies in the excess of \$100,000 per year for the first two years following adoption under the requirements of Minnesota Statutes, section 14.11.

If no hearing is required upon adoption of the rule, the rule and the required supporting documents will be delivered to the Attorney General for review as to legality and form to the extent the form relates to legality. Any person may request notification of the date of submission to the Attorney General. Persons who wish to be advised of the submission of this material to the Attorney General, or who wish to receive a copy of the adopted rule, must submit the written request to Ralph W. Corey.

# Notice of Hearing and Notice of Intent to Cancel Hearing if Fewer Than Twenty-Five Persons Request a Hearing in Response to Notice of Intent to Adopt Rules without a Public Hearing

NOTICE IS HEREBY GIVEN that a public hearing on the above-entitled matter will be held in Conference Room D, Veterans Service Building, 20 West 12th Street and Columbus Avenue, St. Paul, MN 55155 on July 31, 1987 commencing at 9:00 a.m. and continuing until all interested or affected persons have an opportunity to participate. The proposed rules may be modified as a result of the hearing process. Therefore, if you are affected in any manner by the proposed rules, you are urged to participate in the rule hearing process.

PLEASE NOTE, HOWEVER, THAT THE HEARING WILL BE CANCELLED IF FEWER THAN TWENTY-FIVE PERSONS REQUEST A HEARING IN RESPONSE TO THE NOTICE OF INTENT TO ADOPT THESE SAME RULES WITHOUT A PUBLIC HEARING PUBLISHED IN THIS STATE REGISTER AND MAILED TO PERSONS REGISTERED WITH THE DEPARTMENT OF HEALTH. To verify whether a hearing will be held, please call the Minnesota Merit System between July 23, 1987 and July 30, 1987 at (612) 296-3996.

Following the agency's presentation at the hearing, all interested or affected persons will have an opportunity to participate. Such persons may present their views either orally at the hearing or in writing at any time prior to the close of the hearing record. All evidence presented should be pertinent to the matter at hand. Written material not submitted at the time of the hearing which is to be included in the hearing record may be mailed to Howard L. Kaibel, Administrative Law Judge, Office of Administrative Hearings, 400 Summit Bank Building, 310 Fourth Avenue South, Minneapolis, Minnesota 55415; telephone (612) 341-7608, either before the hearing or within five working days after the public hearing ends. The Administrative Law Judge may at the hearing, order the record be kept open for a longer period not to exceed 20 calendar days. The comments received during the comment period shall be available for review at the Office of Administrative Hearings. Following the close of the comment period the agency and all interested persons have three business days to respond in writing to any new information submitted during the comment period. During the three-day period, the agency may indicate in writing whether there are amendments suggested by other persons which the agency is willing to adopt. No additional evidence may be submitted during the three-day period. The written responses shall be added to the rule-making record. Upon the close of the record the Administrative Law Judge will write a report as provided for in Minnesota Statutes, sections 14.15 and 14.50. The rule hearing is governed by Minnesota Statutes, section 14.14 to 14.20 and by Minnesota Rules, parts 1400.0200 to 1400.1200. Questions about procedure may be directed to the Administrative Law Judge.

### 4670.2520 EMERGENCY APPOINTMENT.

  - C. the rate is an rates are interim rate rates subject to refund as part of a general rate case;
- D. the public utility or telephone company is a party to a commission proceeding pending on January 1, 1987, or initiated between January 1, 1987, and July 1, 1987, in which the commission has ordered an investigation for the stated purpose of determining whether the public utility's or telephone company's rates should be reduced and has directed, in the investigation, that the company file financial data that address the impact of the tax reform act; or
- E. the rates have been established under a stipulated settlement and a commission decision approving the settlement. If a public utility or telephone company files with the commission before July 1, 1987, an agreement to make collections for its federal income tax expense subject to appropriate refund, the public utility or telephone company shall have an additional 90 days to obtain commission approval of the stipulated settlement.

<u>Public utilities and telephone companies whose rates are found to be just and reasonable under item B, C, D, or E are exempt from the requirements of parts 7827.0400 to 7827.0600.</u>

An abstract of title is a legal document which records the history of ownership of a parcel of land. This document shows the purchases and sales, mortgages, assessments, judgments and other liens or rights against the property. The abstract should be carefully reviewed by a purchaser before making a decision to buy property.

An abstract is a necessary part of the sale, financing or refinancing of your land. You can replace a lost or damaged abstract, but it may cost you hundreds or even thousands of dollars depending upon the history of ownership. Right now, the *average* cost of replacing an abstract is \$350.00 in the Twin Cities Area and \$200.00 in other parts of the state.

You, as the owner of land, are entitled by law to possession of the abstract. You should store it with the same care you use for other valuable documents such as wills, stocks and bonds. You may wish to store it in a secure facility such as a safe deposit box or an abstract company. If an abstract company presently has your abstract, they must offer to return it to you before charging any fees for storage.

3. Minn. Stat. § 386.375, subd. 3 is effective 60 days after the form is approved by the Commissioner.

This notice is published pursuant to federal regulations which govern the administration of the Medical Assistance program, 42 CFR 447.205 (1986). The purpose of this notice is to inform the public of changes made in Minnesota Medical Assistance because of changes in state law.

The 1987 statute changes provide changes in the areas of:

- I. Reimbursement for long term care therapy services;
- II. Payment for Day Activity Centers;
- III. Eligibility criteria for the MA program;
- IV. Reimbursement for MA services;
- V. Utilization review;
- VI. Long term care facility rates and exceptions to the nursing home moratorium;
- VII. Extension of the Medicaid Demonstration Project;
- VIII. Implementation of a Prepaid Health Plan program for AFDC recipients;
- IX. Changes affecting recipients residing in state facilities;
- X. Notification to spouses;
- XI. Home care licensure;
- XII. Surveillance and utilization review and third party liability, and
- XIII. Probate-estate collections.

Information on implementation of these provisions will be sent as needed to local welfare agencies via instructional and informational bulletins and manual material, to MA recipients via their MA cards, and to health care providers enrolled in the Medical Assistance program via provider bulletins.

### I. Therapy services in Long Term Care facilities

Minnesota Statutes 1986, section 256B.064, subdivision 1a, is amended effective the day following enactment to allow sanctions against LTC facilities for providing services not medically necessary.

Minnesota Statutes 1986, section 256B.433, is amended effective the day following enactment to:

- \* require therapy services to be medically necessary and appropriate to the medical condition of the recipient;
- \* require certification that treatment is appropriate;
- \* establish requirements for therapy services billed separately, including nursing home provider number, limiting charges for renting space, etc. to 108% of the annualized cost effective July 1, 1987, offsetting revenues in excess of 108% of cost when facility and therapist are related effective July 1, 1988, and limiting ratio increases to 5 percentage points, and
  - \* establish an advisory committee to study alternative methods of payment.

Minnesota Statutes 1986, section 256B.47, is amended effective the day following enactment, by adding a subdivision to establish requirements for allowable and nonallowable costs and cost finding.

Minnesota Statutes 1986, section 256B.48, subdivision 1, is amended effective the day following enactment, to establish a penalty of 3 times the excess payment together with costs for both facility and provider when rent exceeds established amount or when offset is improperly avoided.

#### **II.** Day Activity Centers

Minnesota Statutes 1986, sections 256B.501, subdivisions 5, 6, 7, and 9, which govern MA payment for day activity center (DAC) services, are repealed effective the day following enactment. This legislation amends current DAC reimbursement rules and incorporates some provisions in other statutes.

No change is projected in MA expenditures.

### III. MA Eligibility

Minnesota Statutes 1986, section 256.98, is amended effective July 1, 1987, to add wrongfully obtaining assistance provisions, including joint trials for 2 or more defendants charged with the same offense; clarify that action can be taken when assistance was received on the basis of misrepresentation or concealed facts; mandate recovery of assistance through criminal or civil action or both, and allow counties to retain 1/2 of non-federal share if recovery is directly attributable to the county.

Minnesota Statutes 1986, section 256B.02, subdivision 8, is amended effective July 1, 1987, to allow the state to pay Medicare Part B premiums out of state appropriations in those cases where MA funds may not be used.

Minnesota Statutes 1986, section 256B.06, is amended to include new policy and to incorporate language into statute. The new policy changes effective July 1, 1987, are:

- \* require use of AFDC income and asset methodology for families and children cases;
- \* exempt personal jewelry acquired more than 24 months prior to the period of MA eligibility and personal jewelry acquired within 24 months immediately prior to the period of MA eligibility and not purchased with assets of the applicant or recipient;
- \* increase income standards to 115% of AFDC for aged, blind and disabled and to 1331/3% of AFDC for families and children and pregnant women;
  - \* change the six month spenddown period to a monthly spenddown period;
  - \* disregard the asset test for pregnant women;
- \* provide that the \$40 personal needs allowance provision affects persons residing in hospitals, in addition to persons residing in long term care facilities and Regional Treatment Centers, and

\* authorize emergency medical care for aliens.

Incorporated into statute are the following changes which were effective January 1, 1987:

- \* restrict automatic MA to MSA recipients whose assets are within MSA limitations without a waiver of excess assets;
- \* provide MA coverage for pregnant women for 60 days postpartum;
- \* disregard increases in income as required by Public Law Number 99-272 and Public Law Number 99-509;
- \* exclude homestead for long term care residents for their initial six months residence in a long term care facility;
- \* exclude nonhomestead property not salable, with an equity of \$6000 or less and income producing at least 6% of the equity, or excess real property for nine months if a legally binding agreement is signed to repay the amount of assistance paid for that nine months:
- \* exclude capital and operating assets of a trade or business, insurance settlements to repair or replace property for 6 months, and vehicles which meet certain criteria, and
  - \* require income to be anticipated on a semi-annual basis.

Minnesota Statutes 1986, section 256B.064, subdivision 1a, and section 256B.15 are amended effective July 1, 1987, to allow recovery of MA funds after the death of a spouse for MA rendered for the pre-deceased spouse.

Minnesota Statutes 1986, section 256B.17, is amended effective July 1, 1987, to establish the period of ineligibility resulting from an uncompensated transfer as the average monthly per person payment made by the MA program to a skilled nursing home facility and allow the transfer of excluded resources.

Minnesota Statutes 1986, section 524.3-1201, is amended to allow a county agency to recover MA fund by affidavit of successorship.

Minnesota Statutes 1986, section 256B.37 is amended effective August 1, 1987, to require private health benefits to be used before MA

The estimated increases in MA expenditures are:

\$9,900,000 FY 88

\$23,400,000 FY 89

### IV. MA Services

Effective July 1, 1987, to require that MA reimbursement for the following services be subject to a 5% reduction from payment levels in effect June 30, 1987: physician; dental; vision care; podiatric services; chiropractic services; physical, occupational and speech therapy services; audiology services; mental health center services, psychology services; public health clinics and independent laboratories and x-ray services. This does not apply to prenatal or delivery services.

Minnesota Statutes 1986, section 256.969, subdivision 2, is amended effective July 1, 1987, to:

- \* provide state payment of the state share of cost from 8/1/85 through 6/30/87 for outlier adjustment. The change also allows continuation of the provision unless HCFA disapproves the language.
- \* limit annual increase in hospital pass-through cost for depreciation, rents and leases, and interest to the annual growth in the consumer price index for all urban consumers.

Effective July 1, 1987, the maximum pharmacy dispensing fee for MA/GAMC to \$4.

Minnesota Statutes 1986, section 256B.02, subdivision 8, is amended effective July 1, 1987, to:

- \* add hospice as a MA covered service effective July 1, 1988;
- \* allow the Department of Human Services to publish in the State Register Second Surgical Opinion criteria and requirements for inpatient and outpatient surgeries;
- \* limit drug reimbursement to the lower of the actual acquisition costs plus a fixed dispensing fee; the maximum allowable cost set by the federal government or the Department of Human Services, plus the fixed dispensing fee or the usual and customary price;
- \* allow an additional \$.30 dispensing fee for prescriptions dispensed to residents of LTC facilities when a unit-dose blister card system is used;
  - \* expand MA to cover preventive services for pregnant women at risk of poor pregnancy outcomes, and
- \* provide authority for the Department of Human Services to promulgate rules to allow MA payment for case management services to persons with serious and persistent mental illness and persons with brain injuries.

Minnesota Statutes 1986, section 256B.03, subdivision 1, is amended effective July 1, 1987, to limit the maximum payment for new vendors enrolled in the MA program after the base year to the average usual and customary charge of the same vendor type enrolled in the base year.

Minnesota Statutes 1986, section 256B.04, subdivision 14, is amended effective July 1, 1987, to add drugs to the competitive bidding list for volume purchasing of MA services.

Minnesota Statutes 1986, section 256.969, subdivision 3, is amended effective July 1, 1987, to provide for supplemental grants to hospitals receiving MA payments through a county-managed health plan that serves only residents of the county.

#### V. MA Utilization Review

Minnesota Statutes 1986, section 256B.04, subdivision 15, is amended effective July 1, 1987, to establish appeal rights of providers and recipients.

No change is projected in MA expenditures.

### VI. Long Term Care Facility Rates and Nursing Home Moratorium

Minnesota Statutes 1986, section 256B.431, subdivision 2b, is amended effective July 1, 1987, to adjust long term care facility rates for certain facilities located in geographic group I.

Minnesota Statutes 1986, section 144A.05, is amended effective July 1, 1989, to limit renewal of licenses for nursing homes to rooms with no more than 4 beds and change replacement criteria.

Minnesota Statutes 1986, section 144A.073, is amended effective July 1, 1987, to allow exceptions to the moratorium procedures and establish replacement restrictions.

Minnesota Statutes 1986, section 144A.27, is amended effective July 1, 1987, to require acting administrators to secure an acting administrator license within 30 days of appointment.

Minnesota Statutes 1986, section 256B.431, is amended effective July 1, 1987, to:

- \* provide real estate tax liability provisions in the operating cost provisions;
- \* allow special dietary needs adjustments for rates after 7/1/87;
- \* provide authority to contract for services for ventilator dependent persons;
- \* add property-related cost changes for nursing homes with a reduced licensed bed capacity after January 1, 1986;
- \* change depreciation recapture provisions;
- \* allow effective July 1, 1987, the lesser of the plant and maintenance costs or \$325 per licensed bed.
- \* provide special ratesetting for ICF/CD/IMD facilities effective July 1, 1986;
- \* change appraised value appeals criteria, and
- \* provide for a task force study of moratorium definition of hardships, need for nursing home beds based on age 75 instead of age 65 and older, and geographic maldistribution of beds and alternative services by December 15, 1988.

Minnesota Statutes 1986, section 256B.0641, is amended the day following enactment to require current owners of ICFs/MR and nursing homes to be responsible for debts to MA of prior owners.

Minnesota Statutes 1986, section 256B.091, is amended effective July 1, 1987, to expand the Preadmission Screening and Alternative Care Grants Program to include clients who are high risk to a boarding care home and to provide a penalty to counties for lateness in conducting screenings. Counties are also required to notify providers of the opportunity to be selected as an ACG provider, follow specified criteria for the selection of that provider and tell a provider why it was not selected.

Minnesota Statutes 1986, section 144A.31, is amended effective July 1, 1987, to change the composition of the Interagency Board and meeting dates to quarterly. The chair will alternate annually between the Department of Health and the Department of Human Services. Current relocating plan provisions are also extended to residents of ICFs/MR.

Minnesota Statutes 1986, section 144.0722, is amended effective July 1, 1987, to:

- \* change the time lines for reconsideration of resident assessments and for notification to residents of classification;
- \* provide further statutory authority for resident access to facility information and facility penalties for not providing it;
- \* set additional criteria for facility reconsiderations, and
- \* provide further statutory authority for the Department of Health audits of facility assessments.

Minnesota Statutes 1986, section 252.292 and 256B.092, are amended effective the day following enactment to:

\* establish RFP process and criteria for county initiated proposals to convert ICF/MR residents to community services, and

\* establish rate setting guidelines for payment to ICF/MR facilities during a phase-down to closure.

Minnesota Statutes 1986, section 256B.50, is amended effective July 1, 1987, to remove nursing home appraised value appeals board and implement a system of comparison between DHS initiated finding of value and facility initiated finding of value.

The estimated increase in MA expenditures is:

\$400,000 FY 88

\$1,200,000 FY 89

#### VII. MA Demonstration Project

Minnesota Statutes 1986, section 256B.69, is amended effective July 1, 1987, to extend the current MA Demonstration Project, which is implemented in Itasca, Dakota and Hennepin counties, is a prepaid program for the administration and delivery of health services to MA recipients. The project, which began November 1, 1985, is a federal waiver project which was due to expire at the end of the three year period. The project, which includes AFDC, aged, blind and disabled clients, will be extended pending approval by the federal agency. The statute changes also:

- \* require demonstration providers to pay clean claims within 30 days;
- \* change appeal procedures for the Demonstration Project to conform with other MA appeals;
- \* adds an expedited appeal process for "urgent care", and
- \* provide for judicial review of appeals.

No change is projected in MA expenditures.

#### VIII. Prepaid Health Plan

Minnesota Statutes 1986, section 256.045, is amended effective July 1, 1987, to include the Prepaid Health Plan appeals in the same process as public assistance appeals. The ombudsman, whose role is defined in statute, must be notified within 3 days of formal complaint. State agency hearings are not required if the sole issue is mandatory enrollment in a prepaid health plan.

Minnesota Statutes 1986, section 256B.031, is added effective July 1, 1987. This new section:

- \* defines Prepaid Health Plan contract requirements;
- \* requires payments be made within 60 days after the month of coverage;
- \* includes MA services, except chemical dependency and mental health services, skilled nursing home facility services, personal care services, transportation and community mental health clinics services;
- \* requires plans to provide assessments of pregnant women to determine their risk of poor pregnancy outcome and provide treatment of women at risk of poor pregnancy outcome;
  - \* requires plans to provide certain information to the state;
  - \* limits Prepaid Health Plan payment rates to no more than 90% of the projected fee-for-service MA costs;
- \* requires mandatory enrollment of AFDC recipients, except refugees, in counties where there are at least two prepaid health plans to choose from;
- \* allows recipients to have 30 days to choose a health plan. If the recipient does not choose, the commissioner shall randomly assign the recipient to a health plan;
  - \* requires a minimum 6 month enrollment;
- \* exempts women who are receiving MA as pregnant women and transfer to the AFDC program and the infant born to the mother through the 60 day postpartum period;
  - \* requires the recipient to participate in the prepaid health plan provided through an employer or former spouse;
  - \* designates an ombudsman;
  - \* provides services pending appeal in certain cases;
  - \* requires counties to have a prepayment coordinator;
  - \* requires the commissioner to allow public or teaching hospitals to participate, and
  - \* requires plans to use nonprofit community health service agencies.

The estimated savings in MA expenditures are:

\$2,000,000 FY 88

\$4,200,000 FY 89

### IX. Regional Treatment Centers

Minnesota Statutes 1986, section 246.511, is amended effective July 1, 1987 to require that this statute is applicable to children in all state facilities, including regional treatment centers and state nursing homes.

Minnesota Statutes 1986, section 246.531, is amended effective July 1, 1987 to give the Department of Human Services subrogation insurance settlement rights for patients of state facilities and establish charges for care in state nursing homes in the same manner as is done for the Regional Treatment Centers.

The estimated savings in MA expenditures are:

\$50,000 FY 88

\$50,000 FY 89

### X. Notification to Spouse

Minnesota Statutes 1986, section 256B.48, is amended to:

- \* require nursing homes to notify private pay residents of MA standards relating to assets allowed to be retained by a resident and the resident's spouse and of Medicare coverage of post-hospital extended care up to 100 days, and
- \* require the Department of Human Services to notify nursing homes and boarding care facilities of changes in determination of MA eligibility that relate to resources retained by a resident and the resident's spouse. PAS/ACG screening teams have primary responsibility.

No change is projected in MA expenditures.

#### XI. Home Care Licensure

Minnesota Statutes 1986, section 256B.04, is amended effective July 1, 1987, to provide the Department of Human Services rule authority to change from individual personal care assistant providers to organizations that employ and subcontract personal care assistant services. Personal care assistant organizations are exempt from Department of Health licensure, but must comply with the home care bill of rights.

No change is projected in MA expenditures.

#### XII. Surveillance and Utilization Review and Third Party Liability

Minnesota Statutes 1986, section 256B.02, is amended effective August 1, 1987, to include directors and officers of corporations or members of partnerships under the "vendor of medical care" provisions for purposes of MA.

Minnesota Statutes 1986, section 256.015, is amended effective August 1, 1987, to allow for a public assistance lien on a recipient's cause of action for benefits paid as a result of the claimed accident or injury.

Minnesota Statutes 1986, section 176.191, subdivision 4, is amended effective August 1, 1987, to:

- \* clarify that the state agency has a right to recover from any settlement or award compensating an injury for which public assistance was received, and
  - \* require notification to the state of workers' compensation claims.

Minnesota Statutes 1986, section 256B.042, subdivision 2, is amended effective August 1, 1987, to:

- \* allow the state agency one year from the date of the notice or the date the recipient's cause of action is concluded to commence an action to enforce a lien;
  - \* require notification to the state of monetary claims, and
  - \* establish a formula for satisfying DHS' lien out of a person's settlement or award from a cause of action.

Minnesota Statutes 1986, section 256B.37, is amended effective August 1, 1987, to require private benefits be used prior to MA.

#### XII. Probate—Estate Collections

Minnesota Statutes 1986, section 524.805 is amended to allow nursing home expenses of the last illness of the decedent to be a probate claim of the same class as medical and hospital expenses. It also provides of an additional class following medical, hospital and nursing home expenses of the last illness of "reasonable and necessary medical, hospital and nursing home expenses for the care of the decedent during the year immediately preceding death."

No change is projected in MA expenditures.

#### Supreme Court Establishes Statewide Task Force for Gender Fairness in the Courts

The Minnesota Supreme Court announced June 12 the formation of a task force to study whether men and women are being treated differently in the Minnesota courts. The Task Force for Gender Fairness in the Courts will examine whether gender based myths, biases and stereotypes result in the unfair application, interpretation and enforcement of the law within the Minnesota Judicial System.

No studies have been conducted previously in Minnesota, but recent studies in other states have revealed a pattern of different and unequal treatment of men and women. The Minnesota study will be an internal evaluation of the Minnesota System to document the existence of gender bias and to recommend methods for its elimination, where found.

The Supreme Court named thirty persons to the Task Force. Members are from around Minnesota and include men and women judges, lawyers, and public members. Justice Rosalie Wahl, Associate Justice of the Supreme Court, will chair the Task Force. Judge Susanne Sedgwick was named Vice-Chair. The Supreme Court also named as Task Force Consultant Dr. Norma Wikler of the University of California Santa Clara. Wikler was the first Director of the National Judicial Education Program to Promote Equality

for Women and Men in the Courts, and currently serves as advisor to the New Jersey and New York Gender Bias Task Forces. Wikler is Senior Advisor to the Foundation for Women Judges. Marsha Freeman of the Humphrey Institute was named Task Force Reporter.

The study is being funded in part by a \$50,000 appropriation authorized by the Minnesota Legislature. The Task Force must report findings to the Supreme Court by June 30, 1989. Thereafter, it will monitor the implementation of approved reform measures, if needed, and evaluate their effectiveness in assuring gender fairness in Minnesota's courts' processes.

#### Order Establishing Minnesota Task Force for Gender Fairness in the Courts

WHEREAS, recent scholarly investigations in local communities and states of this nation have revealed a pattern of different and unequal treatment of men and women in American legal and judicial systems; and

WHEREAS, such studies have demonstrated that gender based myths, biases and stereotypes operate in the application, interpretation and enforcement of numerous areas of the law; and

WHEREAS, the Minnesota Judiciary is committed to assuring the equal treatment under law of all Minnesota citizens;

NOW, THEREFORE, IT IS HEREBY ORDERED that the Minnesota Task Force for Gender Fairness in the Courts be, and hereby is, established to:

- 1. Explore the extent to which gender bias exists in the Minnesota State Court System, by ascertaining whether statutes, rules, practices or conduct work unfairness or undue hardship on women or men in our courts;
- 2. Document where found the existence of discriminatory treatment of women or men litigants, witnesses, jurors, and of women judicial, legal, and court personnel;
- 3. Recommend methods to eliminate gender bias in the courts including the development and provision of necessary judicial education, the passage of legislation and the promulgation of court rule and policy revisions;
  - 4. Report the findings of its investigation to this Court by June 30, 1989; and
- 5. Monitor, thereafter, the implementation of approved reform measures and evaluate their effectiveness in assuring gender fairness in our courts' processes.
